Mr. Fenstermacher,

As you probably know, meitner quit on thursday as my lawyer, no notice given. Because I have no more money left, I will have to be pro se. He will be emailing me the file at some point. I have no idea of legal matters and this is beyond unfair to me and to my mother since I have been the only one who exposed this scam on her and has tried to get her back to her beautiful large home in a private gated community, where she should be, to live happy and healthy until she dies. That is what she wants, but nobody has cared to do so, including her court assigned lawyers, guardians and you, her trust lawyer and guardian of her estate for 8 months. As you recall, you said in court you wanted the house sold, her loved possessions junked and me evicted. But, you also said you had not seen or talked to mother, your client, for about 2.5 years. How can you make decisions involving her without ever talking to her about them?

As you know, the nursing home costs her \$90,000 a year compared to about \$16,500 at her home (court records). As both mother's guardian of the estate and at some point my trust lawyer, it is your responsibility to protect mother's assets that some of that will be mine when she dies. At the rate those others are wasting her money, I will not have any inheritnce. I have reached out several times to Camp and also to my sister to save mother's money and her life at that disease infested nursing home, but neither of them care. As you are aware, my sister has a hate of me so intense, she seems to have a mental disorder that has existed all of her life for unknown reasons. You are also aware of the massive lawyer and guardian bills that are not needed. Neither I or meitner ever signed any document that said the guardian could hire any lawyers, other "care managers" or "monitors" pam blumer wanted and mother would have to pay for them. That also applied to logie and the lawyer he hired, Zabowski, and the "care manager" Klock. According to information, klock is still on as "care manager". Why? Klock is well known for stealing from her clients and other serious actions. Pam blumer is the guardian. Why did she keep a "care

manager" on? Again, mother's assets are being stolen and 50% of that money given to them and at the nursing home would be mine when mother dies. Mother still has a home to go to.

Mother still does not need any extra personnal daily services: dressing, undressing, hygiene, bathing, eating, maintaining her room, etc. She has never been claimed to have any mental illness, never a threat or menace to herself and others. But, she is forced to live in solitary confinement, in a sensory deprived environment 24 hours, in a locked down mental ward where just recently the metal knives were taken away at mealtime, never had a phone to call her friends or for help if needed (she has fallen 3 times in the past 7 months, hit her head, no CAT scan given), no visits to her regular doctors for the past 18 months, has not been allowed outside for 18 months, her legs have been extremely swollen for the past 17 months which had been blamed on me for bringing her our lunches for a while but, my guilt has been now disproven because I had not been bringing her any food for the past 3 months. Her money is no good to her if she is dead or brain dead from the lack of doctors visits and any physical or mental activities. Mother has skin cancer and was seeing her dermatologist twice a year, along with seeing her dentist twice a year and her other doctor's before she was taken away by sister.. There is a "house doctor" but he is on the payroll of the nursing home and his job is to save money, not wasting it on health care on people that are basically near death at any time.

At the petition hearing and in his second evaluation, I exposed the so-called "evaluations" by the psychologist Ledakis as being a total fraud. He was paid \$4,000 by mother for about 2 hours of time. I also proved that because he never recorded or video taped mother's "evaluation": ledakis cannot he even prove he ever gave her one, the results are hers and his report only belongs to her.

As you are aware, mother was dragged away from her home by sister and logie, forced to stay at sister's, sister refused to let mother see or call me on the phone, within 24 hours mother had to be put on anti-depressents because mother does not like sister and did not want to be forced to stay there, 2 days later, mother's hairdresser of 16 years said at mother's last hairdresser appointment, mother was shaking and crying saying "I want to go home, I want to go home", after 2 weeks at sister's, mother had to be taken to the hospital by ambulance unconscience for malnutrician, spent 6 weeks confined to bed, had daily blood tests and needles in the stomach to prevent blood clots, got covid and then was dumped into a low rated nursing home that had just opened up from a major covid outbreak. Now, mother has been forced to live under the conditions I described earlier. Why, when she can live at home and not needing any daily care at a fraction of the cost at the pig pen and live her life as she had been: happy and healthy?

About 3 months ago, because pam blumer (guardian of person) claimed staff people have claimed I would get my mother "agitated" (their word) when I used to be allowed to call mother and after I see mother after my visit. My visits since September 2021 have been only 1 hour per visit, 3x a week. Blumer hired a "monitor", brandi, of unknown background to sit next to me and mother during my visit and forced me to pay \$200 a week to see mother. Brandi would submit "reports" that have been almost all lies. Her reports look like a 5th grader wrote them (never typed) and were recently used as evidence to claim I was still getting my mother upset. Neither blumers lawyer, Gelsinger, or mother's court appointed lawyer, jaskowiak, ever brought in those staff people to verify their claims. That information is called here say.But, Judge weilheimer used those fake reports to cut back my visits from 3 to 2 a week. I still must pay brandi \$75 visit for only 1 hour with mother.

Because of the \$25,000 I paid meitner in cash and I still owe him about \$200,000 more, I do not have any more money to pay for those fake monitored visits based on those made up claims. I get only \$600 a month for social security and \$100 a month for welfare. I have been selling my things to pay for basics, including about \$75 a week in gas when I used to see mother and about another \$150 a week for mother's daily newspapers and the flowers I always bring her every visit. Before meitner, I had paid \$7,000 to my first lawyer after the petition was filed and \$12,000 I paid to the second lawyer before meitner.

As it stands, I cannot see my mother or even talk to her by phone. The next time I can see her will be in her coffin. Is this your idea of how you want your client of 21 years to be treated and living until she dies? Do you think a woman, at 98, wants to exist until her death in a tiny room, no place to put anything, not seeing or talking to her son that she loves and cares for every day like we used to and to go outside for activities, like restaurants, walks in the park, seeing her favorite movies on TV, calling her friends, etc?

Mr. Fenstermacher,

Very recently, Mr. Meitner quit, no previous notice given. He claims he has health problems. As you are aware, I have no legal knowledge at all and especially of my case to know when deadlines are due, matters to be appealed, how to do filings, etc. Also, as you know, because of all of the money I have wasted on lawyer fees on this guardianship scam since May 2021 with various lawyers, who basically did nothing to help my case, for the past year I have been living on about \$600 a month social security and about \$100 a month welfare. After paying Meitner about \$25,000 cash in the first three months of him being hired, I still owe him tens of thousands of dollars more. The \$14,000 check you gave me as my mother's gift to each of her children every year, I gave it all to Meitner to help pay my bill after you sent it to me late last year. The fact is, despite him being my lawyer for 14 months, for the sole purpose of bringing my mother home, she and I are far worse off now (visits, phone calls, outside activities, etc) than we were before he started.

As you are aware, I had found several very nice places for mother to live for the past year and much cheaper if she could not come home for some reason.. Both you and Blumer have refused to let mother come home where she can still live daily without any outside help to dress, undress, bathe, eat, walk, etc, or live in a much nicer, safer and healthier place and to also save her money that she may need if her health or memory get worse. You are also mother's guardian of estate and though you have told Meitner where mother lives is the responsibility of Blumer, you are the one who looks after her financial assets. Wasting \$90,000 a year on a tiny, disease infested room, locked down in a mental ward, in solitatary confinement, no phone, no doctors appointments for 15 months, not allowed outside to enjoy her house, her loved possessions, restaurants, etc, is not the way any person should be living when Mother has a large 3 bedroom, 3 bath house in a private gated community and about \$1.8 million in her Raymond James account (as of 2020). As you recall, several months ago, you signed off to sell the house, her loved possessions would be trashed and have me evicted, contrary to what my mother wants for

herself and for me. You stated in court that is what you wanted, but upon questioning, you stated you had not talked or saw mother for about 2.5 years. As both her trust lawyer of 21 years and her guardian of estate for 10 months, you have responsibilities and obligations as a guardian. If the house is sold (even though the money is not needed now) and all of her loved possessions are trashed because there is no room in her very tiny little room, then is that how a person, with her previous lifestyle and with the money she has now should have to live untill she dies? Would you allow that for your mother? As you know, my sister has no problem with mother living in that tiny room by herself, until she dies. I find it disgracefull for a daughter who did what she did to mother just to get what she always wanted: mother lives in a nursing home, house sold and all possessions trashed.

What was mother's crime that she had to be taken away by force by my sister and former guardian Logie and be forced to do what my sister and Logie wanted? That plan was to put mother into a nursing home (it seems anyone, no matter how low quality) whether Mother wanted to or not. Neither my mother or I were ever consulted about sister's and Logie's plan. Why not? Mother only had a little memory issue and she had no outstanding bills, no financial problems, no medical problems and was still driving her car when the petition was filed.

I am asking you to do what is best for mother and what being a guardian is responsible for: mother's happiness and her financial wellbeing. There is no need for mother's house to be sold and force the trashing of her possessions. Her room is so tiny, there is literally no place to put anything now, let alone any of her possessions from her house. She has more than enough money to live, as her lifestyle was certainly able to handle when she became "owned" by people. I only want mother to be happy. Who knows how much longer and in what condition mother will be living. She is owed happiness every day. The disgusting way she is forced to live now is not what I will accept for her. At the very minimum, I have found several extremely nice and much cheaper places where she can bring some of her furniture and other items. The other items can be stored nearby. Those places were totaly ignored by those in charge. Mother would be saving between \$30-\$60,000 a year over manatawny manor.

Let this stupidity and wasting mother's money by using billing hours stop being charged to mother by those lawyers. Her money is not theirs to grab for their lifestyle. When mother dies, 50% of the money they stole would have been mine. I am not giving my money to strangers.

You are wrong in every thing you said in your reply to me.

You have forgotten that in court several months ago, you said you had not seen or talked to mother for about 2.5 years. How can you ignore your client you have had for 21 years, especially now as her guardian of estate of 10 months? What have YOU done for her benefit? Anything? Why don't you want to see and talk to her? Do you hate my mother? How can you ignore your own client's financial welfare, her health and her happiness at her soon to be age of 98? If you don't want to be a guardian, quit. There are many other qualified people to replace you who care about their clients. She still can take care of herself and does not need to be locked in a very tiny section like a caged animal. Is my mother a caged mouse to you? Don't you want to know what and how your client is living until her death, maybe for years?

You are obligated as her guardian of her estate (including me as my trust lawyer when she dies) to be concerned with how her money is being wasted in various ways. The money you allow to be wasted now, until she dies, 50% of that wasted money would have been mine. I will not let you or anyone else just give away my money to strangers that my father worked hard for 65 years to make and save. My father kept you as his lawyer after you left the law firm. Why don't you want mother to do what she wants, especially since she still has the abilities to make logical decisions and still does not need any daily

assistance. Therefore, she does not need to be locked down in a tiny mental section, deprived of her doctor appointments, denied a phone, denied reading materials (always supplied by me and other items since September 2021), outside enjoyment of being in society, day trips, going home to see her loved possessions, enjoying life, etc? Mother is wasting \$90,000 a year on that pig pen. You do not know anything that is going on there or in this case, but you are going along with what those same people want who are stealing money from mother for their financial benefit. You know how much the checks are you are writing.

You said weilheimer said mother cannot come home. Why not? Weilheimer, blumer and jaskowiak never say. Why? Because I have exposed the scam on mother by many others, including the judge and jaskowiak, since September 2021, I have been falsely accused of many things just to deny me visits and phone calls, which is being done now. Several months ago, I was told I had to to pay for a "spy" hired by blumer and jaskowiak to watch us, listen to our conversation and make reports. The spy was told to make up lies in her reports to use them to ban me from visits until my mother dies, alone. Jaskowiak, weilheimer and gelsinger REFUSED to allow me to be able to protect myself from the made up lies of their hand picked "spy". Why? Mother has said my sister, your good friend, hardly ever sees her. Did you know that? Do you care that mother's money was/is being wasted on that "spy" of theirs just to deny mother from seeing me until she is dead just because I have been exposing the scam on her and many other elderly persons falsely accused of being "incapacitated" by psychologists using made up "evaluations". Those "evaluations" that have no independently proven accuracy. These type of scams are documented in the news all the time. I have a huge website about these scams of guardianship corruption at www.protectmy.parents.us that I created in November 2021. The proof of mother's fake "evaluation" is in the petition transcript and it was me who proved it in court in front of weilheimer, jaskowiak, camp and sister. Because of me, the FBI have been investigating the scam in Montgomery County Court since November 2022. As you know, my sister was interviewed by them because of her part in this scam on mother.

I totally reject your casual claim below that I should "face certain facts". Why aren't you facing the fact that you do not know anything about this guardianship corruption matter and what mother, your client of 21 years, wants? You said mother has a guardian. Both guardians of person and her court assigned lawyer I have proven corrupt, ignored mother's health, happiness and welfare and are stealing mother's money with made up billing hours by lawyers, while doing nothing for mother's benefit in any way. That gang of certain corrupt judges, lawyers, guardians and psychologists in the orphans court in Norristown have been known for doing that for many years, to thousands of elderly people with memory issues and I have the people's names that had that happen to their loved ones. Neither my sister or jaskowiak ever produced one example of my

mother needing a guardian for any reason at the petition hearing. Why? Why didn't jaskowiak ever produce any one of those people at the petition hearing to show why mother did NOT need a guardian? Because jaskowiak WANTED mother to be declared "incapacitated" just to start the plan of stealing money from mother, like they do to their other victims. Mother's health was in excellent condition, all her medical appointments were always kept, her bills were always automatically paid, she never bounced a check, she never wrote any strange checks, all taxes were always paid on time and she was still driving her car on her birthday without any tickets or accidents for 75 years. Not even her doctor of 21 years said mother should stop driving. So how could she declared "incapacitated"? Because of a corrupt psychologist, using a fake "evaluation" said so, so the gang could begin looting her money, as they do to many others who have money and a house. Because of my efforts,

At no time, did I ever sign any document that said pam blumer could hire as many people, including lawyers and a "care manager", as she wanted and mother had to pay for them. So WHY are you paying them? I had logie replaced with pam blumer, a good friend of jaskowiak (mother's court assigned lawyer). Blumer replaced logie who started the scam on mother, with my sister. I have documented many, many problems caused by and or ignored by the guardians, lawyers of guardians, Manatawny Manor, etc. Did you know mother got covid twice and influenza where she could have died? Did you know mother was taken by force by sister and Logie just to fulfill sister's long dated plan of putting my mother into any nursing home (needed or not), junk her possessions and sell the house just so sister would not have to deal with those matters when mother died? Mother was tormented so bad for 2 weeks at sisters, mother's hairdresser (Natalee) of 16 years saw mother 2 days after mother was basically kidnapped from her house for her last hairdressing appointment and Natalee said mother was shaking and crying saying "I want to go home, I want to go home". Did you know that. Meitner's repeated subpoenas were constantly denied by weilheimer for those hospital records and her records at the nursing home. Why? What is there to hide? While logie was there and mother was being forced away by sister, 2 cops had been called a head of time and held me on the porch. Why? There was NEVER any discussion of sister wanting any type of guardianship with mother or me before she did it. Why?

As you recall, you sent a letter exactly a year before sister filed the petition for guardianship to mother telling her I was lying to her (mother) when I told her(mother) that sister wanted to put her into a nursing home and sell her house, whether mother wanted to or not. Exactly a year later, with your help and you giving sister the law firm down the hall from you its name, sister did exactly what she wanted to do: file a petition for guardianship. Sister dropped out only because I had proof that she had been taking money from mother without mother knowing it. As you also recall, you tried to trick me into signing the "delegate authority" several years earlier that would have given sister absolute control of mothers vast assetts, including

being able to sell mother's house and put mother anyplace she wanted. While being forced to stay at sister's house, she denied mother to leave or call me or see me. After 2 weeks at sister's mother had to be taken to the hospital, unconcious, by ambulance, where she was treated for starvation for 6 weeks and confined to bed. Are you aware of that?

You claim that other's think everything is going fine with mother's care. Really. How would you know since you have not seen her or talked to mother for "2.5 years". Wasting \$90,000 a year for a tiny room, old and broken furniture, urine stained towels, bedsheets (if she gets them) stained pillow cases, tattered bed spreads, no phone in the room, no access to any reading materials (unless I bring them), only a hairdressing appoint once every month or so, not allowed outside for 17 months, no visits to her doctors for 17 months, not allowed to call her friends, no TV because she does not get the stations she used to watch so she cannot watch her old movies, not allowed food in her room to snack on, , no place to put anything so she has to put things on the floor, etc. You think that is good care for a 98 year old woman? Are you aware that since novemebr 2021, mother's legs are twice the size as they used to be and I have been fighting up to this day to get them looked at by a hospital, not just their retired "house doctor" who simply said keep her legs elevated and wear compression socks. They are still large and her feet swollen. Most of the time, the staff never puts those special socks on. The staff, logic and now blumer have claimed the legs were swollen because of the food I gave mother for our lunches 3x a week we used to have. But, mother has and still is not on any diet restrictions. The fact is, for the past 4 months, I have not given any food to mother, but her legs are still swollen and one of them is even more swollen. I have made police incident reports about that and other matters. That proves them claiming I am the reason for mother's swollen legs are a total lie, as all of the other lies said by them about me.

She has a \$400,000 3 bedroom, 3 bath house, paid for 21 years ago new, in a private gated community and as of about 4 years ago, she had \$1.8 million in her Raymond James account. So why does mother have to live in that disease infested, locked down section when there are much, much nicer and cheaper places for her to live (if not at home at \$16,500 a year court documented) with many of her loved possessions? Why do you allow mother to live there and in that way? What did she ever do to you or sister to be treated that way. Why do you allow them and you to waste that much of her money? What do you think your job is as her guardian of her estate? Why haven't you told pam blumer mother cannot be allowed to live that way until she dies?

Finally, that is really crappy and childish of you to claim I am wasting guardian and lawyer fees. Why don't you ask
Meitner what he knows and saw about how mother is living and being treated. He will verify everything in this email.

Everything I have told you in this email has been documented. To the delight of the gang of corrupt lawyers, guardians, judges

and psychologists, all who are feeding off of mother, I will not waste her money just to pay a hired liar who was told by blumer and jaskowiak to write lies in her reports about me just to build up enough so weilheimer will deny me visits until my mother dies. I am on a very little social security and some welfare because of all of the money I have wasted on lawyers, without any results to benefit me or mother. I have been the only one fighting to bring mother home so she will be happy, get exercise, doctor's appointments and do everyday activities to keep her memory as best as it can be.

As far as mother being happy there, what do you want her to do: yell, scream, throw things at people because she is not at home where she should be? Do you know anything about what they do at nursing homes? If mother acted up, they would drug her to the point of being a zombie, she is being very smart by staying in her room, except for meals. When I used to visit her, I brought newspapers, magazines, and thousands of pictures of the house, various items in the house and pictures of her past vacations to make her happy.

WILL YOU EVER EXPLAIN TO ME WHY SHE MUST LIVE THERE WHEN SHE CAN LIVE AT HER HOME OF 21 YEARS, SAVING ABOUT \$80,000 A YEAR (PLUS NO MORE WASTED LAWYER AND GUARDIAN FEES) SHE CAN STILL TAKE CARE OF HERSELF IN DAILY LIVING AND DOES NOT HAVE ANY MENTAL DISORDERS THAT SHE NEEDED TO BE IN A LOCKED DOWN WARD WITH PEOPLE WHO DO HAVE MENTAL AND BEHAVIOUR ISSUES OR WILL YOU JUST IGNORE THE FACT YOU FAILED AS HER TRUST LAWYER FROM SISTER'S ACTIONS THAT PUT MOTHER (YOUR CLIENT) IN HER CURRENT DISGUSTING LIVING CONDITIONS AND HAVE TOTALLY FAILED AS MOTHER'S GUARDIAN OF HER ESTATE? Mr. Fenstermacher,

I am now pro se. I have emailed you before about where my mother is living and the extreme high cost of that dump at \$90,000 a year. You have stated that where mother lives is blumer's responsibility. That is not true.

You are allowing massive amounts of money to be stolen from Mother for fake billing hours by many lawyers when no agreement was ever signed allowing a guardian to hire as many people she wants and bill Mother for them. Logie hired a well known person, deb klock, as a "care manager" for Mother, but klock has a well documented history of stealing from clients and overdosing them. Blumer kept klock on. Why? Blumer is the guardian of person, that is her job. Any legal expenses, are paid by blumer as part of her operating her business. .

As you see by the latest Order by weilheimer I will send you, she wants to hire ledakis again for another type of "evaluation" to determine if I can be left alone with Mother. Weilheimer said she is going to bill Mother's estate. There is absolutely NO evidence, by anyone, only undocumented here say by unknown people who after 2 years, still refuse to

put their names to any of their accusations, saying I am a danger to Mother in any way or I get mother "agitated". Why don't they ask Mother? Mother has never refused to see me or refused my 2x a day phone calls before blumer stopped them a year ago. I received the documents today regarding my eviction and they will be answered. I have no been able to find a place to live. If I have to live in my car, then I will do so. Since I am going to be evicted soon, as you know, I need the money from my Mother's gift money now. The yearly gift was sent by you last November and covered the next entire calender year.

Do you care that she has not been allowed outside and into society for 2 years, has not been allowed to go home to see her loved possessions of 98 years for 2 years, no phone in her room, no access to any reading materials (unless I brought them), no visits from ministers that I arranged, no letters to her from me or her friends, etc? WHY? I have found her much cheaper, much bigger and much nice places to live, but all of the others have refused. Why don't they think Mother is entitled to enjoy her own money at 98? She never adopted any of them and does not know them.

What did she do so bad? She only had a little forgetfullness. Nobody ever said she was mentally unbalanced or a threat to herself or others. Ledakis, who was hired 3 times now by weilheimer, said originally she could stay at home and with me there, everything was going fine. How can any guardian, especially guardian of person, allow a 98 year old person to live and die in that pig pen at \$90,000 a year when Mother has a huge beautiful 3 bedroom, 3 bath house in a gated community to go home to at the court accepted cost of

only \$16,500 a year? I would be there for free, as I was for a year, so she would have no problems being taken care of. You would still be in charge of her money, so there is no way I could be accused of getting something from her without you knowing it. How can anyone allow Mother to be there for 2 years so far, after having her own daughter do what she did to mother for 2 weeks in sister's home that put Mother into the hospital, unconciious, by ambulance, confined to bed for 6 weeks, treated for starvation, with 42 blood tests and 42 needles in the stomach to prevent blood clots?

You said Mother's things were not going to be junked. WHERE is she going to put anything in that very tiny room? You have never been there to see where and how she must live. Plus, those staff people are constantly stealing things from her room for 2 years. I have given mother many things that have been taken.

Are you aware that since last Novemebr 2022, I had to pay a "monitor" \$75 per visit to sit next to us because never named "staff" supposedly said after my phone calls and after my visits my mother was "agitated. But, nobody ever asked my mother. Why? She never refused my visits or my phone calls. As a lawyer, when nobody is giving their name and testifying to a claim, that is only here say. But the guardians and lawyers have used that lie only to waste my money, especially since they know I am on welfare for over a year because of all the money I have spent on lawyer fees and gas, gifts, etc to see mother and since November to pay a monitor, hired by blumer, to write lies about what I say to mother to further reduce my visits. In february, weilheimer, because of those made up reports, reduced my vists to 2 per week. About 3 months ago, I had no more money to waste on paid liars and I had to stop seeing mother. I do not use Mother for her money like others do. The \$24,000 is only a slight increase from \$16,000. My sister would get the same. There is NO reason for the house to be sold. Mother is not dead. pay \$75 an hour to a unemployed friend of blumer who is told to make up lies in her reports about me so my visits will be cut down, AGAIN, and eventually banned. NONE of their accusations against me have ever been brought to trial where I could have proven the lies by blumer and her lawyers.

Basic contract law dictates they not get paid. I will be filing a petition to deny those charges.

Blumer, Jaskowaik and I am sure my sister want to ban me from seeing Mother for life. The fact is, Ledakis said she should live at home in his first report. In addition to all of the money I have spent on gas to see her, the flowers, newspapers and other gifts I always brought her on my visits. I asked you for a slight increase to \$24,000 a year and when you ask her (see attached) I am sure she would want me to have it. In addition, when you ask Mother about the money, also ask her if she still wants me to live in the house as she had stated many times verbally and in writing, including in her hand written note (see attached).

For the past ten days, I have seen about 5 different places to live. Those landlords have told me they called you several times, but you never returned their calls. You stated several months ago that you would pay the rent as my trust lawyer from my future inheritance. I have told you that I have not trusted you for many years because of what you tried to do to my Mother, then and now. About 6 months ago, you signed off to evict me (against my Mother's well known wishes), sell her house and trash her loved possessions when there is no reason to do so. But, you admitted in court you had not seen or talked to my Mother for about 2.5 years. As her guardian of estate for over a year (including her trust lawyer fabout

23 years) you have obligations and requirements as her guardian (see attached). I told you in a email, if you do not want to be Mother's guardian, I have highly qualified replacements. I also have made it clear to you, that you have no right to tell me where to live and to know where I am living. That is why I need my gift money now.

I need the money now to live and pay for those daily expenses. You have not hesitated to pay for pam Blumer as a guardian of Mother when I have constantly shown that Blumer has done nothing for Mother as her guardian and in fact has done tremendous harm to Mother that Mother may not be able to recover from, including Blumer breaking the law. Blumer had hired many lawyers, care manager and other costs that she is not entitled to and neither I or Mr. Meitner ever agreed to pay if she was hired. There was no agreement ever signed by us that Blumer is entitled to be paid for those costs. That is basic contract law. Blumer's husband is a lawyer. Blumer claimed in court she has 10 clients now and has been in business for 11 years. After all of that time, she knows how to handle her business, without the need for lawyers. After all the money and other things Mother has given to her after my Father died, my sister's actions to Mother is disgusting and deplorable. It should be clear by now to all, I love my Mother and will not abandon her to those vultures.
