Re: Gifting

Mr. Fenstermacher,

I am entitled to my gift money to spend as I want and it has always been that way with Mother's gift money. I have made that point clear to you several times. You have no right to control my life and my Mother's gift money to me. You have wasted vast amounts of my Mother's money on that pig pen she has been forced to live in at \$90,000 a year, to her guardians and their lawyers without hesitation for their fake lawyer billing hours, while they have totally ignored Mother's health, welfare and their obligations to her under Title 20 section 5521.

That is your job, as guardian of estate for over a year, to oversee and protect Mother's assets, which you have not done. You admitted in court about 6 months ago, you had not seen or talked to Mother for 2.5 years. How can you ignore your obligations and requirements as her lawyer and guardian of estate and make decisions for her without asking Mother, your client under Title 20 section 5521 what she wants? You signed off to have me evicted and sell the house just for more money for the guardians, their lawyers and jaskowiak to waste with made up, fake billing hours. That is financial exploitation of the elderly and a crime. Do you know anything about this matter or only what the others in the Racket have told you, including my sister.

There is no reason that I cannot have my yearly gift money now. The last time you sent it was in November 2022 for my birthday and it was for the full year. The new gift limit is \$16,000. I said since you will be ignoring what mother wants and is legally entitled to make decisions about, if you are going to evict me, then I will need \$24,000 a year to live. At this point, since you are not going to protect my Mother's assets from this guardianship fraud, I do not expect those vultures of guardians, their lawyers and jaskowiak to leave anything as my inheritance. But, I am sure you have made sure my sister has been taken care of in some way.

Why has my sister, despite my 4 emails to Camp and to my sister, allowed my Mother to have \$90,000 wasted on a tiny room per year when I have found beautiful places for 50% less and she has also allowed the massive waste of fake lawyer billing hours of hundreds of thousands of dollars so far? Money Mother wants me to have

Mr. Fenstermacher,

For 8 years, before Mother was kidnapped by your "client", Ms. herring, and Logie who you dealt with (jsh) often and who you and her tried on several attempts to steal Mother's money away from Mother, (without her knowledge or permission) by using Mother's investment company, Raymond James, Mother gave us the same amount (\$14,000) to cover birthday, Easter and Christmas. You are bound to do what Mother wants (see attache) as her guardian of her estate as I have attached in your emails many times. You have also been her trust lawyer for 21 years. You admitted in court about 6 months ago you have not seen or spoken to her for 2.5 years. You have given hundreds of thousands of dollars away to a low rated nursing home when there is NO reason for Mother to be there. I am constantly finding much bigger, much nicer and much cheaper places for Mother. That is something YOU should be doing to protect Mother's assets and my future inheritance that you (unfortuneatly) are in charge of. You are also giving away hundreds of thousands of dollars to Mother's guardian of person, pam blumer, who hired her husband bill and then he hired many lawyers from his law firm. pam

blumer also hired a "care manager", Klock, who has a long history of stealing and over drugging her clients. They were hired by pam blumer without ever getting the court's permission to do so. Any expenses blumer occurred as a business, except her hour rate, are HER responsibility, not Mother's. That is basic contract law. You are giving Mother's money away to the Racket for any amount they wanted by their invoices of fraud. Mother's funds are being stolen by the Racket in several ways that I have pointed out to you, but you refuse to stop it. You still have not, to my knowledge, talked or seen my Mother since the your court appearance about 6 months ago.

You signed off to have me evicted, against what my Mother wanted (see attached) way before the psychologist, using fake "evaluations" claimed Mother was "incapacitated. By your actions, all of Mother's much loved possessions will be trashed. Why? Is she just supposed to either sleep in a chair, in bed or stair at the walls until she dies with nothing of hers to ever see? My sister has refused to let Mother have a phone to call her friends, not allowed outside into society, no access to reading materials, no visitors (including ministers), Mother does not look at TV because there are none of her channels she used to watch, not allowed food that I used to give her as snacks, etc. The flowers, gifts, news papers and magazines and letters I would write to her, my sister has told the staff to throw them out. Why? because she hates her mother. Look at what my sister has done to her and put her through. That is elder abuse and financial exploitation of the elderly, all major crimes.

Many times, I have offered to pay the yearly operating costs of the house (court established at \$16,500 a year, Manatawny Manor \$90,000 a year) since the beginning, but you and the Racket, which has included my sister since the beginning, have refused. The house only gets more valuable each year. You want to sell it only because money is being needed to refill the Racket's pot.

Do you know anything about this case? Jaskowiak, Mother's lawyer picked by weilheimer, never brought in anyone in court during my sister's fake petition hearing that Mother dealt with every year to prove Mother had no problems. They including medical doctors, investment people, tax people, etc. Jaskowiak refused to bring Mother into court to speak for herself and weilheimer refused all subpoenas to have her there. Those subpoenas also included Mother's medical records from the hospital and from the pig pen she has been for 2 years, in solitary confinement and in a sensory deprived environment. You, as her guardian, are obligated to know about what is going on with your client's life, health and welfare. I want to know because she is my Mother

You are refusing to give me the money, as Mother wants me to have, for birthday, Easter and Christmas every year for 8 years and for 2 years by you to live. You have NO right or authority to tell me how to spend that money. I am NOT asking for rent to be paid on top of that. As you know, you will be giving the same amount to my sister, if you have not already done so without my knowledge. But, you give her money to people that have been

lying just to make money for themselves using that made up "incapacitation" as their bank account. WTF?

You are just a common crook like my sister, weilheimer and the Racket are. You have NO justification to deny me what my Mother wants me to have to LIVE, not to buy a new car or a trip. You have refused to see her to see how the the guardian, blumer and my sister, have forced my Mother to live for 2 years when there is still NO reason that Mother cannot live at home happy and healthy. About 4 months ago, I had no more money left to pay liars who were now going to write more lies about me and I have severe restrictions what I can talk to my Mother about. You also denying me my Mother's gift money in retaliation because of my Mother firing you because of those independenty proven, very serious mistakes by you in my Mother's various legal documents. Mr. fenstermacher,

House Bill #1397 and Senate Bill 506 are supposed to eliminate the corruption and gross incompetence that you and others as guardians and lawyers of guardianships are doing to steal money and their lives from those victims.

I have emailed you many times about my money problem for the past 2 months that you are responsible for, but still no word from you and still no gift money (instead of birthday and Christmas presents) that my 98 year old mother has given to me and my sister for 8 years since my father died and from you, for the past 2 years that is coming from my Mother. Mother's gift money to her children has been \$14,000 a year and the new legal limit for non-taxable gifts is \$16,000 a year. My mother would want me to have any money I needed to live.

You have no problem wasting hundreds of thousands mother's money on lawyers and guardians who are not supposed to be paid because their charges are the responsibility of blumer as her business and NOT charges that are paid by Mother. Blumer has given herself pay raises without you challenging them. What else has blumer decided to have Mother pay for that are not to be charged to Mother, but you have allowed? Neither blumer, her husband and the various lawyers he hired in his firm, jaskowaik or the so-called "care manager" Klock who blumer hired have done anything for my Mother's happiness or her welfare. That certainly includes visits by her son and phone calls to him as she certainly wants. You have no problem wasting \$90,000 a year on a low rated nursing home for her to live (die) in a very tiny room with only a bed, a chair and a bathroom. No tables to put things on or phone so I can call her or her to call me or her friends, both banned by the guardian of person, blumer. Blumer was made guardian by judge Weilheimer in May 2022 after I forced the first guardian, Logie, appointed by weilheimer and promoted by jaskowaik, to quit for his gross incompetence and theft. Mother got covid and influenza at the nursing

home both of which could have killed her. The nursing home, Manatawny manor in Pottstown, had to be shut down several times because of the widespread outbreaks. About 39% of people that die from covid, die at nursing homes.

You admitted in court, about 6 months ago, you had not seen or talked to Mother for about 2.5 years. You, as guardian of the estate since May 2022 by weilheimer, pam blumer (guardian of person by weilheimer) and jaskowaik (weilheimer assigned lawyer for mother despite mother having all the money to hire her own lawyer) have made very serious decisions for spending mother's money without ever talking to her for you and the others to do what SHE wants according to the law (see attached). You have allowed her assets to be drained on the low rated nursing home at \$90,000 a year when I have found many times much nicer, much bigger and much cheaper places for her to live (unless she comes home) where she can her own loved possessions to enjoy. Why have you, guardians, my sister and jaskowiak REFUSED to let her go home to live in her large, beautiful house of 21 years and her much loved possessions, as weilheimer's hand picked psychologist Ledakis said she could and with me there as I had been living there for about 2 years (see attached) before my sister tried to get ownership of my Mother and her vast assets or to a much nicer, much bigger and much cheaper place to live? Are you and others in the Racket getting a kickback from the nursing home? There is no other reason.

As you also know, my visits with my Mother have been reduced from 3x a week for only 1 hour a visit (since September 2021 for no reason by weilheimer) and now reduced to only 2 visits a MONTH by Weilheimer several months ago because I have been exposing the scam by the Racket, not only on my Mother, but also on thousands of other victims of guardianship corruption for decades by corrupt guardians, corrupt judges, corrupt lawyers and fake "evaluations" used to declare people "incapacitated" just for their money and their houses.. I established in court at my mother's petition hearing when she was "judged" to be "incapacitated" that in Pennsylvania, there are NO rules or requirements as to what is accurate "evaluation" to determine "incapacitation" before a person's life and money are owned by the state and guardians. But, my Mother was NEVER asked if I did so and there were NEVER any "staff" who were named. My Mother NEVER reused my visits and calls. Those fake claims are called "here say" and are not

allowed as evidence in any way in court. But, weilheimer always allowed them. Weilheimer and jaskowaik put me into prison twice in 2021 and 2022 for exposing the scam.

Because I had spent all of my money on lawyers to get my Mother home without any success, I have been on welfare for about 1.5 years and do not have any money to pay the "monitor" to see my Mother. I have not seen my Mother for about 5 months. I am not allowed to call her or write her. My Mother has no idea why I do not see her anymore. Does she think I do not love her anymore? Will she think that if she dies?


Since August 2021 to September 1 2023, when my Mother was literally kidnapped by my 72 year old sister and the first guardian Logie, out of a possible 12,400 hours I could have spent with my mother (16 hour days), weilheimer has only allowed me 215 hours to be with her. 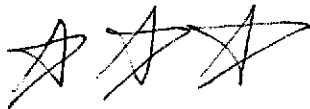
