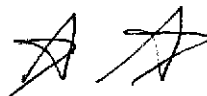



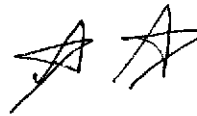

Now that the vultures and their entourage are leaving, that will save much, much more money for my Mother to keep. 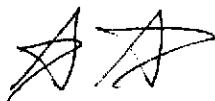

AND NOW, this 9th day of August 2023, upon consideration of the Emergency Petition of Arthur Herring, III for Supersedeas Stay the Eviction Order (Seq. # 84), the Court makes the following findings of fact:

- ~~1. This Court issued its Order of Eviction on October 7, 2022 after a hearing.~~
2. Arthur Herring, III appealed this Court's Order to the Superior Court of Pennsylvania.
3. The Superior Court quashed Mr. Herring's appeal on April 21, 2023.
4. Nothing in the instant Petition raises facts not known or considered by the Court at the time of the original hearing.

Therefore, based on the foregoing, the Emergency Petition for Supersedeas to Stay the Eviction Order is DENIED. There is nothing in any of the Court's Orders that prevents Arthur Herring from working with the Guardian of the Person to receive a reasonable advance on his inheritance to assist with his relocation.







During the hearing on Wednesday, I was able to prove that mary ellen has no training at all (she admitted it) to listen accurately, make notes accurately, make quotes accurately while continuing to listen, etc. In other words, she was told to make up lies against me by the guaridanship mafia to restrict and to eventually deny me visits with my Mother. I have known that since the monitors first started. 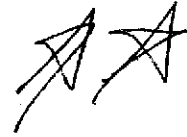

Fenstermacher,

As you know you, as a lawyer and also guardian of estate of my Mother for the past 2 years, you admitted in court about 5 months ago you had not seen or talked to my Mother, your client, for the past 4 years. As you are also aware, you and Mother's court appointed lawyer, Jaskowiak, had me evicted from her house in August 2021 against her previous written wishes without consulting her in any way before you did so. By court order by judge weilheimer, I have been forced not to tell my Mother I am living in my car.. So far, after 2 years, you still are not certified to be a guardian. About 5 months ago, you admitted in court you thought your only job as guardian of estate was to sign the checks for others without caring about fraud and waste of Mother's money. I was the only one who pointed out to you in court that preventing waste and fraud to Mother was one of the responsibility's of a guardian of estate. The actions in this matter and all previous matters that involve Mother, you, jaskowiak and lawyers for the guardians never consulted with Mother for her direction and input in this guardianship scam that she has been a victim of for the past 3 years. Ignoring those legal responsibilities clearly violate PA Rules of Conduct for lawyers. See attached.

Mother's rights given to her in federal and state laws pertaining to guardianship have also been violated and ignored by this "guardianship mafia" that involves corrupt judges, corrupt guardians, their lawyers, a corrupt psychologist, jaskowiak and you. See attached PA Title 20, S. 5521.

Since I was evicted from Mother's house in August 2021, it has sat unoccupied, but you have been wasting about \$2,000 for phone, cable and internet. You have wasted about \$1,500 for gas, water and electricity. You have wasted about \$2,500 for home owners association fees. Why? For the past 10 years, my Mother has given each of her 2 children \$14,000 as a gift instead of presents. You had given it to us each year after Mother was guardianized until last july when you claimed Mother could not afford to pay it because of the massive legal fees I was costing her. But, those legal fees were NOT Mother's responsibility to pay, but were only the responsibility of the guardians who hired their lawyers as part of operating their business, but billed to Mother. You simply paid them

anyway despite my demanding them not to be paid because those invoices were not Mother's responsibility. I was and still am the only one finding the many problems affecting Mother's health, welfare and her happiness. I am constantly having to file petitions and other documents trying to fix those problems. Where are the guardians and why aren't they doing their jobs? Why isn't Jaskowiak fighting for his client: Mother?

Because of you refusing to carry out Mother's request of giving me the gift money in August 2023,, I have been forced to live in my car since then, including during winter. I have been on welfare for 2 years because I have spent over \$100,000 on legal fees and other costs to get Mother back home where she should be living now. Mother has a large 3 bedroom, 3 bath house that has a spare bedroom and bath for any care worker if Mother should ever need one. In early 2022, the court accepted yearly cost of Mother's house was \$16,500. The low rated nursing home where my sister and first guardian logie dumped Mother is costing Mother about \$90,000 a year. Why have you allowed such massive waste to Mother, your client? Since September 2021, Mother has been kept in solitary confinement, in a sensory deprived environment, no phone, not allowed into society and not allowed back home to see her much loved possessions of almost 100 years. In May, Mother was 99 years old. Why do you allow such waste and mismanagement? That is your responsibility. Why do you allow such barbaric and inhumane treatment to Mother, your client? Mother never had any medical, financial or physical problems to be guardianized. She never bounced any checks, had no unpaid taxes, no unpaid bills. Mother was still driving her car safely when she turned 96. About 2 days later, her then 70 year old daughter filed the petition to own mother and her assets.

Noone has ever said Mother had any mental or behavior problems that would make her a threat to herself or others, but she has been locked in with those type of people since September 2021. Jaskowiak never brought in any of the people Mother dealt with every year (doctors, CPA, investment, weekly hairdresser of 16 years, housekeeper, etc) to defend Mother against guardianship of both person and estate because Jaskowiak and this guardianship mafia wanted Mother to be guardianized for her vast assets. Mother and I have always had a very close and loving relationship. I have been the only one who lost his home, lost massive legal fees, spent about 9 hours every day since this scam started on legal matters as pro se and went to prison 3 times by Jaskowiak for exposing the scam on Mother.

Since Mother was kidnapped from her home in August 2021 by her then 70 year old daughter, who filed her petition to own Mother and her assets, to June 1 2024 out of a possible 16,300 hours (16 hour days) Mother and I could have spent time together, Jaskowiak and the guardianship mafia have only allowed us 224 hours. Is this what you and the guardianship mafia consider a guardianship for the benefit of an elderly person who can live at home and be happy?

As you also know, both Mother and/or I have had to pay friends of jaskowiak to be "monitors" when Mother and I had our 1 hour visits. This was another example of using the court as a weapon to me for exposing the mafia's scam on Mother. Those "monitors" were told to write lies in their reports they made for every visit to be used against me to reduce and restrict our visits. This tactic by corrupt guardians is used nationwide on family members as a punishment for criticizing corrupt/incompetent guardians. The mafia has used their 2 lies that I made my Mother's legs swollen by the food I was giving her for our in-room lunches we used to have and the mafia also claimed I "agitated" Mother on my visits for 2.5 years. But, nobody ever asked Mother if I ever upset her and the mafia refused to ever file a petition for them to prove their claims. Every lawyer knows a person is innocent until proven guilty in a court of law. But, the mafia only wanted to make up those lies to punish me by reducing those 1-2 visits a month and then banning me from seeing Mother. I have not been allowed to see Mother for the past 6 months this year and for 5 continuous months in 2023.

I recently got your report and saw you and others still have my address as my Mother's house. That explains why I have not received most of the filings and other documents from the lawyers and guardians. But, all of you have had and know you had my address in Quakertown since I was forced out. It is obvious, this was done on purpose, also as a punishment so I would miss deadlines.

I was also informed recently some items were taken from Mother's house for her. Since the locks were changed by the mafia last August, I have no way of getting in. What was taken?

The new guardian that jaskowiak picked to replace pam blumer in February 2024, is still NOT certified to be a guardian, but is charging Mother \$160 an hour just to sit with her for 1 hour a month. That is a waste of money. I also noticed in a recent report by blummer that for the almost 2 years she was the guardian of person to Mother, Mother did not need any special services. So WHY is Mother NOT living at home where she will be happy, safe, be able to see her same doctors who know her health, be allowed to be in society and enjoy her life again?


