

Guardian Mafia

In Montgomery County Orphans Court, facts and information have proven for decades, the memory impaired have been victims of unspeakable crimes to them for their assets. This Orphans Court corruption has been documented for about 25 years on the Facebook website "Shenanigans in the Montgomery County Court". Mother's "guardian mafia" included corrupt judges, corrupt guardians, their lawyers, Mother's lawyer Jaskowiak, corrupt psychologists and my sister, Jsh. In mid May 2021, Jsh (then 70) filed a petition for guardianship on Mother (96) to get control of Mother's house and assets. Judge Weilheimer immediately assigned lawyer Jaskowiak as Mother's "lawyer". But, Mother had vast assets to hire her own lawyer. But, she was never allowed by Weilheimer/Jaskowiak. Weilheimer/Jaskowiak never allowed Mother in court as Mother had the right to be in court to speak for herself and what she wanted. Jaskowiak refused to defend and protect Mother against guardianship in court. By not defending Mother, Mother would be guardianized for her assets for this "mafia". Jaskowiak only saw Mother twice at her "cage" in 2.5 years, after she was falsely declared "incapacitated" by Weilheimer on August 6 2021. But, Jaskowiak was filing petitions and replied to petitions on "behalf" of Mother. NO lawyer can act on his own in legal matters WITHOUT consulting with his client on a REGULAR basis. Jaskowiak never did. Jaskowiak was acting ONLY for himself and this mafia. Weilheimer, later Judge Sterling, appointed various guardians, their lawyers, a "care manager", "monitors" and a psychologist to Mother just to drain Mother's assets. All of them were picked/approved by Weilheimer/Jaskowiak. Weilheimer assigned lawyer Fenstermacher in May 2022 as guardian of estate to Mother. But, Fenstermacher admitted in court in early 2024, he had not seen or talked to Mother for 4 years, including his two years as guardian of estate. He said he thought his only job was to sign checks of all invoices for this "mafia" and not care about waste and fraud. None of those guardians, monitors, lawyers or the staff at Manatawny Manor ever cared about Mother's medical, mental and physical wellbeing and her happiness as federal and state laws demand. Jsh and this "mafia" kept Mother in a low rated nursing home, in solitary confinement, in a sensory deprived environment, not allowed into society or back to her home, of 21 years, to live and enjoy her much loved possessions.

Mother had NO mental and NO behavior problems. Mother had NO financial problems. She had NO medical problems. She always went to her doctor's appointments. She never wrote checks to strangers or for strange amounts. She still drove her car safely at 96. Her taxes and bills were always paid on time. She cooked all of the meals. Her house was neat and clean because she and I did the house cleaning. Mother was living on social security and only a small part of my late father's vast savings he made during his life. Mother did not use a cane, no walker, no dentures, no hearing aid and no diapers. Mother was happy, healthy and enjoyed life.

In Pennsylvania, basically, anyone can be a guardian of person and/or estate. Guardian of Person has responsibility of the victim's life, health and location. Guardian of Estate has responsibility of the victim's assets to use/invest in any way they want. There is NO LIMIT how many clients (victims) either guardian can "own". Those guardians can have 100's or thousands of "clients" (victims) to steal their assets. Guardianship is human slavery until the victim dies. Guardian's charge what they want per hour. Guardians hire their friends and lawyers at the victim's expense, but there are NO laws or rules for them to do so. Those hired "kick back" money to the people who hired them. The guardians use the victim's money to pay the guardian's lawyers to protect the guardian. Guardians can reduce/restrict/ban family members from their loved ones for life. Corrupt judges protect the "mafia" and always approve their invoices.

The guardianship corruption and slavery starts when a petition is filed, usually by a family member, because the victim has a lot of money and a house. A corrupt judge will assign a corrupt lawyer to the victim, who will not defend the victim so the victim will be guardianized. The corrupt judge assigns a corrupt psychologist, who uses his "evaluation" to prove incapacitation. But, these "evaluations" have never been

proven independently to be accurate. The corrupt judge will then assign corrupt guardians, person and estate, to the victim. The guardian of estate will sell the victim's home very cheap to a friend who resells it at full value. The "mafia" keeps the profit. There are many, many federal and state laws that give many rights to the victim, but are always ignored by these "mafias".

In Pennsylvania and nationwide, there are NO requirements and NO standards for what a accurate "evaluation" must be to determine incapacitation. This includes how long the "evaluation" must be, how many questions must be asked, accuracy of those questions, was it audio or video taped, etc. No recording means NO proof it was ever done. Because no recording is ever made, the same report by the psychologist can be used over and over for other victims by using cut and paste of one name for another. NO medical tests are ever done. If a product is sold, but fake, it is fraud and a criminal offense. Weilheimer hired Ledakis, a psychologist, to do Mother's "evaluation". Ledakis used his made up "evaluation" and said Mother was "100% incapacitated". I exposed his "evaluation" as a total fraud in court. But, Weilheimer, jaskowiak and jsh's lawyer praised Ledakis and hired him many times for his fake reports to reduce, restrict or to deny my visits.

Weilheimer and Jaskowiak put me in prison in 2021 and 2022, for exposing information about their scam on Mother on my news website www.protectmyparents.us. In April 2024, Jaskowiak used a cop's fake affidavit about me to put me in prison again, twice, because I was protesting in front of Jaskowiak's house, on a public sidewalk, exposing the "mafia's" scam on Mother. Weilheimer/Jaskowiak violated my constitutional rights of freedom of speech and freedom of press. I and other victims of these guardianship scams, have contacted the Montgomery County DA's office and the FBI office in Ft. Washington many times by email, phone and in person. Many documents were given to both of them. They refused to open any cases. But, in December 2023, Gloria Byers, a guardian, was found guilty of stealing \$1.5 million dollars from her 105 victims doing the same thing as this "mafia" was doing on Mother. The FBI, IRS and the DOJ in Philadelphia prosecuted Byers.

Ledakis said in his first "evaluation" Mother could live at home because Mother had no problems with daily activities and with me living there for 2 years, everything was fine. But, on August 25 2021, Logie (original guardian of person and estate by weilheimer/jaskowiak) and Jsh kidnapped Mother from Mother's home and forced Mother to stay at Jsh's home. They had 2 local cops there at Mother's house to hold me so I would not stop jsh and Logie from kidnapping Mother as part of "the plan". For almost two weeks, Mother was drugged, starved and tormented by Jsh. During those 2 weeks, Jsh denied Mother to leave to go home, denied Mother the food Mother always ate, denied Mother to see me or talk to me. Jsh told me she (jsh) would have me arrested if I showed up at jsh's house to see Mother. That night of Mother's kidnapping by jsh and Logie, that Logie referred to as "the plan" in his invoice, I contacted the police to do a wellness check on Mother. The stupid cop told me he saw mother at the window and she smiled at him. To him, he thought she was alright. He never went inside to talk to her privately. Jsh could have had a knife at Mother's throat to get Mother to smile. The next night, I again called the police for a wellness check. The receptionist said she knew who I was and that Mother was fine and hung up. The next day, on a conference call with the other lawyers and judge weilheimer, weilheimer threatened me with prison if I ever called for another wellness check for Mother. A son calling to make sure his 96 year old Mother was alright after Mother was kidnapped for no reason by her daughter and Logie, and threatened by a judge with prison if I did. WTF? After about 2 weeks, Logie emailed me to say Mother had to be taken to the hospital because she fainted because of dehydration because it was a hot day. BS! I checked the temperature for that day in September 2021 and it was only about 79. Logie lied. Mother had to be taken by ambulance, unconscious, to a hospital, confined to bed for six weeks and treated for starvation. Mother had to get daily blood tests (42 times) and daily needles in the stomach (42 times) to prevent blood clots. Mother also got covid in the hospital where she could have died. Logie/jsh later dumped Mother in a low rated "nursing home" (Manatawny Manor) at \$90,000 a year, compared to only \$16,500 per year if Mother lived at home. Mother later got covid again and influenza where she could have died.

Manatawny Manor had many bad outbreaks of covid while Mother was there. According to the CDC, about 39% of the people that died from covid, died in nursing homes.

For 3 years, Mother was kept locked in solitary confinement, in a sensory deprived environment, no phone, not allowed into society and not allowed to go back home to live, to be with her loved possessions and to enjoy life. Mother was kept with people with mental and behavior problems. I fought for three years (mostly pro se) to get Mother back home to live before she was killed by the "mafia" with morphine. Weilheimer, Jaskowiak, Fenstermacher, jsh, guardians and their lawyers refused Mother's many requests to be in court to say what she wanted, as allowed by law.

Weilheimer/Jaskowiak/Fenstermacher evicted me from Mother's home in August 2023, which was against Mother's written wishes. I have been living in my car. I have been on welfare since about May 2022. Weilheimer/Jaskowiak restricted and/or denied me visits for 3 years because I kept exposing their scam. Mother was kept as a dog in a cage until she died alone in a horrible, agonizing morphine induced death.

Out of a possible 24,736 hours Mother and I could have been together (16 hour days, 8 hours sleeping) from August 25 2021 when Mother was kidnapped by jsh and logie to Mother's death on July 2 2024, this "mafia" only allowed us 224 hours together.

This was never guardianship. It was financial, physical and mental abuse and neglect of a human being.
