

## INTRODUCTION

Welcome to [www.janeherring.net](http://www.janeherring.net). Before reading the documents, seeing the pictures and watching the videos in this massive website exposing the guardianship scam on Jane Herring (my forever much loved Mother), on this website under "Guardianship Scam", read "Narrative" and Facts of Case" to learn the facts that happened in this guardianship scam and the "guardianship mafia" (Mafia). This mafia included corrupt judges, corrupt guardians, their many corrupt lawyers, Mother's daughter, jsh (age 70 and my sister), a corrupt psychologist, a corrupt care manager and most important, the lawyer the corrupt judge Weilheimer forced Mother to have at the very beginning of this scam: David Jaskowiak. Instead of Jaskowiak defending Mother and protecting Mother in court from this obvious fake guardianship, Jaskowiak refused to do so. Jaskowiak wanted Mother to be guardianized for her financial assets and home for this mafia. For 3 years, this mafia kept Mother in a tiny "cage", locked in solitary confinement and kept with people that had serious mental and behavior problems. Mother was NEVER accused of having such problems. Mother's "prison", until her death, was called Manatawny Manor, in Pottstown, PA. Their staff was only an extension of the mafia's barbaric and sadistic treatment of Mother.

You will learn about the types of barbaric and inhumane treatment this mafia did to my Mother for almost 3 years: mental, physical, psychological and financial. Mother's very happy and loved life ended for both her and me when Mother's daughter, jsh, filed the petition for total guardianship (person and estate) just 2 days after Mother's 96<sup>th</sup> birthday on May 16, 2021. Jsh later admitted in court she never discussed such a life changing petition with Mother or me because jsh did not think it (petition) was that important. Jsh continued to condone the mafia's inhuman treatment, isolation and financial exploitation of Mother until Mother's agonizing death of starvation and dehydration on July 2 2024 at age 99.

The mafia's 3 year torture of Mother ended when they finally had Mother killed by many morphine injections. Mother finally died after many painful days of being unconscious and not able to eat or drink. Mother was condemned to die in her tiny bed alone, in silent pain, agony and misery. There are laws nationwide that forbid a person to treat animals the way this mafia treated my Mother. This mafia considered my Mother LESS than a animal just for Mother's financial assets and her house.

This mafia denied Mother the right to have hospice (if Mother was really dying of cancer as they suddenly claimed), denied to have her last wishes and die with dignity in her huge home of 21 years and with her much loved possessions in her life. The mafia refused to allow Mother to have me, the son Mother loved and was always extremely close, with her during those final days while the mafia knew they were killing her by morphine because she would not be any more use to them. During those 3 years of captivity, from August 25 2021 when Mother was kidnapped by jsh and the first owner Logie to July 2 2024 when Mother was reborn, out of a possible 24,700 possible hours Mother and I could have been together (16 hour day, 8 hour for sleeping), the mafia only allowed us 224 hours. Instead, the mafia forced Mother to die alone, in her tiny cage, in a very tiny bed, at the low rated nursing home where the mafia had kept her locked up, in solitary confinement for the 3 years they owned her. Mother was also forced to exist in her cage by Mother's own daughter, jsh, who never really loved her Mother and who started the guardianship fraud on Mother just to own the assets. Many times, after jsh and my father died in 2013, jsh and the Executor of my parents Will for 21 years, Ronald Fenstermacher, tried to steal assets from Mother and to control Mother's life. I always stopped them. I fought this mafia pro se for almost 3 years and was sent to prison 4 times by this mafia for exposing their corruption on Mother and I am sure on many, many other victims just for their money.

Guardianship corruption has been massive nationwide and worldwide for decades. Guardianship is basically ownership of a human being and their assets. There are very few laws that protect the elderly from this slavery. The guardians, both for the person and of estate, can have as many "clients" (victims) as they

want. Massive amounts of very easy money can be made by those corrupt guardians nationwide.
