1. In his report, psychologist Ledakis said Mother had no problem with living at home and with me living with Mother for 2 years everything was fine. So why did he say she must have a guardian of person? His categories did not add up for Mother to be 100% "incapacitated" as Ledakis claimed. Ms. Herring appears to be receiving an appropriate level of support through her son (who resides with her) for her basic physical safety and ability to thrive, as necessary due to her progressive neurological condition (dementia). She is need, however, of a Plenary Guardian of her Person.
