- 75. Mother and I were always very close and loving during our lives. Mother depended on me after my father/her husband died in 2013 at 88 years old. They were both the same age. She still had no problems living independently, including still driving her car. She had no physical or medical problems, including at the time in August 25 2021 when her daughter, jsh and first guardian logie kidnapped her from her house as part of their/mafia's "plan" to steal Mother's assets and her home. I spent 3.5 years trying to protect her from this guardianship scam and trying to get her back home to live happily as she had been. Jsh filed her petition of guardianship 2 days after Mother turned 96 years old. Jsh admitted in court she never discussed her "plan" (scheme) of guardianship because jsh did not think it was "that important". I lost my home, a car and about \$100,000 on lawyer and other costs to help Mother. Mother was reborn on July 2 2024. She was killed by the mafia by morphine because the mafia because they were tired of her.
- 76. Another note by Mother proving her trust in me.
- 77. Another note by Mother making it clea she always wanted me to have the house and live there whether she was alive or dead.
- 78. Another note by mother showing her love for me and hoping I have a good life.
- 79. Mother was constantly saying, during our very short visits, she wanted to go back home to live after she was dumped at her pig pen and kept in solitary confinement until the mafia killed her by morphine on July 2 2024. I told her to write a letter to judge weilheimer who was in charge of the case. She wrote it on July 20, 2022 and I mailed it for her. She said she wanted to go home, get a new lawyer, come to court to tell weilheimer what she wanted (had the RIGHT to do in guardianship) and did not want me evicted from her house as I had been living for almost 2 years at her request she had been living alone since her husband died in 2013. Notice how perfect her handwriting and spelling were. Her sentences were correct and were straight across and evenly spaced between sentences. She had periods and dotted her "I's" and "t's". She had margins. Note: I had to turn in her original letter as a exhibit. When it was scanned, it was not scanned correctly so the end of her sentences were turned upwards. The mafia hired the quack/crook psychologist Ledakis again because the mafia thought I was telling Mother what to write in her room. Of course, ledakis's report said I told Mother what to write. Ledakis was hired several more times because he made more money by saying in his reports what the mafia wanted him to say. NO ONE ever went to Mother and asked her if she wanted those things. Why? BUT, on a zoom call to only lawyers and weilheimer in March 2022 (my former lawyer heard it), jaskowiak claimed he saw Mother at her pig pen and she said she liked her room, her food and the people there. So, jaskowiak was claiming Mother knew what she liked and had common sense. About 6 weeks AFTER his supposed visit with my Mother, Mother wrote her letter to weilheimer. So, why did the mafia think only 6 weeks later Mother did not know what she wanted or liked????? She did, BUT the mafia could not allow Mother to have what she wanted because they would have to admit they violated federal and state laws and the rights of those in guardianship by guardianizing her and denying her those rights, especially by the ADA, Olmstead, Rosengarten decision and PA Title 20, \$ 5521.
- 80. In December 14, 16 and 26 2022, Mother wrote me 3 very personal and loving letters in her own handwriting. This was Christmas time and she was NEVER allowed out of her tiny section in solitary confinement, even though Mother was NEVER accused of any mental or behavior problems. She was put there because that section was the most expensive to drain her money.
- 81. On November 2022, I wrote a letter to my then lawyer and pointed out my Mother trusted me so much with her care that she would not have a flu shot at the pig pen unless I told her it was OK. I did and she took the shot.

- 82. In a reply to a decision, my former lawyer pointed out that Mother had a kidney injury. To this day, I do not know what it was about.
- 83. Because the mafia was creating more lies to visit my Mother, I filed a petition and included this list for more visits.
- 84. Some, of the many, various painful things Mother had to go through because jsh filed her greed petition on Mother just for Mother's assets.
- 85. Reasons why Mother had to come home.
- 86. Some of the many court orders by judges weilheimer and sterling to keep Mother as property for the mafia to financially bleed to death. They finally did.

Mr. Meitner.

As you recall, pam blumer asked me to bring a seat for the shower for my mother about 10 days ago. Mother does not have one. Since she is the guardian and deb klock is "care manager" I cannot believe pam is asking me to do their jobs.

Today, I saw another Deb who is a nurse and she and Kay Richardson are in charge of the second floor where my mother is. I mentioned pam wanted me to get a chair for mother from manatawny manor and Deb made a unhappy face. It seems she does not like pam or her husband. Deb told me when bill asked her to testify a week or so ago she said no. Then bill subpoenaed her. Deb is mad at them because she said she will not be paid for the day. She seems to be mad at pam for other things, too. Deb told me mother showers standing up and it is standard practice to have a person watch in case they fall. Deb mentioned she put Colinda and a few other of those women at a different location because of their actions that day about 6 weeks ago. For the past month, usually no staff person is in the TV room to watch and listen to us when we have lunch.

VERY interesting. Deb also told me today on friday they were giving new covid vaccinations to residents and mother really refused to have one. Deb said she did not force it because mother was getting "agitated". Deb said mother said she would have to ask me if she should have one. I asked mother about that today and told her it was alright. Deb said she will have it scheduled for wednesday when I am there. Deb said mother constantly talks about me.

What is very important and should be brought out at the trial is that mother showed how much she depends on me and trusts me based on fridays statement that mother wants to talk to me first before she gets the vaccination. That will be very important to our argument that mother should be home with me because she trusts me and believes what I say is the best for her.

I strongly feel we have to be on the attack with all of them and show how they have done nothing for mother and been a danger to her and her health and happiness. Weilheimer will use every bad remark by anybody to cut my visits and keep mother there. Ledakis only said mother had a little memory problem. He never said she should be locked up in a mental ward so far for 13 months, no outside trips anywhere, no doctors visits for 13 months, no phone in her room and no unlimited visits and time she can be with me. She still does not get any special help from the staff: dressing, eating, hygiene, bathing, toilet, walking, etc. Mother is getting weaker with her legs when she walks. That is blumer's fault denying more time for outside walks at the nursing home or other physical and mental activities that she would have everyday at home.

People (fenstermacher, jaskowiak, weilheimer) last time were so concerned about mother's savings that they wanted to sell the house and trash her possessions, but no body cared that it was costing mother \$90,000 a year for a very tiny room with worn out furniture and locked down in a mental ward with people with serious medical, mental and behavior problems that had no benefit to mother when she could live at home basically free.

Why should mother have to live like that untill she dies in solitary confinement in a sensory deprived environment? Under blumer's, fenstermacher and jaskowiak's "care", mother will die a crippled person with advanced dementia and other medical problems because of their lack of proper care way before she should die.

The question that must be asked of blumer, fenstermacher and jaskowiak is after 18 months under their and logies care, how is mother better off now than BEFORE the petition was filed on May 18 2021? Whether medically, mentally, physically, emotionally and financially the answer is NONE of those. That should get them fired and mother home.

- 1. I make her happy.
- 2. Mother and I enjoy each other's company.
- 3. I will make her feel she is normal again in the life she was living by her being in the real world.
- 4. Mother was living happily in her large 3 bedroom, 3 bath house in a private gated community for 21 years with all of her loved possessions that she enjoys looking at, including all of her many photo albusms.
- 5. Mother has done nothing wrong to anyone to be kept caged like an animal.
- 6. I will take her to all of her doctor's appointments like she was always going to for decades.
- 7. I will take her to the hospital for her legs to be looked at that have been ignored.
- 8. There is no reason why she is kept locked up 24 hours a day, for almost 2 years like she is a danger criminal until she dies. No body ever said she has mental problems or is a threat to herself or others.
- 9. Mother still does not need any special services each day: dressing, undressing, toilet, hygiene, toilet, eating. Every day she still makes her bed perfectly like she had done all of her life.
- 10. Mother trusts me. About Decmber 2022, she refused her flu shot until I told her it was safe.
- 11. While I lived at the house for over a year, we always had breakfast together, lunch and dinner together.
- 12. Since my father died in 2013, my mother and I had dinner every night at her house. We would watch movies afterward.
- 13. She would cook and I would wash the dishes.
- 14. At least several times a month, I would buy her roses that she loved very much.
- 15. Every month since my father died, I would buy her roses and we would take them to the cemetary and put some on my father's grave, her mother's grave and her grandparents's grave.
- 16. Several times a month, we would go out to dinner and I would always pay.
- 17. If the weather was bad, I would always drive her to her appointments. Since her car was taken by logic, I will drive her all the time.
- 18. She had wanted me to stay in the upstairs bedroom ever since my father died for company and to save me money from paying rent on my mobile home.
- 19. Mother depended on me to to keep things going well, like car repairs, house repairs, shovel snow, etc.
- Mother never had to take anti-depressents with me or be treated for starvation at the hospital.
- She was never starved by me like she was by her daughter.
- 22. Mother never had to go to the hospital, by ambulance, unconscious because of passing out from starvation, confined to bed for 6 weeks, daily blood tests (42 times) daily needles in the stomach (42 times) to prevent blood clots.
- 23. She never had to worry about me stealing money from her or trying to:
- 24. I never made her so upset that she was shaking and crying, saying "I want to go home, I want to go home".
- 25. The last 5 years went she went to her primary doctor, she always wanted m to go into the room be a part of the discussion.
- At the nursing home, she always enjoyed us having lunch together and talking about private matters.
- I never asked her for moneyor tried to steal it like her daughter has done with fenstermacher's help..
- 28. When she was in the hospital, I saw she was not eating her food because it was always cold and she hated the taste. With the doctor's permission, I brought her home made food. She would gobble it down.
- 29. I saw she did not have any glasses to see, so I went to her doctors and bought her a pair.
- 30. At the hospital, everyday, I would bring her roses, newspapers, gifts, cards. I had to pay \$3 per paper because logic had canceled her subscription.
- 31. More visits all day and Sunday means mother can go home to see her home of 21 years, her loved possessions, go to restaurants, more exercise, more mental activities to keep her mind active.
- Mother's QUALITY of life now is almost nothing since she has been under their control and of her daughter's.

- 33. She wants to go to New Hope, Peddlers village, her husband's grave and other places that we used to go to all the time.
- 34. I have been on time and was at every visit 3x a week since Mother was kidnapped from her house by logie and her daughter on August 25, 2021. Until my phone calls were canceled by blumer in about May 2022, I used to call my mother 2x a day to talk and to mke sure if she had any problems I could help her.
- 35. As of June 1 2023, out of a possible 16,480 hours I could have been with my Mother (16 hour days, 8 hours for sleeping), the court and the guardians have only allowed me 215 hours. Pam blumer has denied us Christmas, Thanksgiving, Valentine's day, Mother's birthday, Mother's Day, Easter, Good Friday and many other visit days for no reason.
- 36. On every visit with Mother, I bring her pictures, gifts, flowers, cards, newspapers and other things she could use.
- 37. I always provided her with many things she could use for her room.
- 38. I was the one who got her a refridgerator for her room so she could keep her favorite food, milk, ice cream, etc. Neither her daughter or her guardian ever did that. I bought her no slip socks after she fell on the slippery floors so she wouldn't fall again and break something.
- 39. When we used to hie lunch together, I would always make it a treat by bringing her favorite foods and desserts, like ice cream.
- 40. I keep trying to get her a medic alert necklace, for her safety that logie had canceled, but blumer refuses to get her one.
- 41. When Mother was first dumped at the nursing home, I gave her a cell phone twice, but each time the staff stole them. I have tried to get her a phone in her room many times, but the director and the guardians have refused.
- 42. With more visits and much more time, mother and I can have private conversations of what she is concerned about without having guardian hired monitors right next to us.
- 43. Every week she would go to the hairdresser. Since she has been at the place, she rarely goes. I would take her back to the hairdresser every week so she would feel like a woman again.
- 44. None of Mother's doctors, maid, hairdresser, or friends have ever said anything bad about me. In fact, they have always said how much Mother says she loves me and brags about me.
- 45. It would cause mother extreme pain and suffering for Mother to think she would never see me again as it is now. Does she cry every night thinking I do not love her anymore or I am tired of seeing her/
- 46. Should everyone with a little forgetfulness be put into a dungeon until they die?
- 47. By being with her, I find the problems no body else does and I fix them.
- 48. I have found dead mice in her room, torn and tattered bed spreads, urine stained sheets and towels, broken furniture, I bought her a new watch when the staff stole the other on,etc.
- 49. I found her much nicer, much bigger and much cheaper places for Mother to live, but the guardians and jaskowiak refuse. At those other places, she can have some of her own furniture, pictures, paintings and be with people who are more normal to see and talk to.

- 1. Mother taken away to stay at jill's house on August 25 2021. Within two days she is seen by a eye witness (weekly hairdresser of 16 years) crying and shaking and saying "I want to go home, I want to go home". After being taken, logie (guardian) had mother's car taken away, canceled her medical alert necklace, canceled her newspaper and sent Arthur a 30 day eviction notice to leave mother's house where he had lived for about 1.5 year with her.
- 2. On August 27, judge weilheimer threatens Arthur with contempt of court if he calls for anymore wellness checks after only one had been called the day mother was taken away by logie/jill.
- 3. Within 1 day she is on a anti-depressent prescribed by her doctor, Dr. Kuhar. A week later, mother is put on another type of pill of unknown type.
- 4. For 12 days she was at jill's house, jill/logie refused to let mother see or talk to Arthur by phone. Jill threatened Arthur with arrest if he showed up to see Mother at her house.
- 5. After 12 days, Mother is taken to the hospital, unconscious, by ambulance for mainutrician. Logie claimed it was a hot day and jane fainted because of dehydration. In the second ledakis report, logie claimed jane was taken to jill's as a trial to live there.
- 6. Mother was at the hospital for 6 weeks.
- 7. While at the hospital, mother was confined to her bed for no reason, was not given any exercise, could not watch TV because no one there showed her how to use the complicated system for it.
- 8. At the hospital, Mother was treated like a fall person so her alarm on her bed was always on and everytime she tried to move in her bed, the alarm would go off constantly, waking her up in the night.
- 9. Everyday at the hospital mother had blood tests (42 times) and daily needles (42 times) in her stomach for unknown reasons. Her arms were black and blue from those blood tests.
- 10. Mother was not eating her food because it was always served cold and tasted awful.

 Arthur was bringing her food for her to eat. None of the hospital staff ever noticed she was not eating her food. Doctor's gave permission for me to give her food.

- 11. Arthur was not permitted to talk to the doctors or nurses about his Mother. Logie refused to tell Arthur anything about his mother's condition.
- 12. Arthur, by court order and by logie (legal guardian), has been only allowed to see his mother 1 hour per day, 3 times a week since about September 15, 2021. No reason given for such a small amount of time for a mother to see her son.
- 13. At week 5 at the hospital, Mother got covid and was not allowed to see Arthur for 2 weeks.
- 14. At the end of week 6, logie took mother to manatawny manor to where they just opened up from being totally shut down because of covid outbreak. About 39% of people that die from covid die at nursing homes with it.
- 15. My mother's tiny room is about \$7,500 a month.
- 16. Mother did not have a refridgerator in her room until Arthur got her one.
- 17. The room still does not have a telephone in the room because logie, pam blumer and mother's daughter does not want her to have one.
- 18. After 11 months (July 15, 2022) Mother is still only allowed to see Arthur for 1 hour, 3 times a week because logie, pam and the daughter do not want her to have more.
- 19. Mother lives in a tiny room with worn out and broken furniture, torn bedspreads and only a bathroom sink to wash her underwear.
- 20. Mother is in a locked down section with people that also have mental problems. There are no locks on the doors and there are men on the floor. There are no cameras in the hallways for staff to see if men go into any room at night to be with women or to hurt them.
- 21. Mother has never been allowed outside or go for any day trips or restaurants with Arthur for meals.
- 22. Jane has been kept in solitary confinement and in a sensory deprived situation.
- 22. The only other room is a room with card tables where 4 people eat breakfast, lunch and dinner. After meals, the TV is turned on for a TV movie for people to see. The people in mother's section also have medical problems and behavior problems that cause great

distress to mother to eat her meals in comfort. The people are not allowed extra helpings of food. That room is only about 35 feet away from mother's room. That is the only exercise she gets.

- 23. About November 18 2021 or so, mother's legs became very swollen and hard. Logie/sister refused to take mother to a hospital for ultrasound tests to determine if there was a blood clot, infection, etc. About March 1, it is believed mother had such a test. Logie claims the swollen legs are just poor circulation and tried to blame Arthur for giving mother junk food to eat. As of July 15 2022, mother's legs are still swollen and hard.
- 24. About November 15 2021, Arthur found a dead mouse under mother's bed. The director, joe, was told. Several days later the mouse was still there and again joe was told. Arthur called East Coventry police about the dead mouse and mother's legs were still swollen. On a conference call, joe claimed I yell at his staff. The police wrote a report about the issues.
- 25. When Arthur calls mother, he has to call usually every 10 minutes, up to sometimes 2.5 hours before a staff person picks up the phone and tells Mother to come to the staff desk to talk. Mother is limited to only about 10 minutes or so to talk while the staff listens. During phone calls on an extension, jane hears clicking that is definitely linked to staff picking up the phone and listening. There is a intercom in jane's room that is believed the staff can listen in on conversations between jane and Arthur.
- 26. At the end of Arthurs 1 hour visits with mother, she sometimes start to cry because he has to leave so soon. Since August 25 2021, Arthur and mother can only see each other, at the most, 1 hour, 3 times a week. Mother will be 97 in May 16, 2022. Mother had just turned 96 in 2021 when the daughter, jill, filed the papers to start legal guardianship of mother.
- 27. About june 19,2022, mother said her right shoulder was hurting because she slipped and fell on on her head and shoulder because of a just waxed floor. I bought her several pairs of no slip socks. I told Meitner; about a week later someone came in to xray it. As of July 22 2022, her shoulder still hurts and she cannot raise her arm above a certain level.
- 28. For a week, July 8-15 2022, jane does not have her TED socks on. On days past that, she does not have those TED socks on.

- 2. After almost 24 months, mother still does NOT need any type of assistance or services in any daily ways: dressing, undressing, bathing, hygiene, toilet etc.
- 3. Visits to her room would prove she is still extremely neat and tidy.
- 4. Mother is extremely safe at home from any deadly diseases. Mother was infected with covid while at the hospital for 6 weeks because of sister starving Mother. Manatawny Manor (MM) had just opened up from a total covid shutdown when Mother was dumped into it by logie, sister and deb klock. It was shutdown again for two weeks for a complete influenza outbreak in early 2022. Mother got influenza. She later got covid again where she could have died. Now there is monkey pox. About 39% of all covid deaths happen in nursing homes because lack of proper masks. MM has extremely unsanitary conditions. The janitors that clean bathrooms also wear the same gloves to empty the trash. They touch all the doorknobs of people's rooms then the residents touch the same doorknobs and touch themselves. Senior citizens do not care about being clean. Other people then touch the same doorknobs. That is how disease is spread.
- 5. There are still active cases of covid at MM.
- 6. Cost: \$16,500 living at home----\$90,000 living in the nursing home.
- 7. Mother has not been outside for about 2 years and has not been to her regular doctors for about 2 years. That never happened before. Mother has been confined to a 35 foot hallway as exercise. NO doctor would say sitting in a chair all day or laying down most of the time is healthy for a senior citizen.
- 8. No daily activities to keep her brain active.
- 9. No regular exercise. Mother is now walking with a cane and taking very small baby steps.
- 10.Mother has been living in solitary confinement, in a sensory deprived environment for about 2 years.

- 11. Since August 25, 2021, out of a possible 18,000 hours I could have been with my Mother (16 hours per day, 8 hours sleeping) I have only been allowed to see my Mother 224 for 180 hours at her age now of 190. 99 you at her death July 2 2024
 - 12. No fresh meat, vegetables or other healthy food for mother for almost a year.

- 13. Mother has a 3 bedroom 3 bathroom \$400,000 house to live in and \$1.8 million in the bank so why is she forced to live in the pigpen? At nursing home she has only tiny one room with broken and worn out furniture, tiny bed, urine stained sheets and urine stained towels torn bedspreads and basically no place to put anything except on the floor.
- 14. Mother has no telephone to call people or call for help if needed. Staff is usually not at their desk even if she calls them there.
- 15. Since May 2022, guardian of person blumer has refused to let mother call me or call anyone else or they call mother. She is not allowed visitors, including ministers. Mother is not allowed letters or send letters to me or her friends. Mother has no access to any reading material. Her TV only gets very limited channels that she does not like.
- 16.Mother does not have any medical alert necklace like she had for 9 years. She has fallen already in her room after the floors were just waxed and hit her hip, shoulder and head. I bought her no slip socks. No CAT scan was ever done by blumers.
- 17. Mother's room has no locks on the door. There are people (including men) with mental and behavior problems that can walk into her room day or night. There are cameras in the hallways so staff at desk cannot see anybody entering her room. Mother has said many times the women go into her room thinking it is theirs and sit down if she is not there.
- 18. Mother has skin cancer that has not been looked at for about 2 years. She needs her medical visits to HER doctors.
- 19. Mother is wears old. She wants to be with me and be able to live normal again until she dies and to go places. She wants to eat the snack foods she likes. Mother is extremely healthy and active for her age.
- 20. Except for a very low dosage cholesterol pill, mother is not on any other medications BEFORE she was kidnapped. Her medications now seem to be a antidepressent and other pills for unknown reasons.
- 21. What meds is she getting now and why.
- 22. She has made it extremely clear she wants to go back to her home of 21 years.
- 23. Mother drinks special milk for her stomach. I have brought it to her for a year. I fought to get her a refrigerator so she could have other food she likes.
- 24. For a year, every time I visit, I use sanitizer spray on all 4 of her doorknobs to reduce her chance of getting a disease. I cannot do that now because of blumer's "new" rules.
- 25. There are no charges against me of any kind, so why have I only been allowed 1 hour visits 3 times a week including special holidays: my birthday, her birthday, Christmas, Easter, Valentine's Day, Mother's Day, etc, plus no phone in the room violates the 8th Amendment that prohibits cruel and unusual punishment, especially for a 98 year old woman who wants to spend as much time with her child as possible before she dies, which can be at any time or have a stroke where she does not remember her son.

- 26.In this country, a person is innocent until proven guilty in a court of law and the person has the right to face their accuser. So far, there have been no "staff" reports, with anyone's name on them pertaining to logie's and now blumer's claim that after the phone calls (canceled by blumer in May 2022) I had with my mother and my visits, they claimed the "staff" said I got my mother "agitated". Nobody has ever asked my Mother. Why not?
- 27. Mother's money is rapidly being depleted by the guardians, their lawyers, jaskowiak, sister, klock and ledakis with their made up billing hours. Most of those people are part of blumer's business and she never had approval by the court or my ex lawyer to hire those people and make Jane pay for them. Contract law is very specific.
- 28. Many studies have proven lonliness, isolation from people (especially loved one's) and lack of exercise is extremely harmfull to a senior citizen's physical and mental health.

- 5 21 21- jaskowiak appointed mom's lawyer
- 8 6 21- mom declared incapacitated "by clear and convincing evidence." AHIII is not an appropriate guardian for jane. She did not have the capacity to change her legal documents in December 2020 and January 2021.
- 8 11 21- logie appointed guardian of person and estate.
- 8 27 21- AH cannot go to jsh's house; no wellness checks by ah.
- 10 7 21- visits 3x a week; cannot share information about jane.
- 12 15 21- AH in contempt; 6 months prison or until information on his website and talk show deleted; must pay fine of \$4,680 to jaskowiak.
- 12 19 21- AH released from prison; cannot tell mom he was in prison.
- 5 9 22- no JTH at hearing; no kuhar, MM or hospital records; no hearing for Jane's incapacity.
- 5 13 22- logie quits; blumer and fenstermacher appointed guardian of person and estate.; definitions of what they can do; mom still incapacitated according to weilheimer.
- 10 7 22- contempt # 2 granted; contempt fees paid no further penalty. But weilheimer lied. She put me into prison for a week. Cannot discuss guardianship or sale of house with jane.
- 11 14 22- no records given; mom cannot testify.
- 11 16 22- paid monitors; picked by pam blumer, visits 3x a week.
- 12 21 22- AH in contempt; 7 days in prison, cannot tell mom AH in prison.
- 2 16 23- Ah must pay for visits; visits 2x a week 1 hour; no food given to mom; monitor listens to conversations and makes notes; no talking to mom about guardianship, MM, or ah eviction; no visit restrictions on ish.
- 3 2 23- pay ledakis.
- 4 17 23- fenstermacher pay pam blumer, barley Snyder.
- 4 29 23- appeal of eviction denied per curiem.
- 5 12 23- visits still 1 hour with monitor; blumer will make "best effort" to find a monitor for mom's birthday and mother's day.
- 6 13 23- ledakis does evaluation of mom for visits with mom; ah cannot discuss court proceedings with mom, going home and ah going to prison.
- 6 27 23- parties reply to ledakis report of jane of 6 13 23 and future visits to mom by Arthur; fenstermacher pay ledakis for report.
- 8 9 23- remove fenstermacher denied. Eviction appeal denied; AH can work with fenstermacher to get money to move.
- 10 4 23- AH sees mom only 2x a month; must pay monitor; contempt if he fails to do so.
- 11 2 23- pay blumer.
- 11 9 23- no emergency to unblock AH's emails.
- 12 21 23- all 3 petitions of AH denied: AH is danger or menace to mom, remove jaskowik, remove fenstermacher. Other motions rescheduled.
- 1 2 24- 3rd contempt hearing put on hold; no visits by ah.
- 2 14 24- subpoenas by ah denied to all parties.
- 2 16 24- blumer out as guardian of person, ellis replaced her.
- 2 27 24- Emergency petition for unlimited visits and no supervision with mom denied; petition to remove jack ass will be heard march 20 2024.
- 4 3 24- no unblocking of AH emails that had been done by weilheimer; no money from fenstermacher; no

unmonitored visits; no visits till may 1 then 1 visit every other week; monitor is Harris of the Lincoln Center; \$150 per visit, extra charged time can be added; no pictures of mother or monitor; no contact with harris/Lincoln center; jaskowiak stays as mother's lawyer.

7 1 24- AH visits mom to see her die, 3 people must watch ah, no pictures or video taken, no devices brought into room.
