

## VIDEOS EXPLAINED

The first video under "Video's of AH" pertains the day I protested on a public sidewalk on April 23 2024 in front of Jaskowiak's house. I walked back and forth on a public sidewalk in silence. About 10 days earlier, I handed out my 2 page newsletter about guardianship corruption on my then 96 year old Mother and how Jaskowiak was involved. I gave my newsletter to his neighbors on his street.

After being there for only about 30 minutes, a man, Harmon, came up to me, said he was a Pennsylvania state cop and told me the sidewalk was private property, I could not be on it and he would arrest me if I did not leave. I told him sidewalks are public property. Harmon threatened me again with arrest, so I left. I went to the police department, New Britain, and the code enforcement told me it was public property. A cop, Komatic (shaved head), had been sent to the location, but I had already left. As I was leaving the police department, I met Komatic and I told him why I was there protesting for the guardianship scam on my Mother. He did not care. I gave him my business card with my huge website about guardianship corruption. We talked for about 25 minutes and then I went home.

I came back, with the same sign, on April 27 2024. Jaskowiak did not want his neighbors to know what kind of crook he was, so he called the police. For 2 hours, Komatic and Jaskowiak were on their phones. I videotaped most of my time being there as evidence. At one point, Komatic came up to me and stood in the middle of the sidewalk blocking me from walking. I asked him to leave, but he refused to move or talk. He was trying to get me to brush him as I walked past him so he could arrest me for assault of a cop, a felony. I very carefully turned sideways and went past him. The cops kept trying to get me to leave because Jaskowiak did not want his neighbors to see my sign exposing him as a crook.

After about 2 hours, Harmon drove past Komatic in a pickup and asked if Komatic was satisfied with the charges. Those charges were 2 counts of harassment. Komatic claimed in his affidavit after he arrested me that my claims for protesting were baseless. But, 4 days earlier I told Komatic why I was there. It was also my constitutional right to protest in a public area. Komatic has no power to decide if a person protesting has a just cause. Komatic arrested me after I was protesting for 2 hours. If I was breaking the law when the 2 cops arrived just as I started protesting at 9am, why didn't they arrest me in the beginning? Because, I was not breaking any laws. The cop, Jaskowiak and all the people who they were talking to on their phones for 2 hours had to make up charges. With those charges, the local judge set my bail at \$100,000. I needed 10% (\$10,000 cash) to get out. Jaskowiak knew I was living in my car because Judge Weilheimer, Jaskowiak and Fenstermacher (guardian of estate of Mother for 2 years) had me evicted from my Mother's house 6 months earlier and against my Mother's demands not to. They knew I had no money for bail and I would be in prison for about 6 months waiting for my trial.

In my table of contents, I have a picture of my sign and Komatic's affidavit that he signed stating his affidavit was true and correct. He signed it under penalty of perjury. He lied (perjury), that makes his affidavit a fraud (felony) and Jaskowiak (lawyer for about 45 years) signed the false complaint as being true (felony). All 3 of them colluded together to file false charges with the police against me (felony).

Look at my sign and the words. Then, look at what Komatic CLAIMED was on the sign. I also took pictures of what I wrote on the sidewalk. Komatic lied about that also.

The second video is me at the Montgomery County Commissioners meeting in mid 2024. I always brought a protest sign about guardianship corruption by corrupt judges and the DA Steele refusing to open cases on them. The commissioners refused to let me or other victims speak about it. Corruption!

The third video was made in winter of 2023. I was protesting when a passer by asked me about my sign. He videotaped me as he was interviewing me.
