PROBLEMS AND CORRUPTION BY LOGIE, JASKOWIAK, KLOCK, PAM BLUMER,
BILL BLUMER, ZABOWSKI, FENSTERMACHER, Judges WEILHEIMER and Sterling
PERTAINING TO JANE HERRING IN GUARDIANSHIP AS DISCOVERED BY SON
ARTHUR HERRING III

- 1. "Evaluations" by both Ledakis and Carrol were a total fraud. Ledakis was hand picked by weilheimer to be the "expert" to determine if Jane Herring was legally incapacitated. There are no standards or requirements in Pennsylvania as to what is a accurate "evaluation" to determine incompetency. Arthur proved that in the court trial. Weilheimer totally ignored that proof that those "evaluations" were worthless and accepted Ledakis's fake report that Jane was 100% incapacitated even though Ledakis's own numbers did not add up to 100% or even close to it.
- 2. Judge weilheimer has refused to allow Jane into court to meet Jane several times to see for herself Jane's condition. Why?
- 3. Jaskowiak, Janes's lawyer assigned to her by the court, never brought any witnesses to court to prove Jane was not incompetent and after Arthur exposed the Ledakis evaluation as a fraud, never used that information to defend Jane in court. Why?
- 4. Jaskowiak never informed Jane or Arthur that we could hire our own lawyer, instead of jaskowiak, to defend jane. Why?
- 5. Jaskowiak never made notes for Jane and Arthur to learn about the guardian process and what was going to happen. Why?
- 6. Jaskowiak never allowed Arthur to sit in on the meetings with Jane so Arthur could learn more about this matter and to also be able to explain things to Jane, also a person who does not understand legal matters, especially in this legal guardianship matter. Why?
- 7. Jane was taken by force, against her will for ongoing monetary gains (kidnapped) by her then "guardian" logie and daughter Jill from her huge \$500,000, 3 bedroom, 3 bathroom house in a gated community on August 25 2021 where she has lived for 21 years. It was part of their plan to evict Arthur (who had lived there for 2 years at that time at Jane's request), to put Jane into a nursing home, depriving Jane of her much loved and valuable contents forever, junk the contents and sell the house at a very low price to a friend who would then resell the house at market value and logie and jill would pocket the difference and depriving Jane of such profit. They would then loot the house for themselves and deny Jane of the money.

- 8. Logie, zabowski, weilheimer, blumer, jaskowiak, camp either never read the ledakis report that said Jane could live at home, with Arthur there, or refused to accept the report only so logie and jsh could make a tremendous amount of money. As Jane's total guardian, logie and the others were all obligated to know what the court's "expert" said was best for Jane. Logie had lied to both Jane and Arthur about why his "care manager" Deb Klock (who has a well known reputation as being grossly incompetent and dangerous) wanted to meet Jane that day at jane's house. Logie lied so he would know Jane would be at home. Klock never was at the house. Why did logie hire klock as care manager when he was hired to be guardian and any responsibilities were his.
- 9. Logie took Jane's valuable car away on August 25 2021 for his own financial gain, without asking Jane what she wanted which was to have Arthur get the car for his use. Then he claimed on his inventory it was only worth about \$1,500. The fact is the car was worth about \$6,000 because of its extremely clean condition.
- 10. Logie/jill refused to allow Jane and Arthur see and talk to each other for next 12 days Jane was forced to stay at jsh, a daughter Jane was never close to or liked. Jsh threatened Arthur with arrest if he came to house to visit Jane. Jsh has never wanted any contact with Arthur for more than 50 years.
- 11. Arthur talked to Jane's weekly hairdresser for 16 years. She saw Jane 2 days after jane was kidnapped from her house and forced to live with jsh. The witness said Jane shaking, crying and saying repeatedly "I want to go home, I want to go home".
- 12. Arthur found out 2 days after jane was kidnapped, she was put on anti-depressents. Why didn't jsh take Jane back home if Jane was so upset? Jane's house was only 15 minutes away.
- 13. That night of August 25, Arthur called the state police in that area to do a wellness check on Jane out of grave concern for Jane. The state police told Arthur he saw Jane at the window and she waved at him so he thought she was fine. He never talked to her privately.
- 14. On August 26, Arthur called the state police at night a second time for a wellness check on Jane but was told by the dispatcher jane was fine and not to call them again.
- 15. On August 27, in a conference call with weilheimer, jsh's lawyer camp, logie and jaskowiak, weilheimer informed Arthur that he was never to have any more wellness checks on jane or weilheimer would charge Arthur with Contempt of Court.

- 16. On August 29, 2021, Arthur discovered Jane was put on anti-depressents because Jane was so upset at being forced to stay at jsh and not allowed to see or talk to Arthur. About a week later, Arthur found out Jane was put on another type of unknown pill.

  Both logie and jaskowiak have refused to tell Arthur about those pills at all.
- 17. On August 6 2021, logie emailed Arthur and told him his Mother was taken to the hospital the day before by ambulance. Logie claimed Jane had fainted because it was a hot day and Jane was dehydrated. BS. A hospital keeps a person for 1 day with IV fluid, maybe 2 days, NOT 4 weeks. Then Jane had covid for 2 weeks at the hospital. Arthur discovered Jane had been taken to the hospital, unconscious, by ambulance, confined to bed for 6 weeks and treated for starvation. Jane was in the hospital for starvation because jsh was not feeding her and Jane could not stand being forced to stay at jsh's house. Jane was not allowed to leave jsh's house or call or see Arthur while there.
- 18. Ledakis said in his second evaluation that Jane was taken to jsh as a trial to see if Jane would like it there. BS. Why did logie send me a eviction email that night Jane was kidnapped if not to put Jane into a nursing home, evict me then sell the house at a huge profit? Why did logie and jsh never inform or discuss their plans with Jane and Arthur?
- 19. Ledakis said in his June 2023 report about Arthur's visits with Jane, that the "staff" was saying Arthur got Jane "agitated" after his visits and former phone calls. But, ledakis never listed names and no names of any "staff" who made those claims has ever been in any reports. That is called here say.
- 20. But, ledakis also said that when Arthur was NOT there, sometimes Jane was "agitated. There are many side effects to alzheimers, including agitation. Why does every body always blame Arthur without knowing the REAL cause of Jane being upset.
- 21. Who wouldn't be "agitated" when they are kidnapped from their large 3 bedroom, 3 bathroom house where they lived for 21 years, their loved possessions of 96 years, starved, not allowed to go home, confined to a hospital bed for 6 weeks, 42 blood tests, 42 needles in the stomach, then dumped into a ghetto like pig pen nursing home and locked in solitary confinement, in a sensory deprived environment and not allowed to go anyplace until she dies, just because she has a little forgetfulness..
- 22. Fenstermacher, Jane's trust lawyer for 21 years, (May 15 2022 became guardian of her estate) told Jane Arthur was lying to Jane in a letter about May 2020 when Arthur told Jane, jsh wanted to sell Jane's house and put Jane into a nursing home.

Fenstermacher told Jane in that letter jsh did not have the power to do so. But, about 1 year later, jsh filed the petition for guardianship on Jane. Camp, jsh's lawyer, is down the hall from fenstermacher.

- 23. Judge Weilheimer, logie or jaskowiak have never allowed Arthur (including his current lawyer Meitner) to see Jane's hospital or Manatawny Manor medical documents. No reason given.
- 24. Arthur was not allowed to visit or talk to Jane for the first 2 weeks Jane was in the hospital.
- 25. Jane suffered tremendously physically and psychologically while in the hospital under jaskowiak and logie. Jane was confined to bed for 6 weeks.
- 26. Arthur discovered Jane was not eating her hospital food. It was always cold and the food tasted awful. Arthur was bringing in food, newspapers, magazines, other needed articles and roses to help his mother survive and help her relax in the hospital. Even when Jane had covid, Arthur would leave those items at the security desk to be given to jane. Jane was kept in isolation for no reason, nobody took her for any walks or go outside for fresh air. Nobody helped her learn how to use the TV. Arthur was not allowed, because of only a 1 hour visit, to take Jane outside for fresh air and exercise.
- 27. At the hospital, Jane had daily blood tests (42 times) and a daily needle in the stomach (42 times) to prevent blood clots. Jane's arms were black and blue from all of the blood tests.
- 28. Logie always kept Arthur in the dark on her medical situations because Arthur was told he could not ask the doctors or nurses any questions by logie. Logie always refused to answer Arthur's questions about his mother's medical situations, including the pills she was taking.
- 29. Logie did not bother trying to find out who Jane's doctor's were in case they were needed. As of October 1 2022, Jane has not been allowed by any of her guardians to see any of her regular doctors, including her dermatologist because she has skin cancer.
- 30. When Arthur finally saw his mother after she had been at the hospital for about 2 weeks, he saw Jane did not have her glasses that she used for reading and seeing. Arthur got her reading and distance glasses from the store to use while Arthur went to Jane's eye doctor, got the prescription and made several trips to get them made and paid for them and then took them to Jane. Neither jaskowiak or logie did that for their "client" Jane, nor did jsh ever notice Jane did not have her

glasses while Jane was held hostage at jsh home.

- 31. Logie canceled Jane's medical alert necklace on August 25 2021 after she was taken from the house which is needed for Jane's life and health. Blumer will not give her one.
- 32. Logie canceled Jane's newspaper after she was kidnapped that Jane got for about 70 years. Jane has no access to reading materials unless Arthur bring her newspapers, magazines, etc.
- 33. Blumer and jaskowiak refused a phone in Jane's room at manatawny manor (MM) for her happiness and possible medical emergency. The staff on Jane's floor is hardly ever at their desk to be contacted in case Jane falls, stroke, etc. Jaskowiak does not seem to think his client should have a phone to call her son or her friends.
- 34. About June 19 2022, Jane slipped in her room on a just waxed floor by the housekeeper at MM. She fell, hit her head, shoulder and pelvis on the floor. She was x-rayed 2 days later and nothing was broken. According to Jane, her shoulder still hurts as of October 1 2022. The next time Arthur saw Jane, he gave her 6 pairs of no slip socks.
- 35. Since May 15 2022 being Jane's "guardian of person", pam blumer has not done anything for Jane, especially getting more visits and time for Arthur, no phone in the room, no medical visits after 1 year, no medical alert necklace, refused to see mother's house to see how she was living, has not met Arthur to get information to help Jane be happy and has not seen the mother's house to see how great she has been living until Mother was stuck into the tiny one room pig pen at Manatawny Manor.
- 36. Since May 15 2022 being mother's guardian, pam kept klock on as "care manager" and did not know about klock's long history of corruption and dangerous behavior to others.
- 37. Pam's husband bill, as her personally appointed lawyer, accused Arthur of many accusations without asking Arthur his side and then issued drastic conditions onto Arthur pertaining to his mother and his time with her.
- 38. Logie, zabowski, blumers, jaskowiak, weilheimer have refused to give medical records from the hospital, records from Manatawny Manor or the names of the pills she is on to Arthur and his current lawyer Meitner for unknown reason denying her son to know anything about the health of his mother. Why?
- 39. Logie sold/gave away Jane's car without asking Jane or Arthur if he wanted it and seems

to have sold it at a extremely low value.

- 40. Logie refused to disclosed who his insurance company is and did not list Arthur on the inventory sheet as required. Why?
- 41. Zabowski (logies lawyer) and logie had refused to respond to Arthur's lawyer's emails on various matters. Why?
- 42. Jane got covid the last 2 weeks she was in the hospital because Jane was kidnapped and forced to be at jsh house and where later had to be taken to the hospital for starvation caused by jsh. After Jane got over covid, logie then put Jane into a low grade nursing home 40 miles away that had just opened up after a complete shutdown of covid. According to news reports, 39% of the people that die of covid are in nursing homes.
- 43. Logie/jaskowiak, blumers have kept Jane in a locked down section of that place for 2 years as of October 1 2023 that also has people with mental and behavior issues. There are men in that section. There are NO locks on the doors which puts jane and other women in danger of being physically or sexually abused. There are no cameras in the hallways for the staff to see if any men go into womens rooms during the night The staff is usually never at their desk if they are needed.
- 44. Logie/jaskowiak, blumers have refused to give any more time or days since February 2023 of 1 hour 2x a week for Jane to be with Arthur. No reason given after almost 2 years year since (October 18 2021) of Jane being there. Jane is being deprived of her son to enjoy her life of being active and happy. Jane's life could end at any time or her memory could completely fail. Since Novemebr 2022, Arthur has to pay blumer's monitor \$75 per visit.
- 45. Jane has been kept in solitary confinement, in a sensory deprived environment causing her memory to probably forget how to do many everyday activities. The only exercise Jane gets is walking about 35 feet from her room to the meal room and back again. Jane basically sleeps in a chair or in bed all day and night. Jane has been kept this way for almost 2 years as of October 1 2023. Blumers canceled all of Arthur's 2x a day phone calls to Jane as of about July 2022.
- 46. From August 25, 2021 to July 2023, out of a possible 11,248 possible hours Arthur could have spent with his mother (16 hour days) Arthur has only had 215 hours with her at 1 hour 3x a week in her room only. Arthur has not been allowed to take Jane passed

the locked doors in her tiny section. No reason given.

- 47. Logie/jaskowiak/blumer have refused, since November 2021, to have janes very swollen legs taken to the hospital for a ultrasound to see if there is a blood clot or infection that cause amputation or death to Jane at 98 (as May 16 2022).
- 48. Logie claimed Jane was taken to a vein specialist by jsh about June 2022, but refuses to provide any proof of that.
- 49. Logie/jaskowiak,blumers have missed every one of Jane's various doctor's appointments putting Jane's health and life in danger since august 25 2021 to October 2023.
- 50. Logie claimed none of the 20 or so new nursing homes in the Souderton area wanted her. Why would they not want a almost perfectly healthy and normal person with a worth of about \$2.5 million?
- 51. Arthur keeps fing many much nicer, much bigger and much cheaper places for Jane to live. But, weilheimer, jaskowiak, blumer, fenstermacher and jsh always say no. But, THEY continue to give themselves Jane's money while doing nothing for her.
- 52. Arthur found a dead mouse under jane's bed in November 2021, reported it to the director but it took the director almost a week to have it removed.
- 53. Arthur had to buy a much bigger trash can than the one in Janes room because Jane had to put the trash on the floor often because it would not fit into the one in her room and the janitors were not emptying it on a regular basis. Jane's room still has broken and worn out furniture and tattered and torn bed spreads as of July 2023.
- 54. About November 2022, blumer, claiming the never named "staff" claimed after Arthur's visits and phone calls with Jane, Jane was always "agitated", hired a monitor to sit next to Jane and Arthur and write reports. Weilheimer refused to let Arthur know anything about the 2 different monitors as to their experience to listen, make accurate notes, make accurate quotes. The monitors were told by blumer to lie about what Arthur said so weilheimer could reduce his visits to none because Arthur had exposed their scam.
- 55. In about February, weilheimer reduced Arthur's visits to only 2x a week and ONLY if he paid the monitor each time. So, they were using Arthur's Mother as a carrot to make Arthur want to see his Mother, waste his welfare money only so fake reports would be

made to ban Arthur and Jane from ever seeing each other again until Jane is dead as Arthur's punishment for exposing their scam.

- 56. Logie/jaskowiak/ weilheimer/blumers/zabowski/klock refused to obey what their handpicked "expert" ledakis said in his first report that
  Jane could live at home and with Arthur there is fine for Jane's health and wellbeing.
  Instead, Jane has been in a one room "pig pen", in a locked down section in a mental ward,
  she is denied the large library, large recreation room and the luxury large dining room that
  the rest of the floor enjoy. She has not been allowed outside for 2 years months as of
  October 1 2023 or to see her son for more than 1 hour 3x a week until about February
  2023 when weilheimer reduced Arthurs visits to only 2x aweek, but ONLY if he paid
  blumer's monitor \$75 an hour.
- 57. Because of all the money Arthur spent on lawyer's fees which put Arthur on welfare in about January 2022, Arthur could no afford to pay \$75 monitor fee in about March 2023. He has not seen or talked to his Mother since then.
- 58. Arthur is extremely upset everyday because he does not know if his Mother thinks he does not visit her anymore because he does not love her and does not want to visit her. Will she die thinking that about her son that she loves?
- 59. No more than I hour for Christmas, Mother's Day, Mom's birthday, Easter, or Valentines Day was allowed by weilheimer, jaskowiak, zabowski, logie, klock or blumers in 2021 and early 2022. Later in 2022 and 2023, blumer refused Arthur and Jane Christmas, Thanksgiving, several visit days, Valentine's day, Easter, Good Friday, Mother's Day and Jane's 98<sup>th</sup> Birthday.
- 60. A so-called "care manager" was hired by logie shortly after August 6 2021. So far, logie/jaskowiak/blumers refuses to tell Arthur what she does or has done for Jane and how much she has been paid. Blumers were not aware, until arthur's lawyer Meitner told them in July 2022, about klocks extremely serious past with klocks guardians.
- 61. According to Meitner, he never signed any contract that said blumer could hire anyone (including her husband as her lawyer) and bill Jane for those hours.
- 62. Because of the 2 fake and made up ledakis "evaluations" and the matter of guardianship was started by jsh just to control Jane's wealth, Arthur had to lose his \$30,000 house, for no money, for lawyer fees to try to protect his Mother from losing all of her money to those conmen and women, spent 10 days in prison in December 2021 for exposing

the scam, spent a week in prison in December 2022 for exposing the scam, had to sell a car for a small amount to help pay lawyer fees, has spent (spending) many ten's of thousands of dollars for lawyers and has had to spend 7 days a week dealing with this scam since May 18 2021 when jsh filed the petition, as of October 1 2022.

- 63. Because of the great distance to Jane's location, it takes Arthur about 1 hour to drive there each way, about \$100 a week in gas just for a 1 hour visit with his mother.
- 64. Arthur created a massive website dedicated to the massive guardianship corruption around the country and in the Montgomery County court for many years called www.protectmyparents.us.
- 65. Logie/jaskowiak/weilheimer/zabowski prosecuted Arthur for contempt in December 2021 because he documented their corruption and gross incompetence to Jane, endangering her health, life and happiness. They used the court as a weapon which is not allowed. Mother's lawyer, jaskowiak, never asked his client, Jane, if charging me with contempt was ok. Jaskowiak was aware the trial was already fixed by weilheimer and that I would be going to prison for 6 months where I could have been murdered. Arthur was able to have the website information deleted and he was out in 10 days.
- 66. Weilheimer and jaskowiak forced Arthur to delete his information on his news website exposing their scam. They violated Arthur's constitutional rights of freedom of the press and speech.
- 67. Weilheimer and jaskowiak charged Arthur with contempt again in December 2022. They forced Arthur to sign a letter to Amazon to delete Arthur's archived, original website with the same information. They put him in prison for a week and jaskowiak charged him almost \$5,000 to compose the contempt papers.
- 68. Despite Meitner asking weilheimer to excuse herself several times because of her obvious hate of me and her blatant incorrect actions, weilheimer has refuse to do so.
- 69. In February 2022 Janes watch stopped and Arthur bought her a new one. No one else knew her watch was broke.
- 70. Jaskowiak never brought any witnesses at Jane's guardian trial in July 2021 to show Jane was not incapacitated by having done anything strange or unusual. She only had a short term memory/instant recall problem. Jane has NEVER been accused of having any mental

- disorders. She has been in a locked down mental ward at MM for 2 years as of October 1 2023 Why?
- 71. In about June 2022, Jane wrote a letter to weilheimer saying she wants to go home, she wants a phone in her room, she wants a new lawyer, she wants to appear in court and she wants to go to her doctors. Weilheimer refused to have Jane come to court to speak. Why?
- 72. In ledakis's "evaluation" #2, he claimed Jane probably did not write the letter, but NEVER asked her to write it again to see if she could write the letter. Why? Weilheimer claimed the letter was a fake and basically written by me.
- 73. But, on a Zoom call with the lawyers and weilheimer about the same time, jaskowiak said he had met Jane in her room, he said she liked the food, room and the people. Then, jaskowiak is admitting Jane still knew what she wanted. Then, Jane's letter is real!
- 74. Ledakis does not record his made up "evaluations" of his clients because he has a great memory. BS. He works for lawyers and judges who want proof of what people say and how they said it to make their decisions. It is called evidence. Ledakis made claims of what my mother said and how she said it, but he has NO proof of it. He has no proof his reports on jane actually are about only jane and not hundreds of other people. Why?
- 75. Weilheimer says I cannot talk about Jane's case to anyone because it violates Jane's privacy. BS. If Jane says it is OK, why not? Because, the information would prove the corruption of weilheimer, blumers, logie, jaskowiak, ledakis, zabowski, camp, jsh.
- 76. Janes nursing home still has active covid cases. Until about March 2022, there were about 12 rooms with 12 inch metal tubes from them that pulled out the contaminated covid air.
- 77. In May 2022, MM was closed to visitors because of a major influenza outbreak.
- 78. Many times Arthur has found things he has bought for Jane missing because the staff steals them when Jane is not in her room.
- 79. The corruption in the Montgomery County orphan's court has been known for 20 years. There is a massive Facebook site called Shenanigans of the Montgomery County Court.
- 80. Jane was kidnapped from her huge home, because of jsh's obsession to get Janes money and to control her by jaskowiak, logie, zabowski, klock, blumers. The cost of the

tiny, one room pig pen costs Jane about \$90,000 a year just to live there. The costs for logie, jaskowiak, klock, zabowski and blumers have been probably been another \$200,000 as of July 2023.

- 81. At no time when Arthur/Meitner signed pam blumer to be guardian, give we give her permission to hire other people and have Jane pay for them. Blumer and the law firm simply bill Jane anyway.
- 82. How has Jane benefitted from all of those people stealing her money since May 2021? How is Jane better off today under those people than she was without them?
- 83. After pam signed up as new guardian of person in May 16 2022, pam hired her husband (friend of jaskowiak) as her lawyer just to make more money. In late 2022, bill blumer was replaced as pam's lawyer because of his temper. He was replaced by Gelsinger.
- 84. On June 19 2022, Jane fell in her room from a newly waxed floor and hit her head. Her hip was x-rayed but never her head with CAT scan. Arthur bought her no slip socks so Jane would not fall again.
- 85. Because of the primitive living, unsanitary and unhealthy conditions forced upon Jane by logie, jaskowiak and blumer, Jane is deprived of human dignity since August 25 2021. She has been treated in a very inhumane and barbaric way.
- 86. People in prison have more privelidges than Mother. POW's have more priviledges than Mother under the Geneva convention.
- 87. Despite the extreme costs and hardships placed upon Arthur by this made up "incapacitation" scam, Arthur has not abandoned Jane (unlike her daughter jsh, logie, blumers and jaskowiak) and continues to defend and protect Jane to bring her back home to live happily for the rest of her life.
- 88. Jaskowiak, logie and blumers have not allowed more days and time so Jane could be with her son who they know she loves very much and he loves her and has been totally dedicated to her welfare since Jane was kidanpped in August 2021.
- 89. Logie and jaskowiak NEVER discussed with Jane and/or Arthur that they were going to remove Jane from her home of 21 years and where they wanted Jane to live for the rest of her life. Why? Janes current location is 40 miles away from the place where she has lived for 21 years.

- 90. Back in December 2021, Arthur bought Jane various types of hand sanitizer to keep the risk to Jane of getting covid by the staff and residents. According to CDC, about 39% of people that die from covid, die in nursing homes.
- 91. Because Jane has been refused by logie, jaskowiak, blumers and jsh to have a phone in her room since when she was forced to be at the nursing home against her will and Jane does not have their phone numbers, she cannot call them when she has a problem or call family and friends. 8<sup>th</sup> amendment prohibits cruel and unusual punishment..
- 92. Logie stated people must wait 24-48 hours before he will return their calls and does not call people back on the weekends. What kind of guardian refuses to take phone calls from his clients?
- 93. When Jane was kidnapped to be at jsh's house for 12 days, jsh refused to let Jane have use of the phone to call Arthur or to see Arthur. jsh emailed Arthur and threatened to call police and have him arrested if he showed up or called Jane. Why?
- 94. About June 2022, mother complained her right shoulder hurt a lot, I told Meitner, he said he would tell pam the new guardian. Two weeks later, no one had seen Mother about it. I took a video of it. On June 17 2022, I noticed mother did not have a bed sheet on top of the fitted sheet. She only had a thin quilt like blanket. Why?
- 95. On July 10 2022, Arthur saw Jane's bedspread was again tattered and torn. Pictures were taken.
- 96. When jaskowiak filed to evict Arthur, he never asked Jane if that was alright that her son would be evicted. Jane wrote that she wanted Arthur to live in the house in the letter she wrote to weilheimer about that in about April of 2022 and in two notes Jane signed and dated in 2019...
- 97. Fenstermacher, Janes trust lawyer for 21 years and as of May 2022 her guardian of the estate, said he did not object to Arthur being evicted, Jane's house sold and all of her loved possessions and antiques trashed. He admitted in court in very late 2022 that he had not seen or talked to jane in about 2.5 years. He never asked her about it. Why? PA state law for guardians and guardianship says he must, in addition to the rules of conduct for lawyers.
- 98. Fenstermacher, jaskowiak, camp, logie or jill never tried to find Jane a nicer and much

- cheaper place to live. Why? Arthur has always found much better places, if Jane could not come home.
- 99. Fenstermacher, logie, camp, jill, jaskowiak have forced Jane to live like a caged animal even though Jane has a huge house and is financially very well off. Why?
- 100. Jane only has a small memory/instant recall issue. Jane does not have any type of mental issue, she is not a danger to herself or to others and she is not a wanderer. As of July 1 2023, Jane does not need or get any type of special services to bath her, dress her, help her to use the bathroom, fold clothes. Since Jane does not need any special care then there is no reason why Jane cannot live at home.
- 101. By denying Arthur all the time he wants to be with Jane and Jane at home to do everyday activities to keep her brain as good as it can be, fenstermacher, blumer, weilheimer, camp and jsh are denying Jane the most basic treatment for her continued mental and physical health and happiness. That is elder abuse and elder neglect.
- 102. As of February 1 2023, out of a possible 8,100 hours arthur could have spent with jane (16 hour days) since august 25 2021, Arthur has only been allowed to see jane for 205 hours. No reason given by weilheimer or any guardian why arthur's visits are only one hour 3x a week.
- 103. On Thanksgiving 2022 and Christmas 2022, pam blumer refused Arthur to visit his Mother. No reason given. On 11/16/22 and 11/18 2022 pam blumer denied visits to Arthur for no reason.
- 104. Because Arthur has been blamed by logie and later pam blumer, since November 2021, of making Jane's legs swollen by bringing bad food for lunch for Jane (even though there are no diet restrictions for Jane), Jane is not allowed to enjoy her favorite foods, snacks, fresh fruit, and having lunch with Arthur. Jane is 98 years old.
- 105. Brandi started 11/21/22 as new spy watching and listening to Jane and Arthur. She was hired by pam blumer because pam claimed jane was always agitated after Arthur talked to her on the phone and after he visited her. No one from staff has put their name to such a claim. Blumer should know that is called here say because blumer's husband is a lawyer.
- 106. Because at one time Jane had food in her room, she had other residents come into Jane's room and talk. For the past 5 months, because Jane has no food to give, those residents no longer go to jane's room to meet, depriving Jane of happiness and talking.

- 107. As of October 2023 Janes legs are still very swollen and her left leg has a cantelope size enlargement on it. Blumers and jaskowiak have not done anything about it.
- 107. About February 2023, in a court hearing, Fenstermacher had already signed off to have me evicted from my Mother's house, trash all of her loved possessions of 98 years and sell her house. My Mother had asked me to move in about January 2020. She had made it clear verbally and in writing she wanted me to live in the house whether she lived there or not for free and to have the house when she died.
- 108. When Fenstermacher was asked when was the last time he saw or spoke to Jane, his client of 21 years, he replied "about 2.5 years ago. A lawyer's duty is to his client and to do as much as the client is asking for. If the client wants something the lawyer refuses to do, then the lawyer is obligated to quit.

## Summary

Fenstermacher, who was appointed as guardian of estate to Jane about May 2022, should have known all of these presented facts about his client and should have discussed this matter with me. Fenstermacher knew Jane and I were extremely close and he should have wanted to learn everything about this extremely serious matter about his client. He never asked me and still does not know all of this documented facts. Because of his gross incompetence, his client Jane, my Mother at 98, has suffered mentally, physically and psychologically. His law license must be revoked.
