Dispatched to the listed location for the report of possible elder abuse. Upon arrival, contact was made with the complainant, Arthur Herring III. Herring advised that he does not believe his mother, Jane Herring, is being treated properly. Herring further advised that his mother's court appointed guardian, Dwayne Logie, does not properly take care of her. Herring also advised that about three weeks ago, he was visiting his mother and her legs were not circulating blood properly. Herring requested an ambulance to transport his mother for further evaluation. His request was denied by the assigned doctor. Herring also advised that he observed a deceased mouse under his mother's bed during his visit. Herring complained to the director of the nursing home, Joanel Torillo.

After speaking with Herring, Torillo requested to speak with me in private. I then followed Torillo to his office. Torillo then called Logie over the phone and requested his colleague, Tom O'Neil, also be present during the conversation. Logie advised that Arthur Herring has disagreed with how he is taking care of Jane Herring. Logie further advised that he is a court appointed guardian, and both parties have a court hearing scheduled for next week for Herring violating a court order. Logie also advised that Herring has called numerous ambulances for his mother to transport her, when he disagrees with the care she is receiving at the listed location. Torillo advised that all claims of neglect that Herring has expressed are investigated and have thus far been determined to be unfounded. Logie also advised that Herring has had recent police contact. Herring also threatens Logie when Herring disagrees with how Logie manages treatment of his mother, which is documented with his local department. Logie also advised that Herring also owns firearms and is concerned not only for his safety, but Torillo expressed the same concerns for Manatawny Manor employees and residents. Logie does not believe he will threaten or use the firearms in a malicious matter, but feels that he should advise police.

I advised all parties in Torillo's office that a report will be created documenting the incident. I also advised Torillo and Logie to call police if they believe they are in danger. I then spoke to Herring once more and advised him that a report will be created documenting the incident. Herring seemed upset at the lack of care for his mother, but understood and thanked police for speaking with him. Officer Nafziger and I stayed on location until Herring left the area.

Herring advised, that while he does own firearms, he has never threatened any staff members or resorted to any kind of violence. Herring stated that he just wants to be able to visit his mother and make sure that her well-being is a top priority by the Manor. I advised Herring that I would add a supplemental report noting his concern. No further action taken.

Arthur Herring III came into our station to speak with an Officer in regards to a guardianship issue. Arthur informed me that his mother, Jane Herring, is a resident at Manatawny Manor and is in the section of the building that restricts her ability to leave or make phone calls (possibly the memory care unit). Arthur advised that his mother is of sound mind and should not be in this section of Manatawny Manor.

Arthur then went on to explain that his sister applied for guardianship of his mother in the past, but gave up the effort after he discovered evidence that she was stealing money from their mother. She reportedly gave up the effort so she would not get in trouble for taking the money. Arthur then advised that the court in Montgomery County assigned a lawyer to pick a guardian for his mother. A guardian was picked, but the guardian also reportedly began stealing money from Arthur's mother and was removed from the position after

Arthur exposed the incompetence of the guardian and his lawyer.

Arthur then went on to explain that the reason the lawyer and guardian were appointed is because of alleged corruption. Arthur advised that the judge gets a kick back for appointing certain lawyers. The lawyers get a kick back for appointing certain guardians, and the guardians get a kick back from the nursing homes for filling beds.

Arthur then explained that his mother's current guardian, Pam Blummer, placed his mother in Manatawny Manor and she has not received adequate care. Blummer is also reportedly the wife of the lawyer that made Blummer his mother's guardian. Arthur also reports that Blummer has limited his visits with his mother with no explanation. He is reportedly only allowed to visit his mother three times a week for an hour each time for reasons unknown. Arthur is not allowed to call or leave voice messages for his mother, again for reason unknown. Arthur also informed me that the employees at Manatawny Manor are feeding Blummer information about him. Blummer and the employees are reportedly lying about him, claiming that he upsets his mother when he visits.

Arthur also reported to me that he had just visited his mother at Manatawny Manor before coming to our station and was being listened to by an employee named Colinda. Arthur advised that Colinda told him he could not bring food to his mother, but after a call to Blummer, she allowed him to. Colinda then reportedly sat three feet from Arthur and his mother and listened to their conversation. She was reportedly rude to him and began making comments based off of Arthur's conversation with his mother. Arthur then informed me that he began recording Colinda with his phone and she grabbed it from him. He then reportedly demanded it back and eventually got his phone back.

While speaking with Arthur, I asked him why he was not made the guardian of his mother. He informed me that he was not allowed to be because his sister had made up lies about him. I then advised Arthur that he could not record people without their permission, and he informed me that he was technically the press because he created a website to stop corrupt guardianship and he has 1st Amendment rights, more specifically freedom of the press. I advised him that whether he was a journalist or not, he could not record someone on private property at their place of employment without permission. He then gave a hypothetical scenario in which an employee beats up his mother. He then asked if he is not allowed to record such an incident. I advised him that there are always exceptions but no crime was being committed when he began recording.

I requested Arthur send me any evidence he had to my email and I provided him with my business card. I informed him that our department would look into the matter and he left our station. Nothing further to report.
