Subject: eviction

Still no word from you or jaskowiak as to meet at the house for the keys and walk through as was supposed to be done last week. Why?

Still no money from you fenstermacher. Why. Without money, I cannot see my mother and you are violating weilheimers court order pertaining to my visits. Why aren't you trying, as I have been

You have been her guardian of the estate for over a year and you have not contacted her in any way to see what she wants or needs. Why? You have allowed hundreds of thousands of dollars to be wasted. Mother was NEVER claimed to have any mental disorder that would make her a danger to herself or to others. No claims were ever made in court that Mother did anything that justified a guardianship, especially by the daughter or jaskowiak. As I said before many times, jaskowiak did not protect or defend mother in the petition hering because he WANTED her to be guardianized for the Racket to steal her money.

jane herring paid visits

Gelsinger,

As you know from my previous email to you, I do not have any money for the past 4 months to pay blumer's friend to see my mother based on those made up and never proven claims that I "agitate" my mother with my visits and my previously allowed phone calls that I used to have before blumer canceled them in may 2022 when she got appointed as guardian of person to my mother after I got the previous crook, logie, fired. My mother went from the Racket, including weilheimer, of one crooked guardian and his shister stealing from her to again weilheimer, more guardians, their lawyers, jaskowiak, klock and my sister stealing from her and condemning my mother to die in a tiny room, alone, in solitary confinement, in a sensory deprived environment and none of her cherished possessions, instead of her large 3 bedroom, 3 bathroom house in a private gated community worth about \$500,000 and her \$2 million bank account where she was living very happy and healthy and FREE.

As you also know, many times I have said I have not been allowed any way by the Racket to prove my innocence of those made up charges by never named "staff", including by having a cell phone used to record my visits. Cell phones do not lie. But, corrupt monitors, corrupt guardians, corrupt lawyers and corrupt judges do lie and have done so from the beginning of this guardianship scam.

As you know as a lawyer, without those people stating on the record in court that I said or did something, those claims are only here say, just gossip. But, weilheimer, you and the Racket have ignored that fact of law. As you also know, the basis of US law is a person is innocent until proven guilty in a court of law and a person has the right to face their

accusers. Once again, weilheimer, you and the rest in the Racket have also ignored that fact of law.

Because I was evicted from my mother's house against her known wishes and wants, I have and will be living in my car. My monthly social security and welfare do not cover my living, let alone wasting \$150 for only 2 visits a month, with another blumer paid liar to lie in her reports about me, that have been used before, to reduce my visits from 3x a week to 2x a week and now only 2x a month.

Is this what weilheimer, jaskowiak, blumer, my sister and you think how a 98.5 year old woman should be treated: less privileges than a POW and less privileges than any criminal in prison while weilheimer, you and the rest in the Racket are stealing hundreds of thousands of dollars from her for yourselves on a fake guardianship that I proved in court was based on a fake "evaluation" of no independently accuracy? Weilheimer and the rest of the Racket have only been using the court for retaliation and revenge on me because I have been exposing this guardianship scam on my mother and how many thousands of other victims on the radio, my website, with the DA and the FBI.

Fenstermacher has refused to reply to my emails for the past 2 months per me getting my yearly gift money from my mother to live as she had done for 8 years to my sister and I and fenstermacher has done for the past 2 years. I have sent him many emails telling him I need the money to live. He and the Racket know without that money, there is no way I can see, talk to or allowed by blumer to even write a letter to my mother. I have not seen my mother for over 4 months. Punished for what? Because unlike my sister, I am not going along with the scam? Weiheimer and the Racket put me in prison twice to scare me for exposing the scam and them.

Since blumer is guardian of the person, it is HER/your job to get fenstermacher to give me the money my mother wants me to have to live and if I have to, to pay to see her before she dies. Does blumer/you know or care that is also part of her job and yours as her one of many shisters and "care manager" (klock) she hired WITHOUT any authorization to do so and charge my mother for them, including giving herself a pay raise? Blumer has never shown any concern for my mother's welfare or happiness. She excuses and deflects her gross corruption and incompetence on lies about me.

The law attached is extremely specific, but has been totally ignored by the Racket and this scam. Is this how a 98.5 year old woman should be treated and living until she dies? Just keep her alive long enough to get as much of her money as possible, even if she becomes a invalid because of lack of exercise and depressed because of nthing to do and nobody she loves sees her? For that, according to the Racket, she should be paying \$90,000 a year for a tiny room and not allowed to go home or enjoy life and be happy, while the Racket steals from her with made up billing hours and fake "evaluations"? Since nobody took the quack's ;edakis advice the first time where he said my mother could live at home

and with me there, everything was working fine, then why did weilheimer hire him a second and third time and believe him THEN? Was it because he trashed and lied about me to force me to waste money on a lying "monitor" to punish me more by reducing my visits more and more, BUT weilheimer praised my sister and canceled any visit times on my sister after my sister had kidnapped my mother, forced my mother to stay with her, starved and tormented my mother until mother had to go to the hospital, by ambulance, unconscious, confined to bed for 6 weeks and treated for starvation. During those 6 weeks, my mother had to have daily blood tests (42 times) and daily needles in the stomach (42 times) to prevent blood clots. While in the hospital, mother also got covid where she could have died. Then she was dumped at her present low rated nursing home where she got covid again and influenza where she could have died. That place, manatawny Manor, had just opened up after being closed for months for a massive covid outbreak. about 39% of people that die from covid, die in nursing homes.

For the record, based on 16 hours a day I could have spent with my mother since she was kidnapped on august 25 2021 by my sister and the first guardian logie, out of a possible 12,240 hours I could have been with my mother, I have only been allowed to see mother for 215 hours. Is this and the Racket's idea of a guardianship for a now 98.5 year old woman and mother?



Before the visit began, I found a large American flag on a pole laying in the parking lot. I picked it up to take inside. As I was walking into the building, behind me was the monitor. I gave her also a bag of souvenirs that mother brought home from trips to give her some happy memories.

When I left, I wanted to see the director, kessler. The receptionist said that blummer said I could not see the director. Did you tell her that? If so, you and blumer have no authority of who the director meets or who I meet. I have every right to talk to him about my mother and what problems there are. I have been after him for months to put a regular size table in her room so she can look at the newspapers, documents and other things I bring her to make her happy. Mother just cannot become brain dead and physically disabled because nobody is there to be a friend and give her someone to talk to who she wants to be with and have her be in society and at home to see her loved possessions..

Just like before, basically just lies by your paid liars and them ommitting almost all of the information that really happened. But, your paid liars have done what you and jaskowiak told them to do: write as many lies as possible and deny me the ability to prove what was really said or done in those meetings.

To review the facts, since when did the purpose of those paid liars by you/blumer/jaskowiak go from ONLY making sure I do not "agitate" my mother and if I did, they could tell me to leave to now where those paid liars INTERFERE with those visits, including going through all of the items I bring mother, constantly sticking her cell phone in our faces to take pictures, sitting 3 feet from us and harassing us instead of across the room, standing next to mother and me when we talk, etc? My mother was constantly asking me why did she have to be there and she could not tell me what she wanted because the person was in the room. The first amendment protects freedom of speech and mother and I cannot have it when we cannot discuss out private thoughts that Mother wants to tell me. There is no court order that says that person has any purpose other than if I make my mother "agitated", they could tell me to leave. As you recall, the spying was started by logie in about january 2022 by him telling the staff to listen in on our phone calls, when I called mother twice a day, and listening at the door when we had lunch together to forcing us to eat lunch in the TV room with the staff watching us a few feet away and again their orders were to tell me to leave if I "agitated" mother to the paid liars of brandi and now this one. Blumer,

Since you have been appointed as guardian of person on my Mother, there have been many, many problems that have happened because of your control and my Mother is suffering, physically, mentally and financially because of them. I going to expose the 2 lies that the Racket has been using to create a evil and sinister image of me, which started with logie. First, I proved my food NEVER caused Mother's legs to be swollen. I was the one who called the paramedics in November 2021, only a month after she was dumped there by logie and jsh because the staff refused to take mother to the hospital for possible blood clots that could kill her. You were well aware Mother never had or has any food allergies and there are no diet restrictions on the food she can eat, but you and others have continued to use that lie only to do what is also done nationwide by corrupt guardians: divert the incompetence and corruption of those guardians and make the loved ones look like they are the problem only to keep the victim away from their loved ones. Just like you, logie, jaskowiak and other lawyers have done to me for the past 2 years because I have been exposing the guardianship scam on my mother and the massive looting of her money.

The other lie the Racket has been using against me for 2 years is that I cause Mother to be "agitated". How hard is it to accept that a then 96 year old person, with no medical, physical, financial or any other type of problems, was still driving her car safely, her primary doctor of 21 years and other professionals mother dealt with every year were NEVER called in to testify by jaskowiak to prove mother did not need any guardianship, is suddenly kidnapped from her home of 21 years and her much loved possessions, crying and screaming that she did not want to go, starved and tortured for 2 weeks at jsh's house, collapsed, had to be taken to the hospital and confined to bed for 6 weeks, underwent painfull medical tests, got covid where she could have died and then dumped into a tiny section since then, kept in solitary confinement, in a sensory deprived environment, kept with people with mental and behavior problems and not allowed to go home or anywhere as freedom? The fact was, jaskowiak never defended her or protected Mother because he and the Racket WANTED Mother to be guardianized for her vast finanical wealth and assets. Who wouldn't be angry and disgusted being held and treated that way? How can you or anyone else think such a pathetic lie of me causing Mother to be "agitated" had any merit?

I see in your notes of may 2022 to may 2023, the many times you contact my sister, but never me. I am not surprised because she was the one that gave you the gold prize of my Mother's vast assets, her expensive house and you and the others have her as part of your Racket. You should contact Dr. Kuhar, my mother's primary doctor for 21 years. She will tell you, as she had told my mother and myself several times, my suister has a "personality disorder" (kuhar's words). My sister has made up and created many, many lies about my mother and me for the past 10 years after my father died just to try her many attempts to do what she finally got now: Mother in a sleazy nursing home until death. Jsh also wanted total control and ownership of my Mother's assets and house that she worked with fenstermacher to get, but I stopped all of those attempts. Why would you want to deal with her after what she and logie did to my mother: dragging her away crying and screaming she did not want to go, while she/logie had 2 cops holding me on the porch as part of their plan, 2 weeks in jsh's home of starving her and keeping her as a prisoner, refusing to let her leave, refusing her to see me or talk to me, finally Mother had to be taken to the hospital, unconcious, by ambulance, confined to bed for 6 weeks, treated for starvation, got covid where she could have died, daily needles in the stomach to prevent blood clots (42 times), daily blood tests (42 times) where her arms were black and blue and then dumped into a low rated nursing home where she got covid again where she could have died, got influenza where she could have died, has fallen several times where she could have a concussion or broken hip or bones, her glasses shattered where the glass could have gone into her eyes, various medications she is on now that I have always been refused to know what they are, medications that she was never on in her life? From what I heard those medications are for depression and/or agitation because she does not want to be there and

has NO reason to be there. It is also a fact that at no time did you/lawyers ever bring in any reports by the "staff" or bring them in to testify about you and the Racket have claimed they said about my words or actions causing mother to be "agitated". Here say is NOT evidence. Your husband and your many lawyers know that, but continue to use it against me.

Based on 16 hour days (8 hours for sleeping) I could have spent with my mother, since August 25 2021 when she was kidnapped to November 1 2023, out of a possible 13,620 hours mother and I could have been with each other, weilheimer, jaskowaik and you have only allowed 217 hours. As a mother, would you be "agitated" at 96 and later if you could not be with YOUR child? I have seen constantly in the monitor's reports, they never say how mother constantly tells me she loves me, wants to be with me and wants to go back to the home and life she had before jsh started the nightmare on her.

As per the many, many lies that both paid spies, hired by you, have said in their reports, I am not surprised that the Racket refuses to allow me to use a cell phone to prove I and my Mother did not say or do the things your paid liars claim in their reports. Facts above have proven it has been logie, you and the Racket that has made her greatly upset and causing her physical and cognitive regression because of the way you/Racket have caged her for 2 years in solitary confinement, denied her a phone, visits from friends, letters, going home to live like she used to: happy and free?

3. For the past 3 years, I have been trying to get a table, at least a card table size, in her room so she can look at things as a normal person does, instead of on the floor. That tiny thin on wheels is NOT a table.
4. Why do you/Racket refuse to put mother into a much nicer, much bigger and much cheaper place to live, IF not her home, where she can have some of her furniture and loved possessions. I constantly have found those places, but you/fenstermacher and the rest of the Racket refuse them. Why?
5. When did you give yourself a pay raise and why from \$100 an hour when we hired you to \$125 an hour now?
6. When did the rules change for monitors from simply listening at the door when mother and I ate lunch, listening on the phone when we talked, to sitting near us in the TV room and could tell me to leave if I got mother "agitated", to having a paid liar sit near us and could tell me to leave if I got my mother "agitated" to now Mary Ellen who is not sitting a few feet away, interrupting us when we talk, constantly taking pictures as she walks around us, going through the things I give her now and by the staff when I used to drop things off to Mother when I could not see her and listening to our private conversations where my mother gets upset at her for trying to listen to our conversations and mother's private thoughts to me? Nobody ever said not to. Was that staff that incompetent for 2 years?
8. For the record, basically everything you said about me in your 1 year diary was not true or incomplete just to make me look bad, just what the Racket has constantly done as an excuse to reduce then cancel my visits, just as Jaskowiak has wanted all along for exposing the Racket's scam on Mother and others.



She has no phone, no table, kept in a locked in section with people with mental and behavior problems, no food allowed even though she has no food allergies and no diet restrictions, no mail allowed, no friends allowed (not even ministers), has not been allowed back to her large 3 bedroom, 3 bath paid house, in a gated community where she has lived happy and free for 21 years to see her loved possessions and to enjoy the life she had before this guardianship scam was started just for her money and house. I had lived at her house for about 1.5 years and had seen her every day for dinner, for about 6 hours, after my father had died in January 2013. I knew Mother better than anyone, including her primary doctor of 21 years. My Mother was still driving her car safely without any tickets or accidents of over 50 years.

This guardianship was started by my now 73 year old sister who had tried many times, with the help of her friend Ronald Fenstermacher (current guardian of estate since May 2022) to steal my Mother's money and her house, valued then at about \$400,000, but I always stopped those attempts. The current cost of Mother's tiny room is about \$90,000 a year, but the court accepted cost of Mother's home is only \$16,500 a year. I had also found many much nicer, much bigger and much cheaper places for Mother to live if she could not live at home, but for unknown reasons and never said, the others have refused to do so. There has been NO, repeat NO, reason why my Mother had to be kidnapped and dragged from her home by her daughter and Logie in August 2021, forced to stay as a prisoner at my sister's house. Mother was refused to leave, was refused to call me and was refused to see me. The first day Mother was forced to take medication to keep her quiet. After 2 weeks, Mother had to be taken to the hospital, unconscious, by ambulance, confined to bed for 6 weeks, treated for starvation, daily blood tests (42 times) daily needles to the stomach to prevent blood clots (42 times) and then got covid where she could have died.

In about February 2022, judge Weilheimer removed all visit restrictions and times to my sister, but reduced my visits to only 2x a month and 1 hour per visit (from 3 originally and unlimited phone calls). The so-called paid "monitor" was started by Blumer in November 2022 based only on here say by blumer. Nobody has ever put such claims by the staff or in court of claimed "agitation" by me to Mother. Nobody ever asked my Mother if such lies were true. Why not? Did Judge weilheimer know what barbaric and inhumane treatment

my sister did to her Mother? Why did Judge Weilheimer even put any visit restrictions on? Because of those visit restrictions which have been constantly reduced as per Jaskowiak's demands, from September 2021 to January 1 2024, out of a possible 14,320 hours I could have been with my Mother (16 hours per day, 8 for sleeping) we have only been allowed 224 hours. How inhumane to a now almost 99 year old person. I have many written notes by my Mother of how much she loves me, wants to be with me and how much she trusts me with her care if she ever needs it, like now. When she goes home, my father's private bedroom and bath is there for any care worker if she ever needs one. I can do almost every thing for her, except if she ever needs shower or toilet assistance. I have lost over \$100,000 trying to protect my Mother and to get her back home to live again happy and free to enjoy her life. There is no reason why she has to be kept there.

There has been no proof of me ever "agitating" my Mother or causing her legs to be swollen as has been claimed for 2 years. The allegations of cell phone use have never been proven. When I did bring out my cell phone, it was when my phone rang, text messages or to see what time it was because I could only stay an hour. For the past 2 years, Blumer has denied Mother and me to be together on birthdays, Thanksgiving, Christmas, Valentines Day, Mother's Day, Easter, Good Friday and other special days. Blumer had no reason for that! POW's and people in prison for all types of crimes have more privileges than my mother. WHY?

I have been denied a cell phone to record visits by jaskowiak, Gelsinger and court to protect myself from lies by their "monitors". The claim is a cell phone would violate Mother's privacy. But, they want THEIR hand picked "monitors" (liars), to be able to write lies about me to further reduce my visits to none for exposing this guardianship scam. They refuse to release monitor's qualifications to do this legal work. But, a total stranger sitting next to us, making notes, taking our pictures, listening to our private conversation is NOT violating Mother's privacy and mine? Under Title 20, section 5521 and reinforced by the new law SB 506, MOTHER is the one who decides how she wants her guardianship to be run and how the guardians must act. Nobody has ever asked Mother what she wants and she has always been refused to come to court to speak.

My solution about this cell phone issue is extremely simple. I do not know why none of the guardians, their lawyers, jaskowiak, Klock ("care manager" hired by logie and kept on by Blumer) or anyone has ever mentioned it. Answer: no cell phone allowed in the room during my visit. Simple and perfect. We used to have lunch in her room in private and phone calls during the day. Under Blumer, she made up those claims that I "agitate" Mother and my food caused Mother's legs to swell to cancel our lunches and phone calls as more punishment to me for exposing the guardianship scam. I keep proving guardians, their lawyers, jaskowiak, Klock and court are NOT doing their jobs to keep Mother healthy, happy and physically and cognitively fit.

As per proposed guardian Mahoney, I believe he will be dedicated to my Mother's wants and needs and I have no objection to Mr. Mahoney. Pam blumer has already resigned and it is imperative a new guardian be appointed now. Jaskowiak claims he has someone else. But, he promoted his friend Logie, who he had used many times and Blumer, whose husband is a friend of his and look how destructive they were to my Mother's health, wellbeing, happiness and her finances. In his acceptance letter, Mr. Mahoney strongly shows he is dedicated to his clients wants and needs, as per PA Title 20, section 5521 and PA SB 506.



Since May 2021, I have been fighting everyday to protect and help my Mother in this scam since this scam was started by my sister. I want my Mother to be healthy, happy and free to enjoy her life as it should have been for the past 2 years. Mother wants to go home and put his nightmare behind her. She deserves to have the rest of her life the way it was.

The Mafia again continues to refuse such a simple and free way of solving this and many other issues and problems I have found pertaining to Mother's physical and mental health, her financial welfare and most important her happiness. It is very clear the Mafia has refused cell phones because they cannot be paid off and cannot lie for them, NOT as it claims that it would violate Mother's privacy. The Mafia violated her right of privacy when they dragged her away from her house to be their property and their bank account.

Recently, I filed a petition for the Mafia to either prove their accusations or "Get off of the toilet". But, you demanded Judge Sterling deny my petition to be heard. As you wanted her to do, Judge Sterling denied me my right to be heard and to prove my case.
