

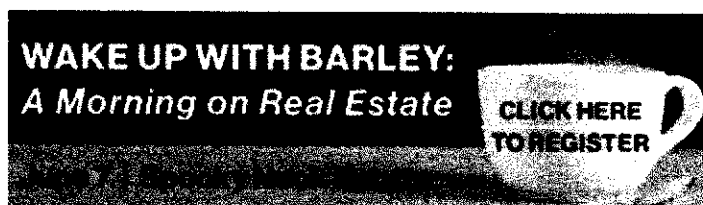

To All,

For over a year, this laughable act by guardians, lawyers and judge has become extremely boring to me. food, treatment of Mother

gelsinger,

Why aren't you responding to my questions? I spend my time writing them only because they deal with the health, welfare and happiness of my now 98 year old Mother. There is a person behind the bank account your client, her lawyers, husband and care manager feeds off of.

Why is my Mother not allowed to have food and snacks in her room like she used to and enjoyed at home without any problems? Mother does not have any diet restrictions. Why can't blumer make her happy and instead of being sad everyday? Does blumer care that my Mother is so sad and lonely and that she is probably crying everyday because she cannot be with her son who she loves and enjoys being with? My Mother is 98 and is a human being. Is this how blumer thinks my 98 year old Mother, as her supposed guardian, should be living the rest of her life? Is my Mother's life and welfare today, with blumer, what Mother should be paying for, along with the lawyers and klock that goes with it?

Blumer is the guardian of person. It is her responsibility to be there as a "monitor" if she thinks there is a problem during a visit, not telling me I have to pay for one of her friends who is out of work. As per her health and happiness, Mother is 98, she has been kept in solitary confinement for almost 2 years, in a sensory deprived enviroment, has not been allowed to see her regular doctors for almost 2 years, has not been allowed outside for almost 2 years, has not been allowed to see her house and her much loved possessions for almost 2 years, has no access to reading materials, no phone allowed in her room, she is not allowed to call her friends or them to call her, no access to be in society and with normal humans to talk to and engage with, spends basically 24 hours a day sleeping in her bed or in the chair, not allowed letters or cards from her friends, not allowed to see ministers, denied to see me on Christmas, Easter and Good Friday (3 of the most important Christian holidays) no visits allowed for her birthday, Mother's Day, Valentines Day, Thanksgiving and other visit days that were canceled by blumer for no reason.

A guardian is supposed to answer to the victim and fulfil their wants and wishes under the law (see attached), NOT own them and make their life far worse than it was before,

including depleting their bank account.

Again, you have not answered my question I have asked you many times: Why doesn't blumer come to my Mother's house and see how big and beautiful it is and how she has been living happily for the past 21 years? How can blumer think a person be expected to live in such a extreme solitary confinement and be expected to live like a normal human being? Why doesn't she take ledakis's advice in his report #1 and let Mother live at home and enjoy everyday like ledakis said she should and with me there, everything was going fine? POW's, under the Geneva Convention, have more priviledges than my Mother and people in prison, for all types of crimes, have more priviledges than my Mother.


How does blumer explain her treatment, under her ownership, for the past year of a 98 year old person compared to what the law says of how a guardian must act and guardianship must be done with a person?
