BLUMER VARIOUS DOCUMENTS

- 1. More extreme visit restrictions by the mafia to Mother and me without any proof those restrictions were ever needed and NO proof by the mafia that I had ever done anything to have them. The mafia refused to prove their fake accusations in court and when I filed a petition for them to do so in September 2023, jaskowiak, camp, gelsinger and fenstermacher begged judge sterling to deny my petition. She did.
- 2. pam blumer's claimed work experience. She claimed before she was hired she was a certified guardian. She lied. I discovered she never was. After being hired to be the guardian of person for my 97 year old Mother, she still never became certified. Her lawyer husband was good friends of jaskowiak.
- 3. I had sent my then lawyer a letter telling him that my Mother had refused to get a flu shot until she talked to me. It proved how much my Mother trusted me and counted on me. Blumer had told me she wanted me to get a chair for Mother to sit down in the shower. Who the hell is blumer to tell me what to do? She is the guardian of person at \$125 an hour Mother is paying her. Blumer's job is to serve Mother.
- 4. In the beginning, I contacted blumer so she could meet me and for her to see how Mother was living before she was kidnapped by logic and jsh. Blumer never wanted any meeting. Why would she thing she could make Mother happy if she did not know how Mother was living?
- 5. By about September 2023, I was tired of seeing my good name being used by the mafia for 2 years to claim I was doing many bad things to Mother, including making her legs swollen, making her "agitated", etc. The mafia used their own lies to restrict and deny visits with Mother. I filed a petition that month for them to either "prove I am a danger or menace to Mother, in other words either defecate or get off of the toilet. The mafia, including blumer, jaskowiak, jsh, etc, replied to sterling they demanded my petion be denied. Sterling did what they wanted. Don't lawyers know in this countery a person is innocent until proven guilty in a court of law?
- 6. A page of some, of many, many, wasteful billing hours blumer/her lawyers demand Mother pay for. Blumer hired them as part of her business. It is HER responsibility to pay them as a expense in her business. In addition, the mafia, especially jaskowiak, was trying to get the DA to file criminal charges against me for wiretapping for supposed videotaping Mother with my cell phone. Blumer's lawyer, gelsinger, was told to contact a DA detective, Kelly, about doing so by weilheimer. Why would weilheimer get involved with getting the DA involved for the mafia's benefit of prosecuting me and trying to put me in prison again, as jaskowiak had done twice before? Re: New Procedures for Visitation with Jane Herring

Dear Counsel:

In accordance with Judge Weilhimer's instructions to me during the July 20, 2022 status conference, I am writing to confirm the new visitation procedure for Jane Herring that my client is directing. I will certainly entertain any feedback any of you may wish to provide, but please understand that these new procedures are effective immediately subject to my client's ability to modify them in the future if she believes that is appropriate. They are intended to apply to both Jill and Arthur, although I think it is abundantly clear that they are aimed squarely at addressing Arthur's past behavior that has been inappropriate and upsetting to Jane.

The new procedures are as follows:

1. All visits between Jane Herring and her children are to occur in the dining room at Manatawny Manor. Visits will continue to occur on the dates and times and for the duration set forth in the court's earlier order. Staff at Manatawny Manor may elect to sit with Jane during these visits, so there should be no expectation on the part of Jane's children that their visits with their mother will be private. If the staff at Manatawny Manor believes Jane is becoming upset during a visit, they have the authority to take Jane back to her room so that Jane can regain her composure. If the allotted time for the visit expires while Jane is recovering her composure, no additional visitation time will be permitted, and the child will need to return at his or her next scheduled visiting time.

- 2. Neither of Jane's children are to visit with Jane in her room. In fact, they may not enter Jane's room for any reason or attempt to communicate with Jane from the hallway outside her room or through the window in her room without the express consent of my client or the staff at Manatawny Manor. Should Jane wish to go to her room during a visit with her children, she is free to do so. However, her children may not accompany her to her room or interact with her while she is in her room. Jane's room will now serve as a place she can retreat to should she wish to cut short a meeting with one of her children. If a child enters Jane's room during a visit, the staff at Manatawny Manor will be authorized to end the child's visit and direct the child off of the property.
- 3. Jane will not be permitted to have a telephone in her room. Similarly, no one is permitted to bring a mobile phone to Jane for her use.
- 4. Jane will not be permitted to receive telephone calls from her children at the nurses' station or at any other location at Manatawny Manor using its telephone system. If Jane wishes to initiate a call from Manatawny Manor to a third party, the staff and Manatawny Manor will notify my client and she will determine if the staff is to assist Jane in making the call or make the facility's telephone system available to Jane.
- 5. The staff at Manatawny Manor will have no obligation to relay messages from Jane's children to Jane. They have been directed to use their discretion, subject to their work assignments, to advise Jane if one of her children is unable to visit or is running late for a visit. Without my client's approval, they are not permitted to relay any other messages to Jane from either of her children.
- 6. If Jane becomes upset during a visit with one of her children, my client will determine if future visits with that child are to be conducted in the presence of a third party who will supervise future visits. The supervisor shall have the authority to report to my client disruptive and/or upsetting behavior by the child or conduct that violates any of these procedures or any prior instruction of the Court. If supervised visits become necessary, every effort will be made to obtain the services of a third party supervisor for visits with Jane's children. However, if a supervisor is not available, the visit with the child will be rescheduled to another time when the supervisor and the child are both available.
- 7. Consistent with the Court's earlier orders, Jane's medical care takes priority over her visits with her children. If Jane needs to meet with medical personnel for any reason during a time when one of Jane's children is permitted to visit her, the child's visit will be postponed so as to begin at the conclusion of Jane's medical treatment. However, if a child interferes in any way with the care Jane is to receive during the child's scheduled visit, the child will forfeit the opportunity to visit'with Jane for that day and will be escorted off the campus at Manatawny Manor.
- 8. Food items are not to be brought to Jane without my client's prior approval. Requests for approval are to be submitted only via email to pblumer@hotmail.com. Items that have excessive sugar, sodium and/or fat like lunch meat, mayonnaise, doughnuts, etc. will not be permitted. If they are discovered in Jane's room, they will be thrown out regardless of whether

they were meant for Jane or someone else. Her room is not to be used as a repository for other people's food items. Jane's care plan includes a dietary component, and her children are expected to follow and support the dietary components on her care plan.

Mr. Meitner and Ms. Camp, I would appreciate you passing on a copy of this letter to your clients as soon as possible. The procedures listed above are in effect now and your clients are expected to abide by them effective immediately. My client reserves the right to petition to the Court to modify its prior orders regarding your clients' ability to visit with Jane should concerns about those visits persist. The types of concerns to which I am referring include without limitation, (1) statements to Jane that she will be leaving Manatawny Manor and returning to her home, (2) impolite and/or verbally abusive interactions with the staff at Manatawny Manor (whether in Jane's presence or otherwise), (3) discussions with Jane about any legal proceedings involving Jane, her residence and/or her guardianship, (4) statements to Jane that undermine her confidence in the care she receives at Manatawny Manor and/or (5) discussions with Jane about any legal proceedings or threatened proceedings involving any of Jane's children. Jane has no ability to address or assist with any of the aforementioned topics and therefore it is completely inappropriate to burden her with these issues.

It is a very simple matter to visit with Jane and not upset her or the staff at Manatawny Manor. It only takes a minimal amount of effort and self-control. Those who are unwilling or unable to exhibit that minimal level of effort and self-control are injurious to Jane's well-being and best interests. My client will seek to bar anyone who is injurious to Jane's well-being and best interests from seeing her, contacting her or receiving any information about her. Consequently, I hope both of Jane's children will comport themselves appropriately so that it will not be necessary to seek the termination of their visitation privileges. I thank you all for your anticipated cooperation with these new procedures, although my client and I remain saddened that they are necessary.

Mr. Meitner,

As you recall, pam blumer asked me to bring a seat for the shower for my mother about 10 days ago. Mother does not have one. Since she is the guardian and deb klock is "care manager" I cannot believe pam is asking me to do their jobs.

Today, I saw another Deb who is a nurse and she and Kay Richardson are in charge of the second floor where my mother is. I mentioned pam wanted me to get a chair for mother from manatawny manor and Deb made a unhappy face. It seems she does not like pam or her husband. Deb told me when bill asked her to testify a week or so ago she said no. Then bill subpoenaed her. Deb is mad at them because she said she will not be paid for the day. She seems to be mad at pam for other things, too. Deb told me mother showers standing up and it is standard practice to have a person watch in case they fall. Deb mentioned she put Colinda and a few other of those women at a different location because of their actions that day about 6 weeks ago. For the past month, usually no staff person is in the TV room to watch and listen to us when we have lunch.

VERY interesting. Deb also told me today on friday they were giving new covid vaccinations to residents and mother really refused to have one. Deb said she did not force it because mother was getting "agitated". Deb said mother said she would have to ask me if she should have one. I asked mother about that today and told her it was alright. Deb said she will have it scheduled for wednesday when I am there. Deb said mother constantly talks about me.

What is very important and should be brought out at the trial is that mother showed how much she depends on me and trusts me based on fridays statement that mother wants to talk to me first before she gets the vaccination. That will be very important to our argument that mother should be home with me because she trusts me and believes what I say is the best for her.

I strongly feel we have to be on the attack with all of them and show how they have done nothing for mother and been a danger to her and her health and happiness.. Weilheimer will use every bad remark by anybody to cut my visits and keep mother there. Ledakis only said mother had a little memory problem. He never said she should be locked up in a mental ward so far for 13 months, no outside trips anywhere, no doctors visits for 13 months, no phone in her room and no unlimited visits and time she can be with me. She still does not get any special help from the staff: dressing, eating, hygiene, bathing, tollet, walking, etc. Mother is getting weaker with her legs when she walks. That is blumer's fault denying more time for outside walks at the nursing home or other physical and mental activities that she would have everyday at home.

People (fenstermacher, jaskowiak, weilheimer) last time were so concerned about mother's savings that they wanted to sell the house and trash her possessions, but no body cared that it was costing mother \$90,000 a year for a very tiny room with worn out furniture and locked down in a mental ward with people with serious medical, mental and behavior problems that had no benefit to mother when she could live at home basically free.

Why should mother have to live like that untill she dies in solitary confinement in a sensory deprived environment? Under blumer's, fenstermacher and jaskowiak's "care", mother will die a crippled person with advanced dementia and other medical problems because of their lack of proper care way before she should die.

The question that must be asked of blumer, fenstermacher and jaskowiak is after 18 months under their and logies care, how is mother better off now than BEFORE the petition was filed on May 18 2021? Whether medically, mentally, physically, emotionally and financially the answer is NONE of those. That should get them fired and mother home.

I, PAMELA WOODWARD BLUMER, hereby tender my resignation as the permanent plenary Guardian of the Person of Jane T. Herring, an incapacitated person. I intend for this resignation to be effective upon the appointment of a successor permanent plenary guardian of the person of Jane T. Herring, an incapacitated person, by the Court of Common Pleas of Montgomery County, Pennsylvania, Orphans' Court Division.

I tender this resignation with regret as I have truly enjoyed my interactions with Jane T. Herring during my tenure as the Guardian of her person. However, the combative and litigious nature of her son, Arthur Herring, III, and the need to respond repeatedly to his false and unsubstantiated allegations relating to his mother's care and his assertion of his own non-existent legal rights as Jane T. Herring's son places an untenable burden on me that adversely impacts my ability to fulfill my fiduciary obligations to my other wards. It also has a negative impact on my mental health. Arthur Herring III's public and defamatory allegations against me and his repeated petitions for my removal as his mother's guardian have also made it challenging for me to maintain professional liability insurance coverage which is vital to my work as a professional fiduciary.

Reply to petition to accept resignation of guardian of person, pam blumer, to Jane Herring.

Petitioner, Rev. Arthur Herring, III, pro se (hereinafter referred to as "Arthur") files this Reply to petition to accept the resignation of guardian of person, pam blumer, to Jane Herring. Arthur is requesting a hearing on this matter of change of guardians. In addition, under PA law Title 20, section 5521, Jane has the legal right to be there at the hearing to finally be able to speak for herself and determine what she wants after two years of being denied to do so. If necessary, a subpoena will be issued by Arthur for Jane to be there so her voice will finally be heard in this guardianship corruption on her for the past two years.

- 1. Denied. Pam blumer (blumer) was never a guardian to Jane in any sense of the word. Blumer's business is only to make money by deceptive practices, not to care the elderly and cater to their needs, wants and happiness. Blumer had no legal authority or right to hire anyone she wanted, spend what ever she wanted and then bill Jane for it. Her hired entourage, included her lawyer husband bill, is related to pam by marriage and violates the Canons of Ethics since they share the profits of what he makes. Blumer then hired many lawyers in his law firm. Blumer's entourage included a "care manager" deb klock, who has a well known and documented history of stealing from her clients and over drugging them. Jane Herring (Jane) was never proven to be "incapacitated" in the real world. A paid off psychologist, ledakis, claimed Jane flunked his so-called "evaluation". Ledakis admitted in court his "evaluation" had no independent proof of accuracy, he could not prove Jane ever had such a "evaluation" because he never audio or video records his sessions, therefor ledakis's "report" and his later ones cannot be proven they only pertain to Jane and not hundreds of other people. Jaskowiak, court appointed lawyer by weilheimer for Jane and a member of the Racket, refused to bring Jane into court so she could speak for herself and refused to bring in any of the professional people Jane dealt with every year to prove Jane did not need any guardians. Jaskowiak refused to defend Jane against guardianship because Jaskowiak wanted Jane to be guardianized for the Racket for Jane's vast assets.
- Agreed.
- 3. Denied. Jane is a prisoner, not a resident, at a very low rated, disease infested nursing home. Jane has never been allowed to leave her place in two years to enjoy life in society as she had before the guardianship scam was started by her estranged daughter, jsh. Contrary to the Racket's own expert, ledakis, he said Jane could live at home and with Arthur there everything was fine. But, Jane was kidnapped from her home by Logie and jsh, put through 2 weeks of torture and torment that led to Jane being taken away, unconscious, by ambulance to a hospital, confined to bed for 6 weeks and treated for starvation. Jane had to have daily blood tests (42 times) anddaily needles in the stomach to prevent blood clots (42 times) and then got covid. Jane's first "guardian" and jsh then dumped Jane into her current prison. Jane has been forced to live there in solitary confinement, in a sensory deprived environment and been refused to be allowed by blumer (Racket) to go into society and back to her home to be with her much loved possessions and to enjoy life as she was living free and happy in her large 3 bedroom, 3 bath house in a gated community of 21 years. Jane was never claimed to have any mental or behavior problems that would make her a danger to herself or others.

Blumer/Racket have used barbaric and inhumane treatment on Jane since blumer was appointed "guardian" (owner) to Jane in May 2022. Such barbaric treatment include keeping Jane away from her much loved son, Arthur, who both have always had a very long and loving relationship as Mother and son with gross, inhumane visit limitations. From August 25 2021, when Jane was kidnapped by Logie and jsh to December 1 2023, based on 16 hour days (8 hours for sleep) out of a possible 13,730 hours Jane and Arthur could be together, they were only allowed 222 hours, with many of those limited hours they were spied on by the staff and paid liars hired by blumer and paid for by Arthur. Blumer's purpose was harassment and retaliation by Blumer/Racket because of Arthur exposing the money scam on Jane by blumer/Racket.

- 4. Agreed. Good by and good riddance. Blumer/Racket have caused great and irreversible damage to Jane's physical, mental and financial harm to Jane and caused Jane such daily unhappiness and lonliness that such elder abuse cannot be measured by anyone.
- Denied. Strict proof demanded at trial. Arthur was constantly finding many problems with blumer's 5. gross ignorance of the law and the caring of Jane, starting with Jane's age of 96. Arthur's emails to blumer, gelsinger, jaskowiak, fenstermacher and logie prove those constant problems and lack of correcting those problems by guardians paid for by Jane. Since the beginning of the "guardianship, Arthur was aware Jane was only a bank account to blumer/Racket, but he refused to allow his much loved Mother to be used as a bank account. Today, POW's, under the Geneva Convention, have more privileges than Jane. Prisoner's convicted of all types of crimes, have more priviliges than Jane. Jane, with blumer/Racket, have none of those priviliges, including freedom. PA Title 20, section 5521 dictates how guardianships and guardians are supposed to do their jobs. Blumer/Racket have refused to follow that law and other laws. Blumer/Racket have refused to follow the federal Olmsted Act that says a person with a disability cannot be warehoused if another place is available. The Americans with Disabilities Act says people with a memory impairment are considered disabled. Mother has a house to go home to and live. Pennsylvania law demands the least restrictive way for a person, before guardianship, who is incapacitated. Jane did not have any problems with medical, physical or financial matters, no unpaid taxes, no unpaid bills. Blumer's "guardianship" is solely based on fraud for financial profit by blumer/Racket. When Blumer was hired, she committed fraud by claiming she had been certified as a guardian by a business doing so.
- 6. Denied. Blumer/Racket is only trying to deflect their corruption and gross incompetence on Jane by blaming Arthur with their made up lies since May 2022 when blumer was appointed. Blumer said in court she had 10 other "clients" (victims) and admitted she had 70 total "clients" (victims) in 11 years. If blumer/Racket any of my statements are false, let them file a lawsuit against me. I welcome it. I will have many subpoena's for people and documents that will prove they are only a criminal enterprise that scams people out of their assets using fake guardianships, corrupt judges, corrupt lawyers and corrupt psychologists. Their current and previous victims will want to join in that lawsuit.
- 7. Cannot comment as to truth of that statement.
- 8. See. #7. Arthur will have questions for Mr. Mahoney in court to avoid any more barbaric and inhumane treatment to Jane that she has suffered with blumer/Racket for the past 1.5 years and to avoid the massive corruption and incompetence, including the senseless waste of her finances to Jane at this late stage of her life, and to be sure Jane will enjoy the happiness and freedom to that she had before jsh started this money scam on Jane and Arthur.
- 9. I will welcome Mr. Mahoney, if he is chosen, and hope he will do what he promised to do in his acceptance of being a guardian to Jane. I hope Mr. Mahoney will begin by taking Jane back home to live as she was before she became a victim of this guardianship scam and where ledakis said she could live in his first "evaluation". Once home, Mother would be free once again, to enjoy the pleasures of life, her large home, her much loved possessions, her happy daily life as a human being and to be with the son who she loves and has

always trusted to help and protect her when she ever needed it. There are many laws designed to protect the elderly from this type of scam of guardianship corruption that have been completely ignored by blumer/Racket that I would expect any honest and caring guardian of person to carry out for his client. I am glad blumer will be replaced because I only want and have only wanted the best life for my Mother.

10-12. Denied. There must be an independent audit of Jane's estate. There have been too many sticky fingers that have had unlimited access to debit cards, withdrawls, etc, which have been approved by guardians of the estate and weilheimer without any evidence to back them up.

Denied. There has been too much secrecy to know what loans, etc have been taken out by guardians, lawyers, etc.

- E. Amount/Reason for Request.

16. a& b. Denied. The two most important questions must be asked: 1. What did pam blumer do after she was hired to make Mother's life better in any way than before blumer was hired? 2. What did pam blumer do to continue the happy and healthy life Mother had before blumer was her guardian? Answer: Nothing. A guardian has a specific duty. Blumer totally failed in her obligations as a guardian. Blumer never did her job and there is no reason for her to be paid. Mother is far worse off now after having blumer for 1.5 years than before. Pam blumer was the only one appointed by the court. She was only entitled to her billing hour of \$100 an hour, no other "extra's". Sometime in 2022, she gave herself a pay raise to \$125 an hour without permission by anyone. Immediately after being hired, Blumer took it upon herself to hire lawyers, including her husband bill as part of her "staff". Hiring bill was a clear conflict of interest in the Rules of Conduct for lawyers. Bill blumer then hired other lawyers in his law firm just to create padded billing hours to make more money for himself, his wife, family and barley Snyder. Pam blumer had no legal rights to charge Jane for her newly hired staff. Blumer/Barley Snyder fees are excessive and not supported by anyone approving his hiring and there was no fee agreement approved by the court. Jaskowiak basically handled all matters on behalf of Jane as her court appointed lawyer and pam blumer did not need a second lawyer representing her business. Barley/Snyder did nothing for Jane's benefit and those lawyer fees also benefited blumer's family by any fees paid to barley/Snyder. Blumer also kept a "care manager" deb klock on that previous guardian Logie hired, also without permission by the court. Klock has a well known history of stealing and over drugging her victims. All of those "entourage" expenses are now being charged to Jane. All expenses by pam blumer, in her business, are her responsibility, NOT Jane's. Blumer/lawyers have been and still are blaming Arthur for unnecessary emails and lawyer fees only to deflect blumer's massive failure as a guardian, including her gross incompetence, corruption and failure to obey the national law of Olmsted Act and various Pennsylvania laws of guardianship: Title 20, section 5521 and Pennsylvania demanding the victim live in the least restrictive way before guardianship. There were never any examples in court that Jane needed guardians and weilheimer's lawyer for Jane, jaskowiak, deliberately refused to defend and protect Jane from guardianship because he wanted Jane to be guardianized for Jane's vast assets. Pam blumer has seen Jane and her 71 other victims she has had as only bank accounts to use for blumer's and Barley Snyder's financial enrichment at the expense of elderly people's pain and suffering. Arthur's constant emails of problems affecting Jane, since may 2022, have either never been read and/or never corrected by pam blumer. To blumer and the Racket, Jane only exists to

make them richer, not for Jane's welfare and happiness. Under blumer's "ownership" Mother declined physically, mentally, financially and her happiness has basically evaporated. On December 18, 2023, gelsinger informed Arthur a week ago Jane felt dizzy and was taken to the hospital. Gelsinger said the doctors said she had a subdural hematoma. It was because she fell a month ago because of the lack of exercise, medication and the constant slippery floors. I gave Mother several pairs of no slip socks 2 years ago, but the staff refuses to make sure they are on, just like the TED socks that are supposed to be on her legs. In contrast, when Arthur lived with Jane for about 1.5 years, before Jane was kidnapped by jsh and logie, Jane had no problems and life everyday was happy, fulfilling and nobody was stealing her money. Even ledakis said so in his first report


