

CYNTHIA ELLIS

Before ellis was hired to be guardian of person to Mother in March 2024, she stated she never was a guardian of person to only one person. She had been only a social worker at a business. She stated, at the time of being "hired" to what would be Mother's last guardian of person, she was only a co-guardian of 2 people. She was never fully in charge of a person. She stated also she was not certified to be a guardian and at the time of Mother being reborn on July 2 2024, ellis was still NOT certified. Hardly the qualifications to be handling the life, welfare and happiness of a soon to be 99 year old woman, my Mother, or guardian of any person.

Upon further investigation by me (41 years doing criminal investigations nationwide), the company, ellis worked for, was chosen to replace pam blumer, by jaskowiak. Pam blumer was another "guardian of person" who also never was certified to be a guardian for the almost 1.5 years blumer was "guardian of person" to my Mother. Pam blumer had lied when she was hired and claimed she was certified to be a guardian. I proved she had lied. When Pam blumer was "picked" to be "guardian" of Mother in May 2022, she hired her husband bill blumer to be her "lawyer" which is not only a conflict of interest, but pam blumer had NO authority to hire anyone and then bill my Mother for those costs. Only pam blumer could charge Mother for her time, mainly for visits to Mother. Blumer stated in court she only saw Mother for about 1 hour each month. Anyone blumer or anyone else they hired would be the sole cost to pam blumer's business as a business expense. Bill blumer then hire several other lawyers in their law firm who then billed my Mother for their massive lawyer work. Bill blumer was good friends with jaskowiak. It's all about vultures on the side of the road feeding on the road kill. In this case, a very elderly woman who had a great amount of assets. Her corrupt court appointed lawyer, jaskowiak, since day one when the petition for guardianship was filed by Mother's daughter, jsh, jaskowiak NEVER defended or protected Mother in court at the petition hearing, NEVER advocated for Mother for anything for her health, welfare and happiness, kept Mother totally ignorant of what was happening to her and her finances and what the mafia was doing to her son, Arthur. Jaskowiak only saw Mother 2 times in 3 years, but kept filing petitions and replying to petitions in behalf of Mother. A lawyer is obligated to keep in constant contact with his client and do what his client wants or he must quit.

The emails posted in this section prove ellis and the company she worked for was controlled by her puppet master, jaskowiak. The company she worked for was making money only as long as they did what jaskowiak wanted them to do. Their main job was NOT to care about Mother's wants and needs, especially when it came to visits to Mother by me. Nationwide, visits are used as punishment to the families if they criticize the guardians and the poor jobs they are doing to their loved ones. The guardianship mafia, that owned Mother from beginning to her end, did the same thing. They restricted and denied my visits because I was exposing the mafia's massive corruption on Mother. On the other hand, jsh never had those restrictions of visits because she was part of the mafia from beginning to the end of Mother's life. From august 25 2021 when Mother was kidnapped to when Mother was reborn on July 2 2024, out of a possible 16 hours per day (8 hours for sleeping) out of a possible 24,700 hours Mother and I could have been together, the mafia only allowed us 224. Is that what guardianship is supposed to be for a elderly person?

As my emails clearly prove, ellis refused to answer my emails and the questions in them pertaining to Mother's welfare and happiness. Even when Mother was close to be reborn, ellis never cared about Mother and I being together. I have been refused all medical records that would show what really happened the week before Mother was reborn. I was never told Mother was dying by ellis or anyone. If Mother was really dying, not being murdered by morphine as she was, then why wasn't Mother given hospice and allowed to have her last days being happy in any way she wanted, including to be with me as much as possible. Why was Mother denied the dignity of her last wishes. Why did ellis and the mafia force Mother to die by a very slow, painful

and barbaric way of starvation and dehydration by morphine, in her tiny bed, in her cage, in solitary confinement for 3 years instead of in her huge 3 bedroom, 3 bath house in a gated community with her much loved possessions of about 100 years where she had lived happily for about 20 years?

On July 1 2024, I went to see Mother. The director Kessler met me. I brought red roses for Mother. I had many fights with kessler during 3 years Mother was there in her cage because of the way Mother was kept in solitary confinement by him when there was no reason for her to be kept locked in with people with mental and behavior problems as Mother had been for 3 years. Mother's floor had a far bigger and much nicer section on the same floor but on the other side of Mother's locked in, pig pen section. The other side had normal people, library, activites room, a beautiful large dining room, much nicer food and a game room. I found out Mother was kept in that locked in section because the pig pen made more money with Mother in that locked in section. Kessler never did anything for her. After Mother was dumped there in October 2021 by jsh and logie, I saw Mother did not have a refridgerator. It took me several weeks before the former director gave her one. But, in may 2022, pam blumer banned me from Mother's room and I found out the refridgerator was taken out. No reason given. Mother could only eat what the pig pen gave her at meals. Why? Was this place a place for the elderly to be happy for years or a POW camp? Kessler took me upstairs to Mother's room. The door was open and the other 2 "witnesses" were there. Mother was in bed. She looked asleep to me, but she was really unconscious. Kessler said "don't you want to go in"? I said she was asleep. He said "She is passing". I said "You mean she is dying"? That is when I found out how close to death she had been. I went in and said hi to her. Her head looked as if it had shrunk. Her hair felt like it had not been washed for months. It felt like straw. Her eyes were about 30% open and her mouth was open. Her tongue was twisted. Every once in a while, she would make a moaning sound. I squeezed her hand several times, but got no reaction. I put her roses in a vase. The 3 of those watchers just stared at me the entire time. Several times I asked the "Are you enjoying watching me you ghouls"? They never responded. I lifted up the sheet and saw how boney her legs were. I checked to see if her 2 rings were still on her finger and they were. I told her how much I loved her. I cried often. At exactly one hour, one them said my time was up and I had to leave. What a bunch of barbaric animals. The next morning, July 2, at 715am, ellis called me to say Mother had died about 7am. Mother was reborn and was away from the mafia and out of their ownership. Mother will never be owned by anyone in this world to be used as their bank account and toy. She will be free for eternity and to enjoy the love with the people she knew and loved during her life, including her husband, her Mother, her grandparents and many others. Her new home will always be of love and happiness.

What was the guardians and jaskowiak's purpose for Mother? None! The mafia's only concern was for their own financial benefit that Mother had.

Ms. Ellis,

I fail to understand why you have not contacted me by phone or email after I first contacted you on March 4 2024. It is now March 22 2024. I am the son of Jane Herring, your client and her guardian of person. I do not understand why you have not or do not think it is necessary to contact close family members, in this case me. Just because you were named as a guardian, I and all of the other family members who have loved ones in guardianships, did not and will never simply allow any guardian (who is a total stranger to us) to "own" and "control" our loved ones without watching what they are doing on our loved ones. Guardianship corruption is so massive nationwide and worldwide, it is at epidemic proportions for decades. You Tube and my massive website www.protectmyparents.us will prove that massive corruption. As you recall, you stated in court you have not been a guardian of a person, only a co-guardian of 2 people.

There has been massive isolation, fraud, mental abuse, medical abuse, physical neglect, physical abuse, financial abuse and corruption to my soon to be 99 year old Mother pertaining to and during this fake guardianship on Mother for the past 2.5 years while she has been kept, against her will, at her current place. My mother was never claimed or accused of having any mental or behavior problems that would make her a danger to herself or others. There has been never any reason why she had to be locked in a section, in solitary confinement, in a sensory deprived environment for 2.5 years. My sister and the others have demanded Mother live and die in her tiny room, in a disease infested place, no phone, no table, no friends or ministers allowed, no reading material (unless I brought them) and only allowed the small amount of food they give her, even though she has a refrigerator that I got the place to put in her room. He has no, repeat no, control of your position as Mother's guardian. You have been her guardian for about a month.

As you heard in court on 3/20/24, I exposed that "monitor" mary ellen as a liar, crook and I destroyed her credibility. She admitted that she had no training to make her fake notes that have been used against me by this guardianship mafia since November 2022 to constantly reduce and restrict my visits and force me to pay those monitors from my money if I wanted to see my Mother. So far, you have done nothing for your client (in a month she will be 99) that I have been aware of so Mother and I can have a normal relationship as we used to have before this guardianship scam was started by a sister only to get my Mothers vast assets. She had tried to do so many times before, with the help of fenstermacher (guardian of estate), but I stopped them. She wanted to be both guardian of person and estate, but dropped out because I had proof of her trying to steal in the past. As you should also be aware, if not already if you had reviewed this case, there is NOTHING that I have ever done to warrant those barbaric and inhumane "visit" restrictions with Mother since the beginning of this scam guardianship in May 2021. In fact, Sterling, jaskowiak, blumer, gelsinger (one of her many former lawyers) had REFUSED to ever file a petition to prove their made up claims against me. I finally filed a petition last September for them to do so, but jaskowiak, and the previous names all begged Sterling to deny my petition for them to prove their made up claims. Sterling did what they wanted and denied my demand to either prove their claims or never say them again and to use them against Mother and me..

As a Christian minister, I was appalled yesterday when I called the pig pen my Mother to wish her a Happy Easter, Mother has been forced to live in that pig pen for 2.5 years by jaskowiak, Mother's guardians, their lawyers, her "care manager" klock (who has a long history of stealing and overdrugging her victims) and my sister. Mother has been forced to stay in solitary confinement, in a sensory deprived environment, never had a phone to call

me or her friends, no reading material, etc, and has less privileges than POW's have under the Geneva Convention and less privileges than people have in prison for all types of crimes. How is that torture good for anyone, at any age, let alone a person they claim has dementia to be denied to be active mentally and physically? Keep in mind, Jaskowiak NEVER brought in any professionals Mother used every year to prove she had no mental, medical, physical or financial problems where she needed any guardian. Jaskowiak never defended Mother against guardianship because he wanted her to be guardianized for her vast assets for him and this guardianship mafia. Even my sister never gave one example in her petition of Mother needing a guardian. There were no unpaid taxes, no bounced checks, no unpaid bills, no missed doctor's appointments, no checks made out to strange people, etc. She had a housekeeper come in for only one day a month, for only two hours, because Mother and I did the house work. Mother was still driving her car safely until her 96th birthday when her license expired. My sister filed her petition 2 days later and admitted in court, with my questions, she NEVER discussed such a life changing petition with Mother before she filed her petition because my sister said in court "She did not think it was that important to discuss it with her (Mother).

I called Mother to wish her a happy Easter yesterday, one of the 3 most religious holidays of the year for Christians. Within a second of being given the phone by a staff person and Mother said hi to me, another one took it away from her. I heard her say "Why did you grab the phone" and it was hung up. After not being allowed to see her or talk to her for 3 months by Sterling, I am sure my Mother was extremely upset. She and I have always had a very close and loving relationship.

Is this your idea of being a guardian of person, a position you admitted you have only been a co-guardian of only 2 people you admitted to at the hearing you were appointed a month ago?

You claimed in your response that you responded to my emails, That is a lie. I left you a phone message on 2/28 and you claimed you did not leave a message because you claimed you did not know if my phone was secure. That is BS. Everybody's phone can be hacked and they always are. What are you afraid of?.

I emailed you on March 4, 5, 7, 10, 13, 15, 22 (long email) and I also left you a phone message that day, emails also on 26, 28, 29, April 1 long email, 4/3 long email, all to discuss my Mother. You were appointed on february 16 2024. I gave you about 2 weeks before I contacted you..

But, you claimed you answered every one of my emails My email server proves you never did. As of today, you still are not certified to be a guardian and are not a member of the guardianship association. Since jaskowiak has been my mother's lawyer since May 2021 and is supposed to be dedicated to my mother's health and welfare, I do not know why he wanted you, who has no experience of handling a falsly accused victim of being incapacitated as their own client and not certified to be a guardian over many others who were. I am assuming, like the others jaskowiak has picked for Mother, including himself, he is making money out of it. The fact is, jaskowiak has made tons of money from Mother and other people he scammed. I know of what he does. I also do not know why he allowed her to go from a large 3 bedroom, 3 bathroom house, in a gated community to be dumped into a locked in section, a nursing home that is a disease infested pig pen where she has been now for 2.5 years, kept in solitary confinement, in a very tiny room, in a sensory deprived environment, no phone, no visitors, not allowed into society or home to see her loved possessions for 2.5 years. Mother was NEVER claimed to have any mental or behavior problems that she needed to be kidnapped and locked down. At the hearing on march 20, you saw me destroy one of the previous paid off guardians and lawyers and jaskowiak's paid liars, mary ellen, who was paid, like the other one, to simply make up lies about what I said and did during my visits to reduce my visits, time of those visits and the content of those visits. For almost 2.5 years, this guardianship mafia has used those lies that they claimed I got my Mother agitated, but who nobody ever asked her. She never refused my visits or phone calls and the other lie they used was my food made her legs swollen. Mother has no diet restrictions and no food allergies. I will make it very easy for you to answer these and later questions. I attached title 20 5521, 5555, 5502, 5518 FYI at this time.

1. Mother was living in a 3 bedroom, 3 bath house in a gated community for 21 years. Mother saw her primary doctor, Kuhar, of 21 years about 4 times a year and one month after the fake petition was filed by my sister who had tried many times, for years, to put Mother in a nursing home without cause and to take control of her vast assets, using fenstermacher's help. Kuhar never said anything, at any time, that she had a problem living at home and in fact Mother was still driving her car safely. AND NOW, this 1st day of July, 2024, the Court having been informed of the advanced deteriorating medical condition of Jane T. Herring (“Jane”), it is hereby **ORDERED** and **DECREED** that the visitation restrictions and limitations previously put in place with regard to her son, Rev. Arthur Herring, III (“Arthur”), shall be temporarily modified, subject to the conditions set forth herein to allow him an opportunity to see his mother:

1. Arthur shall be permitted to see his mother Jane at Manatawny Manor where she currently resides beginning at 4 p.m. today, July 1, 2024, for those reasonable periods of time during which any of the following are available and agreeable to be present and supervise the visits: Mark Kessler, Administrator at Manatawny Manor, Cynthia Ellis, Guardian of the Person and/or Kerri Lynn Blakey of The Lincoln Center. Any visits shall be scheduled in advance by Arthur with Mark Kessler, Cynthia Ellis and/or Kerri Lynn Blakey to take place during their normal working hours, and taking into account the Fourth of July holiday.
2. No photographs, videos, or recordings of any kind are allowed. No cell phones, cameras or other recording devices shall be permitted to be brought onto the premises of Manatawny Manor by or on behalf of Arthur and, if this condition is violated, such devices may be confiscated by the facility during the pendency of the visit.

3. During any permitted visitation by Arthur, he shall at all times be respectful and dignified with Jane, those supervising the visits and any facility staff. Any disruptive behavior of any kind is expressly forbidden and Arthur will be instructed to immediately leave the facility if he violates this condition. Further, Manatawny Manor is authorized to engage local law enforcement if unacceptable behavior occurs.
4. Any violation of any aspect of this Order will result in sanctions, including possible contempt.
5. All prior Orders and Decrees of this Court shall remain in full force and effect, except as modified hereby.
