DEB KLOCK, "Care Manager"

Shortly after Mother was falsely declared to be "incapacitated" by the quack psychologist, ledakis, on August 6 2021, logie (first guardian of person and estate to Mother, good friends with jaskowiak) sent me a email saying klock wanted to meet Mother in Mother's home alone. He said klock wanted to get to know Mother without any interference from me. I knew something was not right. Logie was extremely anxious to get that meeting. A date was set for august 25, 2021 at 12pm. At that time the door bell rang and it was logie. About 5 minutes later, a tow truck arrived and took my Mother's car away. About 15 minutes after that, I heard my Mother crying/screaming "I don't want to go, I don't want to go". I was in a state of panic because I heard my Mother crying and nobody would tell me anything. About 10 minutes after Mother was taken away, logie came out and the 2 cops released me and they left. It was like they did some military operation. I kept asking logie why was my Mother taken, but he refused to answer. I asked him why my Mother's car was taken and he replied "It is my car now". I would later on during this 3 year money grabbing scam on Mother how much those in this guardianship mafia were criminals who only wanted to steal other people's money, just like any other common crook.

Klock has a long history of stealing and over drugging her victims as I hve been told by the families of those victims. Her lack of concern as a "care manager" for her victims proves she is no better than any other criminal. In her case, she seems to take great pleasure out of owning people, like they were toys. I have never met klock or talked to her. She has never emailed or spoken with me. But, she did with jsh because jsh was a member of this mafia. The fact was, logie was the guardian of person and it was his job to take care of Mother. He had NO authority to hire anyone he wanted and billed Mother for it, as did also all of the other guardians later, their lawyers, monitors, etc. Those people were to be paid by the person who hired them, not Mother.

Since you have been my Mother's "care manager" for 2 years, how come you have never contacted me about my Mother? Why is her condition physically, mentally and her happiness in such poor condition? What is your job if not to prevent that?

With her guardians past and present and you as Mother's "care manager" for 2 years, including by blumer, I constantly find many, many problems that are never fixed by you, logie and now blumer with her group of lawyers. For 2 years, my Mother has been kept in solitary confinement, in a sensory deprived environment, no phone, no visitors allowed, no mail allowed, no food for herself even though she has no diet restrictions and no food allergies, has not been allowed outside into society for 2 years, clearly has not been to a hairdresser for a long time and does not even have a table in her room. That current tiny thing on wheels is NOT a usable table. Mother has suffered greatly mentally, physically and psychologically under your "care", logie's and now blumer since May 2022. She enjoys my company and looked forward to our dinners everyday at her home and the phone calls we had twice a day and our lunches we had 3 times a week at the prison until blumer stopped them in May 2022. Blumer has also denied every important holiday, including birthdays, Christmas, Easter, Good Friday, Mother's day, etc. Is this your ide of being a "care manager"? It is your job to know what Mother likes, wants and needs, especially under the law (attached).

Mother was never claimed to have any mental or behavior problems that would cause her to be a danger to herself or others. There is NO reason for her to be locked up as she has been and to live like a animal in a cage. POW's have more privileges under the Geneva convention than my Mother. People in prison for all types of crimes have more privileges than my mother. WHY?


