FENSTERMACHER'S LIES

Ronald fenstermacher, about 55, was my parents trust lawyer and Executor of their Wills for about 20 years. He would also be my trust lawyer when my last parent died. After my father died in 2013, my sister and him became very good friends. My sister, jsh, had hated my/her Mother all of her life. It was never known why. She was very close to our Father. After father died, jsh and fenstermacher, for some unknown reason decided to try to steal money from my then 88 year old Mother in various ways. One of them would be for jsh to take ownership of my Mother and her vast financial assets. I always told my Mother about those attempts. In mid 2020, I took fenstermacher's various legal documents to a law firm for evaluation. They found many mistakes. Mother decided to fire fenstermacher and she did. In may 2021, fenstermacher told jsh about legsl guardianship to get what jsh wanted: total control of my Mother and her assets. Fenstermacher told jsh to go to the law firm down the hall from his office to do it. On may 18, 2 days after my Mother's 96 birthday, I was emailed the petition for guardianship by jsh's lawyer, camp. Ish admitted in court, by my questioning, she (jsh) never discussed such a radical move with Mother because she said she did not think it was that important.

For most of the 3 years Mother was owned by the guardians, I was pro se and spent about \$100,000 in lawyer fees and other costs to get Mother back home from the pig pen nursing home she was being kept in solitary confinement, in a locked in section, in a sensory deprived environment, no phone, no visitors allowed, not allowed to go into society or go back home to see her loved possessions of almost 100 years. Mother died on July 2 2024 at 99. The guardianship mafia killed my Mother by morphine. Mother died a very slow, extremely painful, barbaric and inhumane death by starvation and dehydration.

In may 2022, fenstermacher became the latest guardian of estate to Mother. He admitted in court in early 2023 he had not seen or talked to Mother for 4 years. But he was a lawyer and he was obligated by federal, state laws and rules for the AIP (alledged incapacitated person) and the PA Rules of Conduct for lawyers to do what his client wanted and to always keep his client informed of what was going on in her guardianship. He never did. He also admitted, by my questioning, that he thought his only job was to sign the checks of the mafia. I asked him what about waste and fraud by them and he replied maybe he should look into that. He never did. He gave away and wasted hundreds of thousands of dollars of Mother's money. He admitted he refused to read my emails to him about the waste of Mother's money in various ways and how mother could be much happier at her home and saving massive amounts of money because he said they were rants and rantings.

He also refused to carryout my Mother's wishes that she wanted me to live in her home, as I had been for 2 years, whether she was there or not and also continue to get my/jsh gift money Mother had given both of us for 8 years. Fenstermacher hated me because Mother fired him and was punishing me by allowing Mother to live in a low rated nursing home with people with mental and behavior problems. Mother was NEVER accused of having those problems.
