

JASKOWIAK EMAILS

1. I ask jaskowiak (jasko) since the quack psychologist ledakis said in his report Mother had no problems with daily activities and since I had been living there for 2 years everything was fine, why has he not demanded Mother go back home to live instead of the pig pen she has been forced to live in a locked down section, in solitary confinement, in a tint room.
2. I asked him again #1 a few days later and he said he would tell me at my contempt of court trial he filed against me for exposing the guardianship mafia (mafia) scam on Mother. He never did to this day.
3. I ask him who told logie (first guardian of person and estate to Mother) and my sister jsh to kidnap Mother from her home on august 25 2021. He has never answered the question.
4. Me explaining to jasko about the scam that was done on Mother using ledakis and his made up "evaluation".
5. I ask jasko did he have Mother kidnapped on his own or with other people.
6. Asking more questions that he refuses t answer.
7. I ask him does he plan to keep Mother in that pig pen until she dies. Why would he think she would want to live there instead of her huge home that jasko was in.
8. I referred to PA title 20, S 5521
9. Title 20, S 5521
10. Mother used to write me notes of affection and leave them on the steps to my room sometimes. I am telling jasko that I want to show them in court to show my Mother wants to be with me instead of her pig pen the mafia is keeping her as a prisone.
11. Jasko never answers my questions. He and the mafia only care about Mother's bank account, not her as a human being.
12. Jasko doing his usual shister game of not answering questions, but avoiding them with non answers.
13. I review many of the problems Mother is affected by, but the mafia never has fixed.
14. No answer from jasko to my questions.
15. Order for a hearing for visitation. Nobody of the mafia ever wanted to have a hearing to prove why I could only have extremely restricted visits and now paid liars (monitors) with my Mother. In US law, a person is innocent until proven guilty in a court of law. When I filed a petition in September 2023 for the mafia to prove their accusations against me or shut up, all of the shisters demanded corrupt judge sterling deny my petition and she did.
16. I wanted to know who and why the hearing for more restrictive visits was demanded instead of asking my Mother what she wanted.
17. I wanted to know if my Mother was going to finally be there to speak for herself at the hearing for visitation. She was not allowed.
18. I ask jasko again since he was in Mother's massive house in a gated community, why would he want her to live in her tiny pig pen and away from her loved possessions.
19. I ask him did he know about how my sister, jsh, tormented mother while mother was being held hostage in jsh's home after mother was kidnapped by jsh and logie and forced Mother to be in the hospital for 6 weeks for starvation. He never answered.
20. He never responded to my questions.
21. Still no answer from him.
22. I sent this to all the shisters. The Olmstead Act is a federal act that says, among many things, that a AIP (aleedged incapacitated person) cannot be warehoused in a institution but must be given as much

freedom as possible. Ledakis said mother had no problems with daily activities, so why did the mafia keep her locked in solitary confinement and not allowed to go outside or visit her home.

23. I point out to jasko the many problems pertaining to Mother that the mafia does not care about. I ask him how is Mother better off now with him as her so-called lawyer than before he was hired. He never answered.
24. Me telling the sisters what punishment Mother has had to put up with under their ownership. No answers from them.
25. I want to know why deb klock, a person well known for stealing and over drugging her victims, was ever hired as a "care manager" and Mother had to pay also when there was a guardian of person. I never met or talked to klock.
26. I saw a lawyer video about guardianship that jasko, another guardianship lawyer and a college law professor (pearson) was on a panel discussing the topic in October 2019. I tried telling her about jasko, but she was extremely rude and hung up on me. She did not want to hear about her "friend".
27. My reply to pearson hanging up on me.
28. Me telling jasko again many problems Mother is having but the mafia is not doing anything to fix them and help her in her locked down pig pen.
29. Ellis, the guardian of person who is friends of jaskowiak but never a guardian of person and never certified to be one, was mad because I used her private email. But, it was on her biography that she sent to me after she was hired.
30. Jasko tells me how he thinks I should write emails. Bullshit! He should be helping my Mother be fighting to make mother happy and healthy instead of ignoring her problems that I keep pointing out to him and the mafia.
31. Jasko does not want a change in the guardian of estate (fenstermacher) because fenstermacher is in the pockets of the mafia sealing Mother's money.
32. I ask jasko since he seems to always respond for ellis and her with him at hearings, is he her lawyer. No response from him.
33. Jasko responding to me wanting him removed as Mother's lawyer. He never protected her and never defended her from harm.
34. Jasko refuses to answer #32.
35. Because I have been exposing the scam on Mother and contacting the various mafia involved demanding they do their jobs and correct problems affecting Mother, jasko wanted to have a court order demanding I cannot contact any of those people involved in this scam involved with Mother. Does jasko know anything about constitution law and freedom of speech?
36. At the hearing #35, I was denied to make a closing argument by judge sterling to prove my points. The mafia wants to keep their corruption in the closet.
37. In June 2023, judge wilheimer got the county IT person, Olivieri, to block my email to all county type agencies I was using to help my Mother as a punishment to me for exposing the mafia. Bookler is sterling's lawyer assistant. She is trying to tell me that I have to give olivieri all of the emails I sent to various people to have them unblocked. BSI. I told her whatever he did to block them, he can unblock them. To this day, my emails to those people are still blocked. Weilheimer has NO legal power to do what she did.
38. Jasko, ellis, mafia refused to let me call my Mother on Easter. First amendment right: freedom of religion.
39. I ask jasko again, since he never answered the same question I asked him several times before, how is my Mother better off with him now than before he was hired in her life.
40. I ask him how he liked my news letter about the guardianship mafia he was in that I passed out to all of his neighbors on his street on April 10 2024.

41. Because of jasko being a common crook and he was on the October 19 2019 guardianship video panel put out by PBI, I contacted them to tell them about jasko/mafia corruption and to ban him from being on any more panels. They refused to keep him off of any panels.
42. I ask jasko again #39. No answer from him.
43. I tell him again about helping Mother and all of the problems she is having that he/mafia refuses to correct.
44. I ask jasko again who ordered the kidnapping of Mother by jsh/logie on august 25 2021. He never answers.
45. The day I was arrested for protesting on a public sidewalk in front of jasko's house, a PA state cop, Harmon, was part of making up false claims about me along with jaskowiak and the local cop komatick. I filed a complaint with the PA state police internal affairs, but they refused to do anything.

Scroll all the way down. Now I remember. That was the hearing that you still never answered my question about why mother shouldn't go back home to live, instead of the pig

(a) **Duty of guardian of the person.**--It shall be the duty of the guardian of the person to assert the rights and best interests of the incapacitated person. Expressed wishes and preferences of the incapacitated person shall be respected to the greatest possible extent. Where appropriate, the guardian shall assure and participate in the development of a plan of supportive services to meet the person's needs which explains how services will be obtained. The guardian shall also encourage the incapacitated person to participate to the maximum extent of his abilities in all decisions which affect him, to act on his own behalf whenever he is able to do so and to develop or regain, to the maximum extent possible, his capacity to manage his personal affairs.

IN RE JANE HERRING: "notes"

Mr. Herring,

You continue to address issues which, in my judgment, have already been addressed in multiple proceedings before the Court. I do not intend to constantly re-litigate issues which have been decided. To do so would only unnecessarily dissipate your mother's estate. Accordingly, I will only respond to your inquiry by stating that any evidence which you seek to introduce must be in strict compliance with the Pennsylvania Rules of Evidence. To the extent that you seek to introduce evidence which you have not previously sought to introduce, I will state my position at the appropriate time and according to the context in which that evidence is being offered.

I would add one further note. I believe that the way in which you continue to address the parties and the Court demonstrates incivility and disrespect. I would ask that you *not* address people simply by their last names in your correspondence and emails. That includes the Court. "Mr.," "Ms.," "Judge" (or "your Honor" if directly addressing the Court") is what is required. I respectfully submit that those are the rules of a civil society, no matter whether we agree on the underlying issues or not.

Respect and disrespect work both ways. After two months of weilheimer also directing Olivieri to block me from having access and use my court docket for an ongoing court matter, weilheimer still is illegally denying me the use of my court docket on the same ongoing legal matter involving the health, welfare and happiness of my 98 year old Mother.

Which of you lawyers and guardians think you should have respect after what you have done and still doing to a 98 year old woman just to steal her money and her house? Read the Pennsylvania law attached of who is really in charge of guardians and guardianships. Do your wives and children know how you are stealing money off of my Mother and other victims like her by using fake guardianships, based on fake "evaluations", by paid off psychologists, (in this case George Ledakis) who never audio or video record their "evaluations" to prove their "evaluations" were ever done, let alone being in any way

accurate? Those same, paid off psychologists (also called "whores of the court" by lawyers) also cannot prove their "reports" pertain only to that person and not 100's of other people by using cut and paste? Those fake "evaluations" are used only to declare victims "incapacitated" just to steal their money and home. As you recall Jaskowaik, I exposed Ledakis's "evaluation" in court as being basically worthless. How come none of you lawyers and guardians ever did what YOUR hand picked "expert" Ledakis said, that Mother had no problems living at home and since I had been there for over a year, everything was fine? Instead, Mother was kidnapped by my sister and Logie, spent two weeks of hell in my sister's house, denied to leave, put on anti-depressants, starved, sister refused Mother to see and talk to me, Weilheimer threatens me with contempt of court for calling for a wellness check, after 2 weeks of torture Mother had to be taken to a hospital, unconscious, by ambulance, spent 6 weeks confined to bed and treated for starvation, daily blood tests (42 times), daily needles in the stomach to prevent blood clots (42 times), got covid where Mother could have died, dumped into that current pig pen, at \$90,000 a year, for a very tiny room, in solitary confinement, in a sensory deprived environment and not allowed to go home to be happy and do what she was doing in freedom? 



Why have you refused to respond to my emails about Mother and her welfare?
