

## JASKOWIAK IGNORES MOTHER

David Jaskowiak is part of a guardianship mafia, along with corrupt judges, corrupt guardians, their lawyers, corrupt psychologists and others in Norristown PA. There are probably thousands of these type of mafia's nationwide and worldwide who take ownership of usually elderly people because they have vast assets and a house. Those people work together to falsely declare a person is "incapacitated" and must have guardians of persons and estate. They create massive billing hours by hiring various people and bill the "client" (victim). Anyone who gets in their way by trying to help the loved one or complains about lack of care to the loved, will be attacked in various ways. Their main weapon is called "demonizing". That means the mafia will make up lies about the concerned person and will punish the person by restricting/denying visits with the victim. Jaskowiak was assigned to Mother by the corrupt judge weilheimer of the orphans court in Norristown, who deals with guardianship cases. Weilheimer assigned Jaskowiak only 2 days after Mother's daughter, Jsh, filed her petition for guardianship of person and estate of Mother. Jsh admitted in court, by my questions, she never discussed this major change to Mother because Jsh said she did not think it was that important. WTF? The law says the AIP (alleged incapacitated person) has federal and state rights, plus many rules and rights the AIP has in their guardianship. In October 2019, Jaskowiak was on a panel with 2 other experts of guardianship laws. Jaskowika knows Mother had the right to choose her own lawyer. But, if she and I knew that, the mafia would not be able to own Mother and her assets. In addition, Jaskowiak knew Jsh's petition did not contain one example where Mother needed any guardian. His job was to protect and defend Mother from being guardianized. Jsh's lawyer, camp, knew guardianship laws. The judge weilheimer, camp, and Jaskowiak all knew Pennsylvania law demands ALL options be considered BEFORE guardianship. NONE of them cared because they were the ones who were going to make the massive money from Mother's house and money. Jaskowiak and the rest saw Mother only as their private ATM machine, not a human being who had a extremely happy and carefree life living in her huge home of 21 years, with her loved possessions of almost 100 years, in a gated community. Jaskowiak saw Mother 4 times in her 3 bedroom, 3 bath house. He knew how happy she was.

Instead, he only saw her 2 times, in 3 years, in her low rated nursing home and saw her tiny pig pen. Mother had to live in a locked in section, with people with mental and behavior problems, in solitary confinement, in a sensory deprived environment, no phone, no visitors, no useable TV, torn blankets, stained sheets and forced to wear other people's clothes. But, Jaskowiak had the balls to say on a zoom call after Mother was there for a year that she was happy, like the people and her room. What crap! Would Jaskowiak put his 96 year old Mother there as Mother was when she was kidnapped from her house by Jsh on August 25 2021 to begin her 3 years of hell? He probably would if she had money.

Jaskowiak and the mafia made up lies about me and used them to restrict and deny visits with Mother. For 2 years, the mafia refused to want to prove those lies in court. In September 2023, I filed a petition for them to do so, but Jaskowiak and the other shisters demanded the latest judge Sterling to deny my petition because they could NOT prove anything in court. Mother and I had a extremely close and loving relationship. She never refused my few visits I was allowed to have with Mother in 3 years. To further punish me, they claimed I was upsetting Mother during my visits and hired 2 different friends of their to be "monitors" with Mother and I during the visits that Mother or I had to pay for. Jaskowiak and the mafia REFUSED to use a simple cell phone that would be free and would prove I never did anything to make Mother upset.

From August 25 2021 to when Mother died on July 2 2024, based on 16 hour days (8 hours for sleeping), out of a possible 24,700 hours mother and I could have been together, Jaskowiak and the mafia only allowed us 224 hours. Is that a guardianship or just a scam for money?

Mother was killed by the mafia with morphine on July 2 2024. She died alone, an extremely slow and painful, barbaric and inhumane death by starvation and dehydration. The mafia never gave her hospice and any last wishes, which she would have wanted to go home and me be there with her. Such animals.

## kidnapping of Mother

None of you have responded since I sent this before. I wonder why?
