JSH EMAILS AND DOCUMENTS

As with the other emails and documents on this news site proving the barbaric and inhumane "guardianship" of my Mother was only a money grabbing scam by vultures, the following emails and documents pertain to jsh and her involvement in the scam. Jsh was the daughter of my now reborn Mother, Jane Herring. Jsh is also my former sister. These documents and emails, as with the others on this news site, prove the "guardianship" (ownership) of Mother was only a scam from Day 1 and never had anything to do with Mother's health, welfare and happiness. Those people involved in the scam I called the guardianship mafia, the same type of criminal enterprises of any organized gang of criminals. Those in this mafia included corrupt judges (weilheimer, sterling), corrupt guardians (logie, blumer, ellis), their corrupt lawyers (camp, bill blumer, gelsinger, zabowski, others), Mother's corrupt lawyer jaskowiak (assigned by weilheimer), corrupt "care manager" klock (known for stealing and over drugging her victims) and Judas: jsh. Those people were also in charge of other people's loved ones and their tactics, lack of treatment and human decency to their other victims, including the draining of their assets, can only be compared to the worst criminals in prisons today.

The emails and documents may not be in the correct date listing.

- 1. Jsh's lawyer camp, never filed the proper petition for guardianship according to federal and state laws, including the PA Rules of Conduct for lawyers and various rules pertaining to guardianship. Weilheimer did not care and jaskowiak did not care. The fix was in at all levels to declare Mother "incapacitated", make her a prisoner of their's and own her, dump her off to any nursing home, sell her house for more money for the mafia and drain her assets until she dies. Throughout this scam, I tried many, many times with all involved, to get Mother back home to where she lived for 21 years and her happy life. NOBODY cared about Mother, especially jsh.
- 2. Why was Mother kidnapped by logie (first guardian of person and estate, friend of jaskowiak and others involved) to start with? To this day, the mafia refuses to answer that question. As logic said in his invoice: it was part of "the plan".
- 3. Many times I would bring mother flowers, presents and things to read. In the beginning, weilheimer had a "visit schedule" of only 1 hour, 3x a week. NO reason given for a schedule, instead of normal anytime visits. The fact was visit restrictions (later visit denials) was a punishment to me for exposing the mafia and its purpose of stealing from the elderly. On my next visit with Mother, I would find the things I gave Mother missing and it was jsh who took them. I told camp to tell jsh to stop stealing, but jsh never stopped.
- 4. Jsh refused to let her Mother go back home to live, no reason given. Especially, since the mafia's hand picked "whore", ledakis, said Mother could live at home and with me there everything was fine in his first report before the petition hearing. Judges and lawyers call psychiatrists and psychologists the "whores of the court" because they will say what they are paid to say. After I exposed ledakis and his "evaluation" of Mother as a fraud, after that he always accused me of harming Mother to restrict/deny my visits with her. A common tactic in guardianships called "demonizing" the loved ones of the victims.

- 6. How could jsh, who claimed she loved her Mother, deny Mother anything, even a phone to call me and Mother's friends at Mother's elder age of 96? For 3 years, Mother was kept in a locked in section, in solitary confinement, in a sensory deprived environment. Mother was never accused of having any mental or behavior problems.

- 7. Many times I tried to get better guardians, but was always blocked by the mafia. Camp blamed me for the high and constant lawyer fees, but only I kept finding problems that they never saw or cared about and I was fighting them to get them fixed. The lawyers for the guardians were part of the guardians business and Mother had no obligation to pay them at all.
- 8. The mafia was constantly accusing me of doing things as if they were fact. The basis of US law is a person is innocent until proven guilty in a court of law. But, the mafia and corrupt judges NEVER wanted to do so because they had no evidence and NEVER wanted to ask Mother if their accusations were true. Why? Vic Meitner was my lawyer from January 2022 to December 2022. After that I was pro se.
- After my father died in 2013, jsh contacted every one My Mother dealt with in business and her doctors and convinced them Mother should be put away. Jsh sent emails to Dr. Kuhar (Mother's primary doctor of 21 years) saying so. Kuhar learned it was jsh who was mentally disturbed. Jsh is a classic case of being a narcicist.
- 10. Email to jsh from me. I wanted evidence to prove jsh hated her Mother and was part of the mafia to steal Mother's assets until Mother died.
- 11. Jsh's reply to me showing how much she hated me and always had in her life. Who was the one trying to help Mother get back home and who was the one who filed her petition to own Mother and admitted in court during the 2 day petition hearing that she never talked to Mother before jsh filed her petition because jsh did not think it was that important to do so. WTF?
- 12. My email to camp reminding her of the extreme high cost of Mother's cage (\$90,000 a year) compared to living at home for only \$16,500 a year.
- 13. My email to Meitner telling him how I have reached out to jsh to help Mother, but jsh wants to keep mother in the cage.
- 14. Email to camp pointing out various facts.
- 15. Email to camp asking who gave the order to kidnap mother from her house on august 25 2021? Everybody in the mafia has refused to answer that question. No surprise.
- 16. Email I sent to the 2 bosses of camp making sure they knew their lawyer was part of a scam. They never replied.
- 17. Email to camp reminding her how much money Mother was losing because of jsh. Camp did not care about Mother, only building billing hours for her bank account.
- 18. To save his friend, jsh, money, guardian of estate fenstermacher would contact jsh directly so she would not have to pay lawyer fees. Fenstermacher had helped jsh many times before the guardianship to try to help jsh to steal money from Mother. I always blocked them.
- 19. Again I asked camp who ordered the kidnapping of Mother by jsh and logie from Mother's home on august 25 2021. No reply from camp.
- 20. Camp giving a no reply lawyer BS as her "answer" to #19.
- 21. In mid 2023, I stopped at fenstermachers office to talk with him. His office is down the hall from camp's law firm. The office manager of the law firm with camp made up a story I was in their office. A total lie. But the police and the building manager never asked me my side of the story. More demonizing of me because I was a threat to the mafia.

- 23. See #21. I made sure camp's law firm partners knew about the lies on me and the scam camp was involved in on my Mother
- 24. See # 21. Guilty without a trial.
- 25. Another reminder to camp about the money jsh and the mafia is wasting on their scam on Mother.
- 26. Email I sent to camp's office manager about the lie of me being in their office.

- 27. Email to camp reminding her of the waste of money by the mafia to Mother who may need it later on for medical needs.
- 28. Email to camp about jsh's actions on Mother.
- 29. Email to camp about the barbaric treatment and conditions jsh has forced on Mother.
- 30. Email from camp using traditional lawyer BS of not answering a question
- 31. My reply to camp. See #30
- 32. Camp said jsh thinks I should pay for all of the lawyer fees instead of Mother. I tell camp it was jsh who filed the petition to own Mother and her assets.
- 33. Email to camp asking again why doesn't jsh want Mother to have a nicer place to live and save money
- 34. Email to camp telling her guardian blumer said there were 41 cases of covid at mother's cage. Stats say about 39% of people that die from covid die in nursing homes. Because of jsh starving Mother in jsh's home after the kidnapping and putting Mother into the hospital confined to bed for 6 weeks and treated for starvation, Mother got covid in the hospital and again at the cage. Jsh did not care how much pain and suffering mother went through
- 35. Email to camp about jsh's claim she thought Mother's assets were undervalued. I know they were being stolen by the mafia. When was jsh going to wise up she was being used by the mafia?
- 36. Email to jsh reaching out to her agan to try to stop the waste of Mother's money.
- 37. I emailed jsh again because she never replied to #36.
- 38. Cease and decist letter to camp and sent to all of the other lawyers for constantly lying about me.
- 39. Email to camp about current situation with the mafia draining money for "monitors" who must be with Mother and I during visits and paid by Mother and/or me that is costing Mother money.
- 40. Jsh sent these two birthday cards to Mother as if nothing was going to happen. Jsh filed her petition 2 days after Mother's 96th birthday, but never called her on her birthday. Jsh admitted in court she never discussed what she was going to do to Mother because jsh did not think it was that important. Evil and barbaric.
- 41. About one year before my father died in 2013, jsh kept bitching to my parents that she needed money, even though she had a full time job as a medical coder out of her home. They loaned her \$100,000 at a extremely low rate of about 1%.
- 42. About one year after my father died, jsh bitched again to my Mother saying she did not have the money to pay back all of the loan, so Mother sent her trust lawyer and also her guardian of estate in May 2022 fenstermacher, a note forgiving \$25,000 of that massive loan my parents gave my sister. To this day, the \$75,000 has not been paid back.
- 43. The letter, by my former lawyer, demanding discovery of various items from my sister because she wanted to be guardian of estate to Mother. Jsh refused to do so and dropped out to be guardian of person and estate. I wanted to be guardian of person and so did Mother, but weilheimer claimed I was unfit to be a guardian to Mother. The mafia did not want me to have any power.
- 44. Several years before jsh filed her petition, she demanded to do Mother's taxes. Mother wanted to use my CPA. Mother wanted mine instead of the one she and my father had used for about 20 years, breon, because breon kept raising his prices. I stopped using breon also years earlier. My siste was not filing Mother's taxes and not picking up tax documents at Mother's house. I discovered jsh wa not doing her taxes, but giving them to breon to do as he had been doing. Jsh had been lying to Mother.
- 45. The day after Mother's 96th birthday, I sent jsh another email telling her Mother's taxes were due and last year jsh was overdue paying them. Jsh refused to answer my emails so I had to tell Mother taxes were not paid which upset Mother. At one point before the petition hearing, I had to give tax documents to jaskowiak to give to jsh.

- 46. A year before jsh filed her petition, she went to the police department and filed a report claiming I kicked her in the back at my Mother's house, which never happened. She never told me or Mother that she ever went to the police. But, at the petition hearing, jsh claimed I tried to push her down the stairs at Mother's house. What a liar only to get sympathy from others.
- 47. Jsh would not return Mother's calls pertaining to different matters. It upset Mother that she did not know what jsh was going to do. This included Mother going to the doctor. But, when jsh did go there and I was there also, jsh would always insult and degrade Mother in front of her doctor to the point that sometimes Mother would cry. I had to tell jsh to shut up. Jsh would also condemn the doctor for being late for the appointment because she had other patients. Sometimes jsh would leave before the doctor arrived because jsh thought she had better things to do.
- 48. Jsh "bragging" she had everything under control with Mother's taxes, but jsh just lies to avoid admitting the truth about her failures in matters. Jsh claimed she had all of those "friends" of Mother's business people, when she had only been telling them lies for years to make herself look like she knew everything to them and had been lying to them about Mother's mental health.
- 49. Jsh seemed to get pleasure out of causing other people problems. She was acting like a child throwing temper tantrums if people did not kiss her ass and tell her how great she was, as jsh thought she was in her own mind.
- 50. More proof she had fenstermacher wrapped around her little finger for years after my father died. When he was Mother's guardian of estate for 2 years, fenstermacher was always doing favors for her, but not for me because I had and was exposing him as a crook. Even after Mother was reborn, fenstermacher is refusing to carry out his duties as Executor and my Trust lawyer for me to punish me. During his time as a guardian, I filed a complaint against him with the lawyer disiplinary board to have him disbarred because of his corruption.
- 51. My email to jsh telling her how she has hurt Mother and insults Mother.
- 52. Jsh's mentally unstable remarks to me and denying what she does to Mother
- 53. After my father had a nervous breakdown about 2 months before he was killed by morphine, jsh wrote a letter to the chief of police praising him and the other cop who got my father into an ambulance. Jsh would later use that connection with the chief to have him put 2 cops at the house to hold me while jsh and logie kidnapped Mother.
- 54. This shows how much jsh, with fenstermacher's help, wanted to own mother and her assets. She and fenstermacher made up this "Delegate Authority" that jsh and I were to sign. I would be in charge of Mothers house and car repairs and her medical needs, BUT jsh would have total control of all of Mother's financial assets to use any way she wanted. Jsh had been trying for years to get me to put mother into a nursing home and sell her house and junk her much loved possessions of 96 years. Jsh never discussed her plan with Mother AND neither did fenstermacher. I refused to go along with this scam which was about 1 year before jsh filed her petition for guardianship.
- 55. Email jsh sent me telling me, after she and logie kidnapped Mother, that Mother was going to be kept at jsh (like a bird in a cage) and if I went to jsh's house to see Mother, jsh would have me arrested. Who the hell did jsh think she was to kidnap Mother and deny Mother and me to see each other and talk on the phone. While I was being held on Mother's porch by the 2 cops, I heard mother crying and yelling she did not want to go with jsh. After Mother got to jsh's house, she was drugged to keep her quiet. Mother could not call me because jsh only had a cell phone that jsh kept away from Mother. That night, I called the PA state police to do a wellness check. The cop claimed Mother was fine when he only saw her through a window. The next night, I called the police again for another wellness check, but they refused to do so. Mother was 96. She could have had a heart attack from this kidnapping. Two days later, weilheimer

threatened me with prison if I called for any more wellness checks. There was never any court orders for Mother to be kidnapped and NOBODY has admitted who ordered it. Why didn't Mother's court appointed lawyer, jaskowiak, stop it and order Mother back home. His job was to protect and defend mother in this guardianship. Jaskowiak proved he was in the mafia for his financial benefit, not for Mother.

- 56. After about 10 days after being kidnapped, logie sent me a email claiming Mother passed out because it was a hot day and had to be taken to the hospital for dehydration. Treatment for dehydration is only over night. I found out Mother was being treated for starvation and confined to bed for 6 weeks. She had to have daily blood tests 42 times. Her arms were black and blue from them. She also had to have daily needles in her stomach (42 times) to prevent blood clots. At week 5, Mother got covid where she could have died. This document proves in early September 2021, there were NO hot days. Jsh refused to let Mother have the every day foods mother liked so jsh was starving Mother and did not care.
- 57. In June of 2023, camp filed a reply saying jsh thought I should have monitors every time I visited Mother and either Mother or I had to pay for it. Never did anyone in the mafia ever filed a petition to prove their claim that I upset Mother when I visited Mother. Again, the mafia hired their quack ledakis to claim I should be watched. In the US, a person is innocent until proven guilty in a court of law. The mafia thought their accusations were good enough for guilt.
- 58. Another email sent by me the day after Mother's 96th birthday telling jsh Mother's taxes were due. Jsh did not care as she knew in a few days jsh's petition would be filed and sent to Mother and me. Jsh's plan to own mother was going to start.
- 59. About 5 years before she filed her petition, jsh was trying to get me to junk all of the possesions of Mother's in the basement. She never asked Mother if Mother wanted anything she owned of 95 years to be thrown out. I refused to do what jsh wanted. I also say how much I was going to help Mother to mke her happy after father had died in 2013.
- 60. Jsh's email to me telling me everything Mother eats is bad for her. Mother was about 91 at that time and was perfectly healthy. Again, jsh never talked to Mother about her diet and Mother's dotor of then 15 years had no problems with Mother's health.
- 61. About 2 years before she filed her petition, jsh threatened to sue me claiming I was hiding Mother's checkbook and using it for myself, which was a total lie.
- 62. Jsh was trying many times to get people on her side for what she had been planning for Mother. I refused to be one of those people who would be cheating Mother and making her do what she did not want to do" sell her house and go into a nursing home.
- 63. After my Mother died, I remembered Mother told me many times when she was in my sister's car, jsh would give Mother documents and demand Mother sign them. But, jsh refused to give Mother copies of them. I kept telling Mother not to sign anything until I looked at them. Fenstermacher claimed he did not know anything about those documents.

I am familiar with Carol Hershey and Guardian Services of PA. In fact, in the very beginning of this matter when the petition was filed, I contacted a number of agencies, including Guardian Services of PA, and they would not agree to serve due to your client's behavior and historical conduct. I'll note that this was before your client created his website so it is very surprising to me that they would now be willing to serve.

I will confer with my client about Guardian Services of PA, but I would want to speak with Carol or her partner, Sue Brown, as they are the decision-makers over at Guardian Services, and I am not sure how they are currently staffing and handling their guardianship matters.

With respect to the guardian and legal fees, I agree that they are higher than usual, but that is exclusively related to your client's enormously problematic behavior throughout this process, which required an inordinate amount of additional time to be spent to protect Jane's interests, both financially and personally. I know you were not involved in the prior proceedings, but it is worth noting that your client was reminded several times (by the Judge, his prior counsel, etc.) regarding how is actions and various decisions along the way have caused additional expense to be incurred by all those involved and how that ultimately impacted his mother's estate. To the extent your client wishes for another level of care assessment to be performed by the new guardian of the person, he will simply be duplicating fees so that is something to bear in mind.

Your client's continued refusal to vacate the home, where he has been living rent free for a significant period of time, only increases the expenses incurred by Mrs. Herring and prevents that non-income producing asset from being sold and invested for Mrs. Herring's benefit. If your client is truly worried about his mother's financial situation and dissipation of her estate, he should be paying back rent and/or vacate the home. I encourage you to speak with your client about this so we can avoid to avoid further court involvement on this particular issue.

All that being said, we also would very much like to avoid a trial or hearing on the outstanding issues. If you think a joint call with David Jaskowiak would be helpful to get all counsel on the same page, to the extent that is possible, I would be happy to arrange a call.

Let me know and I will report back on the Carol Hershey proposal once I have had a chance to speak with my client.

The fact you and Fenstermacher made up that delegate authority agreement several years ago in hope of taking control of mother's money, house and other assets without even discussing it with her was nothing less than attempted theft by deception. How could you even think of doing something as drastic like that without you even thinking mother

should decide what she wanted? As you recall, I refused to go along with you and Fenstermacher's scam. I also have no doubt that if you had ever got such an agreement, you would have also enjoyed having me evicted, despite mother's wishes of me living at her house, along with her, until her death. I have a letter from mother several years ago that said I could. I also have no doubt you wanted to carry out that type of plan, after Dad died, which was to sell the house, junk mother's loved possessions and put her into a nursing home until she died and then wait for the big "check". Then, add to that the ongoing scam that has been documented for decades of guardianship corruption in the orphans court on seniors with memory issues involving corrupt judges, corrupt lawyers, corrupt psychologists and corrupt guardians. When this guardianship corruption began on my mother, I created a massive news website called www.protectmyparents.us. 

EMERGENCY PETITION FOR LEAVE TO ENGAGE IN DISCOVERY PURSUANT TO PENN. MONT. O.C. LOCAL RULE 7.1A(c)

AND NOW comes Petitioner, Arthur Herring, III, by and through his attorneys, Carol L. Cornelison, Esquire and Sattin, Ronca & Cornelison, LLC, and files this Emergency Petition to Engage in Discovery and in support thereof avers as follows:

- 1. Petitioner is Arthur Herring, III, the son of the alleged incapacitated person, Jane Herring.
- 2. Respondents are Jill Scott Herring ("Sister") and Jane T. Herring ("Mother").
- 3. On May 18, 2021, a Petition for Adjudication of Incapacity and for the Appointment of a Permanent Plenary Guardian of the Person and Estate Pursuant to 20 PA. C.S. §5511 regarding Jane T. Herring was filed. Petitioner was Jill Scott Herring who is the daughter of the alleged incapacitated person and the sister of Arthur Herring, III ("Brother").
- 4. A hearing is scheduled on the Guardianship Petition for July 12, 2021, before the Honorable Gail Weilheimer.
- 5. Sister's guardianship petition requested that she be appointed the plenary guardian of both the Person and the Estate of the parties' Mother.
- 6. The Guardianship Petition contained allegations regarding Sister's historical employment experience, education, and current employment status in support of her qualification to serve as Plenary Guardian.

- 7. No substantive documents were included in the Guardianship Petition to substantiate Sister's assertions regarding her fitness to serve based upon her employment. Sister's financial status is relevant to her qualification to serve as guardian.
- 8. The Guardianship Petition failed to include an acknowledgment that Sister borrowed \$100,000 from Mother to purchase a home when she averred that she has no interest adverse to Mother.
- 9. No documents were provided to establish that Sister has made repayments to Mother for this loan which may constitute a potential adverse interest to Mother.
- 10. The Guardianship Petition included an overwhelming number of averments attacking Brother in every way possible but failed to include actual support for Sister's assertions regarding her motives and interest in serving as plenary guardian.
- 11. This is a complex matter with competing interests between family members which requires full discovery of Sister's financial status, Sister's communications with Mother's medical providers, and Mother's financial institutions via a Request for Production of Documents.
- 12. The undersigned has spoken with counsel for Sister and Mother who did not agree to engage in discovery which necessitated the filing of this Petition.
- 13. A copy of Petitioner's proposed Request for Production of Documents will be provided at the time of any hearing on the instant Petition.

WHEREFORE, Petitioner, Arthur Herring, III, respectfully requests that this Honorable Court issue an Order authorizing the parties to engage in discovery in this matter prior to hearing on the Petition for Adjudication of Incapacity and for the Appointment of a Permanent Plenary Guardian of the Person and the Estate of Jane Herring.

JOINT DELEGATION AGREEMENT FOR THE BENEFIT OF JANE T. HERRING

We, Arthur Herring, III and Jill S. Herring, agree to be joint delegates for the benefit of our mother, Jane T. Herring. In furtherance of this agreement and to properly implement and facilitate its intended purpose, we agree that Arthur Herring, III shall be the delegate as to the person of our mother, Jane T. Herring and that Jill S. Herring shall be the delegate as to the estate of our mother, Jane T. Herring. Each delegate shall perform acts under his/her designated responsibility (i.e. person or estate) without interference from the other and where necessary, with the oversight and agreement of Jane's attorney, Ronald Fenstermacher.

As the parties hereto agree that this joint delegation agreement shall not replace the existing power of attorney, it is intended that this document delegate the responsibility of personal needs and daily healthcare of Jane T. Herring to Arthur Herring, III and the responsibility for all financial transactions of every kind pertaining to or involving Jane T. Herring to Jill S. Herring.

Arthur Herring, III has the authorization to do the following for the benefit of his mother,

Jane:

- To have access to all medical records and information as well as the authority to disclose the information to others;
- To attend to her daily needs and care including but not limited to employment and discharge of healthcare professionals, consent and/or

- refusal of treatment and provision of appropriate releases for such consent or refusal;
- To authorize her admission to a medical, nursing, residential or similar facility and to enter into agreements for her care as may be required for provision of care by third parties.
- To authorize medical and surgical procedures.

Jill S. Herring, III has the authorization to do the following for the benefit of her mother, Jane:

- To pay bills and other financial obligations and to collect moneys owed to
 Jane and to engage in any related postal, banking and financial
 iransacrions of any nature to facilitate timely attention to same.
- 2. To invest, reinvest, deposit, withdraw and/or receive the income or corpus of a trust, annuity or other fund available for my benefit and to engage in stock, bond and other securities transactions including but not limited to sales, purchases and transfers.
- To manage, lease, sell or transfer any real estate or interest therein belonging to Jane, and to purchase or lease real estate for Jane's benefit.
- To borrow money, enter safe deposit boxes and engage in insurance and retirement plan transactions.
- To appear for Jane to handle interests in estates and trusts, as well as the commencement, prosecution, defense or compromise of any claim.
- 10. To receive government benefits and pursue tax matters.

- To make gifts in keeping with past practices/routine of Jane T. Herring such gifts not to exceed applicable annual gift tax exclusions.
- To exercise fiduciary powers that Jane T. Herring has authority to delegate.

In accordance with this Court's Order dated June 27, 2023 and upon review of the June 21, 2023 Report prepared by Dr. George Ledakis (the "2023 Report"), Brittany J. Camp, Esquire, counsel for Jill Scott Herring ("Jill"), daughter of Jane T. Herring ("Jane"), an Incapacitated Person, respectfully provides an opinion, on behalf of Jill, with respect to future visits between Jane and her son, Arthur Herring, III ("Arthur").

Jill strongly believes that it is in Jane's best interests that any and all future visits between Arthur and Jane, to the extent permitted by this Court, continue to be supervised and monitored and that during any such visits, Arthur continue to be prohibited from discussing topics with Jane, whether orally or in writing, which are or may be harmful or detrimental to Jane emotionally or cognitively, as determined by the Court, Jane's court-appointed counsel, the Guardian of Jane's Person, and/or Dr. Ledakis. Notwithstanding the foregoing, in light of Arthur's prior violation of various Orders issued by this Court, Jill believes that Arthur should be prohibited from visiting with Jane in the event Arthur's actions cause him to be in further violation of any existing or future Orders issued by this Court.

Additionally, Jill believes that Arthur should be personally responsible for any and all costs incurred in connection with his visits with Jane, including but not limited to the cost of

supervision and related reporting to this Court, as well as any fees incurred by the parties or their counsel due to Arthur's violation of any Orders of this Court related to the parameters of his visits with Jane, and that such additional expenses should not be borne by Jane's estate, unless they are to be allocated to and deducted from Arthur's share of Jane's estate upon her death.

In conclusion, Jill has no objection to the Court issuing an Order, consistent with prior Orders of this Court and Dr. Ledakis' recommendation in the 2023 Report, requiring that Arthur's visits with Jane continue to be supervised and that the other measures imposed by the Court in an effort to best shield Jane from undue harm related to Arthur's visits remain in place.

Don't' you ever threaten me that you are going to sue me if you don't get your way involving matters involving mother as you did to me last night on the phone. In this case, about getting mother's checkbooks. You said on the phone last night you have power of attorney. For your information, I also have equal power of attorney. It was set up by mom and dad's estate lawyer many, many years ago in case if one of them cannot act for themselves. We both have EQUAL power in case something has to be decided in any matters involving mother if she is incapacitated. If there is a "tie", the lawyer makes the decision.

As I told you last night, if you want to sue me, go ahead. Lawyers today demand at least \$10,000 as a retainer. Do you have that kind of money to throw away? You would lose the case and lose the lawyer money because you have no credible reason suing me. I can also counter-sue you for filing a frivolous lawsuit and abuse of civil procedures. You will lose because you have no real reason to sue. You are demanding people jump and do what you demand, even when you are totally wrong. Just like a child, if you don't get your way, you throw a temper tantrum. Everyone saw that at Dr. Kuhar's office a month ago when you humiliated yourself by your lack of knowledge concerning mother's abilities. After insulting a medical doctor, you ran out of the office because you did not get your way. You showed how childish and bratty you are and always have been.

You never responded to my email yesterday. I keep the checkbooks because mother has misplaced/lost them before. I want to save her from embarrassment of constantly asking for replacements of those checkbooks and the cost of replacing them. Will you pay for those replacements when she loses them at about \$40 or so each? I do not think so. I give her a check when she writes one so she always has a Harleysville check for petty cash and a Raymond James check for big purchases.

It is clear, you have such hate for me, you think I am trying to take over, control mother's life and maybe get money from her. That is a lie. I love mother and spend a lot of time with her. There is no reason why she should be alone most of the time. I do most of the shopping for her and pay for it. I take care of mother's car for maintenance, waxing, washing, etc. I take care of matters around the house including doing the dishes, painting, waxing the floors, driveway, etc. I buy her things to make her life nicer, including canes, cushions, dvd player, taking her out to dinner, take her to the cemetary (once a month since dad died and taking him roses each time), buying mother roses on a regular basis, etc. You pull up some weeds once in a while and leave the smelly bag there for me to put in my car to take away. Finish the job you start.

For the past decades, you totally ignored mother, like she was a nobody. You still do today for the most part. Only for the past couple of years, do you take her on Saturday to pick up your cleaning, go to the market and she buys you lunch. Maybe you see her in church. Maybe a movie a few times a year. Making her soup and giving her a facial once in a while, is hardly spending time with her as a loving daughter. There is no excuse why you don't have her over for dinner on a regular basis, several times a week, while she still drives. Taking her on a day trip once or twice a year is nothing.

You stuck to father like glue all of your life and only wanted to be with him instead of mother. During that time, you basically ignored her. I thought that was very wrong and hateful.

Your childish, short tempered and basically bitchy behavior, is hurting mother and causing her very much pain, suffering and emotional distress often, almost to the point of her crying. I am there and see it. I am there when I hear you yelling at her while she is on the phone sometimes and how she basically has to almost hang up on you because of your bitchy attitude. She was crying openly yesterday and actually shaking because of your yelling at her and your constant open hate of me. Her short time memory loss is causing her to be very frustrated at herself because she cannot be as perfect as she was and independent. She knows she does not remember things and the problems it causes. Why don't you realize that and be far more understanding as her daughter? She is a very loving mother who has given you much money, instead of spending it on herself. She does not buy things for herself to save it for her children. She wants her family to be a family, not to fight and to get along.
