

## JUDGE GAIL WEILHEIMER

From the beginning of this guardianship scam on Mother which was only for her assets and was originally filed by my then 67 year old sister, jsh, for jsh to get those assets for herself, it was very clear to this guardianship mafia how much I loved my Mother. I would never allow just common crooks to steal her money, her house that she had been living in for 21 years, her much cherished possessions she had for almost 100 years and allow Mother to be condemned to exist, in a tiny cage in a low rated nursing home like a mouse, until Mother died. Mother was living a very happy and healthy life in her huge home. I was going to fight this scam whether I had a lawyer or I was pro se.

Weilheimer and jaskowiak, Mother's assigned lawyer by weilheimer, made it clear to me from Day 1 after Mother was falsely guardianized, with both of them using extremely severe, almost non existant 1 hour visits with Mother for punishment, that weilheimer, jaskowiak and the rest of this mafia would not allow me to stop them from stealing Mother's vast assets for themselves. Those assets included Mother's huge, 3 bedroom, 3 bath house in a gated community, her valuable possessions and antiques. Weilheimer and jaskowiak put me in prison twice as punishment for exposing their guardianship scam on my news website, me protesting in front of the Montgomery County courthouse with protest signs with weilheimer's name on them on a regular basis and me being a regular co-host on a national radio show that had been on for almost 15 years that only dealt with guardianship corruption.

I also learned why the Philadelphia Inquirer never did any stories about the massive and long time corruption in the Montgomery County orphans court: weilheimer's husband is chief legal council for the paper. Weilheimer is also very good friends with lorie shapiro, wife of now governor shapiro. He had nominated weilheimer for a federal judgeship and in late 2024, weilheimer was approved by the U.S. senate.

In June 2023, weilheimer sent me a letter telling me she is going to have the county IT person, olivieri, block my email address to her office because I was emailing her staff to many times. That is a total lie. Weilheimer has no legal authority to block my or anyone's email and deny me access to her office, just like any other lawyers do. But, weilheimer lied to me in her letter. The same day she sent me that letter, olivieri sent me and to copestick (weilheimer's legal assistant) an email (by mistake to me) that he did what weilheimer told him to do: block my email address to ALL county agencies, including the ones I was using to help my Mother. Other agencies blocked included sheriff, DA, county commissioners, judges, etc. Again, weilheimer has NO legal authority to have the county IT or anyone else block a persons' email.

In late 2023, another judge was assigned to orphans court and Mother's case: sterling. She refused to have olivieri unblock my email to her office and the rest of those people. I filed an emergency petition with sterling to unblock my email so I could help my Mother in late 2023. Sterling denied it and said there was no emergency to do so. WTF? Sterling pretended to be funny and told me I had to give her all of the email names I had sent that were blocked. I told sterling that whatever olivieri did to block my emails, he can unblock them. As of January 2025, my email is still blocked to those agencies.
