

MANATAWNY MANOR

My former sister, jsh and logie (first guardian of person, estate good friends with jaskowiak) kidnapped (taken away by force, against their will, for monetary gain) Mother on August 25, 2021. I was being held against my will by 2 local cops, who logie had called, to make sure I did not interfere with his "plan". I heard Mother crying and screaming that she did not want to go with them. My Mother was taken to jsh's house and held there as a prisoner for about 12 days. She was drugged to keep her quiet and not fed properly. Mother was denied all phone calls and visits by me to see Mother at age 96. Jsh threatened me with arrest if I showed up at jsh's house to see and talk to Mother. Why? There was NEVER any court order for Mother to be kidnapped. To this day, nobody (jsh, camp, jaskowiak, judges weilheimer and sterling, pam blumer, blumer's entourage of many lawyers, including blumer's lawyer husband (Mother was forced to pay all of them), deb klock (care manager hired by logie), fenstermacher, zabowski (logie's lawyer Mother had to pay) or the last guardian of person, ellis, has ever said who ordered Mother's kidnapping. Why? Jaskowiak was Mother's court assigned lawyer by weilheimer. His job was to protect her and defend her in all matters. Jaskowiak NEVER did so in the petition hearing because he was part of the guardianship mafia on Mother. He WANTED Mother to be guardianized for the vast financial benefit to the mafia for Mother's vast assets. But, the quack psychologist ledakis (hired by weilheimer to do a "evaluation" of Mother to determine her "incapacitation") said Mother had no problems with daily activities and because I had been living there with Mother for 2 years, everything was fine. Ledakis was the one who I got to admit in the petition hearing that his tests he supposedly gave Mother to determine "incapacitation" had NO independent proof of accuracy. Ledakis also admitted he had NO independent proof of the accuracy of his "evaluation". Ledakis also admitted that he never audio or video recorded any of his "sessions" using a simple cell phone to prove what a person said or how said it. Ledakis's "report" cannot be accepted as pertaining to Mother and not 100, 1,000 or 10,000 people using a simple cut and paste of one name for another. Ledakis charged Mother about \$5,000 per "report". But, even though ledakis said Mother had no problems with daily activities (dressing, bathing, hygiene, eating, no neglected medical problems, etc and she was still driving her car safely at 96), ledakis claimed she was "incapacitated" and needed a guardian of person. Why? So the mafia could own Mother for Mother's assets. Weilheimer also forced Mother (with jaskowiak's full agreement) to have a guardian of estate even though Mother had NO financial problems, NO unpaid taxes, NO unpaid bills, NO bounced checks, etc. After ledakis said what the mafia wanted him to say (with NO credibility), weilheimer hired ledakis many more times for his lies to help the mafia. After I exposed ledakis in the petition hearing as a liar and quack, every one of his "reports" were only character assassinations of me for the mafia to use to drastically reduce and deny me visits with Mother.

After about 12 days of being kept as a prisoner and not being fed properly, Mother passed out and had to be taken to the hospital, unconscious, by ambulance, confined to bed for 6 weeks, treated for starvation, got covid where she could have died, had daily blood tests(42 times) to the point her arms were black and blue, daily needles in the stomach to prevent blood clots (42 times). Logie claimed Mother fainted because it was a hot day from dehydration. BS! The weather report for the month said the days were only about 80. Plus, if Mother was dehydrated, the treatment would only be overnight with fluids. Logie lied many times during the scam on Mother.

When Mother was released from the hospital, logie/jsh dumped Mother into a low rated nursing home that had just opened up after months from a major covid outbreak. The fact is, about 39% of the people that die from covid, die in nursing homes because of the lack of sanitation. Mother was never allowed a phone by the mafia, no visitors, no news papers or magazines, her TV only had a few channels, no refridgerator (until I got her one then it was taken out after a few months, no reason given), a very tiny room, her bed was no wider than her pillow, torn blanket, missing sheets, stained sheets and towels, dead mice, no locks on her

door to keep male patients out during the night, no closed circuit TV to see if she fell, etc. Logie took away her medic alert necklace so if Mother fell or had a heart attack, she could not call for help. Go to "Pictures of Scam" to see how disgusting Mothers room was. Go to "Pictures of Mom" to see the huge 3 bedroom, 3 bath house, in a gated community that she had lived happily in for 21 years with her much loved antiques and possessions with her late husband of 70 years. For 3 years, Mother was kept in a locked in section, with people with mental and behavior problems. There was NEVER any claim Mother had those problems. So why was she forced to stay in that section instead of a much nicer, much bigger and much freer place, such as home? The mafia wanted to keep tight control over Mother, her life and who was in contact with her for their financial benefit. Her section was much more money for Mother's cage for the nursing home as opposed to the other section at manatawny manor on the same floor as Mother's prison that had normal people, much bigger rooms, activities room, big beautiful dining room, library and a game room. Mother's was kept in solitary confinement in a sensory deprived environment, not allowed outside, not allowed to go home at any time to see her loved possessions and to ever lead a normal, happy life until she died. Why?

The following emails by me prove how much I saw wrong with how Mother's life there being kept as a prisoner, but NONE of the staff, guardians, their lawyers, director Kessler, klock, jsh and especially jaskowiak ever cared to fix those problems for Mother, jsh's own Mother and jaskowiak's client that he was bleeding for his own financial benefit, but refusing to act for Mother's benefit as her lawyer.

On July 2 2024, my 99 year old, loving Mother was reborn after being murdered by the mafia with morphine. Mother died unconscious, a very slow, extremely painful, barbaric and inhumane death by starvation and dehydration. The mafia/jsh refused to give Mother hospice and refused to let Mother have any last wishes while she was claimed to be dying, including going home and having me with her. How was Mother's 3 years in guardianship ownership by the mafia of ANY benefit to her? But, the mafia certainly made out financially!

The black woman again stated I cannot yell at my mother. Mom went to the door and told the woman I was not yelling at her. About 1145am another woman came to the door and said it was time for my mother to go to lunch. I stated that she had lunch with me and we were on the phone to my lawyer. About 12pm, another woman came to the door and said it was time for me to leave and I told her I knew that but I was on the phone with my lawyer and my mother was also talking to him. About 1215, a older woman with short blond/white hair knocked on the door and told me to leave. I repeated we were just hanging up and I was leaving. She followed me to the locked doors as I left. I explained to the receptionist why I was about 15 minutes over my time.

Mr. Kessler,

I would like to have a meeting tomorrow with the people you mentioned said my mother should not be moved to the other side, which is much nicer, with people who are much more alert and she has more room to walk around for exercise I would like to have it after my lunch with my mother on Wednesday.

My mother has been confined to her one tiny room for a year, no walks outside for exercise, no phone, none of her regular doctor's appointments, no day trips of any kind and no daily activities to keep her mind active. I think it is a disgrace that I am not given time by the guardians to walk my mother outside for pleasure and exercise. with the cold weather coming, those days may be numbered. I have seen the "activities" for others in her section, such as coloring books or filling in words. Those type of "activities" have no benefit to my mother because she is still extremely alert mentally and physically and needs activities at her level to maintain her level. She has not been getting any of that higher level of mental stimulus and physical activity for over a year. She has basically been forced to live in isolation, in a sensory deprived environment like a caged dog at a SPCA by both her "guardians" and Manatawny Manor. she is either sleeping in bed or usually asleep in the recliner. I buy her newspapers and magazines to read. I have taken over 1,000 pictures of various items in her house, vacations, etc, to remind her of how she lived to help her keep her mind alert. I cannot bring her items she would like because they would get stolen, as other things have been of value. She does not watch TV because none of her favorite channels are listed. Her treatment and living conditions are inhumane and barbaric. Such forced living conditions do not benefit her at all at her age of 97. She was NEVER accused or judged to have any "mental" problem by anyone. She was only "guilty" of having a little instant recall/memory issue. Such a condition does not mean she should live like a animal until she dies, or worse because of current treatment, she becomes a mental vegetable and unable to walk anymore

I informed you several weeks ago, I am a ordained minister and mother has said she wants to spend much, much more time with me. She still has constitutional rights to practice freedom of religion. Would you oppose such time of me with my mother in private or in public, such as day trips, lunches, etc.

I do appreciate the alone time we have been having lately. It is nice to know people are not listening in on our phone calls, listening in at the door or over the intercom like it was for almost a year.

Mr. Kessler,

Good morning. I asked my mother yesterday if she would like to get into any various activities there and she said no. She never got involved with the various clubs at her community where she lived for 21 years. She says she likes to be alone to do what she wants. As we can understand, not everyone likes to be in group activities.

My lawyer yesterday got a letter from pam blumer, guardian of mother. Blumer claims the staff have said I am putting various junk food and drinks into mother's refridgerator. That is a total lie and I have told my lawyer that. I know those stupid food rules by blumer made for mother two months ago of not allowing food anymore in her room for mother to eat at her leisure, at her age of 97. But, blumer has ignored all of mother's doctor's appointments for a year and allowing mother to go for daily outings for exercise and happiness. That makes no sense. Blumer claims mother's legs are not swollen anymore, but that is also a lie. Most of the time, her TED socks are not on when I am there at 11am.

For the past month or so, mother is not as steady on her feet as she used to be. It has nothing to do with her age, but lack of daily, normal walking. She says she walks in the hallway once in a while, but she says that is boring after a short while. She is either laying in her recliner or laying in bed day and night. She does not watch TV because the various channels she used to watch are not received there.

As you can understand, once her legs go, the rest of her body will suffer. I do not want to see that. I have told my lawyer our lunches together take up the visit time. I told him that he must get Blumer to increase our time together so we can walk outside or tour the building just to break up her boring day of laying down. Mental stimulus seeing things by walking around is very important for a person's wellbeing.

I deeply appreciate your time dealing with my mother. I know you have the entire staff and residents to deal with every day.

Mr. Kessler,

Happy Holidays. As you recall, I mentioned to you yesterday (Wednesday) in your office that my mother's bed has been missing, on a regular basis, the cotton sheet that separates the mattress from the blankets. I forgot to mention that her 3 pillows do not have pillow cases on them which is more comfortable to put her head on and for sanitary reasons. Yesterday, as I was leaving and Brandi was in the room with Mother and I, I put some of mother's left over milk from lunch in her refrigerator. I noticed in her freezer, there was a half gallon of ice cream. It was not mine. I had been told months ago by blumers not to leave food for mother in her room. No reason given. For the past 11 months since her legs swelled up, the guardians were blaming me for her swollen legs because they claimed my 3 lunches I brought per week were causing them, while ignoring the 21 meals she was getting at Manatawny Manor and no exercise allowed by the guardians.

I also mentioned yesterday (only to let you know) my mother is having much more trouble walking now than she did months ago. It takes her much more time, after she stands up from sitting for a while, before she feels her legs are "ready" to walk without falling. Mother is holding onto things more and more to help her walk so she won't fall down and because she knows she/legs are not getting the needed attention to stay strong. Her current "guardian of the person" (pam blumer) has been aware of that for a long time, but has done nothing to get her more exercise or for that matter anything pertaining to her physical health, mental health, happiness and to keep her memory abilities the best they can be. I am extremely disturbed by her lack of concern for my mother who is 97 and I have told my lawyer many times. The extremely simple solution would be for blumer to just give me more time at visits so I can walk with mother outside or anyplace to get mother more exercise and do things with her for her happiness. My visits of 1 hour, 3x a week was set by the judge last October, but she never explained the continued drastic and barbaric time restraints.

I have no idea who or what this latest person, Brandi, is or what she is supposed to do with my mother. The newest lawyer for pam blumer is Thad because pam's husband (bill) was taken off the case by his law firm because of his mean temper and his attitude to me and my lawyer. Thad is also at the same law firm. Thad refuses to tell my lawyer anything

about Brandi. I only know I am paying her now to sit next to us and listen at lunch to replace the staff people who were told by Logie (first guardian) and later blumers to listen to my mother and I. Those guardians were using your staff for their private use to also listen in on our phone calls and listen to us at Mother's door when I used to be in her room for lunch.

Thank you for your time and attention to this ongoing nightmare.

staff harassment

Mr. Kessler,

I am constantly amazed at the extreme unprofessionalism by the staff at Manatawny Manor. On Monday, I went to see my mother. Before I did, I went to see Deb because last Friday, my mother said that she had an examination. Deb was not polite to me and said Pam Blumer was "in the loop" and Blumer would call my lawyer if needed. I saw no reason for her rudeness. I went to the locked doors at the right side and by the time I got to mother's room, Deb came around from the other doors and was already there at mother's room. Deb told me I was not allowed in mother's room. I told Deb I was aware of that, but I just wanted to put my coat and the 6 packages I brought for my mother on her bed instead of carrying them to the tv room where there is no room for them. Mother was not in the room. Again, Deb was rude and demanded I do not go in the room. I went to the TV room and met my mother. Brandi (hired by Blumer) told me that mother and I were no longer allowed to sit at the round tables we had been at for the past month, we had to sit at the nearby tiny white table. She would not say who made that decision. I believe she made it up because now at the white table brandi was sitting literally right next to my mother's chair and mother who next to me. At the round tables, brandi was about 4 feet away at another table and was not able to see much of what mother and I were doing or saying. Brandi has been writing reports to Blumer of what she claims I say to my mother. I know those reports have been lies just to try to ban my visits with mother because of my exposing the corruption in my mother's guardianship. At about 11:45, I told mother we better leave for her room to drop off my packages to her. As we were walking to her room, both brandi and colinda were literally 3 feet behind us giggling and mumbling the entire time.

When I got to mother's door, about 5 staff people, including Deb, were already near the staff desk. They actually stared at me the entire time until I left, probably hoping I would step one foot into mother's room so they could get points (money?) for reporting me to Blumer, who then tells her lawyer Gelsinger, who then sends my lawyer another email of lies like Gelsinger has done many times before. They continue to try to build a case on me that I am unfit to have visits with my mother for rest of her life. Once mother went inside, she would ask me many times to come inside to help her or I saw she needed help, but I had to say no and tell her it was Blumer who said I could not go into her room. She thought that

was so pathetic and she was not pleased. Is watching a man hug his 96 year old mother goodbye that entertaining for your staff to watch, instead of doing their work or watching out for the elderly? As I was leaving, my mother told me to call her that night. I told her I was not allowed to call her anymore because of Blumer's rules from 5 months ago. She was mad that I could not call her and she said that Blumer's rule was stupid.

If the staff has that much time on their hands to watch me and my mother say goodbye, but watching out for the welfare of the residents is not that important to them, maybe they should start wiping the doorhandles with sanitizer (like I used to do for my mother's room) so covid and influenza are not spread and the place does not have to be shut down again and the old people do not get sick and die. Also, maybe the staff should learn or be told that the blue masks and those cotton masks offer very little if any protection from spreading the flu or covid and only wearing them over the mouth is not correct.

Is Manatawny Manor paying the staff now to spy on me like they used to do for Logie when he told them to listen at the door or through the intercom when I used to be in the room with mother for lunch or when they listened on the phone extension when I used to call my mother twice a day? Or, do they just like to constantly harass a visitor whose mother is paying \$90,000 a year to be in a tiny room where items (before it included food) are constantly being stolen by the staff, including last week where 5 healthy pointsetta plants were stolen, along with 6 different vases with roses and flowers? There are many things my mother would like to have in her tiny room to see from her house that cannot be replaced, but mother has to suffer because I will not allow those losers simply to steal those items to keep or they throw them out for their own amusement knowing it will piss me off when I see the items are gone.

On Monday, her TED socks were not on again, as they have not been many, many times. The staff, under Bruder's orders, were supposed to put them on everyday many, many months ago. Why haven't those socks been put on everyday? Her legs are still very swollen and her left leg has been even more swollen with a large lump just below the knee from about 3 weeks ago. I reported it to the staff. They are so swollen that the TED socks could not even be pulled up to her knee even if they were on.. Her ankles are very, very swollen. I am constantly reporting my findings to my lawyer, who contacts Blumer's lawyer Gelsinger. He only says they are being taken care of. BS! The claim by Logie (previous guardian of mother) and now Blumer since November 2021 was I caused her leg swelling because of the food I brought her for our lunch 3 times a week, but ignoring the 20 meals a week mother gets there. Their lie has been exposed because for the past 2 months, I have not had lunch with my mother and have not left her any food. Mother needs a real doctor and hospital tests before her legs have to be amputated or she dies from a infection or blood clot.

As of Wednesday, I can no longer see my mother at your nursing home because I have run out of money. I was paying \$200 a week for 3 visits for the monitor to sit feet away from us to listen and write notes of whatever I said for the lawyers of mother. If I said something I should not have, then my visits would be canceled and me prosecuted. That stupid idea was forced upon me solely because of the claims in court on Wednesday by some of your staff to pam blumer, the guardian of person for mother. As you know, none of those people were ever called to testify by her lawyers. Such information is called here say. But, with the corruption in this case by the judge, guardians and their lawyers, that judge accepted those made up claims as fact without your people being there. You know my love for my mother and how much I have helped her to try to be happy as much as possible there so she would not get drugged. It is pathetic that not only is she forced to live there, with not being allowed to enjoy the outside world and her beautiful

Forget COVID; CDC now warns this virus is highly contagious

Winter months brought a surge of respiratory illness across the country. As flu, cold and COVID-19 cases further trend down, the CDC is now warning of an uptick in another type of illness: norovirus.

Public health officials have noted an increase in norovirus cases, the highly contagious virus that causes the "stomach flu." The number of infections this year outpace the last few years, but decreased congregation from the COVID-19 pandemic most likely contributed to the lower-case counts, and we are now experiencing normal trends preceding COVID-19.

The stomach flu isn't the same as the "flu" caused by influenza, which is characterized mostly by fever, fatigue and respiratory symptoms. The norovirus stomach flu has more focused and intense gastrointestinal symptoms and, in most cases, a shorter duration of sickness.

While outbreaks can happen anytime and anywhere, they occur most often during the colder months and in crowded environments, like hospitals, nursing homes, childcare centers, schools and cruise ships.

For the overwhelming majority, the illness is usually self-limited, resolving on its own without medical intervention. It's not fun to have and can lead to dehydration quickly. Dehydration can be especially worrisome in the elderly and young kids, and it can lead to serious complications.

The stomach flu sends about half a million people to the emergency room each year for supportive care and to rule out other more ominous diagnoses, like appendicitis.

The stomach flu isn't the same as the "flu" caused by influenza, which is characterized mostly by fever, fatigue and respiratory symptoms. The norovirus stomach flu has more focused and intense gastrointestinal symptoms and in most cases, a shorter duration of sickness.

Unlike the respiratory spread of influenza and SARS-CoV-2, norovirus largely spreads from contaminated food and surfaces, making it the most common foodborne illness in the U.S.

Foods that are commonly involved in the outbreaks include leafy greens (lettuce), fresh fruit and shellfish. The highly contagious virus typically spreads from unwashed hands (especially after using the restroom and/or vomiting) handling food or surfaces food is placed upon. Norovirus can remain viable on surfaces and still infect people for days if not cleaned appropriately. Aggressive handwashing and keeping surfaces unsoiled are key to helping reduce the spread of this pesky virus.

There is some short-term protective immunity following the stomach flu. However, there are over two dozen strains of norovirus known to infect humans, all with many variants, so protection from one does not necessarily protect from another.

It is nearly impossible to avoid the illness once an outbreak does occur. To decrease the risk of infection and further spread of the havoc-wreaking virus, be sure to:

Follow strict bathroom hand hygiene

Wipe and disinfect bathroom's surfaces after someone sick uses it

Wash hands before and after preparing food

Rinse fruits and vegetables

Cook shellfish thoroughly

Each year, one in every 15 individuals in the U.S. will get norovirus stomach flu; it's hard to avoid. If you do get sick, make sure to stay in touch with your doctor and drink plenty of fluids to decrease the risk of dehydration and the consequences of fluid depletion. Do what you can to stop the spread by keeping contaminated surfaces clean and avoiding group settings until 48 hours after symptoms have completely resolved.

Did you get the name of the person who came up to me, next to the staff desk about 10 days ago and told me no pictures were allowed? As you recall, I told you about that incident. I was extremely mad about it. You did not respond to my requests below.

Also, for many weeks, mother does not have her TED socks on that she was supposed to have on all the time. Both of her legs are still extremely swollen. Since I have not been bring her food for several months, as you recall I have been blamed for her leg condition for about 15 months for bringing her only food for our formally 3 meals a week, while mother has been getting 20 meals a week at MM. Mother has not been on any diet restrictions so her leg condition is not food related, it is medical. Dr. Bruder has been totally wrong about mother's legs and he has put her health and life into a deadly situation. . As you know, mother has not been taken to any of her doctor's appointments for 18 months. Mother says she is only getting a hair appointment maybe 1x a month. Why? She can afford it. Women like to have their hair clean and styled. She used to get it done every week. Also, the staff do not put on mother's no slip socks on all of the time. Why? I had bought her 5 pairs.

I do not understand why your staff is so eager to make snarky remarks to me on a regular basis and lie to mother's guardians and current monitor about what I supposed to have said to mother or done, listening at the door to my mother's and conversations and

listening in to our phone calls for, but they cannot do their jobs by putting on her TED socks every day and making sure her no slip socks are on all the time so mother does not slipp again on the waxed floors and hit her hip and head as she has done several times. Does MM want their residents to fall and break their hips and end up in rehab for many months in pain?

Also, several months ago, I asked you to take her out of that tiny prison she has been forced to live in basically solitary confinement since she has been there for 17 months and put her on the other side in one of those private rooms that are much bigger. She would have very nice, almost normal people to talk to (unlike the people in her section), a library, activities room, lounge and much much more room to walk around for exercise and mental stimulation.. You said Kay and Deb said no. I see no reason why that cannot be done. Mother has never been accused of being a run away, there is a ankle bracelet to lock down the elevator if that is ever needed. Mr. Kessler,

I emailed you on Tuesday about my mother's friends not being able to call her because none of the staff are picking up the phone, the SAME problem I continually had with your staff when I used to be able to call mother. So far, you have not replied.

As you recall, my mother knew the staff were listening on their extension and we both knew the staff was listening at the door when we were eating lunch in there in private or when she was talking on the phone in private in her room. They did not do that on their own, they were told and paid to do it by first guardian Logie and pam blumer, the current guardian. You were told by me when you first started to work there your staff were listening on the phone, at the door and watching us where we sat and were always giving snarky remarks just to start trouble. You recall the situation Colinda started months ago. Why was she and others not fired for doing those things?

Is this what Mother gets for paying \$90,000 a year for her tiny room, kept in solitary confinement, no doctors appointments, not even a weekly visit to the hairdresser, her TED socks not put on as required by YOUR staff doctor, the no no slip socks I bought her last year are not on and she told me they are missing, her legs are still very swollen, she is not allowed outside in 18 months and not even able to get newspapers and magazines to read unless I brought the (now they are taken)? All people in prison are allowed to make phone calls, have access to the internet, and be able to have access to a library, like the small one you have on the other side.

Why is my mother being denied the basic pleasures of life by you/Manatawny Manor? She is not allowed to have the food she likes to eat in her room, even though she has NEVER been on any diet restrictions? I asked you before to put mother on the other side where there is a big beautiful dining room, activities room, lounge and library. The other side it much, much nicer, bigger and has those other big rooms she can live in that are

much larger and the people there are much more to her level she can talk to them, as opposed to the people she has been forced to be with for the past 18 months.

Mother also told me several weeks ago, that she likes to walk up and down the hall for exercise, but your staff yells at her and tells her to go back into her room. My mother is NOT a dog in a cage at a animal shelter.

Mr. Kessler,

I have sent you several emails recently about the packages and other gifts I have left for my mother that I have heard she never got, my private letters to her have been opened and taken and cards from her friends were not given to her. You have not responded to my emails. I have also been told, by friends of my mother, they have tried to call her, but your staff does not pick up the phone, the same problem I had for many, many months when I used to try to call mother. It would take hours before a staff person in that section would finally pick up. Why are those problems still happening? Did you authorize that?

I left several bags of newspapers, flowers, letter at the receptionist desk yesterday for mother. She acted like she never knew residents could have packages. I informed the scheduler next to your office the packages were for my mother. As you know, I asked for a meeting with you to discuss the fact my mother has not been getting my packages and her phone calls, but you were in a meeting.

I am disgusted that mother still has to live in her tiny cage and in isolation at \$90,000 a year by her "guardians", instead of being at home with her much loved possessions until mother is dead. I have asked you several times to put her on the other side where she has much, much more room to walk around, much nicer facilities, much more normal people and her room would be much larger so she would not have to have her possessions on the floor. You have denied my requests.

Without my visits, 2x a day phone calls (stopped about 8 months ago by blumer), gifts, flowers, cards and other items needed by her during the past 18 months, mother would have no connection to the outside world. She has had none of her doctors appointments for 18 months, including to her dermatologist for skin cancer treatments. She has been treated much less and given much less there as a human being than people in prison. She has been denied even a private phone to call me when she was allowed and to her friends. She has been denied exercise and even told by staff to go back into her room for simply walking up and down the hallway. Would any medical doctor say a senior citizen, especially age 98, not having medical appointments, various mental activities during their day and exercise, GOOD for their life, health and brain? When I used to be there, most of

the time she did not have her TED socks on and her no slip socks on that were always supposed to be put on by staff.

Does anyone care to do their job in mother's section or just sit around watching TV or using their cell phones in the TV room on their shifts.

As you know, because I do not have the money anymore to pay the monitor, I cannot see or talk to mother as dictated to by mother's slave owner, pam blumer, for the past almost month. It is disgusting that my mother may think I do not love her anymore and do not want to see her because she is not getting my gifts and letters. You have the ability to make sure she gets my gifts and to have mother get phone calls by and to her friends. As you know, these problems of visits, meals with mother in private and phone calls to her by me were because YOUR staff falsely claiming I got my mother upset when I used to call her and after my visits. Their lies have been used to deny my mother and me time together while she is still alive.


Would you want that type of treatment and behavior for YOUR mother?

According to the last court hearing, blumer said she only sees my mother once a month. So, my mother does not get my cards or letters for weeks at a time? Does that sound caring by a guardian to you?

It is very unfortunate that I have not been able to trust you or your claimed concern for my mother, her welfare and her wants and needs for a very long time. You refused to put her in the much nicer and larger section on the other side. I have seen those people. Mother would not have a problem being there. As you recall, your staff, at the request of logie then blumer, were telling your staff to listen in on our phone calls and at the door when my mother and I used to have lunch in her room. I have been the ONLY one for almost 2 years that has brought her newspapers, magazines, cards, gifts, flowers, food, etc for her happiness in her tiny locked down section. She has been kept in solitary confinement, no phone and in a sensory deprived enviroment. She has been denied her doctor's appointments for almost 2 years, outside to be in the world for almost 2 years and to visit her home to see her loved possessions. That section's idea of "treatment" for people with a memory issue is a coloring book and crayons. My mother is NOT like them. My mother was almost perfectly normal before she was dumped there by logie and my sister. What is she paying \$90,000 a year for?

Your business is obligated to provide all neccessary treatment and other needs to those people. My mother has not been given them. Your staff has constantly failed to put her TED socks on and her no slip socks on. Mother told me recently she does not have them anymore. I am not surprised since I have seen how your staff steals things for themselves, including even flowers, food, and other items I bring mother. Blumer does not even get her weekly hairdressing appointments. Mother used to have one every week. WHY? There is no excuse why she cannot go outside on nice days and be treated as a human being, not a caged animal.

You can demand blumer provide what the law says, rules of a nursing home dictate and human beings deserve to live happy and have a place to enjoy their life, including visitors that are not "screened" (WTH?) and guarenteed the gifts that are left for them by me. I do not trust your word at all that she gets them. There is NO excuse why Mother cannot have ZOOM calls for her happiness. she is in a nursing home, NOT a POW camp. A person in prison for major crimes gets much better place to live and and other things to have.. Mother has never been on any diet restricions so there is no excuse why she must only eat what food is given to her. She has lost weight since I have not been allowed to bring her food for many, many months. It has also been proven that it was NOT my food that was causing her legs to be swollen for almost 1.5 years. Your so-called "house doctor" is NOT qualified to do any medical diagnosis, only a hospital can. Even after mother was taken (doubtfull) to a vein specialist, her condition was never better. Lack of exercise and home cooked food, not canned food, is what is needed. Mother never had that vein problem before. Mother will be 98 on May 16. Is THAT how you think a 98 year old person should be treated instead of being in her large home?

If blumer refuses to act as a guardian and a human being (she denied me Valentine's day, Christmas, Good Friday and Easter) then you should demand Mother be taken to another place. But, of course if you did that, you would lose money, which is also why you refuse to put her on the other side as I have requested many times, where she could be more in a enviroment much more likable to her wants and needs. 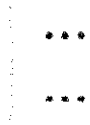

As you know, my mother has only a very tiny table on wheels for her room. There is no other place to put anything and she has to put what little things she has on the floor and cannot spread various things out.

Why don't you remove the old, fat chair next to the bathroom since basically no one is ever in there and there is a second chair in her room and put in a card table and a chair for her to use? At about \$90,000 a year for that tiny prison room, a table should be included.

I have not seen or talked to my mother for about 5 months because of the guardians. How drugged is she now by you and your staff? Can she walk or is she now in a wheelchair because of your drugs and lack of exercise? Is her only "exercise" still only walking 35 feet to get her only food and back to her room to either sit in her chair and sleep or lay in her bed and sleep?
