Counsel,

In looking over the two petitions that are to be the subject of the upcoming hearing on October 3<sup>rd</sup>, I don't believe that my client will have anything to contribute to the proceedings. Consequently, she and I do not plan to attend the hearing unless one or more of you plan to call her as a witness or believe she needs to be involved in the proceeding for some other reason. We're mindful of the expense to Jane's estate these hearings create and are loathe to add to that expense by billing for our attendance.

For what it's worth, Pam believes that Jane no longer benefits from owning the residence and would support its sale so as to eliminate the home's carrying costs for Jane's estate. As long as conservative estimates of Jane's future care cost indicate she will have adequate funds not only for her care but also to pay for any future professional fees and litigation costs that may arise from family disputes about her care, she has no opposition to gifts to Jane's children in furtherance of Jane's known estate planning objectives. She only asks that estimates of Jane's future care cost be conservative and account for (1) increasing annual care costs, (2) likely ongoing family disputes with the attending legal expenses for Jane's estate and (3) a long life expectancy for Jane that sees her living to age 105. She suspects that even with these conservative estimates, Jane's estate will be able to support gifts to her children, but she will rely on Ron to run those preliminary calculations and share them with the group before any gifts to children are recommended to the court.

If none of you plan to call Pam as a witness at the upcoming hearing, I will notify the court that Pam and I will not plan to attend unless the court wants us to be there. I will of course copy all of you on that email to the court. Thank you.

Dave, Hope all works out well with your eye surgery.

Please look at the email chain below and in particular August 9, 2022 with my comments in red. Ron, Arthur and I met in my office to discuss options and it was Arthur who said he wanted to keep the house available and in the estate, just in case Jane ever needed that asset for funding. Arthur thinks the house is an appreciating asset, when Jane passes he would like the option to take the house in kind, if possible, and in the meantime, Arthur would live there, maintain the house and funding at a nominal basis would be provided from the trust, an equal amount to Jill and to Arthur each year, with Arthur paying rent or having the costs to keep Chancery Court offset against his annual stipend/gift, which has been the case for a long time. I think Ron and I favor this option because Jane's estate is preserved, the house stays in the trust in case Jane/Ron ever needs the house for Jane's care and in the meantime, Arthur has a place to live versus on the street, which Ron feels Jane would not want. The "rent" or



offset to Arthur's gift should cover the cost to carry and maintain the house at all times and if the "rent" of offset should be more than 16,500 per year, the "rent" or offset could also rise according to the expense in keeping the house. According to the US Social Security Mortality Table (attached) Jane's life expectancy is just a little short of 3 years, so Arthur, Ron and I would prefer a conservative approach because nobody knows how long anyone will actually live. I understand that what Arthur "pays" does not include a lot of rent, but, the house is an appreciating asset, probably better than stock market or bond risks and Arthur is covering 100% of the cost to keep and maintain the asset out of his advances from the trust, which has a benefit to the trust and to Jill as well.

If you like this option, let me know and if not, do you prefer another option? I think if you, Ron, me and Brittany agree, the Court will approve and we can resolve all the other issues in the Eviction and Contempt proceedings at the same time. Jane's assets will be preserved, at the same time. I recommend this approach because it is much more conservative than transferring a large asset to Arthur or a trust and a like value to Jill, while Jane may need the funds.

If we can agree in principle, we can work on the details together. Let me hear your thoughts. Thanks, Vic

I am aware you told me last week you will handle blumers after the residence situation is over, but

there is NO reason why certain basic questions for mother's humane (medical, psychological, emotional and dietary) treatment cannot be answered NOW by blumers with only a few sentences by them. Mother has been kept basically in solitary confinement for almost a year at MM and before that 6 weeks in the hospital confined to her bed with no exercise.

1. Meeting- in her room, or second, on the "deck" in private. I have told you several times, there is just

too much noise by staff, loud TV and patients talking loud during the past 2 weeks in the

dining/activities room for my mother and me to have a nice meeting.

Blumers have NO justification for their actions as per meeting location.

2. Food- EXACTLY what food can she eat? Why can't we eat lunch together as we did? Why can't a 97

year old woman have lunch with her son in private or at a nearby restaurant?

3. Visits- Why can't I see Mother on Sunday?

4. Why can't I have Mother all day on my visits? She has been kept in SOLITARY CONFINEMENT for

almost a year at MM. I know full well there are laws pertaining to elder abuse. She is living there, just

the opposite of what ledakis said in his report that she could live at home, but he was totally ignored

by judge weilheimer, askowiak and camp. MM is \$90,000 a year and mother does NOT get any

special services at MM.

5. Phone in her room. Why not?

6. Doctor's visits- She has a RIGHT to see various doctors, HER various doctors, that logie and blumer

have refused to take her to for a year.

She does not even allow my mother to walk me to the dining room door to say goodbye and hug.

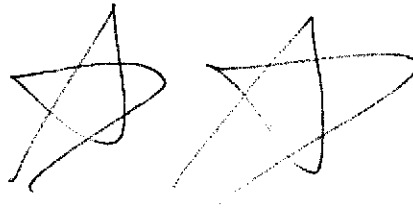



- 2)Waste basket in Jane's room no cleaned/emptied regularly;
- 3)Broken bureau drawer at MM and torn bedsheets and bedspread;
- 4)Lack of grab bars in room and bathroom to help Jane get up and down;
- 5)Covid and flu outbreaks at MM that restrict visits for weeks;

- 6) Jane in lockdown with people/patients with mental and behavioral problems while Jane has no such issues;
- 7) Medic Alert was taken away by Logie. Why not replace it in case Jane falls again.
- 8) Lack of regular doctor visits to dentist, optometrist, foot doctor, etc for more than a year



As we mentioned last week, Pam is moving ahead with the aide who will work with Jane on exercise and mental stimulation. Those sessions will begin this Wednesday and will run from 10:00 a.m. to 1:00 p.m. every Monday, Wednesday and Friday. They will impact Arthur's visits, but Arthur can decide exactly how. Specifically, Arthur can use his visitation time to participate with Jane in the exercise and mental stimulation activities the aide will be performing with Jane. Alternatively, he can continue to use his hour to sit and visit with Jane. For now Pam will let Arthur decide which of those options he prefers.

If he does not want his visiting time used for exercise and activities with Jane, then the aide will supervise Arthur's visits to monitor how he interacts with Jane. She will report back to Pam any positive or negative observations. If Arthur wants to learn from the aide different strategies to respond positively to Jane's questions, he can do so. The aide is not meant to be a spy, but rather a tool for Jane's care that Arthur can use to his benefit or that he can rebuff. The choice will be his, but the hope is that he will use this time to improve his standing in the eyes of the other people involved in Jane's care.

I'm sure that Arthur will be disappointed by these developments, but Pam and I sincerely hope that Arthur will use this time to learn how to interact with Jane positively. No doubt Arthur has concerns about the facility and will have concerns about the aide's activities. He is free to bring those concerns to Pam's attention, but he should not share them with Jane. She can't fix any of the problems Arthur raises, and sharing them with her simply upsets her and reminds her that she doesn't have full control over her life. However, if Arthur uses his visitation time productively and demonstrates a willingness to change his interactions, Pam will be the first to support an expansion of his visitation privileges. She truly believe Arthur can have a positive role in his mother's life, but he's not doing that now. And if things don't go well for Arthur at the October hearing, Pam wants to make sure there are things in place to limit the impact of his disappointment on Jane's care.

Unfortunately, Arthur's most recent email indicates that he will wear his black hat with pride. Consequently, Pam directed me to prepare a petition to the court seeking to limit Arthur's visits to 2 Mondays per month. She will also ask the court to permit her to suspend those visits without prior court approval should Arthur's conduct continue to be unproductive. She will not seek the discretion to expand Arthur's visitation privileges. Rather, visiting more than twice per month will require court approval. She is taking this action both because she anticipates Arthur will not like the outcome of the upcoming hearing and because he clearly does not believe his conduct contributes to difficulties in caring for Jane.

Arthur's focus remains on redressing what he believes was the unfair and unjustified placement of his mother at Manatawny Manor. That cannot be Pam's focus. She must deal with Jane as she is now and where she is now. She would like Arthur to play a productive role in Jane's care, but Arthur needs to change for that to happen. Pam believes Arthur can change and when he does, he should be rewarded for doing so. She wants to provide him with tools he can use to change. Teepa Snow's materials and the aide are both meant to be tools for Arthur.

Arthur clearly loves his mother and wants what's best for her. He's just going about things all wrong. I know you've been trying to help him and Pam appreciates that. I think this is like a Chinese finger trap. Arthur keeps insisting that pulling away from everyone else and what they are suggesting is the best way to achieve his goals. It isn't. He needs to push in and embrace the suggestions and tools that are given to him.

For example, here is a situation where Arthur can "push in" rather than "pull out." Pam will not be barring Arthur from bringing lunch to the facility when he visits Jane. That said, she

prefers that he does not bring Jane lunch. The facility provides Jane lunch and feeding her ahead of the facility's lunch often results in her not interacting with other residents. If all of her meals and snacks are provided to her by Manatawny Manor, any problems with her nutrition will be clearly Manatawny Manor's responsibility. There won't be any opportunity to blame Arthur for swelling in Jane's extremities, etc. because the food Arthur provides. This will also encourage Jane's socialization with other residents over meals. Pam has seen no evidence, nor has anyone other than Arthur reported to Pam, that Jane objects to eating with other residents or finds the other residents upsetting. If Arthur insists on bringing food, he does so knowing that he's creating an opportunity for third parties to say that the food he brings contributes to the swelling in her legs (due to high sodium content) and other problems. At this point, however, she is not going to prohibit bringing in food. She merely suggests that there are other ways Arthur can engage with this mother during their visits, and she wants to see if he's willing to try some new things. As with all things that have occurred to date, the choice is Arthur's.

I will serve you and the other counsel with copy of the petition I'll be filing as soon as possible. The hope is that Pam can get ahead of those seeking even more restrictive terms for Arthur's visits with his mother and give him a pathway forward to expand his visitation if he's able to change. She takes no pleasure in restricting Arthur's visits. She's rarely ever needed to do this in her other cases. If Arthur will simply change his behavior, he will find an ally in Pam rather than an adversary.

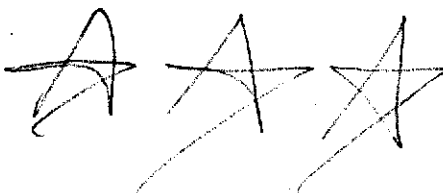

That is based on what jaskowiak said in the zoom several months ago when he said he saw mother, she said she liked the food, room and people. All lawyers and judge heard him say that. By him saying that, he is also saying mother's letter to the judge must also be accepted as fact and written by mother, not me. She wrote she wants to go home, she wants to be with me, she wants a new lawyer, wants a phone in her room, she wants to be in court to testify, wants to go to doctors. He cannot deny he said it. He said in another zoom call he really liked mother and hoped she lived to be 120. Then how can he claim, as her lawyer, he does not know about what ledakis said in his first evaluation that mother could live at home and with me there everything was fine and she had no problems with daily activities and still does not get any special help at MM? How can he claim he does not know mother has been in a locked down mental section for a year, her very poor living and sanitary conditions I found there, no phone in her room, no more phone calls allowed, no food (milk, orange juice, ice cream, fruit, snacks, etc) allowed in her room, not allowed outside for a year for exercise, no unlimited visits during day to go places, staff has been spying on mother and me, all missed medical and dental appointments for a year, including her dermatologist for ongoing skin cancer and now petition for only 2 visits a month instead of 12? How can he says he likes mother what he has done to her and denied her, plus putting me into prison where I could have been murdered. How would my murder benefitted mother? WTF? Mother's only "crime" she was convicted of is a little memory/instant recall problem, NOT a mental or behavior problem.

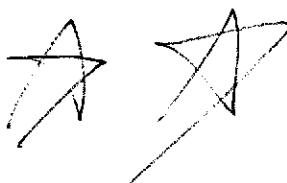

## blumer, fenstermacher go

Mr. Meitner,

Do I understand correctly that you had requested blumers to be at my eviction trial on monday and judge weilheimer refused your subpoena?

It is clear, neither fenstermacher and blumers are fulfilling their duties and obligations as court appointed guardians of mother's estate and of person. They do not care about returning emails and calls in a timely manner (if at all) to me and you, fenstermacher has refused to pay me back money that is owed to me, neither have seemed to have read the ledakis report #1 that says mother can live at home and because I have been there everything was fine, instead they (she) are wasting \$90,000 a year of her money in her tiny 1 room pig pen at manatawny manor, locked down in the mental section with people with mental and behavior issues for a year, has not been allowed outside at all for a year so far, (no reason given), not allowed to see her home and its possessions for a year, not allowed to have any social contact in the world (stores, restaurants, etc) for a year, she has been living in a sensory deprived place in basic isolation and solitary confinement for a year, no phone allowed in the room for a year, because of blumers, for 2 months, I have not been allowed to call mother or she call me under blumer's orders, they (blumers, logie) have refused her to have any medical appointments for a year, including her dermatologist because she has skin cancer, I am only allowed 1 hour visits 3x a week for a year by weilheimer (no reason given), no one (except me) has tried to find her a much nicer and cheaper place to live (I have), no attempt to find any drugs that would help her mental issues and never wanting to give mother more hours and days to be with me and enjoy the outside world. Their treatment of my mother is barbaric and inhumane. She and others in guardianships are only bank accounts to those criminals.

Out of a possible 6,100 possible hours I could have spent with mother (16 hour days) since August 25 2021 when mother was kidnapped, they have only allowed me 145 hours. As you know mother is 97.

As I informed you several months ago, I have been a legally ordained minister for over a year. Mother has the right, in the first amendment, to practice her religion. She has the right to be with her minister at all times and no limit to those times and places she wants to go with her minister. I am asking you to inform blumer of that and if he objects in any way.

he will have the ACLU or any other lawyer take legal action against blumer's law firm. They will have no defense if they deny my mother those rights, visits AND phone contact with her minister: me.

I have been punished for various things by weilheimer, jaskowiak and blumers with only accusations by them. They never proved any of them (including the ledakis report #2 where he claims the "staff" claims I always get my mother "agitated"). If ledakis shows up, I would want a 5 minute recess with you to discuss our questions before he testifys..

The best one is asking him since he was their one and only "expert" and mother has never been allowed in to testify for herself by jaskowiak and weilheimer, how does he feel about all of them (jaskowiak, blumers, weilheimer, camp and fenstermacher) completely ignoring his "expert" conclusion that mother, then and now, still does not need any special services for her daily care and she can still live at home with me as she had been before with no problems? A very important question is about jaskowiak and the letter. As you recall, jaskowiak said he saw mother, she said she likes the room, meals and some of the people. Mother always tries to be nice about things. As we have said, he is stating mother knows what she likes/wants. Therefore, if mother says she wants to go home, then that is what she should have. It also provides proof that mother knew what she was writing in her letter. But, ledakis, in his "opinion", does not think mother wrote it on her own in his report #2. As I have stated, why didn't he ask her to rewrite what she wanted to prove it one way or the other? Ledakis never did. Nobody has denied it was her handwriting. Petitioner and Movant, Arthur Herring, III, by and through his counsel, A. Victor Meitner, Jr., Esquire, files this Emergency Motion and Petition regarding the Eviction Hearing scheduled for October 03, 2022 and Petitions the Court for leave of Court to subpoena documents for use at the eviction hearing and to Compel the Guardian to bring Jane Herring to the Hearing *and* for an Emergency Conference with the Court and a Continuance of the October 03, 2022 eviction hearing to allow the Court, parties and all counsel sufficient time to receive and digest records requested by Mr. Herring and his counsel, so the parties and counsel may resolve certain issues raised in this Emergency Motion and Petition, and in support thereof avers as follow:

1. Petitioner and Movant is Arthur Herring, III, the son of Jane Herring, the incapacitated person.
2. Respondents are Jill Scott Herring, sister of Arthur Herring, III, Pam Blumer and William Blumer, the Plenary Guardian of Jane Herring's Person as well as Mrs. Blumer's counsel, and Person and David A. Jaskowiak, Esquire, Counsel for Jane Herring and Ronald Fenstermacher, Esquire, Guardian of the Estate of Jane Herring as well as Trustee of the Trust created for Jane Herring, which Trust presently has title to the real estate that is the subject of the Eviction proceeding.

3. A hearing on Respondent David A. Jaskowiak's Eviction Petition is scheduled for October 03, 2022, before this Honorable Court.
4. The Court has received a handwritten letter from Jane Herring, the incompetent person, regarding the Eviction matter and her desire to return to her home to live. A copy of the letter dated April 20, 2022, from Jane Herring has been provided to all counsel by Judge Gail A. Weilheimer's clerk via e-mail. The Court appointed Dr. Ledakis to opine on various matters before the Court, including the letter from Jane Herring and other matters before the Court.
5. The Letter sent to all counsel from Jane Herring clearly states the wishes of Jane Herring that, *"I want to go back Home to live. I need to be with my son, Arthur, who I love and he loves me. He has told me he is being evicted from my house. I do not want him evicted from my house... ..I want to be in court sometime so I can tell you myself what I want. Please help me so I can have these things."*
6. Movant, Arthur Herring, III, requests that Jane Herring, through her current Guardian, Pam Blumer, be ordered to attend the hearing of the Review Hearing and Eviction matter on October 03, 2022, and be permitted to testify as to her wishes regarding these matters before this Honorable Court.
7. Dr. Ledakis submitted a Reevaluation Report of Jane Herring on July 5, 2022. In the Reevaluation Report Dr. Lekakis references clinical interview with Jane Herring and others, review of medical records from Albert Einstein Medical Center and medical chart at Horizons at Manatawny Manor, records of Mevin Varghese, MC dated 10/18/2021, Progress note by Srinivasa Tirumalareddy, MD dated 10/08/2021 and Consultation note by Madiha Gilani, MD dated 10/08/2021, and various other tests performed by Dr. Ledakis, on Jane Herring on two (2) separate dates in connection with the preparation of his Reevaluation Report. Petitioner, Arthur Herring, III, believes that the Court will benefit from information contained in medical reports and documents being received by the Petitioner's counsel and the Court regarding the care of Jane Herring since the prior Guardian removed Jane from her residence on August 25, 2021, including past records of Dr. Kim Kuhar, records of Albert Einstein Medical Center, Worcester Township Montgomery County, Pennsylvania and Manatawny Manor, Pottstown, Montgomery County, Pennsylvania and other medical records in the hands of the Guardian, Pam Blumer and or Dr. Ledakis, which information, if permitted to be disclosed to

the parties, the Petitioner's counsel and the Court shall not be otherwise be disclosed nor publicized by anyone, and which records have been denied to counsel for the Petitioner, although requested by counsel on numerous occasions including a prior Motion and Petition to this Court. Such records were used by Dr. Ledakis in support of his Reevaluation Report and as such, counsel for Arthur Herring, III has an absolute right to review such records that form the basis of Dr. Ledakis' report.

8. Petitioner, Arthur Herring, III, requests that his counsel, A. Victor Meitner, Jr., Esquire, be authorized by the Court to Subpoena the following persons and documents for production to counsel and the Court as follows:
  - A. George E. Ledakis, PhD, to attend the October 03, 2022 or continued hearing in support of his report dated July 5, 2022.
  - B. That Pam Blumer, Plenary Guardian of the Person of Jane Herring be ordered to appear to testify and produce Jane Herring to testify as to her letter dated April 20, 2022 that was provided to the Court and in turn to all counsel, as well as her wishes to return to her residence at 26 Chancery Court, Souderton, Pennsylvania, and to allow her son Arthur Herring, III to live at the residence, and all matters before the Court regarding Jane Herring and her son, Arthur Herring, III as well as Eviction proceedings. Also allow the Subpoena of William Herring, Esquire to testify regarding his comments to counsel for Arthur Herring wherein he stated to counsel that the adjudicated incompetent, Jane Herring, had "the rights of a dog", and later directed expletives directly to Arthur Herring as follows: "you are the fucking problem" at a luncheon with Pam Blumer, A. Victor Meitner, Jr., Esquire, Arthur Herring, III and William Blumer, Esquire.
  - C. Permit and authorize counsel for Arthur Herring, III, A. Victor Meitner, Jr., Esquire to cause the issuance of Subpoenas for the medical and billing records and potential appearance before the Court as well as expense of keeping Jane Herring at Manatawny Manor of the following providers: Dr. Kim Kuhar; Albert Einstein Medical Center and its attending physicians; Manatawny Manor and the Guardian Dwayne Logie to produce for examination of counsel all records regarding Jane Herring's medical care, billing, diagnosis, treatment while under each of the respective parties care and that such Subpoenas issue immediately and that all records be produced to counsel in advance of

the hearing on October 03, 2022 well in advance of the continue date for such hearing and that such records be shared with all counsel for all parties before the hearing as produced.

- D. Order that the Subpoenas now requested by counsel, A. Victor Meitner, Jr., counsel for Arthur Herring, III, be issued by the Orphans' Court to require the attendance at the hearing on October 03, 2022 of the following persons and to bring with them their records of their treatment or other contact with Jane Herring; Dr. Kim Kuhar, Internal Medicine DO PC; Albert Einstein Medical Center, Montgomery and its attending physicians; and Manatawny Manor Assisted Living and Senior Care; 30 Old Schuylkill Road, Pottstown, Pennsylvania 19465, Deb Klock's records and;
- E. George E. Ledakis, PhD, to testify as to his report as well as all matters and records he reviewed as well as names of staff and others at Manatawny Manor referred to in his report dated July 05, 2022 as "staff" which are not named and are therefore anonymous. Also, testify as to many references in his Reevaluation Report on comments in his report. For example, references such as: "level of care needs"; "knows she needs care"; "intact basic language comprehension"; "stable emotional functioning"; "reports from Ms. Herring herself"; "probable Alzheimer's disease"; "Mr. Logie's expectation for Ms. Herring to remain in her own home with assistance as necessary"; "Mr. Logie's decision to have Ms. Herring move to live with her daughter Jill"; "medical advice and bring in sodium-rich, processed and surgery foods for Ms. Herring that contributed to her lower leg edema." while Mr. Herring has been informed that there are no such dietary restrictions; why "Ms. Klock did not get to meet with Ms. Herring until after she was moved to her daughter's home in August, 2021" and why "the trial attempt to reside with her daughter Jill was not going to work out"; "Ms. Herring will frequently ask about the purpose of the routine daily medications nursing staff are administering"; "Initial admitting diagnosis was acute kidney injury" to Albert Einstein and details from records on that admission from 09/13/2021 to 10/18/2021; **"He has told me he is being evicted from my house. I do not want him evicted from my house."**; and other matters contained in his Reevaluation Report.
- F. Order such other relief as the Court and the parties agree.
