1. Admitted in part. David A. Jaskowiak, Esquire is the Court appointed counsel for Jane T. Herring, however, it is denied that David A. Jaskowiak has in any manner discussed the filing of this Motion in any way with his client, Jane T. Herring, nor obtained her approval for the filing of the Motion, and further it is averred that if Jane Herring were asked that she would not approve of this Motion. It is also averred that Sanctions nor files will in any way benefit Jane Herring.
2. Admitted.
3. Admitted.
4. Denied as stated. Strict proof of each allegation is demanded.
5. Denied. Strict proof of each allegation is demanded. Respondent avers that the prior website referred to in this Motion and the prior Motion for Contempt did not in fact contain complete transcripts of the guardianship proceedings.
6. Denied as stated. Respondent was held in Contempt on December 15, 2021, but purged himself of such contempt by removing all references to his mother,

Jane Herring, from his website and was released by the Court after having done so.

7. Denied as stated. The Contempt proceeding regarding non-payment of the fine to pay other counsels fees regarding the Contempt proceedings is presently appealed to the Superior Court which matter is pending. All fines were paid by third parties. Respondent avers that he cannot be charged again for the same acts as found and or reported in the first Contempt proceeding. Such prosecution may be considered Double Jeopardy.
8. Admitted.
9. Denied. Strict proof is demanded.
10. Admitted.
11. Denied. Respondent has not reposted or failed to remove such materials from the internet. Strict proof is demanded.
12. Denied as stated. The original content was taken down by Respondent. Google archived some of the original material that was posted by Respondent but the transcript referred to by Movant was either taken down by Respondent or Google did not post the transcript. The other materials that were archived by Google Wayback Machine are not within the power of Respondent to remove or delete in that Google has sole control over what is archived, not the Respondent. Such objectionable materials are not on Respondent's current website. All references to how to access the prior article were removed by Respondent upon the advice of his counsel on November 30, 2022.
13. Denied as stated as provided in response in Paragraph 12 above. Strict proof is demanded.
14. Denied as stated. Respondent does not have control of what is posted on the Google Wayback Machine and to punish or sanction Respondent for the same postings again may constitute Double Jeopardy. All the material that was and is posted on the Wayback Machine is the same as the postings that were the subject of the prior Contempt proceedings, except that Google did not post the PDF transcripts of the Incompetency Hearing and such transcripts do not appear in the Wayback Machine.

- 15.Denied. There are no photos on Respondent's website. All references to Jane Herring do not appear on the current website. Any reference to the Wayback Machine site that was archived by Google, not Respondent, has been deleted upon advice of counsel on November 30, 2022.
- 16.Denied. Jane Herring's name is never mentioned on Respondent's current website. Any facts reported on the existing website of Respondent are facts that are being reported by Respondent and are protected under the First and Fourteenth Amendment as freedom of expression and of the press.
- 17.Denied. Respondent avers that no existing Order prohibits the Respondent from taking photos of his mother nor videos of her for his own personal use. No such photos or videos have been posted on the current website. Such video as referred to were taken prior to November 21, 2021. Jane is not referred to by name or as his mother at all.
- 18.Denied as stated. Respondent has not in any manner identified his mother by name nor as his mother.
- 19.Denied as stated. Respondent avers that member of the public would not be able to identify Jane Herring nor his mother as the subject of the writings. Strict proof is demanded.
- 20.Denied. Strict proof is demanded.
- 21.Denied. Strict proof is demanded.
- 22.Denied that the hearing was closed.???
- 23.Denied as stated. The test is not whether the alleged incompetent requested the hearing to be open. On the contrary, it is the burden of the incompetent or her counsel to request that the hearing be closed. Movant has misstated the statute and its intent. Jane Herring never appeared in person at her incompetency hearing. Check Transcript for request of counsel to close the hearing.
- 24.Denied. Strict proof is demanded.
- 25.Denied. respondent will use his best efforts to follow the Orders of the Court and has done so and will continue to do so, unless such Orders violate the

Constitution of the United States, its Amendments and/or the Constitution of Pennsylvania and its Amendments.

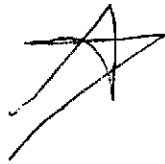

**ORDER**

AND NOW, this 16<sup>th</sup> day of November, 2022, the previous Order of this Court dated 10/7/21 regarding visitation is hereby **AMENDED** by agreement of the parties as follows:

1. Arthur Herring shall have supervised visits with his mother, Jane Herring, at Manatawny Manor three times per week for one hour each visit on Monday, Wednesday, and Friday at 11:00AM, 3:00PM, or at a time mutually agreeable with the supervisory personnel and Guardian of the Person on those days.
2. The individual supervising Arthur Herring's visits will be chosen by Pamela Blumer, Guardian of the Person.
3. The cost of the supervisory personnel will be paid by Arthur Herring by each Friday before the next week's visits.
4. The cost is \$25 per hour with a total cost for each visit, including travel, estimated to be \$75 per visit.
5. This visitation agreement will be in effect until January 16, 2023, at which time the parties shall advise the Court in writing whether this agreement shall continue or whether it needs to be modified.
6. The parties will make every reasonable effort to implement this agreement by November 21, 2022.

A NOTICE, AS REQUIRED UNDER RULE 4.6, SENT ON 11/17/2022

7. If supervised visitation can be arranged by the Guardian of the Person for holidays, the Guardian of the Person has the discretion to allow such supervised visits by Arthur Herring as well as visits by Jill Herring.
8. Unless otherwise modified as set forth above, the Order of October 7, 2021 remains in full force and effect.
9. The pending Petition for Modification of Visitation shall be held in abeyance while this agreement is in effect and all parties of rights shall continue without prejudice.
10. Failure of any party to comply with the terms of this Order may result in the imposition of sanctions, including a finding of contempt, monetary sanctions and/or incarceration if appropriate.
11. Counsel may request a review hearing to address modification to this visitation Order after it has been implemented for at least thirty (30) days.

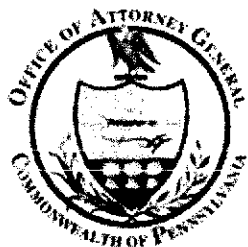

There is NO more reason, with both my money and my mother's money being wasted, to be jerked around by gelsinger, blumer and jaskowiak anymore.
