I'm copying Dave in on this to address your prior email and this one at once. In response to your request, Arthur is not permitted to take pictures of Jane.

As you know, Arthur's visit yesterday was outside the scope of the Court's Order for his visitation. He is permitted to visit Jane from 11:00 a.m. to noon. You requested, on his behalf, a modification for an earlier time yesterday and that request was denied. Notwithstanding that his request for a change of time was not granted, Arthur took it upon himself (perhaps at your recommendation) to go early. It is my understanding that Arthur arrived at 9:40 a.m. and told the staff at Manatawny Manor that Pam had agreed for him to visit Jane alone in her room. As Arthur knew, this is false. Brandy arrived at Manatawny Manor at 10:30 a.m. and found Arthur alone in Jane's room with the door closed. Arthur initially refused to allow Brandy into the room.

The issues at Arthur's visits with Jane, that Brandy has supervised, are numerous, repetitive, and in violation of the Court's Orders. Among other issues, since supervised visits began, Arthur continues to talk to Jane about the guardianship proceedings; videotape/photograph Jane; and talk to Jane about his efforts to take her home. These kinds of behaviors were the reason that supervision was put in place in the first instance. But Arthur's continued actions only serve to show that supervision is necessary and further action may be needed to ensure his compliance with the Court's directives.

As I said, before, we are not able to accommodate Arthur's request for a Christmas visit with Jane.

Mr. Meitner,

I will never be bullied or intimidated by a bunch of barabric and inhumane thugs calling themselves "guardians" and lawyers for guardians. They have totally ignored my mother's medical needs of doctor's appointments for over 16 months, mental needs for both her memory issue and her son being able to have him with her and to talk to him anytime she wants in private, physical needs of exercise, financial needs of not having her money wasted by blood sucking leeches who only make money by sending emails to each other of lies about me and useless court appearances, (instead of on mother's welfare and happiness) and finally allowing her to enjoy her life while she still can.

Since November 2021, mother's leg problems have been totally ignored by them, NOT me. Her leg condition has been blamed on me by logie, zabowski, blumers and now gelsinger. They have all claimed the food I used to bring her for lunch only 3 times a week made her legs swollen, while totally ignoring the prepared, fatty and high sodium food she is given 20 times a week since October 2021 at Manatawny Manor. NOW, as of December 20, 2022, their claims have been proven totally false because I have not brought her food for almost a month to eat, the same food and snacks that she used to eat all the time and had no problems with them. In the past several month, her legs have been getting worse and much, much weaker. In the course of a month (about mid November 2022) her walking has gone from normal, to smaller steps, to shuffling to where she needs a person to hold her up so she doesn't fall. For about the last 2 weeks, she needs a walker to help her walk and balance. She says her left leg is weak to very weak at times. For many, many months, nobody has put her TED socks on every day as they were told to to control the swelling since last November, according to the house doctor. On Friday, December 16 2021, I saw a cantelope size lump on her left leg. I told Kessler (director) about the lump and I went to the E. Coventry police to file an incident report. On Saturday December 17, 2022 I contacted the Elder Abuse Hotline and reported the lump as an emergency. So, none of her "owners" think she should have a phone in her room to call them if she has a problem or for them to call her for a check? Really?

As you know, the first guardian, logie, was only concerned about getting money, a "care manager" and a lawyer at mother's expense. He did nothing for her in any way. Jill's

and logie kidnapped mother: taken away by force, against her will, for monetary gain on August 25, 2021. Jill kept mother at her house in solitary confinement and refused to allow mother to call me or talk to me at all for 2 weeks. That night, logie sent me a eviction notice of 30 days to move out. According to reports jill starved mother for 2 weeks to the point mother had to be taken to the hospital by ambulance, confined to bed for 6 weeks, daily blood tests and needles in her stomach, then she got covid. Logie then Logie then sent mother to a low rated nursing home, that had just opened up after a months long covid shutdown. Mother would later get covid again and then influenza. For 16 months now, mother has been in a locked down mental ward, with people with mental and behavior issues, basically in solitary confinement, existing in a sensory deprived life, no phone, no doctors appointments for 16 months, not allowed outside for 16 months and not allowed to mingle in society. Mother is paying \$90,000 a year for a tiny pig pen, with old and broken furniture, dead mouse (mice?)e on the floor, stained bed sheets, sheets missing, torn bedspreads, etc, when she could be living in her \$450,000, 3 bedroom, 3 bath house in a gated community. No reason has ever been given by any of mother's "guardians", their lawyers or "care manager" Deb Klock hired by logie (for unknown) reasons. Her own court appointed lawyer, jaskowiak, has only seen her twice since mother was put into the pig pen. Does jaskowiak really think she belongs there? According to documents, mother had about almost \$2 million in her account. She certainly could live at a much, much nicer place, like home, where I would be there to make sure everything was fine. At trial, jaskowiak never defended her and never brought in anyone (doctors, financial investors, bills, etc) to prove mother did not need a guardian.

The fact is, the court's own hand picked "expert", Ledakis said she had no problems with normal daily activities in June 2021 (still can do all daily activities), can stay at home and with me there everything is working fine. So why has judge weilheimer, jaskowiak (court appointed lawyer), camp (jill's lawyer), logie, pam and bill blumer and now gelsinger refuse to follow ledakis's firm advice? Has fenstermacher, mother's court appointed guardian of estate, ever read the ledakis conclusion so he can stop wasting mother's money on Manatawny Manor when she could be living at home for basically free? How come ledakis never asked why is mother forced to live like she is now against his advice?. Those same people heard me in court in july 2021, destroy ledakis's "evaluation" as being no better than a coin toss. Ledakis also said in his report, it was only his opinion, not fact. Fenstermach, in about November 2022, said the house should be sold and me evicted (contrary to mother's wish for me to live there free) but, also admitted he has not talked to her for 2-2.5 years. WTF? Jaskowiak and others in the gang also refuse to ask mother, in front of everyone concerned, what SHE wants. Why? I thought a lawyer was supposed to do what his client wants? It was all part of the plan of stealing from mother. Such scum!

It has been obvious from the start that because I did not want to go along with the scam on mother (jill started it and is happy with it) the focus has been on demonizing me to keep mother and I separated, both as a punishment to me and mother and for their sick pleasure. The phone calls twice a day, for many months in the beginning, were cut off by pam blumer about 6 months ago because she claimed the staff said every time I called or visited, I got mother "agitated". But, no one ever asked mother if I did. Why? Even now (December 20 2022, with this so-called brandi (who was picked by pam blumer at \$205 a week paid by me) who is there, sitting 3 feet from us to see if I get mother "agitated". Before, logie and blumer got the staff to do it for free by listening at the door, on our phone calls, and through the intercom.

The deal I am being forced to accept or I will go to prison is mother's trust will pay for my apartment (reasonable cost) and I move out ASAP. Fenstermacher claims all the furniture will be kept in storage and paid by mother. BS. Does that idiot and crook know how expensive that will be? I will not have a house again to keep any furniture and jill does not like or want any of the items for her house, so the items would have to be sold to a auctioneer for only pennies. In the meantime, mother will only have a tiny room to live in. BS! Why doesn't fenstermacher ask his client, mother, what she wants. Fenstermacher is totally ignoring his responsibilities and obligations as a guardian.

You have to call Lobach (senior partner at Barley) and tell him for gelsinger to cut the BS delays and lies. Gelsinger is not doing anything to help mother or to solve problems. He just keeps liabling me with insults and lies.

I will not sign any deal until mother is in a very nice nursing home. If that means jail tomorrow, then other things will happen that will expose this scam in various ways and others will have their lives ruined. They will go to jail for many, many years and all of their assets will be taken by law suits and IRS. Nobody knew I went to the DA cop Shade until he told weilheimer and the others. He completely ignored the confidentiality of a informant and has put my life in serious danger. Nobody knows I went to the FBI, except you. Maybe

Pacchio told them also. Nobody knows that if I do go to prison and I do not make 2 calls to different people tomorrow by 6pm, many things will happen that will expose the scam and the people in it, including my sister.

My deal is as follows. If I go to prison, I will not drop the appeal of eviction. If it is denied, then that is my bad luck. If I cannot see my mother during the time I am in prison, then that is what happens by other's criminal actions. If I do not go to prison, I will move out 90 days AFTER mother is in a very nice place. That will give me time to find a nice place that will be paid for from mother's trust as explained by you. There are several other mobile home places in Quakertown for me to look at.

I have taken pictures of everything in the house. Mother can pick out the furniture, paintings, etc for her room. The other items she likes, can be stored in a climate controlled storage paid for by mother. She will be able to see the things she cherishes. I will bring her things to her when she wants them, like photo albums, etc. I demand monday, wednesday, friday and sunday all day to be with mother, take her to her previous doctors, etc. She will have a phone in her room and a medical alert necklace. Why hasn't blumer given her one after 7 months and 2 falls? If sister wants to see mother, she has her 3 days a week that she very rarely uses since last year. After mother picks her favorite items, jill can take what she wants, to a limit. She is the type of person that will demand everything just to start fights and use lawyers to make it too expensive for me to fight. I had a very nice room at Arbour that saved mother \$60,000 a year. I held for 2 months but they ignored it. There is a smaller room there, but who knows how long that will last. I bet Blumer will deliberately stop any place that does not lock mother in a mental ward just to please jaskowiak.

I'm copying Dave in on this to address your prior email and this one at once. In response to your request, Arthur is not permitted to take pictures of Jane.

As you know, Arthur's visit yesterday was outside the scope of the Court's Order for his visitation. He is permitted to visit Jane from 11:00 a.m. to noon. You requested, on his behalf, a modification for an earlier time yesterday and that request was denied. Notwithstanding that his request for a change of time was not granted, Arthur took it upon himself (perhaps at your recommendation) to

go early. It is my understanding that Arthur arrived at 9:40 a.m. and told the staff at Manatawny Manor that Pam had agreed for him to visit Jane alone in her room. As Arthur knew, this is false. Brandy arrived at Manatawny Manor at 10:30 a.m. and found Arthur alone in Jane's room with the door closed. Arthur initially refused to allow Brandy into the room.

The issues at Arthur's visits with Jane, that Brandy has supervised, are numerous, repetitive, and in violation of the Court's Orders. Among other issues, since supervised visits began, Arthur continues to talk to Jane about the guardianship proceedings; videotape/photograph Jane; and talk to Jane about his efforts to take her home. These kinds of behaviors were the reason that supervision was put in place in the first instance. But Arthur's continued actions only serve to show that supervision is necessary and further action may be needed to ensure his compliance with the Court's directives.

As I said, before, we are not able to accommodate Arthur's request for a Christmas visit with Jane.

All, No photos nor videos will be taken until approved. Arthur had to go to Court yesterday and brought Matt Vanderhoff to Court so he went a little early, and left early spending only one hour with Jane. Arthur was not there at 9:40 a.m. You can check the computer login and it will show about 10:25 or 10:30 a.m. Arthur is permitted that one hour with Jane and checkin, temperature taking etc. does not count towards visitation time. Mr. Meitner,

I am sure you understand how angered and disgusted I am now and have been for over 18 months about what those corrupt lawyers, judge, guardians, psychologists and my sister have done to my much loved, 97 year old mother. This must be done now before the damage to my mother, physically, mentally and psychologically does not go where it is irreversible by her simply going back home with me taking care of her or to a much, much nicer place to live. Not even fenstermacher cares about his client that he had admitted in court he last saw or talked to her about 2.5 years ago. He said in court several months ago he wants the house sold, possessions junked and me evicted, without ever asking her what she, his client, wants. He has totally disregarded the the obligations and responsibilities as a guardian of her estate. All of mother's current guardians must be removed and sued for their actions and neglect of mother..

Her life is at stake and my love for my mother will be lost if she dies or brain dead.

Petitioner, Arthur Herring, III, by and through his attorney, A. Victor Meitner, Jr., Esquire, hereby states the following:

1. Petitioner is Arthur Herring, III, who is represented by A. Victor Meitner, Jr., Esquire as his counsel and attorney in fact.
2. Arthur Herring, III is confined at the Montgomery County Correctional Facility, 60 Eagleville Road, Eagleville, Montgomery County, Pennsylvania 19403, and the Warden of the facility is Sean P. McGee.
3. Arthur Herring, III is currently being held by Order of Judge Gail Weilheimer, Judge of the Court of Common Pleas of Montgomery County, Pennsylvania, Orphans' Court Division pursuant to an Order of Court dated December 21, 2022, which Order is attached hereto as Exhibit "A" and is currently serving a **SENTENCE** of seven (7) days.
4. The Order is in error in that seven (7) days ends on January 2, 2023, not January 3, 2023, as is stated in the Order.
5. By way of background, the underlying above-captioned case pertains *inter alia* to the Court's prior adjudication of Petitioner's mother as an Incapacitated Person, assigning Counsel and Guardians for Petitioner's mother's Person and Estate who, along with the Court, have made certain findings as to the Incapacitated Person's living conditions, level of care and the degree to which Petitioner may see and interact with his mother.

6. David A. Jaskowiak, Esquire, Counsel for Petitioner's (Incapacitated) mother, filed a (Second) Contempt Petition¹ alleging that Petitioner had violated the previous Court Order (finding Contempt) regarding posting private information about his mother (in the form of posting a link to his former website that had been archived by Google and was no longer under his control) and posting a somewhat allegorical narrative of the underlying case largely without identifying names but enough information, according to Mr. Jaskowiak and this Court, to allow someone – whoever would be so inclined – to 'connect the dots'.
7. Undersigned counsel for Petitioner filed responsive pleadings that, if this Contempt proceeding could lead to incarceration as the first Contempt proceeding had, then it was actually a criminal proceeding in nature and, therefore, Petitioner had a constitutional right to trial-by-jury, which the undersigned requested out of an abundance of caution.
8. This Court, at the opening of the first of two (2) days in this contempt matter, indicating that this matter was a civil proceeding, thereby rendering the demand for a jury trial indicated in Petitioner's response to the Second Contempt Motion moot, since this was not a criminal contempt hearing.
9. However, after the second and final day of the Contempt Trial, this Court indicated that what had just concluded was a Trial on *criminal* contempt and sentenced Petitioners to incarceration rather than a fine and without any method for Petitioner to purge himself.²
10. Accordingly, the Petitioner, Arthur Herring, III, was denied Due Process.
11. The Contempt finding by the Court was based upon: (a) the Petitioner inserting the above-referenced link to an archived website not controlled by the Petitioner and; (b) for admitting that he had taken a photo (or perhaps a video) of his mother during a nursing home visit prior to being sentenced to

¹ Mr. Jaskowiak's first Contempt Petition against Petitioner was adjudicated just over one (1) year ago. Petitioner (*pro se* at the time) was sentenced to six (6) months confinement for Contempt but was able to purge the Contempt within a few days by having his (former) website taken down, a site which Mr. Jaskowiak and the Court deemed to contain personal information (in the form of court transcripts, narratives, etc.) about Petitioner's mother, to which the Incapacitated Person's Guardian(s) did not consent.

² Well before the (second) Contempt Trial, in response to Mr. Jaskowiak's allegations, Petitioner voluntarily took down – not only the material objected to by Mr. Jaskowiak – but any material that could remotely be construed as related to the underlying case.

prison in December, 2021 on the previous contempt petition for the same photograph and; (c) other postings about his mother in violation of the Double Jeopardy Clause of the Fifth Amendment to the United States Constitution and the Constitution of Pennsylvania.

12. The Contempt finding was also for posting an internet article that did not mention his mother or sister by name, but which the Court stated actually did identify details about his mother that would enable those reading the article to know that the person referred to was in fact his mother assuming they had the ability and wherewithal to cross-reference court dockets, etc.
13. The mere posting of facts without referencing the name of the person did not violate the Court's prior Orders. Such restrictions imposed by the Court also violate the Petitioner and his mother's rights of Free Speech and Freedom of the Press under the First Amendment to the United States Constitution and the Pennsylvania Constitution.
14. Further, the Court violated Petitioner's Sixth Amendment rights under the Pennsylvania and U.S. Constitution by denying Petitioner's right to examine/cross examine his accuser, David A. Jaskowiak, Esquire, counsel for his mother.
15. Petitioner had the right to cross examine Mr. Jaskowiak because the allegations were construed as "fact" were coming directly from Mr. Jaskowiak himself. In other words, Mr. Jaskowiak did not file this (second) Contempt matter on behalf of the Guardian of the Incapacitated Person (nor did he even bother to attach a Verification by the Guardian), a person who the undersigned clearly would have had the right to cross-examine or the right to examine the person who filed the Second Petition For Contempt, namely, Mr. Jaskowiak.
16. This Habeas Corpus Petition challenges the validity of the Contempt proceedings, the conviction and the sentence imposed for all the reasons explained above.
17. Petitioner requests that the Sentence imposed against him and the finding of Contempt be dismissed and discharged and that he be released from incarceration immediately.

WHEREFORE, Petitioner respectfully requests that the Court hold an immediate hearing on this Petition with notice to counsel for the Petitioner and that a Rule To Show Cause why the Warden should not produce the Petitioner for a hearing before the Court on this Petition should not issue immediately and a hearing be scheduled on this Petition within three (3) days of date of filing of this Petition, or in the alternative, that the Petitioner be released pending a hearing on this Petition and all subsequent appeals of the Order and Sentence of the Court.
