Ms. Camp,

As I am sure you are aware, last week I sent my sister a email similar to the one I sent you in December 2021 about she and I having our mother live as a human being at 96, instead of like a homeless person or a caged animal. Your client's reply to my email was very strange, to say the least.

I do not care at all about her feelings of obvious hate towards me. She has never wanted me to be a part of her life. My only desire, since day 1 at the petition hearing to now, has been about the health, welfare and happiness of Mother. The various guardians and their lawyers assigned to Mother have totally disregarded those needs and requirement of Mother. Instead, they have only cared about getting as much money out of Mother as they can. The results, by their "ownership" of Mother since August 2021, says everything of how little (if at all) they cared about Mother, her life and happiness. Facts do not lie.

As you are aware, Manatawny Manor costs about \$90,000 a year and is only a very low rated, disease infested "pig pen". Mother has been forced to live in a very tiny room, with old furniture, tattered blankets, stained sheets and towels, she is basically living in solitary confinement, in a locked down mental ward with people with mental and behavior problems, has no access to magazines or newspapers (except the ones I give her every visit since she was in the hospital in 2021), no phone, no TV channels she used to watch of old movies, denied her regular visits to her various doctors for about 15 months, has very swollen legs that have not been treated correctly since November 2021, has not been outside at all for about 15 months, she has not been allowed to go home (as the court's own "expert" Ledakis said she could with me there), only one hour visits with me 3 times a week, was recently denied Christmas and Thanksgiving with me (no reason given) or go home daily to see and enjoy her loved possessions before she dies. Why? In case you have not been there, there is no place in her "pig pen" to store anything from home. Most everything she has must stay on the floor in plastic bags. I have given Mother many things that the staff and others have stolen. The various lawyer and guardian fees have not been earned, just taken as part of the scam on Mother. Those fees are well over \$100,000 and climbing daily. When Mother dies, your client would have been given 50% of what those people and the nursing home took. Why would your client want to lose all of that money?.

For the sake of Mother's happiness, health and financial benefit (money that she may need at some point after a stroke, for medical needs or for daily personal care) let's work things out and stop this constant BS with lawyers and court. Mother has received absolutely no benefit, in any way, so far by the ways things have been done by her various "owners" since they were "hired"..

Your client must agree to certain things in order for her and I to over ride the greed and incompetence that the guardians, their lawyers and Jaskowiak have been doing for their own financial benefit, not for mother's health, wellbeing and happiness at 97. Your client's decisions will decide if she will get hundreds of thousands of dollars when Mother dies or no money because the money will have been taken by those people just named. It's her call.

The answer is simple and free. Mother comes home. I live there as a live in helper and also because she wanted me there a year before the petition was filed. Since Logie sold her car, I will be using mine and paying for the gas, repairs, insurance, etc. I will pay 50% of the yearly house operating costs that were accepted as \$16,500. Mother can enjoy her house and her life again until she dies and in the meantime, the house does not lose any value, since there are always people who want to buy the house. Mother has one of the 7 biggest houses in the gated community. Living at home will save Mother \$90,000 a year. I would take mother to her doctor's appointments. If your client wants to see mother, any day or time, she tells you, you tell Mr. Meitner and he tells me. I will drop mother off at the mail room and pick her up there. That way, your client does not have to see me. There is no need for guardians who have done nothing, but make money for themselves. Any other issues can be solved easily for mother's benefit by Mr. Meitner and you, not just your client demanding it be her way, as she expected using her petition.


As long as those guardians, their lawyers and Jaskowiak use mother as their personal bank account, but ignore her health, welfare and happiness, I will continue to defend Mother and protect her. The money that will be wasted by those guardians and lawyers will be your client's loss and her fault for not settling things the easy way, very economical way and most important, the best for Mother.

Mr. Meitner,

Reasons for more and longer visits and Sunday for Mother and me:

1. I make her happy.
2. Mother and I enjoy each others company.
3. I will make her feel she is normal again in the life she was living by her being in the real world.
4. Mother was living happily in a large 3 bedroom, 3 bathroom house, in a private gated community for 21 years with all of her loved possessions that she enjoys looking at, including all of her many photo albums of vacations and her family growing up.
5. She has done nothing wrong to anyone be kept caged like a dog at the animal shelter.
6. I will take her to all of her doctor's appointments like she was always going to for decades.
7. I will take her to the hospital for tests on her legs and for a CAT scan she never had when she fell months ago on the newly waxed floor in her room
8. There is no reason why she is kept locked up 24 hours a day, for about 15 months like a dangerous criminal until she dies. Nobody ever said she has mental problems or is a threat to herself or others.
9. Mother still does not need any special services: dressing, undressing, bathing, toilet, eating, hygiene. Everyday she still makes her bed like she always has perfectly.
10. Mother trusts me. A month ago she refused her flu shot until I told her it was OK.
11. While I lived at the house for over a year, we would eat breakfast, lunch and dinner together.
12. Since my father died in 2013, mother and I had dinner every day at her house and we watched old movies at night. Then I would go home.
13. Every night, she would cook dinner and I would wash the dishes after dinner.
14. At least several times a month I would buy her roses.
15. Every month since my father died, I would give her a dozen roses and we would go to the cemetary and put them on my father's grave and her mother's grave and her

- grandparents grave on the other side of the grave stone. I would then take her to dinner.
16. Several times a month we would go out to lunch or dinner. I always paid for it
 17. If the weather was bad, I would always take her to her various doctor's appointments and usually go to lunch or dinner.
 18. She had wanted me to stay in the upstairs bedroom ever since my father died for company and to save me money from paying rent. she put it in writing.
 19. She depended on me to keep things going well, like car repairs, house repairs, shovel snow, etc.
 20. She never had to take anti-depressants with me.
 21. She was never starved by me like she was with sister.
 22. She never had to go to the hospital because of passing out from starvation.
 23. She never had to worry about me stealing money from her or trying to.
 24. I never made her so upset that she was shaking and crying and saying I want to go home.
 25. The last 5 years when she went to her primary care doctor, she wanted me to go into the room and be a part of the discussion AFTER the personal examination was over.
 26. At MM, we always enjoyed having lunch together and talking about private matters.
 27. I never asked her for money or tried to steal it away by using Fenstermacher.
 28. When she was in the hospital because of starvation, I saw she was not eating her food because it was cold and the taste was bad. with the doctors permission, I would bring her food every day to eat.
 29. I saw she did not have her glasses from sister's house after being kidnapped. I went to her eye doctor and bought her a new pair and paid for them.
 30. At the hospital, everyday I would bring her roses, ice cream, her special milk, food, newspapers and magazines for her entertainment. I had to pay \$3.00 per newspaper because logie canceled the subscription of the paper she got for 70 years.
 31. More visits all day and Sunday means mother can go home to see her home of 21 years, her loved possessions of 95 years, go to restaurants, more exercise, more mental activities to keep her mind active.
 32. Mother's QUALITY of life is almost nothing since she has been under their control.
 33. She wants to go to New Hope, Peddlers Village and the cemetery that we used to go to every month with my roses for my father's grave and her mother and grandparents.
 34. I have been on time on every visit and have NEVER missed any of my 1 hour 3x a week visits unless they were canceled by a guardian or I was in prison.
 35. As of January 1, 2023, out of a possible 7,610 possible hours (16 hour days) I could have been with my mother, the guardians Logie and pam blumer have only allowed me 190 hours.

36. On every visit to her, I bring her roses, newspapers, magazines, gifts for her happiness.
37. I always provided her with various items she needed for her room.
38. Only I got her a refridgerator for her room shortly after she was dumped at the pig pen so she have foods to eat that she liked when she wanted it. Neither her guardians or her daughter did. I bought her no slip socks so she wouldn't slip and fall again and maybe break her hip or have a concussion.
39. When we used to have lunch together, I would always make it a treat by buying her favorite sandwiches, desserts, ice cream and her special milk.
40. I keep trying to get her a medical alert necklace for her safety that Logie canceled after he and sister kidnapped her.
41. I have tried for 15 months to get her a phone in her room so she can call me, her friends or for help. Why is she being isolated from the world?
42. With more visits and times, mother and I can have private conversations about any issue or problem that she has not been able to do since she was kidnapped on August 25 2021.
43. Every week she would go to the hairdressers again like she always did before she was kidnapped. It would make her feel like a woman again. She very rarely is taken to the hairdressers by her guardians since August 2021.
44. None of her doctors, friends, maid or hairdresser has ever said anything bad about me. In fact they have always said how much mother loves me and brags about me.
45. Of course it would cause mother extreme pain and suffering if she was told she would never see me again until she dies. Should everyone with a little memory forgetfulness or confusion once in a while be kidnapped and put in a dungeon until they die, isolated from their loved ones and never see all of their loved possessions ever again because they will be trashed?
46. I find the problems and issues nobody else does and see to it or try to see to it they are corrected.

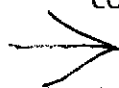

RESPONSE OF ARTHUR HERRING, III TO COUNSEL FOR JANE
HERRING'S MOTION TO STRIKE THE CONCISE STATEMENTS OF
MATTERS COMPLAINED OF ON APPEAL FILED BY APPELLANT
ARTHUR HERRING, III WITH THE SUPERIOR COURT

Arthur Herring, III by his counsel, A. Victor Meitner, Jr., Esquire hereby responds to David A. Jaskowiak, Esquire's Motion to Strike Arthur Herring, III's four (4) Concise Statements of Matters Complained on Appeal filed with the Court on January 9 and 10, 2023 by the Appellant in the Superior Court presently pending in the Superior Court and avers the following in response to Mr. Jaskowiak's Motion To Strike:

1. Admitted. There are the four (4) appeals filed on January 9 and 10, 2023 and an addition appeal filed on January 18, 2023, and appeal from the Order dated December 21, 2022 holding Appellant in Criminal Contempt for a total of five (5) appeals now pending in the above matter in the Superior Court.
2. Admitted. There is also presently a fifth (5th) appeal recently filed.
3. Admitted that the Court did grant an extension of time and that Concise Statements of Matters Complained on Appeal were timely filed.

4. Denied. Each error complained about is separately numbered and identified as well as identified in the Transcript if a hearing was held.
5. Denied. Each error is properly identified as to pages in the Notes of Testimony where error was cited to have occurred in an effort to allow the Court to know exactly what matters and testimony and which Rulings of the Court were to be found. In an abundance of caution where Appellant was not able to understand why the Court ruled the way it did on evidentiary and other matters, the Appellant properly stated where he was not able to discern the basis for the Court's rulings. There has been no violation of Rule 1925 (b) (4) (iv) and there is no redundancy as each specific error is identified is adequately described, is not frivolous and simply because numerous errors are cited is not grounds for waiver.

The Respondent objects to counsel for another person, the alleged Incompetent in this situation and case in substituting himself for the Superior Court who if it wishes clarification or does not understand what the Appellant is stating as an error, it is the place of the Superior Court, not other participants in the case, to return the case to the lower Court for clarification or to dismiss the appeal/s. In this matter, no such action has been sought by the Superior Court and as such, counsel's interference in this appeal is out of place and violative of Rule 1925. These matters have been appealed and only the Superior Court may rule on the matters raised on appeal.

6. Denied. Appellant has not waived any matters and all matters raised or reasonably inferred from Appellant's appeals and Concise Statement of Matter Complained on Appeal are preserved.
7. Denied. The other matters at appeals 2, 3, and 4 were matters that were determined by the Court without hearing nor transcript and the Orders were not sufficiently stated or explained to fully inform the Appellant why they were denied. For example, when the Appellant filed a Motion For a Hearing and appointment of new Guardians as provided for in the Statute and cited reasons therefore as well as suggested a competent replacement and qualified Guardian for the Person and Estate of the Alleged Incompetent, the Court simply denied a hearing, called the application frivolous and dismissed the Petition without sufficient reasons or explanation. The Appellant is not sure why the Court did not at least grant a hearing on the matter to see if there were sufficient cause to appoint new Guardians. In the same manner and without hearings the Court also refused to recuse itself, did not allow Appellant nor

counsel to have witnesses and records to be subpoenaed and/or to appear and as such the denials and Orders ruling on the same were reversible error. These errors and Orders and the appeals on them have not been waived in any manner by Appellant.

8. Denied. When Orders are entered without hearings nor the ability to be heard by the Alleged Incompetent, by her son, while a letter from the Alleged Incompetent was received by the Court and entered into evidence by the Court, when Motions have been properly filed in advance of the hearings seeking appearance and testimony by the Alleged Incompetent of her wishes regarding Eviction, the denial of such Orders are appealable, have been appealed and are matters to be determined by the Superior Court after the lower Court Judge files Opinions on each matter. In addition, the Motion filed by Mr. Jaskowiak is not in the best interest of his client, likely filed without any consultation or approval from his client and against the Alleged Incompetent's express wishes as enumerated in her letter to the Court.
9. Denied. Each error complained about by the Appellant is sufficiently detailed but yet concise and states each and every matter and ruling that appears in the Transcripts (where there are transcripts and hearings) by describing each error that the Appellant wishes to assert "with sufficient detail" under 1925 (4) (ii). This Motion seems to pit each part of Rule 1925 against the other while the entire rules and the purpose and spirit of the rule is what should control. The purpose of the Rule is to provide the Lower Court with sufficient basis to understand what matters the Appellant claims as error and permit the Court to have sufficient information to write an Opinion. As earlier stated the Movant, who is not an Appellant, seeks to insert himself into the position of the Superior Court and seeks to have these Concise Statements and appeals dismissed by him. Rule 1925 places the burden upon the Lower Court to write an Opinion in support of its Orders as is stated in Pa.R.A.P. 1925 (a).
10. Denied as stated. The Appellant respectfully suggests that if the Court cannot understand the errors stated by Appellant in his Concise Statement, then, the Court, not Movant, may state that in its Opinion. If the Superior Court wishes to remand, it may do so.
11. The Appellant has preserved his claims for appellate review in accordance with the Rules of Court and Appellate Review as well as applicable case law. There are many cases including those cases cited by Movant that interpret Rule 1925 over the years. The current Rule 1925 which is current as of April,

2022 sought to clarify not muddy the waters as to what is required of the Court and Appellant, otherwise matters not raised are waived. In every case cited by the Movant and others located by Appellant, it was the Superior Court who determined if Matters Complained of on Appeal were sufficiently stated or not.

- 12.Appellant's errors complained of on appeal are not redundant, state specifically and refer to matters on the record or Order filed and Docketed and as such the Court must write an opinion on the appeals raised and filed in Superior Court.
- 13.Appellant's Concise Statements fully meet the requirements of Rule 1925 which must be read in its entirety and not be taken out of context.
- 14.Denied. Conclusion to which no reply is required.

**NEW MATTER AND REQUEST/APPLICATION BY APPELLANT FOR
COUNSEL FEES FROM DAVID A. JASKOWIAK, ESQUIRE (not Jane Herring
or her Trust or Estate) FOR FILING OF A FRIVOLOUS MOTION**

- 15.The Motion To Strike Appellant's Concise Statements of Matters Complained on Appeal is frivolous since such Motions Are not provided for in the Rules of Appellate procedure and has caused the Appellant counsel fees and expense to respond, which Appellant respectfully requests the Court to award to the Appellant for the actual time spent by Appellant's counsel in Responding to the Motion and preparation of a Memorandum pertaining thereto.

WHEREFORE, the Appellant, by his counsel, A. Victor Meitner, Jr., Esquire, respectfully requests this Honorable Court to dismiss the Motion To Strike the Appeals and award Appellant reasonable counsel fees to his counsel to be paid by Movant.



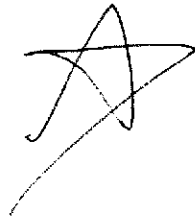

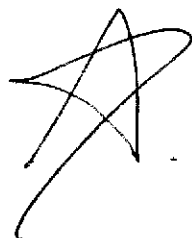

Agent Pacchioli,

Something extremely scary happened to me today about 1pm. About 4 months ago, I contacted the Montgomery County detective bureau about the corruption of certain judges and lawyers involved in the guardianship scam in the orphans court. I may have told you about my contact with them and that is why I went to the FBI.

I talked to Det. Shade. We spoke for about 2 hours and I gave him some documents. He had another appointment and he said he would contact me later. I told him there were many other people who wanted to call him and tell him their experiences with those same judge, guardians, lawyers and psychologists. I left.

I contacted you shortly after that because I was not sure if the DA office handled corruption of judges. After about 2 months, I had many calls from people who said Shade never called them back. At a hearing pertaining to my mother, I was informed that Det. Shade and the DA office were going to prosecute me for violation of the wiretap laws. As I had told you, my 97 year old mother is under guardianship. As I understood it, Shade was claiming I did not get the guardians permission before I supposed to have taken video or pictures of my mother. I never heard from Shade or the DA office after that.

As you are aware, I have found a lot of corruption, as others have, with certain judges, lawyers, guardians and psychologists involved in the orphans court in Norristown because of my mother's guardianship scam. The corruption has been documented for about 20 years. Because of that, I went first to the DA office to file charges against those people and later to you.

Today, I contacted Det. Kelly, who I was told was in charge of internal affairs matters. He told me Shade had retired. I was quite disgusted because of the seriousness of this matter to me and to others that Shade had decided to ignore giving the case to another. I told Kelly I wanted to talk to him about filing charges against Shade. He then asked me if I liked prison. I said "what"? Kelly asked me again if I liked prison. I asked him sarcastically was this a survey, He proceeded to tell me he knew I was in prison because of me being convicted of contempt of court for posting a video of my mother. I told him I never posted any video. I explained to him what the contempt of court charge was about. He then said I was arrested

for wiretap violations. I told him I was never arrested for that. He then said I was arrested but, never charged. He claimed I was just mad that I did not the judge's decision.

He then went on saying several times, very firmly and very loud, that his strong advice to me was I could come in to file charges against Shade, but I would then be arrested for the wiretap violations. He said that several times very loud. I kept saying "Are you threatening me" several times. He never answered my question.

He made it extremely clear that if I filed charges against Shade, I would be arrested for some made up wiretap violations. I believe firmly that he was threatening me and trying to intimidate me against filing criminal charges against a friend he had worked with and because he would be punished in some way for opening a case against judges.

I wanted this to be known to you.

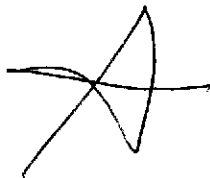

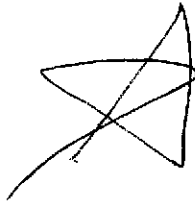

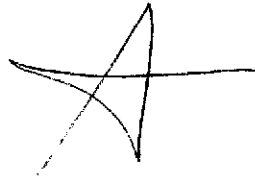
