jaskowiak- Are you out of your perverted mind?

Jaskowiak did not pursue contempt because I exposed his star witness, Mary ellen (monitor) as a fruit cake and a liar. He had based his whole case on her. Because they had such training. I asked mary ellen that question and she said none. She did not want to even say what type of nurse she was until sterling told her to. She was only a nurses aid, not any RN or close to it. She also admitted, she was not paid just for the 1 hour she was with us, but also for 5 hours, during each visit. This mafia is stealing in every way they can find. I also sent a email to camp and my sister telling them how blumer/barley snyder are stealing from Mother and

from her inheritance. I also sent fenstermacher the same to get him not to pay them their money. I am leaving out the other wacky things she said. That is why jaskowiak never pursued any contempt order because I exposed him as a liar 2 months ago with the dead phone and now proved the monitor was doing what they told her and brandi to do for them: liar in their notes. That is why sterling and jaskowiak refused to use a cell phone to record my visits to prove what I said or did not say, which would have saved me money. Cell phones do not lie, paid liars do. They claimed a cell phone would invade Mother's privacy. But, a fat and smelly person sitting next to us and the other one making comments, taking our pictures, listening to our private conversations is NOT invading mother's privacy and mine, plus violating our constitutional rights?

Think of all the money I paid and also came from mother's estate to pay for those liars, my visits from day 1 were limited, then reduced more, contempt of court and prison twice where he made about \$5,000 each time and I had to pay him, forced to live in my car because of lack of money, on welfare, all the time mother could not see me, especially on holidays, her mental and physical decline being kept in that prison for 2.5 years in solitary confinement, sensory deprived environment, all of her money wasted for that pig pen, covid, no phone, etc. etc

The fact is, as you know, U.S. law says a person is innocent until proven guilty in a court of law, they never filed any petition to prove I agitated mother and caused her legs to be swollen claiming it was my food. That is why I filed my petition last september for them to prove their claims or give me full access to my mother as much as I want and to take her anyplace I want, like my sister got a year ago. All of the lawyers wanted my petition quashed and sterling did so. So, they can make up any lie they want but I cannot demand they prove it in court, but I will be penalized for it. WTF?

Sterling is in this Mafia, like weilheimer and the other judges in orphans court. She refused to let me read my opening statement, my pictures of mother and I happy before guardianship she denied because I did not know the month I took them, 40 pictures of inside of her house were denied by her, even though jaskowiak could verify them (he refused) because I could not again name the month I took them along with the pictures of the pig pen. She tricked me into saying I had no new evidence after february 15 for fenstermacher and gelsinger who were there, so she sent them home denying me my questions for them denying the blumer/barley snyder bill and to question fenstermacher to get rid of him. Unblocking my emails and money she was going to decide later, along with those other petitions.. What seems to be happening is the judge, sterling, wants him to make a list and specifics of I can not say to those people. Great. Now I will know who means the most to him. But, his email this morning shows he demands that ALL of the people that are on Mother's case and others I cannot talk about. BS!

Nothing was decided about visits, or getting rid of him as Mother's lawyer or fenstermacher, lawyer for estate, who admitted at the last hearing he had not seen or talked to my mother for 4 years. How can a lawyer ignore the laws and decency of talking to their client? Since jackass hates other lawyers knowing about him, I will do more of those letters. He keeps bitching that I am a spoiled brat that I am using the courts and abusing the courts to "get my way" and won't stop until I do. Does he mean getting my Mother home and spending all the time I want with her at her age of almost 99 in 1 month, is somehow a BAD thing? While THEY are stealing her money, keeping her in solitary confinement for 2.5 years, murdering her mentally and physically?

Last Thursday was great at the 2x a month county commissioners meeting. I went there with my picket sign that said the DA was protecting guardianship corruption. A sheriff deputy followed me up in the elevator and said I could not bring in the sign to the meeting open to the public. I told him the constitution says freedom of speech and expression. I said to him will T shirts be banned that say black lives matter, trump for president, etc? He then called for his sargent. He said the same thing and I said the same thing. He called building security and he said the same thing and I said the same thing. He then said it was ok , but I could not hold the sign up or talk about it during public comment time. I said ok and I sat in the front row, with my sign facing the commissioners for 2 hours. I was not planning to attend after my full day the day before for the hearing.
