

Ms. Bookler,

Weilheimer had my emails blocked by the county IT Olivieri in June 2023, but weilheimer lied to me about it in her email to me. Both of them committed many felonies by doing their actions. Weilheimer had my email address blocked as retaliation and to punish me because I was exposing their guardianship scam on my Mother and also had been done to many others for decades. DA Steele refused to open an investigation, press charges or do anything about the guardianship scam, just like the FBI refused to press charges on weilheimer and Olivieri for committing such outrageous felonies. Both jaskowiak and gelsinger had been in touch with Steele's office many times pertaining to prosecuting me because a fruitcake nutjob (as she proved to be last week on Zoom in court) monitor had lied (because jaskowiak told both monitors to do so) about what I supposedly said or did with my Mother during my visits. Recently, the most recent monitor, Mary Ellen, had claimed I video taped my mother during a visit as she was told to say. As you saw in court last week I proved Mary Ellen had been totally lying in her notes and admitted she had NO, repeat NO training to do what jaskowiak had told her to do as a "monitor", also known as paid liars. Those lies by those monitors, which I was denied the ability to protect myself from their lies by both weilheimer and later Judge Sterling, caused me to have extremely restricted visits of time with Mother. In addition, both Mother and I had to pay those liars to be there, especially me having to use my welfare money or not see my Mother. Because those monitors had lied and because of the extreme limited hours to be with Mother, out of a possible 14,500 hours (16 hour days, 8 hours for sleeping) from September 2021 to March 1 2024, I have only been allowed 224 hours with my Mother at 99 years old. Many of those paid visits had a paid liar sitting on top of us violating Mother's and my right to free speech and privacy.

The other day, jaskowiak created his "Order" that he wants Judge Sterling to sign that prohibits me from contacting anyone connected to this scam and telling those people about the various corrupt judges, guardians, lawyers, psychologists and others handling guardianships. But, jaskowiak does not want a hearing. As you heard last week, jaskowiak does not want his name to be known to other lawyers as a corrupt lawyer and crook. He is only concerned about himself losing business because others will find out of his corruption of stealing from elderly and destroying their lives as he has done to my Mother and many other people. Does jaskowiak remember his oath to become a lawyer that he will obey and defend the Constitution of the U.S. and PA? That includes free speech, free expression and free press. He has ignored the Constitution before, under the lie he is protecting Mother, his alleged client by forcing me to delete my news website exposing the scam 2 years ago and he put me into prison twice, while he charged me money for doing so. His client, my Mother, who he has only seen and talked to twice in 2.5 years. Fenstermacher (guardian of estate for 2 years), in court last month said he has not seen or talked to Mother in 4 years. How can these shysters ignore their own clients, but make decisions for them, without talking to them? The PA Rules of Conduct and PA title 20, S 5521 spells out exactly what they must do as lawyers and guardians. But those two and the guardians, have totally ignored those laws and rules to Mother.

As I left a message on the phone to you last week, tomorrow is Good Friday and Sunday is Easter, two of the most holy days of the year. The previous so-called guardian, Blumer, for two years refused me visits with Mother on all religious and other special days, also as retaliation for exposing her and others involvement in this scam. Since I have proven those monitors were only paid liars, by jaskowiak and Blumer/her husband/gelsinger/other lawyers in Gelsinger's law firm, I expect Judge Sterling to return a normal relationship between me and my Mother of unlimited visits, times and places my Mother and I can be together and without any paid liars, as

weilheimer gave my sister a year ago. Despite the fact of the drugging, torture, torment and starvation my sister did to Mother that put Mother in the hospital for 6 weeks confined to bed at 96, treated for starvation and got covid where Mother could have died. As you are aware, the basis of U.S. law is a person is innocent until proven guilty in a court of law and they also have the right to face their accusers. This guardianship mafia refused to want to prove any of their charges against me in court because they had no evidence. As you are aware, I filed a petition in September for those guardians and lawyers to prove their charges against me. All of them begged Judge Sterling for my petition to be denied because they had NO evidence, only the lies they told the monitors to write. As it is known, Judge Sterling denied my petition.

As per making a list of all the people I contacted in the county and my emails blocked to them since June 2023, I see no reason why I should spend all of my time to do so and for free. Weilheimer and Olivieri caused this mess with taxpayer's money, let them fix it. I will not be the guy at the circus, with a shovel behind the elephants, picking up after those elephants. This guardianship scam has been and still is murdering my Mother mentally and physically. There has been NO reason why my Mother has to be kept in solitary confinement, in a sensory deprived environment for 2.5 years when there were no problems, of any type that my mother needed guardianship, let alone to be locked up and denied to be free and enjoy her life. Jaskowiak's only job was to defend mother and protect her and her rights at the petition hearing. He deliberately refused to do so, just she WOULD be guardianized so this Mafia would get her vast assets by owning her. I have been demonized and punished for 2.5 years because I exposed the fake "evaluation" by ledakis claiming my Mother was "incapacitated". The only thing I have tried to do for 2.5 years was get my Mother back home and for her to enjoy the life she had. Look at the price I have paid: On welfare and living in my car, while the mafia enjoys my Mother's assets like vultures only to increase their life style.
