

## WEILHEIMER MOTHER'S LETTER

Mother was very upset as to why she was kidnapped, starved and drugged by her daughter/logie in August 2021 and dumped into her tiny room. Mother could not understand why she was forced to stay in a locked in section, in solitary confinement, in a sensory deprived environment and be kept with people with mental and behavior problems. She was angry that she was not allowed to go anyplace she wanted, especially with me. I used to be allowed to call her twice a day, before pam blumer stopped those calls after only several months as a punishment to me for exposing her/mafia's money grabbing scam on Mother of guardianship.

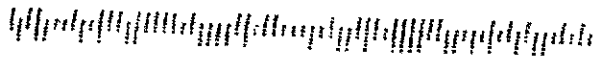
I suggested to Mother she write a letter to judge weilheimer and tell her what she wanted, such as a new lawyer to replace jaskowiak, to go home, come to court to tell the judge, etc. Mother wrote the letter, on blank paper, no margins printed. Mother did not get any help from me to write it. I gave her the court address for the envelope and I mailed it for her.

Her original letter had to be turned in as evidence and the court scanner did not scan it in straight. That is why the sentences are turned upward and cut off. But, the sentences are evenly spaced above and below each other, spelling is always correct, "i's" are dotted and "T's" are crossed, there are margins for the sentences to begin and end. In other words, Mother was very much able to think and write correctly. Her signature is the same look as it had been for decades.

The letter was received and stamped, but it was later refused by weilheimer as being real. Weilheimer hired the same quack psychologist, ledakis, who claimed Mother was "incapacitated" based on him admitting (by my questions of him at the petition hearing in July 2021) in court he had NO independent proven accuracy for the "tests" he claimed he gave Mother in private and he had NO independent proof of accuracy for his "evaluation" of Mother. But, the mafia kept hiring ledakis because he always said what the mafia told him to say: lies about me to be used to greatly limit or deny visits with my Mother. Ledakis wrote various lies about me in every "report" he wrote.

Of course, in another of one of ledakis private sessions with Mother (if he ever had any session with Mother), he claimed I told Mother what to write. Jaskowiak is admitting that Mother's letter was REAL and she knew what she wanted in her letter.
