Karen,

How could that ever work? That would mean I would have to drive to the courthouse, spend money for gas and parking and pay for thumb drives. It takes me about 45 minutes each way to drive. That is not financially feasible to me at all. I don't have the luxury of charging hundreds of dollars per hour as others do in this matter.

Last week, I had asked for a private meeting with the judge. If a meeting were held, even with everybody, this complete mess would end in one sitting and my mother, (98 in 2 weeks) would get what guardianship is supposed to be and do for HER, not for the bank accounts of greedy lawyers and guardians.

So far, Mother at 98, has been kidnapped from her large 3 bedroom, 3 bathroom home in a private gated community by her daughter and previous guardian logie for no reason, her house only cost her about \$16,500 a year to operate and dumped into a locked down dump costing her \$90,000 a year, within 1 day of being kidnapped had to be put on anti-depressants because Mother did not want to be with her daughter, within 2 days of her kidnapping her hairdresser of 16 years is on record as saying Mother was shaking and crying saying I want to go home repeatly, at 2 weeks Mother had to be taken to the hospital, by ambulance, unconcious, confined to bed for 6 weeks and treated for starvation, 42 blood tests, 42 needles in the stomach to prevent blood clots, at week 5 got covid, at week 6 was dumped into a very tiny room in a low rated nursing home that just opened up after months of covid, later got covid again and later influenza. Plus, hundreds of thousands

of dollars wasted by greedy lawyers, guardians and their lawyers when simple meetings could have solved any problem. Mother has been kept in solitary confinement, was only allowed 1 hour visits 3x a week for 18 months for no proven reason, forced to live in a sensory deprived environment, no phone, no reading material unless I brought her newspapers, magazines, etc, not allowed outside to go anywhere for 18 months, no doctors appointments for 18 months, usually only a hairdresser appointment once a month (normally 1x a week for 27 years), was forced to miss religious holidays with her son (Christmas, Easter, Good Friday) Valentines day and other visit days by her guardian for no reason, forced to be humiliated 48 times so far by having a stranger, paid monitor sit 4 feet from her while she is trying to have a private conversation with me, not allowed to enjoy restaurants and other food in her room to eat at her leisure, not allowed to go home to see her loved possessions, not allowed to go home to live as the courts own hand picked "expert" said she could on page 72 of ledakis report #1 (so far "forgotten" by handlers), refused to be allowed by her handlers to go to much, much nicer, much bigger and much, much cheaper places to live and it seems, if I am evicted, EVERYTHING she has ever loved will be trashed because there is no room in her very tiny room to keep anything now, let alone if her house is sold. On page 67 of the ledakis report #1 Mother said she wanted me to have the house to live in. So why has her wish being constantly ignored when there is no financial reason to sell the house at this time and trash all of her loved possessions? I have offered to pay the yearly operating costs. Ledakis said in his report #1, Mother could stay at home and with me there, everything was going fine. So, WHY was she kidnapped, who ordered it and why did nobody in charge send her back home if logie and my sister kidnapped Mother on their own?. Everybody knew what ledakis had said about Mother staying at home. Why did the court and mother's court assigned lawyer, jaskowiak, not order Mother back home.

In Mother's letter to the court about 1 year ago, she made her wishes very clear about wanting to go back home, have a new lawyer and to come to court to speak for herself. However, that letter was dismissed as being unreliable. But, about the same time, Jaskowiak stated on a Zoom call, he saw mother, he said mother said she liked her room, her food and the people. So, Jaskowiak is saying Mother had the mental ability to think rationally and about the same time Mother wrote her letter. But, her letter was dismissed by the court and others as unreliable. How is that possible? It seems to be others believe that Mother will last another 10 years while her handlers drag this out for as much money as they can get.

Does anyone know when Mother will die? On May 14 is Mother's day and May 16 is Mother's 98 birthday. Will she be spending those days alone or with some unknown person breathing down her neck if I am there?

As I said before, the basis of the US legal system is a person is innocent until proven guilty in a court of law and a person has the right to face their accusers. So far, I did not

have those rights, but I have been continuously punished based on only the "claim" that some unknown person of the "staff" said I did., but never asking my Mother if I did. Why? In addition, that monitor has been paid 48 times and not once did she ever tell me to leave for getting my mother "agitated", not once did any of the staff who were told to watch me for months before the monitor was hired by blumer ever told me to leave. That experiment was only supposed to last for a short while. Why is it still going on almost a year later and since November 2022 me being forced to give someone a paid job? Am I welfare for someone?

Even the official website for Montgomery County states what a guardian and guardianship is supposed to be and do. See the attached, read 3rd paragraph.

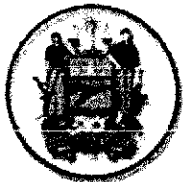

Karen,

Because I am poor, Gail signed a document a week or so ago that said I do not have to pay certain fees. Is the cost of transcripts also waived? I asked you that on Friday, but you did not answer that question.

In addition, I was just informed by gelsinger this morning that tomorrows 98th birthday visit with my mother was suddenly canceled because their hand picked, paid liar could not be there. On Saturday, gelsinger emailed me the visit for Mother's birthday was arranged, but said Mother's Day visit will be on May 26 because their paid liar could not be there. Why not make Mother's Day July 4th or Thanksgiving? Is this how a guardian, her independently hired lawyers and care manager see to the needs and wants of a 98 year old woman? Blumer was hired to do a job. It is her and only her responsibility to be the spy, for free if she thinks there is a need for one. So far, it has only been unnamed "staff" people who claimed I got mother "agitated. But, no one ever asked my mother. Why? So far, no trial was ever held, with that "staff" person. Why? The basis of US law is a person is innocent until proven guilty in a court of law. The person has the right to face their accusers. I have NEVER had those conditions met. Why?

Now, my 98 year old Mother has nobody, who she loves, to be with her on her 98th birthday. People in prison, for any crime, have more rights and priveledges than have been allowed to my mother by the hired slave owners, past and present. Mother's only "crime" was she had a little memory issue, but nothing that interfered with and still does not interfere with her daily living. It can be stated as a fact, my Mother never had a lawyer to defend her and protect her in court. Jaskowiak, court assigned to Mother, NEVER brought in any one who my Mother dealt with (doctors, CPA, investors, tax people, etc) who would have said Mother never ignored those areas. The fact is, jaskowiak WANTED Mother to be guardianized to get the scam going for Mother's Money. Even the court hand picked so-called "expert", ledakis, said Mother had no problem living at home and since I had been there for over a year, everything was going fine. So, why is she locked in a tiny room, in solitary confinement, in a sensory deprived enviroment? So why was she kidnapped by my sister and logie in August 2021? She is now only known as 2021-x2110 and currently owned by slave masters blumer, fenstermacher and this court.

Pam blumer was hired to see to my mother's wants and see to her needs. She continues to fail to do so in every area. My Mother is a living, loving, human being, not a mop that can be put into a closet and ignored. Blumer said 3 months ago that she had 10 other clients and only visits my 98 year old Mother once a month. That is NOT a guardian in any way. Since August 25 2021, I have always seen my mother all 3 visit days per week and called her twice a day. I have been the only one to make sure my Mother was always happy and healthy. Blumer is not a guardian, only a pimp whose only purpose is to grab as many people with money and homes and take them for blumer's and other's own use.. This time, it is my Mother's money and her home to divide up among the racket. Blumer never was given permission to hire all the people she wanted and any other expenses she had and charge my Mother. Meitner and I never agreed to any, repeat any, extra people or any other expenses that can be made up when blumer was "promoted" to us by jaskowiak and then hired. Blumer also hired a proven very dangerous, corrupt and incompetent "care manager" (deb klock) and many lawyers, including her first one, her husband, who later hired other lawyers in the same law firm. Those "guardians" and their entourage paid for by my Mother but, she has absolutely no say at all about her life, including her demands (refused to be heard), what she wants, where she wants to live and where she wants me to live as she stated in her letter last year. If blumer cannot take responsibility as a guardian to a victim, then she must be fired by this court. She cannot be allowed to own any person's life, welfare and happiness until they die AND be responsible for deciding any medical decisions for Mother

Blumer denied my mother to see me on Christmas, Easter and Good Friday, the 3 most religious Christian holidays in the year, along with denying me mother's 98th birthday, Mother's Day, Thanksgiving, Valentines Day and other visit days for no reason. Is this what a guardian does and how they think their clients should be treated?

There is no secret as to why blumer, gelsinger, jaskowiak, my sister and others are doing this to my mother and me: I have been exposing their scam on my mother and many others to the FBI and others for over 1.5 years.

Ms. Copestick,

I am asking the judge for a emergency (as camp requested and got in one day in August 26 2021) in person hearing pertaining to my mother to eliminate these past and current barbaric, inhumane, totally and completely unnecessary denials of contact (person and phone) between my mother and myself and limits of time and visits (that the court eliminated for my sister despite what she did to my mother for two weeks in August 2021) that have been and still are based upon made up accusations passed on by unknown and never presented somebody called "staff" that neither the court, lawyer for Mother jaskowiak or lawyer for guardian gelsinger have ever identified by name and presented in court to testify. According to the basis of U.S. law, a person is innocent until proven guilty in a court of law and a person has the right to face their accuser. So far, that has never been done pertaining to these baseless and never documented "staff" accusations since about November 2021. In addition, these extremely childish, baseless and punitive actions against me and my Mother are illegally using the court as a weapon and for retaliation against me for exposing the corruption and gross incompetence by those involved in my Mother's fake guardianship ownership since it started in August 2021 and reporting and documenting the corruption in my news website, to the Montgomery County DA office, to the FBI and others.

My Mother, who just turned 98 on May 16, has been treated as only a bank account by her various guardian "owners" and by her court appointed lawyer jaskowiak. Mother has been denied the same freedoms and rights that she is guaranteed in the Constitution, denied various abilities people have in prison for major crimes (including murder) and denied the rights that POW's have under the Geneva Convention. I found out yesterday that

several ministers, that I had contacted a couple of months ago to see mother and talk to her so she would have someone to talk to since the people she has been locked in with are extremely past the point of conversation, those ministers were denied to see Mother. They told me blumer had told the staff they had to be "screened". What does blumer have to screen them for? I was also told that mother's long time friends have tried to call call Mother many times, but have been refused contact with Mother, no reason given. They also told me before they were told they had to be screened, the staff was not picking up the phone so Mother could talk to them. I always had that same problem when I called before blumer canceled my phone calls to and from mother about a year ago. I also was informed that all letters and cards I dropped off for Mother were kept by the staff to be given to blumer for her to read. What is blumer looking for, something I said about her? Since blumer said in court about three months ago that she only sees Mother once a month, has my Mother ever gotten my Mother's Day cards, birthday cards, other cards and my letters? How can blumer be more concerned about what somebody says about her her than the lonlieness of a 98 year old woman, in solitary confinement for 1.5 years and denied human contact with the person she loves, trusts and she knows loves her, me? For the past two months, my Mother has not seen me or talked to me. I am sure, like any mother would be, she is worried that something happened to me or maybe she is thinking I do not love her anymore and she thinks I do not want to see her anymore. Is this blumer's idea of being a "guardian" of my Mother until she dies? Does she treat her other 10 victims the same way? Maybe blumer should be more concerned about her obligations and responsibilities as a guardian of Mother, for example Mother's health, happiness and getting Mother back home where the court's hand picked expert, ledakis, said Mother could live and me there also. If not Mother's home, blumer should be disgusted how mother is living now, instead of Mother's large 3 bedroom, 3 bath house, in a private gated community of 21 years that for over a year, blumer has refused to see how Mother was living happily and free to live her life. Blumer has also refused my findings of many much, much nicer, much, much bigger and much, much cheaper places for Mother to live where Mother could have some of her furniture and her loved possessions that would make her happy. In addition, I have been denied subpoenas to see information pertaining directly to the health and welfare of my Mother for no reason. As a lie detector examiner and instructor of 41 years, secrecy to me is only hiding the truth about something that demands further investigation.

Blumer had/is demanding payments to a unknown person to me, in a legal matter, qualifications unknown and those qualifications, if any, refuse to be disclosed by gelsinger, jaskowiak and the court. That person, brandi (if that is her real name) was hand picked by blumer, to "spy" on me, to write lies in her reports and those reports of lies would be and have been used to reduce my visits from three a week (since September 25 2021 no reason ever given by the court) to only two a week from about 3 months ago. If those paid visits

were to continue, those lies in reports would only continue to reduce again my visits from two to one to none, as jaskowiak has always wanted. Why? He is the court appointed lawyer to my Mother and his only legal obligation is to what my Mother wants. If jaskowiak does not like me or does not want to do what my Mother wants, then he can quit and is obligated by the BAR to do so. My Mother would be much better if he did so, since jaskowiak never brought in any of Mother's people she dealt with during the petition hearing who would have proven Mother did not need a guardian she had not done anything that demanded such a drastic and irreversible life changing way Mother was going to be controlled by total strangers. I had requested, in the court hearing, about three months ago, a cell phone could be used to record the meeting of mother and I to prove what I said for free. Jaskowiak refused saying it would violate my Mother's privacy. But a 300 lb female, with strong body odor sitting 4 feet from us, making notes would NOT be violating Mother's privacy and mine? My same request was also denied by the court last week in a zoom meeting for the wrong reason.


Does anybody involved with this guardianship scam on my Mother, for the past two years, actually care about my Mother's life, health, happiness and the truth or are they only obsessed on her huge bank account and the sale of her house so more money can be put into their pot?

Since the court and jaskowiak have refused my Mother to be allowed in court to be seen and testify as she has said in writing she wants to do and is allowed to do, including by subpoenas that were denied, I have enclosed recent pictures of when my Mother was happy, free and never had any problems that required any guardian. Her birthday picture was taken on her 96th birthday, 2 years ago. Several days after my Mother's birthday, her daughter filed the petition on my Mother just to get control of her money, her house, her life and she never discussed it with my Mother before she did so. A couple of months later, her own daughter and logie literally kidnapped (taken away by force, against her will, for monetary gain) my Mother from her house and put her through two weeks of hell. Within 24 hours, my mother had to be put on anti-depressants. On day 3, this court threatened me with contempt of court if I ever called for a second wellness check for my Mother. My Mother's daughter refused to allow my Mother to see me or to call me for the 2 weeks my Mother was being held against her will. Two days after Mother was kidnapped, her hairdresser, with weekly visits for 16 years, said my mother was constantly shaking and crying during my Mother's last hair dresser appointment. She said my Mother kept crying "I want to go home, I want to go home". After 2 weeks of forced confinement, my 96 year old Mother had to be taken to the hospital, by ambulance, unconscious, confined to bed for 6 weeks, treated for starvation, given daily blood tests (42 times) to where her arms were black and blue from them and daily needles (42 times) in her stomach to prevent blood clots. To think a 72 year old woman did that to her own Mother at 96. But, three months ago, the court praised that same daughter and allowed that same daughter all the visits and time daughter wanted with her Mother. But, at the same hearing my visits were reduced from 3 a week to only 2 a week based on the supposed "reports" by the hired "monitor" but was in fact using the court as a weapon and retaliation for my exposing the guardianship scam on my Mother and on many, many others. Since November 2022, the court has forced me to waste my very limited funds just so I could see my Mother and were paid to blumer for her paid liar to "monitor" my visits with my Mother, who then submits false reports about me to the court and blumer to be used to later deny me all visits with my Mother. As late as last week, the court, gelsinger and jaskowiak have refused to allow me the ability to protect myself from those made up lies using a simple and free cell phone.. Everybody knows, cell phones cannot lie.
