Petitioner, Rev. Arthur Herring, III, pro se (hereinafter referred to as "Arthur") files this Emergency Petition to Unblock Arthur Herring III Email to All County Agencies. Petitioner is requesting a decision by the court.

- 1. This Orphans' Court has jurisdiction and venue over the matter of Jane Herring and the Petition Hearing pursuant to 20 Pa.C.S.A. Section 5512.2 and Orphans Court Rule 14.9.
- 2. Jane Herring is currently a 98.5 year old widow, with two adult children: her very much loved son to her, Arthur (age 70), and estranged daughter, jsh (age 72).
 - 3. The Petitioner is Rev. Arthur Herring III, age 70, retired, who has been forced to live in his car since August 25 2023 because of the corruption by the Racket controlling and owning Jane (Arthur's Mother) since August 2021 to now.
 - 4. Arthur has spent his life savings and 7 days a week since this guardianship scamstarted on May 18 2021 to get his Mother back home where she was living happily for 21 years.

- 5. The purpose of a guard is to protect lives and property. The Racket, consisting of judge Weilheimer, guardians (past and present), their many lawyers, "care manager" klock, jsh and Weilheimer's lawyer assigned to Jane, jaskowiak, have constantly violated the laws, including Title 20, Section 5521, the various ethics and morals of "owning" a human being as a guardian and those lawyers also refusing to follow the Pennsylvania Rules of Conduct for lawyers.
- 6. Because of Arthur's 41 years of doing lie detection testing nationwide, which included criminal investigations, Arthur was able to determine that the so-called guardianship petition filed by jsh was only a disguise to seize control of her Mother's vast assets and her very large 3 bedroom, 3 bath house in a gated community.
- 7. Jsh had tried other times to take control of Jane and her assets, usually using Fenstermacher, but Arthur was able to stop those attempts.
- 8. Arthur has proven this entire guardianship, from the beginning, was only a scam to get Jane's assets. The same type of guardianship scam that has been done nationwide on tens of thousands of elderly people for decades just for their money and houses.
- 9. Because of the proven fake, made up and admitted never independently proven accurate "evaluation" (as established by Arthur) of Jane by Weilheimer appointed psychologist ledakis, Jane was declared legally "100% incapacitated" by judge weilheimer in August 2021.
- 10. But, ledakis said Jane had no problems with daily activities and with her son living at the house for over 1.5 years, everything was going fine for Jane. His numbers of Jane's lack of abilities never added up to 100%, only at best 50% in HIS opinion only and only after a brief 2 hour meet with Jane.
- 11. Ledakis admitted he never audio or videotapes his "sessions" with Jane or anyone, including at his first meeting with Jane or anytime after that with

his other so-called "evaluations". Because of that, there is NO proof that ledakis ever gave any such "evaluation" to Jane and the "reports" he wrote about Jane cannot be believed they belong to Jane and not 100 or 1000 other people using a simple cut and paste of names.

- 12. After Arthur had exposed ledakis as a fraud, the Racket continued to hire him, pay him tens of thousands of dollars because he would always say what they wanted him to say against Arthur.
- 13. Lawyers and judges call psychologists and psychiatrists the "whores of the court" because they will always say what a lawyer pays them to say.
- 14. Jane had a assigned lawyer, jaskowiak, by weilheimer. But, jaskowiak NEVER brought in Jane to testify for herself as she wanted to, NEVER brought in any of Jane's professionals she dealt with every year, sometimes several times a year, including her primary doctor of 21 years, Jane's other doctors, her CPA, her investment advisors who had worked for her for 21 years, Jane had NO bounced checks, NO checks written for bizaar amounts or to non living people, NO unpaid bills and NO unpaid taxes.
- 15. Jane was still driving her car safely up to her 96th birthday when her license expired. Jane did not need any walker or cane, no diapers, no dentures, no hearing aid, no problems with hygiene, Jane could still cook, dress herself and only was on a very low dosage pill for blood pressure.
- 16. Arthur (as pro se and a former criminal investigator) has been determined by the Racket to be a threat to their money making guardianship scam on Jane and many other victims of theirs. The Racket has used their hate of Arthur to make life as barbaric and inhumane as possible to his Mother who he loves dearly.
- 17. The Racket, since Jane was kidnapped from her house by jsh and first guardian logie, has forbidden Arthur from any type of normal relationship with his Mother.

- 18. Based on weilheimer's inhumane visit schedule, out of a possible 16 hours per day (8 hours sleeping), from Augustt 25 2021 to November 1 2023, but of a possible 13, 220 hours Arthur and his mother could have been together as they usually were for the 8 years since Jane's husband died, the Racket has only allowed Arthur and Jane to have 217 hours together.
- 19. POW's have more priviliges than Jane. People in prison for all types of crimes have more priviliges than Jane.
- 20. Jane has been kept in a very tiny room, in a locked in section, in solitary confinement, in a sensory deprived environment at the low rated nursing home.
- 21. The Racket has not let Jane go outside or into society, has not been allowed to go home to see her loved possessions for 2 years. Jane was NEVER accused of any mental or behavior problems that cause her to be a threat to herself or others. The Racket have kept her locked in, like a animal in a cage.
- 22. To further punish and harass Arthur, the Racket made up various lies so they hired a friend of pam blumer (guardian of person to Jane) to be a "monitor". The "monitor" had to sit with Jane and Arthur during his visit hour. Arthur had to pay this "monitor" or he could not see Jane. The Racket actually had told the 2 "monitors" to write lies in their reports to be used to eventually deny all visits of Arthur with Jane. The Racket continues to violate Jane's right to free speech because she cannot talk freely to Arthur when a stranger is sitting right next to them listening to their private thoughts.
- 23. Jaskowiak, as part of the Racket, has put Arthur into prison twice for exposing the guardianship scam on Jane on Arthur's news website www.protectmyparents.us. Jaskowiak had violated Arthur's right of free speech and freedom of the press. Jaskowiak also has made a lot of money, at Arthur's expense, by using contempt of court charges. Jaskowiak bragged at a

seminar recently that he uses contempt of court to get his way and to make money.

- 24. Jaskowaik, as part of the Racket, is using the court as a weapon and to make money, which is not allowed by any court.
- 25. To further harass and punish Arthur for interfering with their money making guardianship scam on his mother, which also deprives Arthur of his inheritance when Jane dies, weilheimer had the county IT person, Olivierei, block Arthur's email address to all county agencies to make it almost impossible for Arthur to use them in his fight to get his mother back home as ledakis said she could live in his first report.

This petition must be granted to undo the illegal action by former judge weilheimer. Because of Arthur's dedication and love to his mother, Arthur has been broke for over a year, has been on welfare for over a year and because he was evicted from Jane's house by Fenstermacher (guardian of estate), and she had written that is where she wants him to live, Arthur has been forced to live in his car. Without money and living in a car is extremely difficult, almost impossible to do court business to help Jane get back home.
