FBI IGNORES CORRUPTION, KIDNAPPING AND THEFT BY JUDGES, DISTRICT ATTORNEY,
GUARDIANS, LAWYERS, PSYCHOLOGIST AND DAUGHTER THAT RESULTED IN JANE HERRING'S
BARBARIC AND INHUMANE KILLING/MURDER BY THIS GUARDIAN MAFIA FOR JANE'S VAST ASSETS

About a month after Mother was kidnapped on August 25 2021 by her daughter, jsh, and the first guardian of person and estate, logie, picked by weilheimer and jaskowiak, I went to the FBI office in Ft. Washington, PA and talked to Agent Pacchioli for about 2 hours. We then had another 2 hour meeting about several weeks later. I gave him many documents and testimony that proved Mother was now another victim of guardianship fraud that has been nationwide for many decades. Those involved in Mother's guardianship scam were a corrupt judge weilheimer (later another judge sterling), the first corrupt guardian of person and estate logie, his corrupt lawyer zabowski, a so-called corrupt "care manager" klock (has a long history of stealing and over drugging her victims), Mother's corrupt lawyer assigned by weilheimer, jaskowiak, (who refused to defend and protect Mother from guardianship at the petition hearing and all other times because jaskowiak wanted Mother to be guardianized for this guardian mafia), a corrupt psychologist ledakis (who admitted by my questioning at Mother's petition hearing he (ledakis) had NO independent proof of accuracy for his "tests" he used on my Mother and his "evaluation" that he (ledakis) used to claim Mother was "incapacitated") and Mother's then 70 year old daughter, jsh, (admitted in court by my questioning that she (jsh) never discussed such a drastic decision of guardianship of person and estate for Mother before she filed her petition because she (jsh) did not think the matter was that important). WTF?

After those two meetings, Pacchioli told me the matter was a civil matter, not a criminal one. Pacchioli refused to open any case. WTF?

But, in December 2023, a guardian, gloria Byers, was convicted of stealing about \$1 million from her 105 "clients" (victims) near Philadelphia. Those involved with her prosecution were the local DA, FBI, DOJ and the IRS. Mother's scam included those listed above at that time and soon many, many more would be part of this guardian mafia.

Shallcross worked in the Pennsylvania attorney general's office for the elderly. He never did anything to get the attorney general involved in this massive scam on Mother. Many, many other families of guardianship corruption on their loved ones also went to the FBI, the attorney general's office and Montgomery County DA Steele, as I also did, but their cases were also refused.

I sent many emails and documents to Pacchioli for 3 years while Mother was still alive in her pig pen, Manatawny Manor. Mother was kept in a locked in section with people who had mental and behavior problems. NOBODY ever claimed Mother ever had those problems. For 3 years, Mother was kept in solitary confinement, in a sensory deprived environment, no phone, no usable TV, no outside food, no ministers, was not allowed to go to her huge home of 21 years and her much loved possessions, denied about 24,000 hours of time with her son who she loved and was extremely close to, no outside reading material, flowers that her son gave her were quickly thrown out, no table in her tiny room while Mother was alive, constant danger of dying by covid from others, stained towels and bedsheets (when Mother got them), torn bedspreads and Mother had to wear other people's clothes, even though she had her own clothes.

Mother had about \$2 million in assets and a paid for home worth about \$500,000. Since jsh's petition NEVER had any examples that Mother needed jsh as a guardian and NO people were ever brought in by jsh (doctors, investment people, tax people, etc) to prove Mother needed any guardian, plus no unpaid bills, no problems with checks, no neglected medical issues, still driving her car safely at age 96, etc). WHY was Mother guardianized, kidnapped and forced to live like a bag lady until Mother was killed off?


POW's and people in prison for all types of crimes have more priviledges than Mother had. Why?

If the FBI and others had acted, opened an investigation on the massive scam on Mother and prosecuted those in the guardian mafia, Mother would have been back at home and living a happy life for many more years. Mother would have been 100 on May 16 2025.

Instead, Mother was killed by morphine by the guardian mafia. Mother died unconscious, in a extremely slow, barbaric and inhumane death by starvation and dehydration. No hospice by the guardian mafia. Mother was denied any last wishes, including dying at home with me and with her much loved possessions. The mafia denied her seeing me for about 8 months. They only allowed me to see Mother unconscious, dying only hours before she did. The mafia deliberately added more pain to me by denying me to be alone with Mother and had 3 people watching me for my only one hour last visit with Mother. The mafia denied me taking any pictures of Mother that day and even at her viewing. Why? Ish buried Mother in a pajama top and swat pants, instead of nice clothes from home. Ish even changed the casket Mother chose years ago and put her into a much cheaper one. Ish even took the diamond engagement ring off of Mother after she died that Mother had worn for about 80 years.


Animals!
