

## Judge sterling's lawyer assistant tells my lawyer not to show me documents

About late December 2025, I retained a lawyer to protect me and my inheritance from people in the mafia, including former corrupt guardian of estate and now Executor of Mother's estate, Fenstermacher. Fenstermacher was deeply involved in the corruption and looting of Mother's money by the guardian mafia while she was alive and being kept in a low rated nursing home, in solitary confinement for no reason. 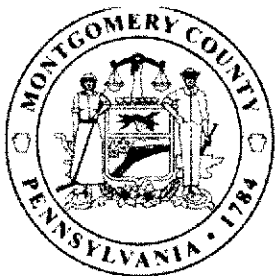
