2. Nature of Incident:

On the Above date and time I, Corporal Ryan Volk was assigned to investigate the citizens complaint filed by Arthur Herring III. Mr. Herring's report states that he has an on going dispute with a judge in Montgomery County and the Information and Technology Department for blocking his email address. Mr. Herring verbally complained about being escorted through One Montgomery Plaza by a Deputy on 07/31/2023.

I spoke with the Deputies assigned to One Montgomery Plaza on 07/31/2023 and at approximately 1520hrs Mr. Herring entered OMP to go to the 4th floor Register of Wills Office. The security guards stated that he needed an escort per Director Robbins and Dep. Wilson escorted Mr. Herring to the 4th floor. Mr. Herring conducted his business and when he was leaving he was angry that he was followed by Dep. Wilson and wanted to file a complaint about it. Mr. Herring left OMP and entered the courthouse to come to the Sheriff's Office and Dep. Wilson escorted him to the office.

After speaking with Director Robbins of the Security Department, Mr. Herring has had numerous incidents of erratic behavior while in the county offices and due to that he needs an escort. Specifically, last week Mr. Herring went to the IT office on the 8th floor of One Montgomery Plaza and was causing a disturbance because his email address was blocked due to on going emails he is sending to a Common Pleas Judge. While Mr. Herring was here last week he also caused a disturbance in the register of wills office while trying to file orphans court documents. Security Director Robbins was present when this issue occurred and told Mr. Herring that acting this way was unacceptable and that while this is a public building but he cannot come in here and cause disturbances and act erratic.

Director Robbins instructed his staff to escort Mr. Herring when he comes in the building due to his continued behavior while he is in the county offices. Due to Mr. Herring's history and behavior while he is on the county property I have found that our staff did nothing wrong by escorting Mr. Herring to the Register of Wills office so he could conduct his business.
