

My letter to Dr. Kuhar, Mothers primary doctor of 21 years at the time she was kidnapped. I told her what happened of Mother being kidnapped and drugged and begged her for help. She never did anything.

Dr. Kuhar,

Last night I found out that my mother, who was forcibly taken from her house by her daughter last Wednesday and told to do so by my mother's so called "legal guardian Logie, Mom is going to be given a pill for anti-depression. I found out that you prescribed it. My mother is being forced to stay at JH house away from me. WHY? I was not even allowed to see or hug my mother before she was taken away. WHY? Mom does not want to be there, and is obviously extremely upset from being away from me and being away from her house and her usual routine that she enjoys. She is not even allowed to call her cousin in North Carolina, who she would talk to everyday. Mom has a very tiny bedroom, no TV and has to walk down the hall to a bathroom. My sister has her own vegan diet and will not let mom eat or drink what she likes. I am not allowed to call Mom or see mom. WHY? The judge told me if I do, I will be charged with harassment. That night, after she was taken, I called the police to do a wellness check. The judge told me again if I do it again, I would be charged with harassment. WHY?

As you know my sister is a very evil person. What you don't know is she has tried to get total control of my mother's money for many years. On May 17, the day after my mother's birthday, JH signed papers to be Mom's legal guardian so she would have absolute control over my mother. JH NEVER discussed the idea with my mother or me BEFORE JH filed the petition. She has made up disgusting lies about my mother and myself for years and she did it again in the petition. JH claimed my mother and I were engaged in a "romantic campaign" (court transcript). JH also claimed I tried to murder her 1.5 years ago by trying to push her down the steps. But, she never told anyone. JH claimed as I was trying to kill her, she said I was "laughing in a demonic way" and "she could see my eyes roll back into my head and she could see the whites of my eyes" (court transcript). JH is clearly a very mentally unstable person and you have seen her vocal outbursts at you and your staff.

After spending at least \$20,000 for a lawyer to do the petition and pursuing it for 2 months, JH suddenly drops out after my lawyer (who I could only afford for a month) had sent her a 22 item discovery list that would have proven JH has been stealing from my mother for years.

I am kept totally in the dark. WHY? Why is my sister in charge? The legal guardian told me he has 31 other clients. I have read a lot about what they can do. They basically have the court to back them up on whatever they do. It is a money making racket. They can put mom anywhere they want and can sell all of their assets. About 10 years ago, 2 state judges were sent to jail for 20 years for sending kids to prison for millions of dollars in kickbacks. The legal guardian treats me as if I do not exist.

Logie told me last week I have 30 days to move out. He told me he is going to sell her car. By drugging her, with your help, the next step I fear is getting rid of all of her property and put her into a nursing home, using her money. What will she be with your help putting her on pills, a mindless vegetable who will not remember who she is or remember who I am? He charges her \$115 an hour for anything, plus what his 30 other clients are charged.

Because of JH, my mother was found totally incapacitated by a so-called "neuro-psychologist" Ledakis after only a 2 hour meeting. My mother did not fit any of the courts definition of incapacitation. The psychologist admitted, because of me, there are no studies that prove his tests are accurate. For example, your MMSE test in June said her score was 26, Ledakis score for the same test a month later was 21. He claimed that meant mom was totally incapacitated. How can those same tests have very different scores almost given at the same time?

Last week, her hair dresser called me and said mom was very upset and kept saying she wants to go home.

Mom has been your patient for 20 years. You have the power to demand changes to help mom and for her welfare. Just like last year, you could have written a simple two sentence letter saying mom had a small memory issue, but she still knew right from wrong and still had common sense. By you refusing to get involved in legal matters, as you said, you created the mess she is in now, including her life at stake. She is with a crazy person who does not care if mom dies, as long as JH gets her money.

Are you going to be a doctor and help your patient????
