Because of the status, at this point, involving the happiness, welfare and life and of my 96 year old mother, I am forced to send you this email.

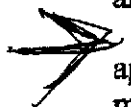

Ms. Herring tried the same tactic this year by filing the legal guardian petition so she again could be in total and unquestionable control of my mother's vast finances and would have had the protection of the court to do whatever she wanted, especially to be used against me, a brother who she has a unknown fire burning hate for me and did not any type of connection with for 50 years. Ms. Herring has that almost same hate towards my mother for many decades and has not wanted my mother in her life. Ms. Herring has sent out letters for years saying my mother is basically insane to people my mother does business with and her doctor. Ms. Herring is also the same person who told Ledakis (the so-called "neuro-psychologist who did his so called 2 hour "evaluation" on my mother and who then said she was totally incapacitated) that my mother and I have a "romantic campaign". As you recall, Ms. Herring also said in court other various lies. They include telling the police, in February 2020, I kicked her in the back then changed her story in your court that I tried to kill her by trying "to push me down steep steps" and "as he was doing so, he was laughing in a demonic way and I could see his eyes roll back into his head and I could see the whites of his eyes". You put my mother into the home of the person who said THAT? My sister lied to the police (felony) and lied to you under oath (perjury). You also refused to let me to give you documents where my sister lied to you at another point during the trial (perjury). during the conference call yesterday, many times you refused to allow me to challenge anything the other people said that were lies. WHY?

Both you and Logie have yet to give any intelligent or logical reason why my mother was forceably removed (kidnapped?) from her home under the lie that a nurse was coming over to see mom. Logie said she needs time to get acquainted at her new home. BS. My mother loves me and trusts me completely. Mom has told Logie, Jaskowiak and Ledakis that many times and also that she only wants me to take care of her, make decisions for her and any medical decisions for her, if she ever needs it. What more do you want. you and others have said I have a influence over her. BS. NO examples have ever been given how I have ever received anything that was improper in any way by my mother. Before the trial, you refused to let my mother come to court to testify and you said you thought she would be upset by it. Ledakis said in his "evaluation" that Mom would NOT be harmed in any way. Why were you refusing to see my mother for yourself? As you recall, Ledakis also admitted none of his paper and pencil tests had any independent proof they were accurate and he had no proof what his accuracy were for his "evaluations". All paid for by the taxpayer. Ledakis was also not a "independent" examiner. Jaskowiak (my mother's court appointed lawyer who was supposed to protect her and promote her wants) should have found one who was not on his or the court's "payroll". Jaskowiak also ignored my mother telling him, Logie and Ledakis many times she wanted only me as her guardian, instead attacked me in court claiming, among many things, I made her change her new will so I would financially benefit from it. Those new changes were written, signed, initialed and dated by my mother in about March 2020. well before the so-called December date that Ledakis claimed, by him going back in time (LOL) he claimed

I drove 2 (10 and 20 year old) cars, with high mileage, I bought with my own money and I bought my 40 year old mobile home with my own money for \$15,000 9 years ago. I sold the 10 year old car to help pay my worthless lawyer who I fired for incompetence before the trial. I could not afford to waste any more of my money for lawyers, so that is why I was pro se in court. For a matter of such great importance and personnal importance, instead of you helping me (a 41 year lie detector examiner) get the information revealed, you yelled at me many times and refused to allow me to ask questions that had a great importance. You had told me I was supposed to know as much as a lawyer in court. If it takes lawyers 3 years to learn that information, how was I supposed to learn it in just days? I had the right in court and on the phone yesterday to challenge anything others said about me and this case that were not true. You said that I had no right to challenge them. Why not?

I am extremely confused why ledakis,jaskowiak and logie talked to my mother in private, but never recorded the conversations to prove what they and my mother said. They can make up things and claim my mother said them at any time. After all, they are claiming she is totally incapacitated. How conveinent for them. This reminds me of 10 years ago, where those 2 state judges went to jail for 20 years for getting paid kickbacks for sending kids to a private jail. They called it "cash for kids". More and more this reminds me of it.



My mother's hair dresser called me yesterday. My sister took Mom to her once a week hair appointment. She said Mom was very upset and kept saying "I want to go home". WHY do you demand my mother stay with her daughter who she has no relationship with, does not like, told ledakis, jaskowiak and logie that, made up those lies about Mom for years, said those disgusting things about mom and me having a "romantic campaign", claimed I tried to murder her (JH) and as I was doing so I was supposedly turning into a werewolf, lied to the police, lied(perjured) herself in your court because she changed her story about what supposedly happened that day of the "incident". Why would any, ANY judge forcibly take a 96 year old woman away from her accustomed life and force her to live in a setting she does NOT want to be? You condemned me yesterday for calling the police to do a welness check when I did not know what was going on and was extremely concerned for my mother's life and health. I told jaskowiak several times that this matter has upset my mother terribly to the point of crying every few days because she and I do not know what is going to happen and she is not allowed to decide where she will live and what will happen. then she starts to shake and hyperventilate a little. To my sister, it seems the sooner the big paycheck in the mail arrives, the better she will like it. Am I mad as hell and disgusted at what has happened so far and how I have seen what this "orphans court" and the people involved have done to a healthy and loving woman who has her son to take care of her for the rest of her life and is now living with her full time (at her request for years), you better believe it!!!!.

I will be sending this email to many people, including the tv media, paper media, all the Pennsylvania state senators and representatives and many others. I have made a website pertaining to this for others to see. I will be handing out detailed flyers at the court house for people to read. I will do everything I need to bring my mother home to her beautifull house and loving son so we can enjoy each other as we have for 50 years, especially the last 9 years, since my father died, where I have been with my Mother every day for dinner, spend about 6 hours a day with her and have taken care of basically all matters so my Mother can have a very enjoyable life.

Dear Mr. Herring:

Receipt of your complaint about Judge Weilheimer is acknowledged. This office will conduct an inquiry into the matters you have reported. You will not necessarily be contacted by our office prior to a decision regarding your complaint.

Since you have requested an investigation by the Judicial Conduct Board you should know what the Board can do, and, more importantly, what the Board cannot do in connection with your request. The Board can take no action to protect or promote your personal legal concerns or personal litigation objectives. You should not delay in seeking legal advice or taking any action needed to protect your interests.

The authority and the jurisdiction of the Board are limited to issues of whether a judge has committed misconduct as defined by the Pennsylvania Constitution, the Code of Judicial Conduct, or the Rules Governing Standards of Conduct of Magisterial District Judges. Where misconduct is found, discipline may be imposed upon a judge. If our investigation does not reveal evidence of judicial misconduct, your complaint will be dismissed.

Often, a person filing a complaint against a judge seeks advice about the case or requests help in getting a judge removed from the case, or to take certain actions. However, the efforts of the Board must be directed toward promoting institutional values for the benefit of the public as a whole, and not toward obtaining relief for, or rendering assistance to, any individual complainant.

The Judicial Conduct Board does not have authority to give legal advice or to seek to obtain any relief on behalf of an individual complainant. The Board does not and cannot act as an appellate or reviewing court to correct allegations of legal error made by the judge. It cannot review, reverse, vacate, or in any way modify a judicial decision or order, nor can it intervene in ongoing litigation. The Board has no authority to

determine whether the outcome of a case was fair or to order a judge to take any particular action on your behalf. The Board also has no authority to order that a particular judge be removed (or recused) from your case.

If you have any questions about your rights, you should promptly seek legal assistance or advice from legal counsel or other appropriate sources. If you do not have an attorney and believe you need one, you may contact the Pennsylvania Bar Association Lawyer Referral Service toll-free at 1-800-932-0311.

Because the Board's work is made confidential by the Pennsylvania Constitution, it ~~will~~ not provide a status update on your case or share information about its investigations. You will, however, be notified in writing as to the final disposition of your complaint in this matter. Please know it is often many months after receipt of a complaint before a final disposition can be made. Please refer to the assigned case number in any future correspondence or inquiries.

Complaints and other documents filed with the Board are not public information. If you supply the Board with documents, then you should retain copies for your own use since the Board does not return documents or other tangible items of evidence.

Finally, the Pennsylvania Constitution provides that all proceedings of the Board shall be confidential except when the subject of the requested investigation waives confidentiality per Pa. Const. Art. V, Section 18(a)(8). We take your claims of judicial misconduct very seriously and provide a thorough review of each request for investigation. Thank you for bringing this matter to our attention.

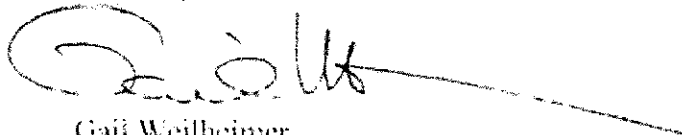

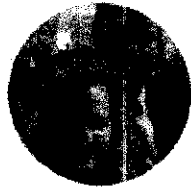

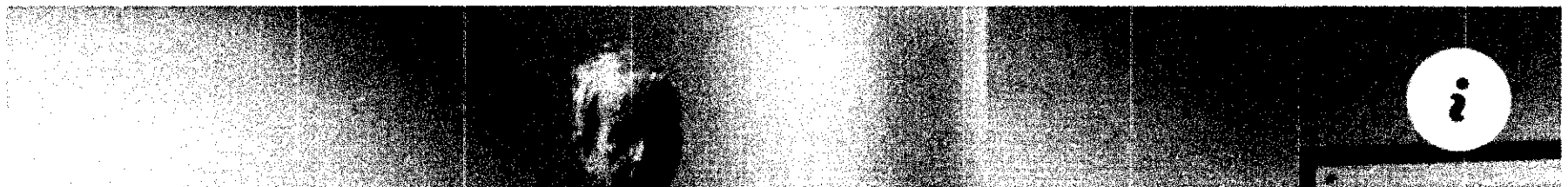
