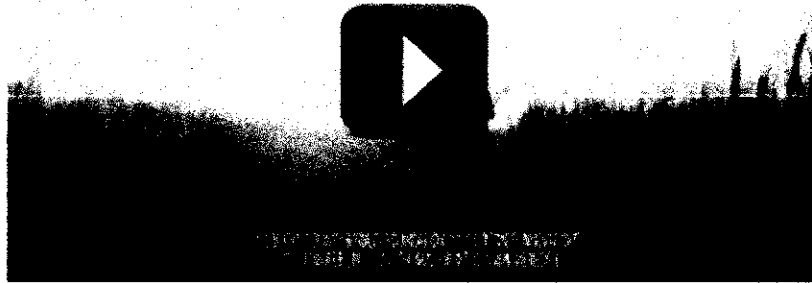

Dear Mr. Wingert,

As publisher of the Bucks County Herald, your readers must know about police corruption, @ DA's that refuse to do their jobs and 2 different board of supervisors who ignore the law and their responsibilities.

This matter deals with the corruption of a former New Britain cop, Komatick and the chief, Clowser.

All information and pictures proving it was a false arrest can be found on my massive news website www.janeherring.net.

On April 27 2024, I was arrested on 2 counts of harassment for protesting on a public sidewalk, in silence in front of a lawyer's house who was part of a group I called a guardian mafia". Those people involve corrupt judges, guardians, lawyers,

psychologists, a "care manager" and my own sister who created a fake guardianship on my late Mother starting at 96 and ended in her killing/death by morphine in a low rated nursing home on July 2 2024. Mother died a very slow and painful death of dehydration and starvation at 99.

Guardianship corruption is massive nationwide. This scam was started by my sister (then 70) only to get my mother's vast assets for herself. Others joined in with 2 corrupt judges in Norristown. Mother had NO personal or financial problems where a guardianship was needed. Mother had NO mental or behavior problems. She was put in a nursing home and kept in solitary confinement, in a sensory deprived environment for the last 3 years of her life, while the "mafia" drained her of much of her money. Mother was never allowed out of her tiny pig pen. Mother owned and lived, for 21 years in a huge 3 bedroom, 3 bath house in a gated community.

Pertaining to my false arrest, packets of letters, documents and pictures were sent certified mail 3 times to the former DA Schorn in 2025. No reply. Another packet was sent to DA Khan certified mail about February 2026. No reply. I sent packets certified mail to the chief Clowser in July 2025 while in prison. No reply. I sent packets in summer 2025 to the former board of supervisors certified mail while in prison. No reply. On June 15, I gave out packets to the current board at the board meeting. No reply. On June 22 2026, Clowser sent me a email telling me only the DA can investigate. I told him the same thing I just told you.

There is NO reason why Clowser is not dealing with this corruption of the corrupt cop, Komatick, How many other people were victims of false arrests and unjust tickets? I was told Komatick has not been at New Britain Police for about a year.

I have contacted John (news editor) several times in the past 2 years about this matter, but he refuses to do a story. Your paper has done stories about other crimes.

Go to my website www.janeherring.net and go to "documents of scam" and "pictures of scam". You will see the affidavit fraud by Komatick and my pictures and documents proving it a false arrest.

Mr. Wingert,

On June 29, 2026, I sent you a long letter about my false arrest by a new Britain cop, Komatick, his chief knew it was a false arrest, as did the 2 board of supervisors in 2025 and in 2026 (including my in person appearance in early June 2026. My arrest was April 27, 2024.

I told you I contacted John Anatasz several times in early 2026 and sent him a packet of documents and pictures about summer 2025 proving the cop and the lawyer he worked with to have me arrested, Jaskowiak.

Those same documents and much, much more can be found on my news website www.janeherring.net. You can also see my 2 hour video of the day when I was arrested for protesting, in silence, on a public sidewalk exposing the corruption of Jaskowiak in my Mother's false guardianship only for her vast assets. My news website proves the massive guardianship corruption on my now late mother, Jane Herring, starting when she was 96-99 on July 2, 2024 when she was finally killed/died by morphine that kept her unconscious in a low rated nursing home. Mother died a very slow, painful, barbaric and inhuman death of dehydration and starvation. The guardian corruption in Montgomery County has been going on for decades. In my Mother's case, it has included 2 corrupt judges, Weilheimer and Sterling, DA Steele, FBI, corrupt guardians Ronald Fenstermacher, Pam Blumer, Cynthia Ellis, various lawyers, Mother's own court appointed lawyer David Jaskowiak, a corrupt

psychologist george ledakis and my sister (at age 70).

Guardian corruption is only for the victims assets and has been nationwide for many, many decades. Many others were also contacted with my packets and were involved with my false arrest by the cop and jaskowiak. They include the former DA Schorn and new DA Khan, judge mchugh, prosecutor mccartney, past parole director shenk and the new one harrison. None of them did anything about my false arrest. I recently spent 8 months for a fake parole violation of that arrest and have spent a total of one year in prison for it.

My june appearance at the supervisors showed the supervisors did not care about a corrupt police chief clowser protecting at least one corrupt cop. I was told Komatick left about a year ago. Where is he? How many other false arrests did he and others do? How amny fake traffict tickets were given by other corrupt cops just to make points for clowser?

I have left several messages for Freda savanna in the past several months to do a story, but she never contacts me. Why?

Does the bucks county herald care about police corruption on its people? My documents, pictures and video on my news website do not lie.
