Mr. Fenstermacher,

I just checked with the Chester County Register of wills for the inheritance tax return you were supposed to have filed within 9 months of my Mother's killing.

They said no return was filed by you. As you recall, you failed to pay a tax due in 2023 and the tax bill was turned over to a law firm to be paid and you were late again to pay another tax in 2024 and the house insurance.

You have refused to answer my emails for 7 months and ignored very important matters pertaining to Mother's estate and to me, including selling me the house as you had agreed to do in about September 2024. No reason given by you. You are wasting my money by paying school and property taxes, HOA and house insurance by not selling me the house my Mother wanted me to have in writing. I am not getting any benefit of that wasted money because of your childish behavior. As you recall, you as guardian of estate and jaskowiak as Mother's lawyer had me evicted from Mother's house without asking her. Since then I have been forced to live in my car. Your obligations, as her lawyers and you as her guardian of estate, were to your client, Mother, even if she was claimed to be a incapacitated person decided by a quack psychologist who admitted in court, by my questioning, that his so-called "tests" and "evaluation" had NO independent proof of accuracy, plus my sister, in her made up petition for guardianship, never provided any of the professionals Mother dealt with every year to say Mother ever needed any guardian. You asked my sister first if she wanted the house during the summer of 2024 and she declined because she had a house. You have refused to prove, with real documents, my Mother ever forgave the

First, you claimed it was part of the estate, but several months later you claimed you did not know about it until after I had just told you in a later email. As you also recall, my sister put Mother in a much cheaper casket just before the burial, instead of the much more expensive casket Mother picked out for herself many years before.

As you recall, during a hearing in early 2024, by my questioning, you claimed you thought your only job as guardian of the estate was to just to sign checks and not be concerned about waste and fraud in those checks. You also stated in that same hearing, you had not seen or talked to Mother for 4 years, including your almost 2 years as her guardian of estate. But, you were giving away her money to strangers who were not to be paid by her, not asking her what she wanted, including where to live and also totally ignoring the federal and state laws regarding those claimed to be incapacitated, including the various rules for those people on their care and their wants.

Will you remove yourself now from being Executor of Mother's estate and my Trustee? You have refused to do your legal obligations in those positions, thus causing me undue harm financially and emotionally.

Mr. Fenstermacher,

I still have not heard from you on any answers of my questions for the past 7 months. They include why you suddenly decided not to sell me Mother's house as you had agreed to do in late summer of 2024, at the agreed upon price, but you had asked jsh if she wanted the house and she declined. You have been wasting my inheritance on the property tax, sewer tax, school taxes, HOA, utilities, etc, but I have not received any benefit of that money wasted by you because the house still is unoccupied since August 25 2023 when you and jaskowiak had me evicted from the house. But, neither of you had ever asked Mother what she wanted and she had that right.

As per your email pertaining to the tax report on april 7 2024, as I have told you several times before, the only people to be paid were the ones appointed: guardians of person and estate and jaskowiak. No one and nothing else, which would include guardian lawyers, a "care manager" klock, travel expenses, any meals and especially the guardian of person's (pam blumer) so called "monitors" blumer's friends, who were told to sit with Mother and me during our visits and were told to write lies in their reports to restrict and deny visits to me with Mother. Those "monitors" were paid with eith my money or Mother's. As you also know, just after being hired, pam blumer hired her husband, bill, as her lawyer and then he hired other lawyers from his law firm. Bill blumer is good friends with jaskowiak, along with many of the other people in this guardian mafia. As you know, those lawyers refused to let me protect myself with a cell phone to record my visits to prove I never did anything wrong and refused to prove any of their claims in court.

In addition, as you recall, you stated in court by my questioning, you had not seen or talked to Mother for 4 years, including basically the 2 years you were the guardian of her estate. You never became a certified guardian so you would know the federal and state laws of guardianship and learn the rights Mother had as being a so-called "incapacitated" person. You either failed to learn them or ignored those federal laws and rules. You also failed to learn or ignored the Pennsylvania Rules that governed the treatment and rights of those so-called "incapacitated" people: Mother. You also allowed the same quack psychologist, ledakis, to be used and paid by Mother, even though he admitted in court, by my questioning, he had NO independent proof of accuracy for any of his tests and for his so-called "evaluations" of Mother. In other words, ledakis was a unqualified person to be used or paid.

You also refused to protect Mother's estate assets (later my inheritance) by trying to find a much bigger, much cheaper and much nicer place for Mother to live, including living back at home and having basic care, such as for bathing. I had been living there for at least 2 years before the fake petition was granted.
