They wanted to fix their petitons their way by me never seeing them. I sent them a email telling them to stop doing it. Jaskowiak got the DA to put me back into prison because I had contacted him, a violation of parole. The corrupt prosecutor did not care that 2 lawyers were trying to fix cases.
