

WEILHEIMER BIO

She was the corrupt judge who was a part of the guardian mafia in Montgomery county court and is now a U.S federal court judge in Philadelphia. Her husband is VP and chief legal council for the Philadelphia Inquirer. For many years, he has killed all of the reporters stories about guardianship corruption in Montgomery county courts, especially orphans court where his wife was a judge in orphans court. Gail A. Weilheimer is a federal judge serving on the **U.S. District Court for the Eastern District of Pennsylvania**, one of the federal trial courts covering Philadelphia and surrounding counties. She took office on **January 3, 2025**, after being nominated by President Joe Biden in 2024 and confirmed by the U.S. Senate in December 2024.

Before becoming a federal judge, she served for about **11 years on the Montgomery County Court of Common Pleas (2014–2025)**, where she presided over:

- Criminal cases
- Civil cases
- Family Court matters
- Orphans' Court (estates, trusts, guardianships)

She became known in Pennsylvania for establishing the state's **first Competency Court**, designed to address criminal defendants' competency to stand trial and related mental health issues. She also held leadership roles on statewide judicial committees focused on mental health and behavioral health in the justice system.

Her professional background includes:

- Assistant District Attorney in Philadelphia (1995–2002), where she tried numerous criminal cases.
- Private practice as a trial lawyer and senior counsel at Wisler Pearlstine LLP.
- Service as an elected commissioner in Abington Township, Pennsylvania.
- Teaching trial advocacy as an adjunct law professor and participating in judicial education and mentoring programs.

She earned both her **Bachelor of Arts** and **Juris Doctor** from Hofstra University and was a Harry S. Truman Scholarship recipient during her undergraduate studies.
