

WEILHEIMER COMMITS FELONIES TO STOP ARTHUR FROM HELPING HIS MOTHER

GET HOME FROM THE PIG PEN NURSING HOME AND SOLITARY CONFINEMENT

On June 22, 2023, judge weilheimer (orphans court, Montgomery county)) told Arthur she was going to block his email address to her office because she claimed I had contacted her office staff too many times. I was pro se and I was trying to get information on various filing procedures. I had no money to hire a lawyer to help get my Mother home. Mother was 96 and was killed/died at 99 under the guardian mafia's ownership.

Weilheimer lied. She had NO intention of only blocking my email address to HER office. She contacted the county IT, Olivieri, and told him to block my email address to ALL county agencies, included were the county board of commissioners, DA, and sheriff department. Weilheimer was trying to STOP me from using those agencies and others to help my Mother get home.

This "guardian mafia" included weilheimer and later judge sterling. My sister's(jsh) lawyer, camp, filed jsh's petition for guardianship on Mother on May 18 2021. Mother's corrupt shister was jaskowiak, who weilheimer appointed on May 21 2021, only 3 days after jsh/camp petition was filed. Why did weilheimer act so fast to appoint jaskowiak to Mother? Mother had vast assets to hire her own lawyer. Because this mafia wanted one of their own people to be able to control everything Mother did and had, including visits and phone calls with me. BUT, Camp did NOT send me her email and the petition until May 24 2021. WTF? Mother and I were never given any time to get her a lawyer she liked. Weilheimer appointed jaskowiak 3 days BEFORE Mother and I even knew about the petition. WTF?

Other people in this mafia on Mother included corrupt guardians, pam blumer, dwayne logie, ronald fenstermacher (also lawyer), Cynthia ellis, corrupt lawyers diane zabowski, bill blumer, thad gelsinger, other lawyers working with blumer and gelsinger, a "care manager" deb klock who is well known for stealing and over drugging her victims and a corrupt psychologist George ledakis.

What happened to my late Mother, Jane, is called guardianship corruption and is massive nationwide. It is also called "white slavery" because it usually only happens to white people because they have the money and a house to sell for more money for those crooks. The corrupt guardians are just pimps and the elderly are their whores. Most of the time, guardianships are started by a close family member just for the money now, instead of waiting until the loved ones die. Montgomery county orphans court has been known for decades as being corrupt, with many other corrupt judges. For over 25 years, on Facebook, there is a site called Shenanigans in the Montgomery County Court.

Mother's 96 birthday was may 16, 2021. Jsh had lunch with Mother on may 17, 2021. Jsh KNEW she was going to file the petition on Mother on may 18, but NEVER told Mother about it. Jsh said in court she never discussed the matter with Mother because jsh did not think it was that important. WTF? Jsh wanted to be guardian of person and estate of Mother because jsh only wanted control and to use Mother's vast money and house. Jsh had always hated her Mother. Jsh/camp NEVER cited one example in the petition that said Mother had any problem mental, medical, financial or personal. NO Professional that Mother dealt with during the year (doctors, dermatologist, dentist, hair dresser, house keeper, CPA, investment people, etc) were ever brought in by jsh/camp to claim Mother had any problems. Both weilheimer and jaskowiak should have demanded the petition be denied, but they never did. Why? They wanted Mother guardianized so they could steal Mother's money. I was living with Mother for 2 years (at her request), so I knew Mother best, but the mafia refused to let me testify. Why? The truth and facts from me would screw up the mafia's plan to get Mother's money. Mother was still driving her car safely at 96: no tickets no accidents for the past 50 years. Mother's primary doctor of 21 years, Kuhar, never said Mother should stop driving. Kuhar was NEVER brought in to testify. She knew Mother extremely well. Why wouldn't the mafia want such a person if Mother had problems? Because Mother did NOT have any problems that needed guardianship.

Weilheimer and jaskowiak always refused to let my Mother come into court to speak for herself because they knew it was the law she could and they were afraid Mother would use her rights to speak and demand what she wanted. Mother had many rights as a AIP (alleged incapacitated person). Those rights also include federal and state rights, PA rules of Conduct for lawyers and various laws pertaining to how the AIP are to be treated by the guardians. Those laws and rules are basically NEVER followed by other guardian mafias.

The mafia used lies about me to severely restrict and deny visits and phone calls with Mother. I was ordered by weilheimer never to tell Mother anything about the scam on her. Jaskowiak put me into prison 5 times, for almost 1.5 years for revealing the scam on Mother on my other news website protectmyparents.us .

From august 25 2021 when Mother was kidnapped from her house by logie and jsh to July 2 2024 when Mother was killed/died, out of a possible 24, 700 possible hours I could have been with Mother (24 hours-8 sleeping= 16 per day), the mafia only allowed 224.

Mother was killed by morphine, kept unconscious and died a very slow, barbaric and inhumane death by dehydration and starvation. Animals.

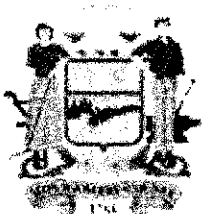
