

LETTER SENT TO THE NEWS EDITOR AT THE BUCKS COUNTY HERALD ABOUT MY FALSE ARREST

On august 7 2025, I sent this letter to John Aganassi while in prison for sending a letter to lawyers looking for a lawyer to sue.

I had been in contact with him several times, for the past year after my false arrest for harassment for only protesting on a public sidewalk in silenece. I had the pictures, documents and video proving it was a false arrest by komatick and jaskowiak. Aganassi refused to do a story about the police corruption.

As of July 2026, he still refuses to have a reporter do a story about a corrupt police department. These same letters, pictures and documents were also sent to police chief clowser, the board of supervisors of new Britain last year and this year, the former DA Schorn (3 times), the new DA Khan, the new township manager Valla, judge mchugh and the former and new directors of parole: Harrison and shenk. All of my packets to them were sent certified mail. I have proof they all got them, but did not care I was in prison on a false arrest.

Corruption!

Dear John,

I hope this letter finds you well. I am writing to you from the Bucks County Men's Center, minimum security, E14. I am here because of the corruption of the police officer Komatick in the New Britain Police Department. I was arrested and charged with harassment, two counts.

As per my false arrest and false imprisonment pertaining to the two charges of "harassment," I am enclosing the cop's two-page affidavit, my two pages of each of his paragraphs, the picture of my protest sign and the picture of what I wrote on the sidewalk the first time I protested in front of lawyer Jaskowiak's house on April 23rd, 2024.

As you can clearly see, Komatick, the cop, clearly lied about the sidewalk message and what was on my sign. Cop CONFIRMED in his affidavit fraud he got my two-page newsletter I gave out to all 36 homes on Jaskowiak's block on April 10th, 2024. He knew then about the guardianship scam on my mother by Jaskowiak's and many others, including two judges, guardians, lawyers, psychologist and others. Cop also confirmed he told me on April 23rd, 2024 that a few of the neighbors did not like me protesting. But, where did he tell me and under what situation?

When I protested for the first time on April 23rd, 2024 at the lawyer's house, after about ten minutes, a man came up to me, claimed he was a PA state cop and told me I would be arrested because the sidewalk was private property. I left and went to the police department. The code enforcement told me sidewalk was public property. As I was leaving, cop had just come back from where I had been and I met him. I spent about twenty minutes telling the cop about the guardianship corruption on my mother by that lawyer and many others. Cop knew TWICE why I was protesting: our conversation and my newsletter he got from a neighbor. So HOW can cop claim in his fake affidavit at the end of it that my reasons for being there were baseless, therefore harassment? No cop has the power to cancel a protest if he does not like it or for someone else, unless the protest is blocking traffic, causing damage, et cetera. There is also the video I made that morning proving it was a quiet protest of just me. It is posted on my news website, www.janeherring.net. There are many more documents of the guardian corruption on my mother that is posted on my website.

Police chief Clowser has my much larger packet of documents about this harassment scam on me because I have been exposing the guardianship scam on mother for four years, which also included Jaskowiak, who was mother's lawyer. He only saw her twice in three years and never defended her or protected her in the fake guardianship, only for her vast assets. Clowser got his packet last Monday. He has not contacted me to discuss what he will do to get me out of prison because of how his cop and the lawyer lied. False arrest, false imprisonment, giving false statements to law enforcement, giving false affidavit to law enforcement, perjury by both many times in court, et cetera.
