

Mother's scam was pre arranged by the mafia

These pages come directly from the court docket of my Mother's case.

Page 1. it lists the date of death as July 2 2024, which is correct. But Mother's death certificate says July 3. How can a serious mistake like that be made when it could involve further legal matters.

Mother's birthday was May 16. Jsh had lunch with Mother on May 17. The petition for guardianship was filed by my former sister, jsh, May 18, 2021. Jsh admitted in court she never discussed the petition with her Mother because sister did not think it was that important. Why wouldn't sister discuss such a serious and life changing matter of guardianship with her mother before doing so?

Page 2- Judge weilheimer appointed lawyer jaskowiak as Mother's lawyer on May 21, 2021. But, Mother was allowed to hire her own lawyer because she had the assets to do so. Weilheimer and jaskowiak always refused to let mother in court to speak for herself and refused to let mother ever hire her own lawyer. Jaskowiak only saw mother 2x in 3 years. But, he was filing petitions and making decisions for her without ever asking her. That is a violation of the rules for lawyers in PA who must consult with their client on a regular basis. On May 25, 2021, jsh's lawyer camp, sent me a email telling me jsh had filed a petition for guardianship. On June 1 2021, weilheimer sent me a notice that a petition for guardianship had been filed.

Page 3. On August 6 2021, weilheimer claimed my Mother was incapacitated, a total lie. On August 11, 2021, weilheimer appointed the first guardian of person and estate logie. Logie had been hired many times by others in this guardian mafia. Weilheimer did not give Mother or me time to find our own guardian of person and estate because weilheimer, jaskowiak, etc, had their own corrupt people they knew would go along with the guardianship scam stealing money
