Giving a false affidavit to law enforcement is a crime. Perjury is a crime. Manufacturing evidence is a crime.

About the end of 2025, a friend found out komatick was no longer at new Britain police. It is a small department of only about 15 cops.

What was komaticks payoff by jaskowiak for lying to get me arrested??? Was it a job with a bigger police department and more money? Who would think that was a payoff? Why would a young cop lie, risk losing his job and career and go to prison for deliberately making up a false arrest for a person?

COUNT 2: Harassment - Course of Conduct W/No Legitimate Purpose - (S)

On or about: 04/10/2024 18 § 2709 §§ A3

On or about 4/10/2024, 4/23/2024, and 4/27/2024, with intent to harass, annoy, or alarm another person, namely, David Jaskowiak, engaged in a course of conduct, or repeatedly committed acts, which served no legitimate purpose
