

LETTER SENT TO NEW DA KHAN AND NEW DIRECTOR OF PAROLE HARRISON

On march 1 2026, I sent a letter to both of khan and harrison, certified mail, telling them how I was falsely arrested by a corrupt cop, komatic, and lawyer jaskowiak. I sent both packets of documents and pictures proving the cop lied in his affidavit.

As of July 2 2026, neither one of them have done anything to help me correct the false arrest that caused me to be in prison for a year.

Dear Sirs,

I am asking for your assistance so I may proceed in various legal matters after I was falsely arrested on April 27 2024 for protesting, on a public sidewalk, in silence, in front of a lawyer's house in New Britain. I was protesting because that lawyer (DJ) and others including corrupt judges, guardians, many lawyers and others were part of a "guardian mafia". This "mafia" had my Mother, Jane Herring (then 96) falsely declared "incapacitated" in August 2021 only so they could steal her vast assets. Guardianship corruption has been nationwide for decades. My massive news website has information about guardianship corruption nationwide. As her loving and caring son (then 68, now 72), I was determined to bring my Mother back to her large and beautiful home and have those barbaric and inhumane criminals put into prison for many years.

I failed to do so. On July 2 2024, Mother (99) died/killed under extremely suspicious circumstances in her low rated nursing home, where she had been kept locked in solitary confinement for three years, with people with mental and behavior problems, in a sensory deprived environment, no phone, no tv, no friends or ministers allowed and never allowed outside into society. No person ever claimed my Mother had any type of mental or behavior issues, financial problems or any other type of problems. While this mafia "owned" my Mother, my visits were either extremely restricted or denied as punishment and control of me because I was exposing then and continue to expose their scam in many ways, including in my other news website:

My news website has many documents, court documents, pictures, emails, videos, court transcripts, etc, proving the mafia's scam on my Mother. That information also includes my false arrest by the corrupt cop and DJ. DJ and the corrupt cop worked together to have me charged with two counts of harassment for protesting. DJ did not want me to keep exposing him in this guardian mafia, a mafia that has and had many, many other victims.

The corrupt cop wrote a fake affidavit to have me arrested on April 27 2024 for protesting. My two public defenders refused to use my documents and pictures in court to prove my innocence and to prove perjury and other felonies by the cop and DJ. Bail was \$100,000. After 3 months in prison, I was finally released on a much, much lower bail. In May 23 2025, I was put back into prison by the parole department and DA Schorn for sending letters to lawyers looking for a lawyer to sue for my false arrest. DJ used his contacts again to claim I was harassing him by doing so. But, it was a lawyer friend of DJ who sent DJ one of my letters. My envelopes had "Confidential" in 1 inch letters, plus the Privilege Rule for any information a lawyer gets cannot be disclosed. The parole department claimed I violated Rule #8. I was convicted of NOT sending a letter to DJ. WTF? Some of those Rules are extremely vague and the list says not all rules are listed. Why not? During my May 23 2025 trial, DJ gave a so-called "victims" speech. He lied 3 times in it, but I was denied my right to speak to prove DJ lied. Why? McCartney and Hunter also did not care that DJ lied. Why? In January 2026, I was finally released from county prison after serving 8 months for that violation. My probation ends in May 2026.

In July 2025, while in prison, I had packets of documents that included the cop's fake affidavit, facts of why it was a fraud and pictures sent certified mail proving my false arrest. Many felonies had been committed by the cop and DJ. Those packets were sent to DA Schorn (3 times), Judge McHugh, Director Shenk, prosecutor McCartney (May 23 letter trial) and police chief Clowser. None of those people ever contacted me about my false arrest. That is called corruption.

At the bottom of the Rules list, it says if I have any questions about those Rules, to contact the parole department. My parole officer has always been Matt Hunter. I sent Hunter, on February 12 2026, a list of 14 questions asking what am I allowed to do pertaining to posting new items on my news website, contacting lawyers, contacting various other people, contacting news media, contacting law enforcement, contacting politicians, etc, about the scam on my Mother. Much of that would also include talking about and information about DJ. Hunter's responses to my emails to him about those questions have been "non answers". But, Hunter continues to claim he answers them. You

can see my email to him where I ask very specific questions and he only has to say yes or no to each one. Why is Hunter deliberately refusing such a simple request? By refusing to answer my specific questions, is he trying to set me up to be put back into prison by he/parole/DA claiming something I did violated a rule without any rule actually saying it, like with my letters to lawyers looking for a lawyer to sue? As every lawyer knows, lawyers must know everyone in a legal matter to avoid a conflict of interest. My letters had names of about 12 other people besides DJ.

I am enclosing the cop's fake affidavit, my explanations of each part proving it a lie, my pictures of the sidewalk and my protest sign proving the cop lied about what I wrote on them. In different courts, several times, both the cop and DJ swore under oath the cop's affidavit was factual. They lied. Among many felonies, both also committed perjury. That includes DJ, who is a officer of the court. I took a video of my two hours protesting. That is on my news site

. But, it was implied by the parole department my news website could be claimed it was harassment to DJ, so the site is down. Can I put my news website back up, in full without the risk of claiming it is harassment to DJ?

I was told by the parole department in December 2025, before I was released, Walsh had asked DJ for a letter if he wanted me to be released. So far, the judges office, clerk of court and parole department have all claimed the other one has the letter from DJ. I want a copy of it. Will either of you send me a copy?

There are many matters, some legal, I need to do because of the scam on my Mother and per my Mothers estate. This simple matter of getting yes/no answers from Hunter to my 14 questions has dragged on for almost a month. Will I get my specific answers from anyone who has the authority?

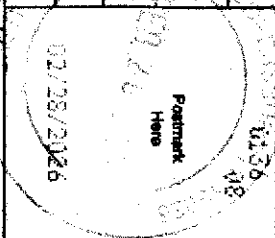
