

LETTER SENT TO PAROLE DIRECTOR SHENK IN MID 2025

I sent her basically the same letter in August 2025 while still in prison. I sent basically the same letter to DA's, police, board of supervisors of new Britain township, judge Mchugh and others about my false arrest. I sent this letter also certified mail as I did with the others.

Shenk never responded as of July 2026.

Dear Parole Director Shenk,

My name is Arthur Herring III. I am now a prisoner in the Bucks County Men's Center, minimum security, E14. To see much more of my false arrest and the guardianship corruption scam by many people, including corrupt judges, guardians, lawyers, psychologists on my late ninety-nine-year-old mother go to www.janeherring.net. I am here because of the corruption of the police officer Komatick in the New Britain Police Department. In April 2024, I was legally protesting, on a public sidewalk in front of a lawyer's house because he was my mother's court appointed lawyer and seemed to be in charge of this guardian mafia. Guardianship corruption on the elderly, for their money and their homes, is massive nationwide. I was arrested and charged with harassment, two counts. But, Komatick clearly lied in his affidavit about me not having a reason to protest. Komatick CONFIRMED in his fake affidavit, he had my two-page newsletter I gave out to thirty-six homes, on the block where the corrupt lawyer lived, on April 10th and in a meeting with Komatick on April 23rd. Komatick also lied about what was on my protest sign and what I had written on the sidewalk. Enclosed documents prove my facts.

I was arrested by Komatick on April 27th during my protest after two hours. It was only walking back and forth in silence. Because of the scam on my mother by this corrupt lawyer and others, my mother died a slow, barbaric death by morphine. She died being kept unconscious of starvation and dehydration at age ninety-nine. The corrupt lawyer, and the others kept mother in a low-rated nursing home, in solitary confinement, in a sensory deprived environment, no phone, no visitors allowed, not allowed into society or even visit her large home of twenty-two years and her much loved possessions. Mother had massive assets and that is why those criminals wanted to guardianize her. Mother had no mental or medical problems, no financial problems, no unpaid bills. Mother and I always had a very close and loving relationship. I fought for three years to get her home and away from those criminals who had sole ownership of her body and soul. After pleading guilty to harassment only to get out of prison after two months. Two different public defenders refused to allow me to testify and refused to prove the affidavit was a fraud. Also, the prosecutor, District Attorney Schorn, and the judge either never looked at the only evidence, fake affidavit, or saw it but convicted me anyway for the well-known lawyer who had me prosecuted.

I have sent this same packet to the police chief. I have not heard from him. DA Schorn has received this same packet 3 times, but she does not respond. This latest prison term is six to twelve months for only sending out letters to lawyers in five counties looking for a lawyer to sue those who stole, tortured, and finally killed my mother. One of those lawyers knew the corrupt lawyer where I protested and sent him my letter. That was a violation of lawyer client privilege. All lawyers must know all people involved in a case to avoid a conflict of interest. My letter to lawyers is included. The law says any contract or clause that is vague is unenforceable. The No

Contact list, number eight, is exactly that: vague. I was sending letters to lawyers I did not know in several counties. How would I know if they had some relationship with the other? That is why lawyers must know all people involved in a case. In addition to Jaskowiak, I also named about ten other people, including two judges, guardians, lawyers, psychologists, my sister, et cetera, to be sued. According to Hunter, my parole officer, he told me on the phone that even if I told a lawyer over the phone, in an email or a letter, I still would be violating that no contact list. So, how would I find a lawyer? That list was NEVER written by a lawyer. I never had any friend of mine send anything to Jaskowiak, never called him, never protested at his house, et cetera. But nobody has any control over what other people do. In the meeting where Brad told me they were going to prosecute me on number eight, he told me the parole department was also going to claim my news website www.janeherring.net was also violating the no contact list. Did anyone train them in the law? A news website is protected by the first amendment of the Constitution. Look at my massive news website. In addition, at the hearing on May 23rd, Jaskowiak gave a "victims speech." He lied three times. Hunter was standing next to me and knew Jaskowiak lied, but never said anything to defend me. Jaskowiak claimed in his speech that I had sent him an email demanding money. But Hunter never spoke up and told the judge the parole department knew the email was a fake because a hacker had stolen all of my email contacts and sent his same money demand to people I knew worldwide. Hunter also never told Judge McHugh that I always paid my \$100 monthly fine on time and always checked in by computer every month on time for nine months. McHugh used Jaskowiak's lies to sentence me to six to twelve months in prison. The severely poor training by the parole department to their employees caused my false prison term. I have been in prison since May 23rd, 2025. What are you going to do about it?

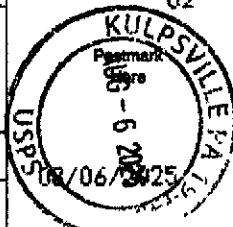
