

LETTER SENT TO PROSECUTOR MCCARTNEY ABOUT MY FALSE ARREST, PROSECUTION AND CONVICTION FOR PROTESTING ON A PUBLIC SIDEWALK

While I was in prison in mid 2025, for sending letters to lawyers looking for a lawyer to sue, I sent him my packet of pictures and documents, certified mail, proving I was a victim of false arrest, but he never cared to respond while I was sitting in a prison cell. What corruption!

Why was he so afraid to admit his department made a major mistake of a false arrest of me? OR, did he know it was a false arrest that put me into prison for a total of 1 year and a corrupt cop made it all up, along with jaskowiak for revenge because I was exposing the guardianship scam on my Mother by jaskowiak and others? Either way, it is corruption.

At my May 23 2025 trial, McCartney held up my envelope with the word CONFIDENTIAL on it and my letter. But, Anderson, the lawyer who got my envelope was not there to verify it and be questioned. Because of that, the letter and envelope were here se. But, mccartney did not know that? Judge mchugh did not know that? OR, did they know it but wanted to do a favor for jaskowiak. As of July 2026, no reply from him either. Why?

Dear Prosecutor McCartney,

Last year, April 27th, I was arrested on two counts of harassment for only protesting on a public sidewalk in front of a lawyer's house in silence by New Britain police officer Komatick. The lawyer was David Jaskowiak. I was protesting because of a massive guardianship scam on my late mother, Jane Herring, starting at age 96 by her daughter, then 70, just to get our mother's massive assets. I am Jane's son. Mother finally died/killed on July 2nd of last year, at age 99. Mother and I had always had an extremely close and loving relationship. Jaskowiak was her court appointed lawyer. Mother had no time to hire her own lawyer. Many other people were involved in this guardian scam on mother.

In January 2025, I put up a massive website, www.janeherring.net about this scam, including documents, court documents, pictures, videos, emails proving it was only a massive money scam. In his affidavit, Komatick confirmed on April 10th he got a copy of my two-page newsletter about the scam and Jaskowiak's involvement and others. On April 23rd, Komatick confirmed again we had a meeting at the police department about the scam and Jaskowiak's involvement. But, Komatick concluded that I had no reason for protesting and it was two counts of harassment. Komatick lied about what was written on my sign and what I wrote on the sidewalk. He made up his own beliefs about the protest. It was a one hundred percent legal protest, freedom of speech. No cop can decide if he does not like the protest, he can cancel it, unless it causes damage, blocks traffic, etc. Komatick signed the affidavit it was true and correct under penalty of perjury. The affidavit is a fraud, he and Jaskowiak committed perjury, both gave false statements to law enforcement, Komatick gave a false affidavit to law enforcement, both committed perjury at the DJ hearing and at the trial. At both times, I had public defenders who only saw me a few minutes before the hearing and trial. I was refused to testify, with documents, to prove it was a false arrest and later false imprisonment. I want to press criminal charges on both. I had a forty-one-year career doing lie detection testing and training nationwide. I know about evidence. The latest charge by Jaskowiak on May 23rd, involves sending out many letters to lawyers looking for a lawyer to sue Jaskowiak and others in the guardian scam. I did not know any of those lawyers. One of them sent my letter, without my permission and breaking the lawyer-client privilege, to Jaskowiak. Brad, of the parole department, claimed I violated number eight of the no contact rules. But, I did not know those lawyers and did not ever authorize it to be sent to Jaskowiak. At the court hearing, Jaskowiak gave a "victim's" speech. He lied in it many times. As an officer of the court, he lied to judge McHugh, but the judge refused to let me prove Jaskowiak lied. McHugh gave me six to twelve months.

The fact is, the entire case was a false arrest to start. My posted video on my site proves it and Komatick confirmed, in his own words in his affidavit, I had reasons to protest. I have been in prison since May 23rd. I am almost seventy-two. My lawyer on record is Vic Meimer, but I am also legally involved since I had not seen Meimer for a year and he was not informed of the many, many facts. One of them was a hacker stealing my email account and sending out hundreds of emails asking for money. Both the DA, Jaskowiak and parole department knew emails were fake, but the parole official, Hunter, never spoke up about it. I am asking for you to have your office contact me in Bucks County Correctional Facility, Men's Center, minimum security, e14, to learn more about this false arrest. I request a hearing on this false arrest, current fake parole violation, and to be released ROR until the hearing. This entire matter

has NO drugs, no alcohol, and no violence involved. It was only a peaceful, silent protest on a public sidewalk. The matter does involve a corrupt cop and a well-known lawyer who seems to have connections to have no one read the only piece of evidence by the prosecution: Komatich's affidavit.
