new britain police corruption

Good day,

I was a victim of a false arrest by the New Britain police on april 27 2024. I was protesting on a public sidewalk, in front of a lawyers house who was part of a group stealing money from the elderly in fake guardianships. My late Mother was one of his victims. Mother died on july 2 2024 after being forced to live in a locked in section in a low rated nursing home. I spent 3 years trying to get her home because she had no problems to be in a guardianship and forced to live in solitary confinement. I spent a total of one year in prison for that because of that lawyers connections with the DA office. I was charged and convicted of two counts of harrassment.

If you go to my news website www.janeherring.net you will see the details of the various corrupt judges, corrupt guardians, corrupt lawyers and others involved in Mother's scam. You will also see the full video of the day I was arrested for protesting, plus the cops affidavit of lies of my arrest, pictures, documents proving it was a false arrest. The cop, Alex Komatick, is no longer at the police department.

Where did he go?

About summer 2025,, while in prison, I sent a packet of documents, certified mail to the police chief, Clowser, proving it was a false arrest and to help me be released. No response from him. I also sent those same packets to former DA Schorn 3 times certified mail and the new DA Khan several months ago. No response. I sent the same packet to the board of supervisors about july 2025

On June 15 2026, I tried to speak at the supervisors meeting, but they denied me. I left packets of documents for each of them. I gave Clowser my business card and told him to call me to meet about

my raise arrest. He never did. Several days ago, I sent him a email and the board or supervisors in detail of what happened to me and the chief did not care to meet.

Those emails are below.

How many other people were falsely arrested by Komatick, but Clowser did not care? How many were given traffic tickets that were not justified.

I am looking for a lawyer to sue for false arrest. Can NAACP get involved to expose this corrupt police chief, board of supervisors and DA?

My documents and pictures clearly prove komatick lied in his fake affidavit, contradicted himself many times in his affidavit, but signed it that it was true and correct.
