

Corruption of the New Britain police, police chief clowser, township manager Valla and Board of supervisors 2025 and 2026

On April 27 2024, jaskowiak had me arrested for protesting on a public sidewalk in front of his home. I was exposing the guardian scam on my Mother, now 99. Jaskowiak called in some favors and had me arrested and charged with 2 counts of harassment. The dirty cop, komatick, wrote many lies in his affidavit, but he and jaskowiak claimed in court what komatick wrote was the truth. I did not have any money for a lawyer, so I had to have a public defender who refused to use my documents or put me on the stand to prove it was a false arrest. I was convicted and got a total of 1 year in prison.

While in prison in 2025, I had a friend send out packets of documents and pictures proving the cop and jaskowiak lied. The packets were sent certified mail. The packets were sent to clowser, all 5 board members, DA Schorn 3 times, news editor of Bucks County Herald, director of the Bucks county NAACP, but nobody cared a dirty cop and a corrupt lawyer put me into prison. In early 2026, I sent out those same packets to the 5 new board members, Valla and new DA Khan.

On June 15 2026, I went to a Board meeting. They refused to let me speak about it. I gave Valla my business card and told him I wanted to talk to him about the corrupt police department. I did the same for Clowser.

Attached are the emails all of them got. None of them care about their corrupt police chief and cops. I found out last year, komatick left the police department. Where is he. Did jaskowiak get him another job with more money as a cop?

Mr. Clowser, New Britain Township Supervisors,

On June 15 2026, I met you after a township supervisors meeting. Earlier, I had briefly spoke in front of the supervisors and you about the corruption of you, one of your police officers and the supervisors from last year about my false arrest by your department on April 27 2024. I left packets of documents proving it was a clear false arrest for you and the Board. I gave you my business card with my news websites www.ProtectMyParents.us, www.Janeherring.net and my email address on it. I told you I wanted to meet with you to discuss my false arrest by your former(?) cop alex komatick.

As of today, June 22 2026, I have not heard from you or any of the supervisors to discuss my false arrest. My packets of documents and pictures proved Komatick clearly lied in his affidavit (felonies), lied in court several times (perjury) about my protest sign and what I wrote on the sidewalk. About July, 2025, you and the previous Supervisors received a long letter from me (while I was in prison for that false arrest) and also the same documents I left at the supervisor meeting on June 15 2026, by certified mail proving it was a false arrest and I was being kept in prison without cause. You and those former Supervisors never responded to my plea for your help to do the right thing and get me released from prison because of that false arrest. I have spent about a full year in county prison, three separate times, because of the false arrest, including 8 months straight recently.

Briefly, on April 27, 2024, Komatick and another one of your cops (name unknown) arrested me for protesting on a public sidewalk, in silence, in front of a lawyer's home in your township. That lawyer, david jaskowiak, and many other corrupt judges, corrupt lawyers, corrupt guardians, corrupt psychologists, a corrupt "care manager" and my sister, are part of a "guardian mafia" in Pennsylvania. This "guardian mafia", operating in many counties, have innocent, elderly people falsely declared "incapacitated" by corrupt judges so those victims could have their savings, house, etc, stolen from them by those in the "guardian mafia" only for this "guardian mafia". Guardianship corruption is massive nationwide

My much loved, late mother, Jane Herring, became another victim of guardianship corruption by this "guardian mafia" in mid 2021 at age 96 until her killing, in a low rated nursing home on July 2, 2024 at age 99. Mother died a extremely slow, barbaric and inhumane death by morphine. Mother was kept unconscious and died from starvation and dehydration because the mafia was done with her. For almost three years, Mother was kept locked in solitary confinement, in a sensory deprived environment. Mother never had any medical, financial or mental or behavior problems to be declared incapacitated. Mother had assets of about \$2 million dollars and a huge house paid for 20 years earlier. Jaskowiak was Mother's court appointed lawyer by a corrupt judge in Montgomery County. But, Mother had the massive assets to hire her own lawyer. Mother was always denied to be in court to speak for herself and denied to have her own lawyer by jaskowiak, the two corrupt judges on her case and the rest of the "guardian mafia".

Mother was kidnapped from her house by jaskowiak and the Mafia on August 25 2021, without any court order or reason. She was put into a low rated nursing home, got covid twice where she could have died, kept in solitary confinement, never allowed to leave to be in society or visit her home and never allowed to see her much loved possessions of almost 100 years. Mother was kept locked in her tiny section until her killing/death on July 2, 2024. Mother and I were denied to see each other by jaskowiak and this "mafia" for most of her imprisonment as a punishment to us because I was constantly exposing the guardianship scam on her by this "mafia". Mother was always denied a phone, TV, her friends, ministers and even a table in her room by jaskowiaak and the "mafia". Mother had to use the nursing home's torn blankets, urine stained towels, urine stained sheets and other peoples clothes that did not fit her. I even found several dead rats in her room.

There is NO reason why my false arrest should not be immediately investigated and those responsible prosecuted and convicted for the many felonies involved by others in my false arrest. Titles of various people have no importance if they were involved.

Re: New Britain police and board of supervisors corruption

Mr. Valla,

How pathetic your decision is. perjury in court many times against me. My posted video on my news website www.janenherring.net on my 2 hours protesting the morning I was arrested prove komatick/jaskowiak lied. My news website also has all of those documents and pictures clowser and the board last year and this year received certified mail. Did you ever bother looking at those documents and pictures I left for you at the June 15 meeting?

I was told the dirty cop komatick is no longer there. Is that true? How many other false arrests did komatick lie about? How many innocent people went to prison because of Komatick and/or other dirty cops in your police department? How many traffic tickets did he give that were false?

After me spending a year in prison, on a false arrest by your police and neither you or the board, past and present, have ever cared it happened and do not want to take action to stop such corruption from happening again to others.

REREAD my email to you yesterday. I told you I contacted both new DA Khan a few months ago and former DA Schorn 3 times by certified mail last year and none of them ever contacted me. Last year, the Bucks county detectives refused to meet with me to file charges on komatick and jaskowiak.

Corruption, by paid off politicians, is available to anyone who wants it. Welcome to New Britain.

New Britain police corruption

Dear Mr. Valla,

I met you briefly at the June 15 2026 township meeting. I gave you my business card with my news website www.janeherring.net which has massive amount of documents, emails, pictures, court documents about my late mother's guardianship corruption by various corrupt judges, guardians, lawyers, etc, and also documents and pictures and the video proving my arrest for 2 counts of harrasment, which was actually only a protest on a public sidewalk in silence.

I spoke briefly in front of the board about my false arrest by the corrupt cop Komatick and how the police chief Clowser knew it was a false arrest because of the packet I sent to him of pictures and documents sent certified mail in summer of 2025 while I was in prison because of the false arrest. Clowser never responded to get involved.

At the end of the township meeting, I gave him the same business card and told him to contact me about the matter. No reply from him. I had spent about 1 year in prison because of that false arrest. In summer of 2025, the former board of supervisors also got the same packet certified mail that clowser and this current board got. No reply from them either to help me while I was in prison. On June 22, 2026, clowser told me only the DA can investigate the matter. I emailed clowser and the various board members on June 23 2026 on this matter telling them the former DA Schorn got 3 letters and my packets certified mail from me in 2025 and the new DA Khan also got my packet certified mail several months ago. No replies from any of them. Corruption and coverup?

I was told Komatick is no longer there as of about a year ago. How many others did komatick lie about to arrest them and how many tickets did he give that were not justified?

What do you intend to do about this corruption matter? I am not going to lose a year of my life in prison at age of 72 last year because of a dirty cop, a corrupt police chief and a do not give a damn board of supervisors who do not care about a corrupt cop and police chief of their own township.

Will you meet with me?

Mr. Clowser, Board of Supervisors,

The FACTS are that I did send a long letter, documents and pictures to former DA Schorn twice by certified mail and once by email in 2024 and 2025 proving my false arrest and the corruption of the New Britain police department, including you. NO reply from her. Several months ago, I sent a long letter, documents and pictures, certified mail, to the new DA Khan proving my false arrest and corruption by New Britain police, including you. NO reply from him, either. Not surprised.

A similar letter, documents and pictures were also sent, certified mail, to the former Board of Supervisors during summer of 2025 while I was in prison for the false arrest. That information again proved it was a false arrest by the corrupt cop komatick and the corruption of the New Britain police, including you. NO response from any of the previous Board, including the township solicitor. As I had also stated, I had sent you a very long letter, documents and pictures, certified mail, in about summer 2025 while I was in prison. NO reply from you. A good friend of mine tried contacting you several times

during the summer of 2025 while I was in prison for the raise arrest. He wanted to meet with you to ask for your help to get me out of prison because it was your corrupt cop, komatick, that put me there. You refused to return his calls. Coverup?

So much for any possible honesty and integrity of Bucks county and its elected officials..

My documents and pictures clearly prove komatick lied in his fake affidavit, contradicted himself many times in his affidavit, but signed it that it was true and correct. Komatick and the corrupt lawyer, jaskowiak, even swore in court, under oath, that the affidavit was true and correct. Besides perjury by both many times, there were many other felonies committed by them in my false arrest. Those same pictures and documents can be easily found on my news website www.janeherring.net.

In addition, there is my video, in full, of the day I was arrested that has been on my news website www.janeherring.net since late 2024. The video proved what happened that day. It also shows how komatick tried to start a fight with me to get a more serious charge against me for more prison time as a favor to jaskowiak and the "guardian mafia". What was komatick's payoff for doing jaskowiak and the mafia the favor of making up lies to have me arrested and put into prison? Was jaskowiak and the mafia hoping I would be murdered in prison to protect the mafia's scam on the many elderly victims they have been stealing from for many years and in many counties?

How many other false arrests did komatick and your other cops do that you have protected? How many other people had to plead guilty to fake charges just to get less prison time? How many fake traffic tickets were given by your corrupt cops to innocent people just so those cops would get a "gold star" from you for generating money for the township? How many Blacks were falsely arrested or given traffic tickets without just cause.

Finally, who am I? I had a 41 year career doing lie detection testing and training worldwide. My clients included many law enforcement type departments in many countries. I have also exposed several other major scams, including on law enforcement.

Why don't you prove you are a real chief of your department and get involved to put the real criminals in prison?

Two counts of harrassment for only protesting on a public sidewalk, in silence? Does anyone know about the Constitution?
