

This was the date of my parole violation trial for sending a letter to lawyers looking for a lawyer to sue. It was claimed by the parole department that I violated a rule of no contact. The fact was a lawyer friend of Jaskowiak sent it to him. On the envelopes of the letters sent the word confidential was in 1 inch letters. The lawyer who got that letter violated my order of not disclosing the contents to anyone without my permission.

The prosecutor, McCartney showed the letter and envelope in court, but the lawyer who sent it was not in court to be questioned. Without that lawyer, the letter and envelope is called hearsay and cannot be used as evidence. Judge McHugh said I was guilty of parole violation and gave me 6-12 months in prison. I served 8 months.

If you fail to appear without cause at any proceeding for which your presence is required, including trial, your absence may be deemed a waiver of your right to be present, and the proceeding, including the trial, may be conducted in your absence.
