

PHILADELPHIA INQUIRER INVESTIGATIVE REPORTERS PROTECT CORRUPT VP LARRY OF
CORRUPTION BY HIS WIFE GAIL IN ORPHANS COURT ON THE ELDERLY. PT 1

On July 30, 2026, I sent emails to all of the Philadelphia Inquirer's reporters who claim they are "investigative" reporters. They have not proved they are. Because, for many decades any reporter who wanted to do a story about guardian corruption in Montgomery County courts had their stories killed by the VP of the Philadelphia Inquirer: Larry Weilheimer.

If you count up 25 items on this list, you will see my massive explanation of the guardianship corruption in the Montgomery County court for many decades involving Gail, the wife of the VP and general counsel of the Philadelphia Inquirer: Larry Weilheimer. Larry is the husband of Gail Weilheimer who was one of those extremely corrupt judges in the orphans court dealing with guardianships. Gail is now a US district judge. Gail is best friends of Lorie Shapiro, wife of Governor Josh. Josh nominated Gail to Biden to be judge in 2023 and Biden appointed Gail. The title of that post is "Larry Weilheimer VP Philadelphia Inquirer".
